CSX replacing historic railroad bridge in City of Livingston

CSX Transportation is currently in the process of replacing the truss railroad bridge over the Rockcastle River in Livingston. According to a press release from CSX, the truss bridge will be replaced with a more modern Ballast Deck railroad bridge to ensure safer, efficient and economical rail service for

trains traveling across the bridge. CSX said the original truss railroad bridge was built in 1906 by the Louisville and Nashville railroad and was targeted for replacement due to its age and safety issues. The truss bridge recently reached its 106th birthday making it one of the oldest railroad bridges still in op-

eration in the state of Kentucky. CSX Foreman Keith Smith said his crew has already completed a majority of the preparatory work for the replacement of the bridge. "Crews have been installing a new pier, assembling new spans, and preparing the site for the 1,000 ton crane that will be used

to remove the old bridge and assemble the new one." Smith said. With weather permitting, Smith said his crew only had 36 hours to remove the old bridge and build the new bridge as operations will begin at 3 a.m. on September 29th and end at 3 p.m. on September 30th.

He said arrangements have been made to halt train traffic during the duration of their work. Smith said he understands and is fascinated by Rockcastle Countians interest in the railroad bridge. However, he said during the 36 hour operation that no one will be permitted near the bridge. "As much as I hate to, we have to rope off the areas near the bridge," Smith said. "We can't take a chance of someone getting hurt due to liability issues for the company."

U.S. Forest Service withdraws commercial logging proposal after negative feedback

Officials have canceled a proposal for commercial logging in the Daniel Boone National Forest in Rockcastle County that had caused concern about the potential impact on a pristine spring and trees hundreds of years old. An official with the U.S. Forest Service confirmed the decision to the Herald Leader and Kentucky Heartwood, a forest education and advocacy group which was against the plan. Opponents of the logging plan had proposed horse and hiking trails as an alternative in one area. They plan to continue pushing that idea with the U.S. Forest Service now that the logging plan has been withdrawn.

The Forest Service proposed a mix of commercial logging and tree-thinning that it said would improve the health of the forest, diversify habitat and provide trees for future use. The Forest Service also proposed using herbicides to kill non-native, invasive plants. Parts of the public forest in the area have been heavily logged in the past. There was some agreement about the need for improvement measures.

Mt. Vernon City Council to begin annexation process

In an effort to more "square up" the town's borders and to increase revenue without increased taxation, the Mt. Vernon City Council voted Monday night to begin the process to annex approximately 15 businesses.

Mayor Mike Bryant told the council that the last time the council tried the annexation process, it was a much bigger area and involved many residents who did not want to be annexed into the city. "Residents can get the question on the ballot with a petition containing 55% of the residents affected where businesses don't have any recourse."

Bryant went on to say that so far no one from the city had spoken with the businesses but that, as a courtesy, they would be notified soon.

The mayor pointed out that the businesses would receive several benefits from the annexation, including: lower water/sewer bills; regular police patrols; lower insurance rates and better fire protection. Of course, they will also be subject to the city 1 1/2% occupational tax for employees, the net profits tax and the city's insurance tax.

The annexation involves three areas: Area #1 in-

nizer Dwain Harris. "American men, on average, live sicker and die

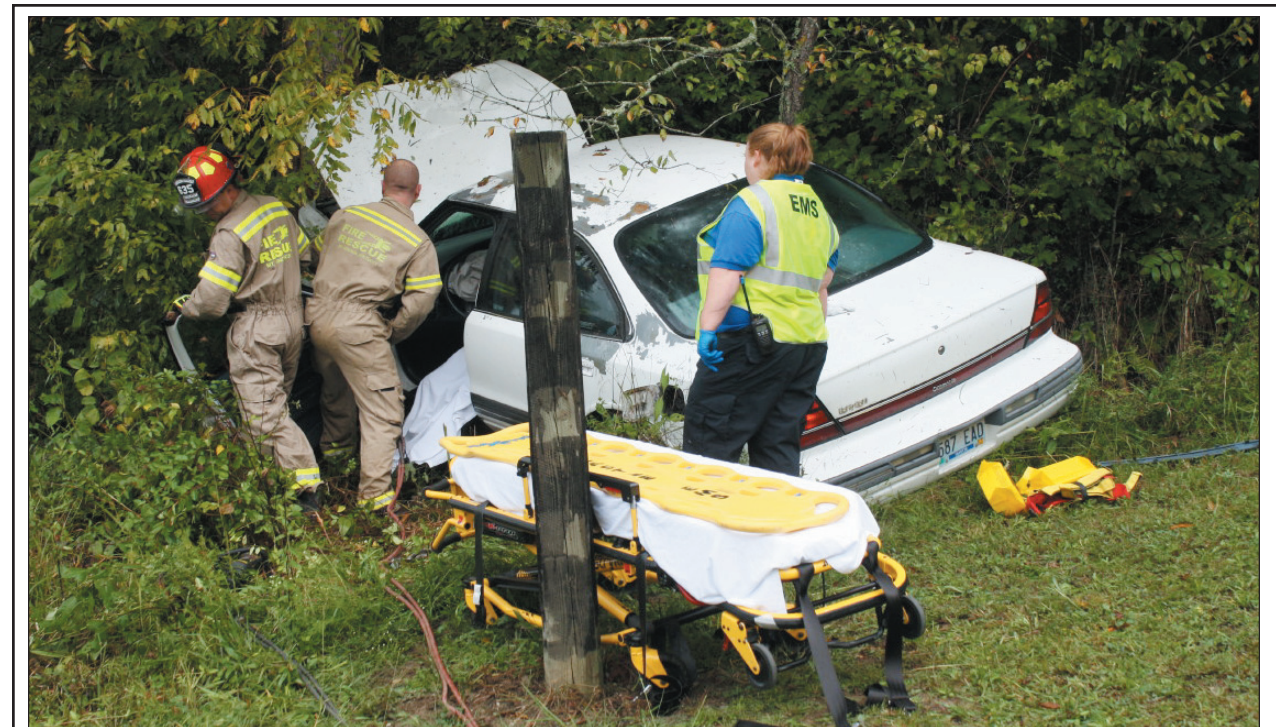

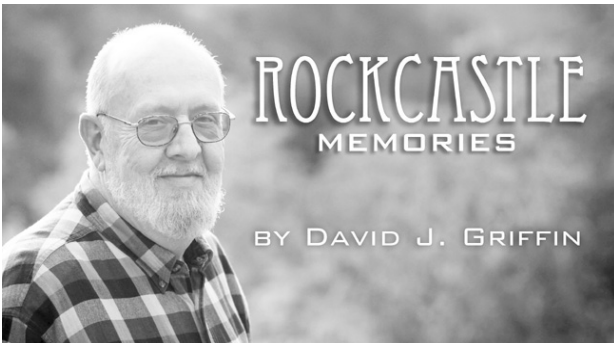

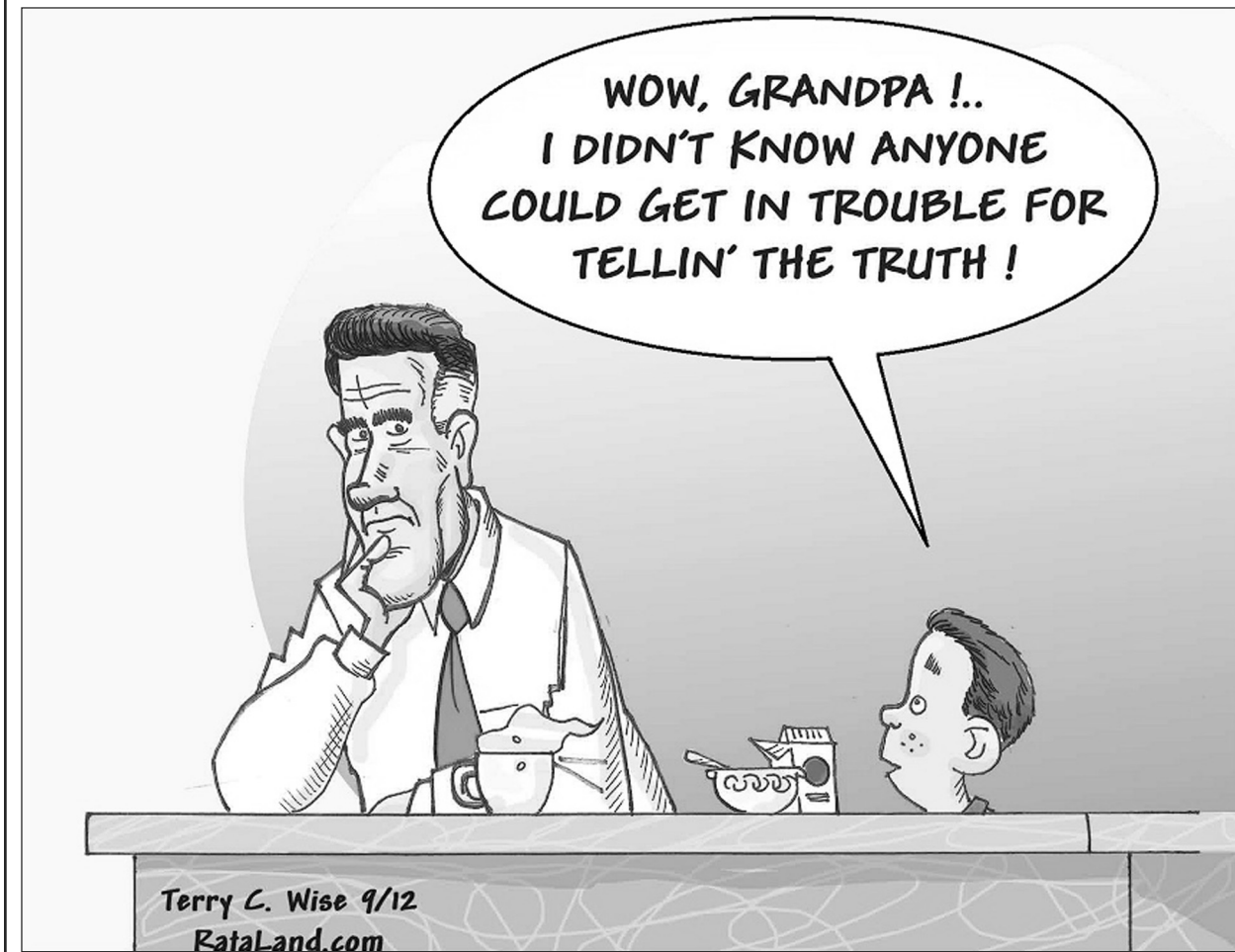
Others exhibited the "Dick Clark" syndrome and had not changed very much since 1962. I would have to say that those included the following: Mary Daily,

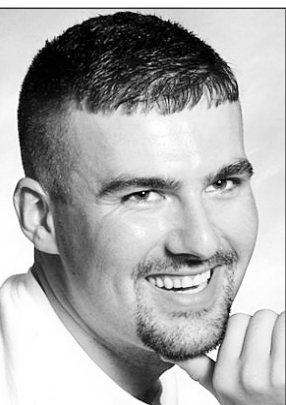

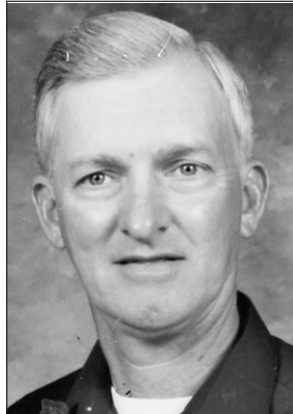

Dear Editor,
My name is Sherry Harper and my Weight Watchers story began in February of 2008 when a friend of mine, Ms. Janice Davidson invited me to attend a Weight Watchers meeting with her. I had never gone to a meeting before. I just knew that I was tired of gaining weight and wanted to make a change. I am an insulin dependent diabetic (type one) and weight for me has always gone up and down.

I was totally impressed with the program that was presented to me that night. I thought this makes so much since. It is just a matter of keeping track of everything I eat daily. The first few days I was amazed I thought I was eating well when in reality I was just not aware of what I was putting in my mouth.

I lost 3.2 pounds the first week. I continued attending the meetings which help you hear what other people are doing and realizing that you are not the only one out there going through the same weight issues. of bamboo reeds on the edge of Black Bottom when we went to trade at Oscar and Susan Back's little grocery store. He would let me select a long reed pole which he would cut off with his pocket knife and then haul

it home dangling off the bed of his old Chevy pick-up.

We housed and boarded several mining ponies in those days and the sweet feed the ate came in 100 pound burlap bags, the tops of which were sewn together with strands of stout nylon thread that made, when raveled out, 6 or 8 feet lengths of perfect fishing line. Mom would bend straight pins into v shapes, tie the pin heads to a length of sack string and we would wind it around the tips of the reed poles, and presto, perfect fishing rig for the horny head chubs then residing in every little pool on Blair Branch.

By the time I was in 4th grade in the late 1950's I was allowed to spend two weeks every summer with my Uncle Jim and Aunt Alpha who lived on the Kentucky River. Uncle Jim was a fisherman's fisherman and he had a big selection of bait casting rods and reels. He also had the patience to teach his nephews how to use and care for them. Other kids may have counted the number of days until Christmas but I counted the days that remained before I got to spend a vacation fishing with my ever grinning Uncle Jim.

I believe he, too, looked forward to our visits because it gave him a valid excuse to pretty much fish around the clock for two whole weeks. Of course Aunt Alpha would insist that the garden had to be hoed, the lawn mowed, her flower beds weeded, beans picked, and other such chores done before any fishing was allowed but that was just fine with me.

With Uncle Jim peering over my shoulder on one trip or another, I caught my first bass, catfish, redeye, and red-honey sucker and I have, on many occasions, watched in awe as he played and landed trophy-grade small mouth bass that nobody else on the river seemed able to tease into biting.

As Les Crandall backed his boat out of my driveway he yelled back at me, "You sure missed out on a heck of a fishing trip!"

And I thought to myself, "I'm sure I did, but I'll bet anything that I've had a thousand better."

I'd also bet about anything that Les never experienced the thrill of catching a big horny head chub with a pin hook and a reed pole.

September 23, 1913. My grandmother would have been eleven years old at its writing. The report is now nine-nine years old, but is just as pertinent to us now as the day it was written.

The First Year of the Revolutionary War-1775
By Evelyn Price-Norton

The Battle of Lexington was fought by General Gage and his British troops. He had instructions to arrest certain leaders who had been disobeying the Royal Government. Among those were John Hancock and Samuel Adams who were at Lexington, ten miles from Boston, and to destroy some military stores at Concord. It was meant to be kept secret, but it was detected, and Hancock and Adams escaped. The battle was fought on April 19, 1775. When the British found a few minutemen on the field, they ordered them to leave and when they refused, they opened fire upon them, killing eight Americans and two British.

The Battle of Concord was fought April 19, 1775 by the British and the Americans. The minutemen destroyed a bridge so as to keep the British off of their side. The whole regions were in arms, which meant great danger for the British. The British were forced to retreat for their companions fell thick and fast. There were nearly three hundred British killed and not quite a hundred Americans.

The Battles of Concord and Lexington kindled the flame of war from New Hampshire to Georgia.

Governor Dinsmore stole the gunpowder from Williamsburg and soon after that, fled to a British warship. On May 10, Colonel Ethan Allen captured Fort Ticonderoga in northern New York and on May 12, took Crown Point, a fort near Ticonderoga. Military supplies fell into their hands.

Congress met on May 10, 1775, which they said that they did not want to be separated from Great Britain, but that they wanted peace, but that Great Britain had begun the war and that allegiance to the Crown would be restored to the Crown only as it was in 1763. While they were desiring peace, they took steps at the same to protect themselves. A call was made for twenty thousand more men. George Washington of Virginia was chosen Commander in Chief of the army, three million dollars in paper money was issued. Later, a small navy was created.

North Carolina assembled in conventions at Charlotte, and declared themselves independent of Great Britain. They were so active in their opposition that the British came to regard them as a hornet's nest.

The Battle of Bunker Hill was fought June 17, 1775, between the British and the Americans. The Americans were learning that the British were aiming to fortify Bunker Hill and Dorchester Heights overlooking Boston. The Americans planned to fortify Breed's Hill, across the River Charles from Boston, and between the town and Bunker Hill on July 17. The British opened fire on them.

The cannonballs fell thick and fast, but the Americans continued their work. About three thousand British soldiers crossed the river in flatboats. They came in close range of the Americans. The first march was successful, but the third time the Americans had exhausted all of their ammunition. The British loss was more than a thousand, and the American's less than five hundred, but it included the brave General Warren who was killed. The British won the victory of this noted battle.

General Washington took formal command on July 3, 1775. The army was in lack of everything. Most of the New England people cheerfully fed them, but could supply all of the things needed. The army received supplies from all parts of the states; among them was some gunpowder sent from Georgia, which had been taken off of a British warship near Savannah.

Canada would take no part in the war. General Richard Montgomery, commanding an army of about a thousand, entered Canada by the Lake Champlain and captured Montreal. On November 12, he prepared to move on to Quebec. Many of his soldiers had deserted him on account of their enlistment had expired and others had died of smallpox until his army was greatly reduced. He received reinforcements in the spring from Colonel Benedict Arnold with eleven hundred who suffered greatly on their way, coming in deep snows and wading rivers of ice. They were reduced to eating roots of trees and their moccasin shoes when finally Indians came to their relief. Montgomery forces arrived on December 3, and the little armies laid siege of the stronghold. Before day-break on December 9, while

heavy snows were falling, they made an attack upon the town in two columns. It was meant to have been kept a secret, but was betrayed by one of the deserters. The Americans met with heavy losses. Montgomery was killed, and Arnold was wounded. They passed the remainder of the winter near Quebec, suffering greatly from cold and smallpox. The next year, British reinforcements were sent to Canada. The next summer the Americans retreated from Canada, thus closing a disastrous campaign.

The Battle of the Great Bridge was fought December 9, 1775. Governor Denmore and his British troops fought the American militia-the militia gaining the victory for revenge. Denmore burned Norfolk on New Year's Day, shortly after he left Virginia, never to return.

During the war, every colony had sprung to arms to protect their property. By the year 1775, Royal governments had virtually disappeared from the colonies, but there was no movement toward independence. There was, however, in every colony some who remained friendly to the king and Great Britain who fought against America. These were called "Tories". The American party opposed to the king called themselves "Whigs".

The course of the war was because the king and Parliament tried to force unjust taxation and laws upon the colonies. It was fought by the British and Americans in the years 1773-1782.

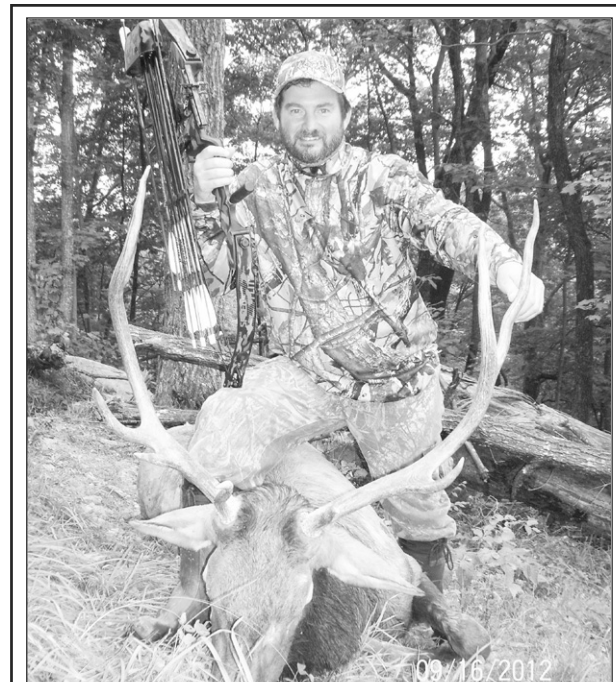

Commonwealth of Kentucky City of Livingston, Kentucky Ordinance No. FY12-610.9

An ordinance of Livingston, Kentucky concerning use of the municipal sanitary sewage collection and treatment system, setting forth policy, definitions, rules and regulations regarding the use of said system, controlling private wastewater disposal, governing the building of sewers and connections, pollutant discharge limits, pretreatment program administration, establishing the right of the district to charge fees for administering the district's reasonably necessary functions related to sewer use-, and delineating powers and authority of inspectors and setting forth the methods and procedures of enforcement of the ordinance and penalties for violation of same and repealing prior ordinances.

Whereas, the City of Livingston has constructed facilities and improved trunk lines to same; and

Whereas, the City of Livingston has determined the need for adoption of a Sewer Use Ordinance to properly control the effluent to be discharged by the public into the District's sewer system and the use of the system;

Now, Therefore, Be it ordained by the City of Livingston, that the following Ordinance shall be in effect from the date of publication hereof and until repeal and/or amendment thereof by the Mayor and City Council.

Article XII - Ordinance in Force

This ordinance shall be in full force and effect from and after its passage, approval, recording and publication as provided by law.

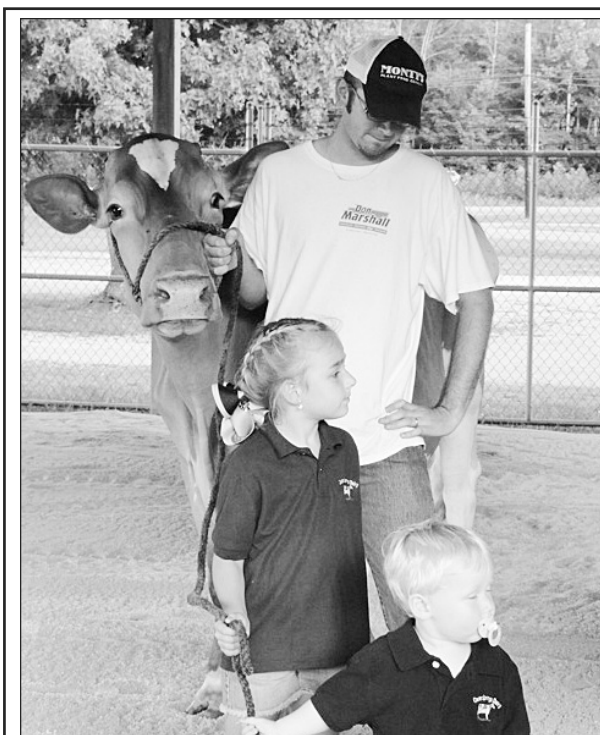

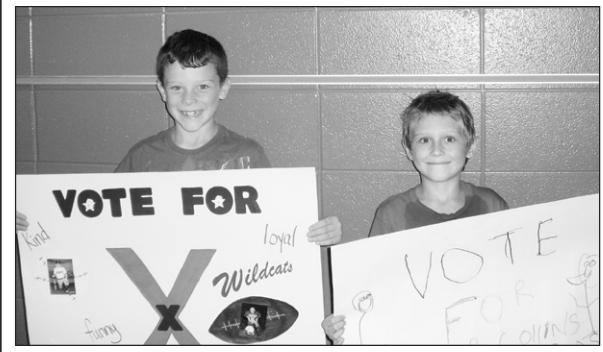
how to strengthen your relationship with your child.

UNITE Coordinator speaks at Kiwanis Luncheon

 Carlos Cameron, Education Coordinator for Project UNITE, was the guest speaker for the Mt. Vernon Kiwanis Luncheon Thursday, August 30, at the Renfro Valley Lodge. Cameron works full time for UNITE, and covers five counties, sometimes using a mobile classroom. The organization grew out of Rep. Hall Rogers' desire to curb the explosive growth in drug abuse in Eastern Kentucky, and was inspired by a special report in the Lexington Herald Leader describing Eastern Kentucky as "Pain Pill Capital of the World [Country]."
 Cameron described one of the main missions of UNITE:

"If we don't stop the generation that's going through time and time again using drugs we're just running around in circles. We're going to spend the money...throw money at it...we're not going to accomplish a whole lot."
 One of the programs that was high-lighted in his talk was a treatment voucher program for residential treatment to help addicts get off drugs. "...I don't know of any other organization in the state of ky, that's not state run, that can provide vouchers for people... that's something that's made Unite very unique. 2500 individuals have entered." This program has provided \$7 million in treat-

ment services.
 UNITE was credited by Carlos with approximately 3800 individuals arrested, netting 110,000 pills, 369 meth labs, including some located in Rockcastle County - 23 lbs of cocaine, 4,000 lbs. of marijuana, 5,000 marijuana plants. The project has recently turned over confiscated monies to police departments for the purchase of vehicles. "...We buy vehicles with drug money. Drug dealer does pay - it just pays us to buy vehicles with it."
 Carlos took particular pride in the creation of over 30 drug courts, and knowing that 195 drug-free babies were born as a likely result.

Mamaw's Kitchen

I don't remember very many Sundays that we didn't have this fried chicken. It was crispy; it was tender and just plain delicious. Before going to Mexico, we spent a couple of days with Mum. Knowing it would be some time before we would have another of her home-cooked meals, she asked us what we wanted for breakfast our last morning before our flight. We answered "Your fried chicken". That, along with biscuits and gravy, is exactly what she fixed.

1/3 cup plus 1 tablespoon shortening
 1 cup plus 2 T milk
 Preheat oven to 475°. Sift flour. Cut in shortening with fork until particles are size of rice. Make a well and add milk all at once; stir only until just well mixed. Drop by heaping tablespoon (about 2 inches apart) onto greased baking sheet. Bake at 475° for about 15 minutes or until golden brown. Makes 10 to 12 biscuits or muffins.

SUNDAY FRIED CHICKEN

2 to 3 pounds chicken cut up
 1 cup flour seasoned with

salt and pepper
 1/2 cup vegetable oil or lard
 Rinse chicken with cold water. Dredge in seasoned flour. Place oil or lard in a large skillet, preferably a 12-inch cast iron one, and heat over medium heat. Fry chicken until browned on all sides. If you don't have a 12-inch skillet, fry in a smaller one in batches. You may need more oil or lard this way. When all is browned, place back in skillet and cover. Reduce heat to low; cover and cook about 30 minutes until tender. Remove cover and turn heat back to medium-hot so the skin can get crisp.

CHICKEN GRAVY

1/4 cup oil from where chicken was fried
 2 1/2 cups milk or cream
 1/4 cup flour
 In same skillet, add oil (you may have to add some oil to make 1/4 cup) and flour. Cook over medium heat, stirring constantly and scraping browned bits loose from pan for 3 minutes. Do not brown flour. Gradually add milk or cream and stir constantly until gravy is thickened. Add more salt and pepper if you want.

RCHS students caught taking drugs in the lunchroom

Two RCHS students were caught on video last Tuesday using pills in the lunchroom during school hours.

Arrested at the scene was Richard Charles Slate, 18, of Mt. Vernon.

According to Mt. Vernon Police reports, officer Nathaniel Price responded to the high school after receiving a complaint that two students were caught on video using pills.

Once Price arrived, he was shown a video portraying Slate and a juvenile sitting down at a table in the lunchroom and crushing up a pill. Slate then rolled up a dollar bill and ingested it

through his nose. Moments later, the juvenile ingested the pill through his nose as well.

Upon further investigation, Slate told Price that the pill was a Watson 30 mg.

Slate was charged with trafficking a controlled substance within 1,000 feet of a school building and possession of a controlled substance, third degree.

Slate was lodged in the Rockcastle County Detention Center where he was later released on a \$5,000 surety bond.

Assistant Principal Barry Noble said this is the first case they've had of someone using drugs openly on school grounds.

"We have never had anything like this before," Noble said. "It was a completely isolated incident and we always make sure to monitor the students at all times." Noble said.

Noble said the two students have been properly disciplined and that the RCHS staff work constantly to ensure students have a safe and drug free environment in which to learn.

"We always make sure to handle all disciplinary situations when they first arise," Noble said. "Students should know we don't take this matter lightly and we won't permit it at all on school grounds."

Neighborhood Watch Program is now in place in Mt. Vernon

The Mount Vernon Police Department and Operation UNITE have now instituted a Neighborhood Watch program for subdivisions, apartment complexes and other areas within the city limits.

The program instructs residents in what to look for in their neighborhoods in regard to criminal activity, drug activity and door to door callers.

The program also teaches personal safety measures for residents, especially instructing the watchers to report only and never physically become involved with those attempting criminal acts. However, it's not a requirement that all residents become involved.

An initial short instructional program will be demonstrated to those residents interested followed by the placement of a Neighborhood Watch sign installed in the area of the watch community.

There is no charge for the instructional program or the signs. If you are interested in initiating a Neighborhood Watch program in your neighborhood call the Mt. Vernon Police Department at 606-308-2404.

Bond lowered

The bail, for one of the suspects arrested last week in a possible meth supply ring in the county, was lowered Wednesday by District Judge Kathryn Wood.

According to County Attorney Billy Reynolds, Tracy Bullock, 43, of Brodhead bonded out on the charge after her bail was lowered from \$50,000 cash/property to \$30,000/10% (\$3,000).

Brodhead woman arrested for cultivating marijuana plants

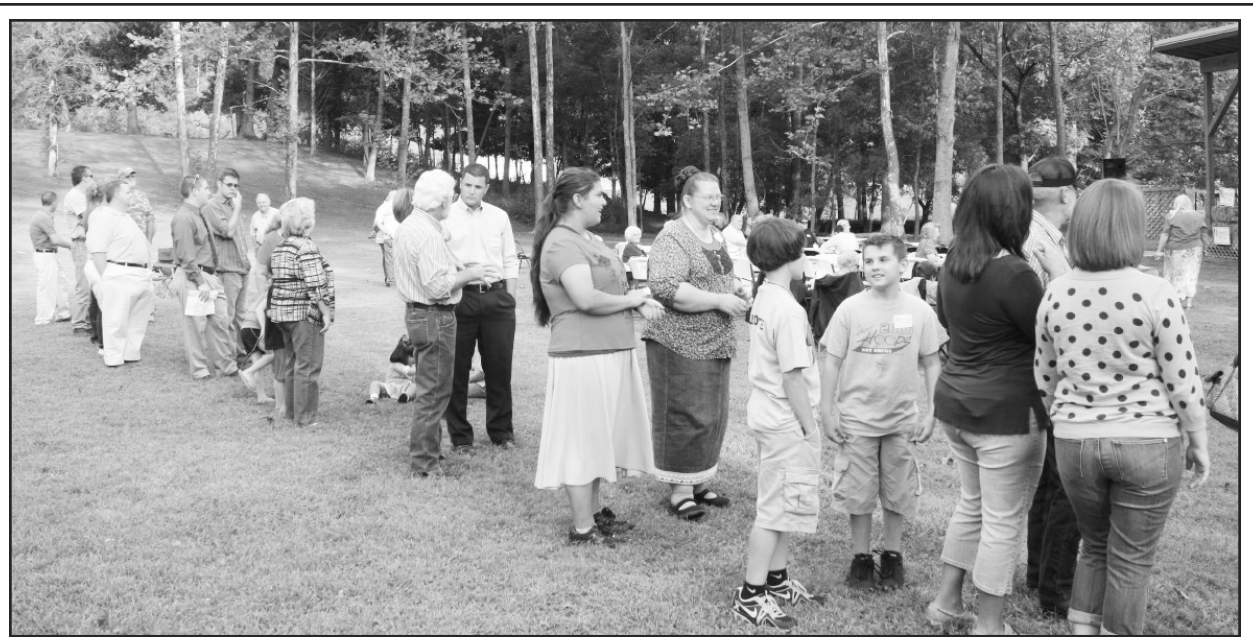
A Brodhead woman was arrested last Tuesday for cultivating marijuana after police raided a home on Barnett Road in Brodhead.

Arrested at the scene was Audry Ann Collins, 64, of Brodhead.

According to the Rockcastle County Sheriff's Department, Deputy Sheriff Matt Bryant responded to the residence after receiving information that marijuana plants were growing on the property.

Upon receiving consent from Collins to search the residence, Bryant found 24 marijuana plants growing inside a large flower pot and another marijuana plant growing separately in the backyard. Bryant also found two more marijuana plants drying inside an outbuilding.

Collins was charged with cultivating marijuana and was lodged in the Rockcastle County Detention Center where she was later released on a \$5,000 unsecured bond.

Scheff said he has documented trees more than 250 years old in the Little Egypt area. One, a shortleaf pine more than 300 years old, is the second-oldest known tree of its species in the Eastern United States, he said.

There also was particular concern that the logging and herbicide use could damage Climax Springs, one of the state's largest continuously flowing underground spring.

A local company bottles the high-quality water and hundreds use the springs to get their drinking water.

"We certainly don't want anybody to do anything that would damage the natural resource," Rockcastle County Judge Executive Buzz Carloftis said.

The Forest Service is required to take public comment on proposals such as the Crooked Creek project.

The agency received some comments in favor of the logging, but also got a significant amount of negative feedback, said Jason Nedlo, the US Forest Service district ranger in the

area that includes Rockcastle County.

The agency looked hard at those concerns and decided it was best to cancel the project and engage the public in further discussion, he said.

"We take those concerns seriously," Nedlo said. "The process worked."

Nedlo said the Forest Service still wants to do non-commercial tree-thinning in the project area to improve habitat and the health of the forest -- something Scheff said he also supports.

It would require a new

environmental assessment to do that, Nedlo said.

Nedlo said he is willing to explore the idea -- put forth by Scheff and others -- to build several miles of hiking and horse trails in the Little Egypt area, a place of deep-green forest, sandstone ridges, rock cliffs, waterfalls and caves, some of which provide habitat for endangered bats.

Kentucky Heartwood has identified some of the potential route for the trails. Local officials have been involved because of the potential to link the trails to nearby Livingston.

The small town was the first to apply for certification under a new state program to designate Trail Towns, an effort to bring in more tourism spending from hikers, horse riders and others.

Scheff said he would like to see trails with signs along the way to explain the history of the area and its natural features.

"I think there's a great thing the Forest Service can be proud of," Scheff said.

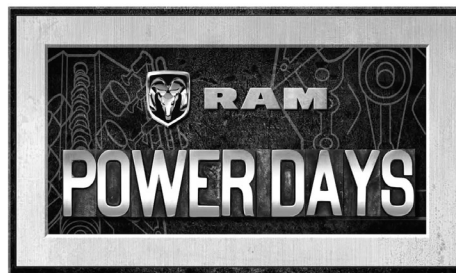

Rockets shutout in second half at Pulaski County

The Rockcastle County Rockets dropped to two and three on the season following a 20-2 loss at Pulaski County last Friday night.

The Rockets outplayed the Pulaski County Maroons in the first half, taking a 2-0 lead into the locker room, after senior Tommy Shaffer forced a safety by tackling Maroon running back Tyler Goins in his own end zone. The Rockets also outgained Pulaski County on offense in the first half with 145 total yards compared to the Maroon's 23 yards.

However, after halftime the Rockets momentum stalled and the Maroons put up an unanswered 20 points against the Rockets. The Maroons also had 235 total yards on offense in the second half compared to the Rockets 16.

Head Coach Scott Parkey said his team's inability to capitalize on touchdown opportunities during the first half proved to be the deciding factor in the game as the Rockets were inside the Pulaski County red zone on three separate occasions and failed to score a single point.

"Missed opportunities really cost us the game and we didn't capitalize when we had the ball inside the 20 yard line," Parkey said. "We had about two or three dropped balls that could have led to points on offense."

Parkey said he thought this team played hard against the Maroons but he said all the effort was wasted when they failed to score.

"Unfortunately, we left a lot of points on the field," Parkey said. "This is really hard to deal with when you know the boys are giving it everything they have and

outplaying their opponent for the biggest part of the game."

The Rocket offense was led by senior running back Damien McDaniel with 14 carries for 171 yards. Senior fullback Tommy Shaffer had six carries for 18 yards and junior running back Jacob Bussell carried the ball eight times for 14 yards.

Junior quarterback Corey McPhetridge was 5 for 13 passing for 27 yards. McPhetridge also had one interception.

McDaniel also led the receiving corps, catching three passes for 17 yards. Receiver Tyler Harper caught one pass for eight yards and Shaffer caught one pass for two yards.

Defensively, the Rockets were led by Bussell who had six tackles and one recovered fumble. Defensive back Tyler Smith also had a big night with four tackles and one interception.

Other Rockets picking up tackles were McDaniel with eleven, Chris Wren ten, Chance Ansardi nine, Boone Saylor seven, Brandon Jones and Shaffer six each, Eli Haddix and Jared Lake with five, McPhetridge two and Austin Spoonamore and Harper were both credited with one tackle.

Saylor and Lake both led the Rockets in sacks with one each.

The Rockets will play in the UNITE Bowl during their Homecoming against the Perry Central Commodores this Friday night at 7:30.

Last year the Rockets shut out the Commodores 22-0 in Hazard. This year Parkey believes his team will get another win since they have the advantage of playing the Commodores at home this year.

"The kids have decided they will accept nothing but a win against Perry Central," Parkey said. "Both the UNITE Bowl and Homecoming always draws in a big crowd to the game so our kids know we can't let our fans down."

Kentucky Afield Outdoors

Cautiously optimistic about dove season, despite brown grass and hard ground

The crisp early morning and earlier nightfall remind Kentuckians that fall isn't far away. The smell of gunpowder, the clunking of spent shotshells in a vest and dove breasts wrapped in bacon and grilled aren't far away either. It is a hunter's favorite time of year.

Dove season opened statewide Sat., Sept. 1. Although brown, crunchy moisture-free grass and cracked brick ground cover large swaths of Kentucky, the drought won't ruin the dove opener.

"There are plenty of doves around Kentucky," said Rocky Pritchert, migratory bird coordinator for the Kentucky Department of Fish and Wildlife Resources. "It's a mixed bag. Some dove fields are looking good while some were affected by the drought."

The Purchase Region is the area of Kentucky hardest hit by drought, but dove field conditions, contrary to what common sense dictates, are in hunttable shape.

"As far as the dove fields in our region, they got off to a slow start and the plants stunted a little," said Tony Black, Purchase Region wildlife regional coordinator for Kentucky Fish and

Wildlife. "The sunflower and millet still headed out with pretty decent seed content in them. It is not too bad considering how dry we've been. On average, the counties in our region are 12 to 13 inches below normal rainfall for the year."

Hunters who put in a little time scouting before hunting a particular field place themselves at an advantage. "Pull out the dove hunting guide and go and look at the public fields before you hunt them," Pritchert said. "If you plan to hunt a private field or your traditional dove spot, you still must scout this year. You still need to see if an area holds any birds."

The field you plan hunting could be laden with doves on opening day. If you don't pick a good spot in that field, however, your hunting vest may weigh less at the end of the day than at the beginning because you've spent your shotshells and have few doves.

"The first thing I look for when setting up in a dove field is a dead tree or snag," Pritchert said. "Then, I look for the flight patterns of the doves. Survey where they enter the field and where they exit. Find the entry spot

and set up near there. It is better to find a place where they enter the field than where they exit."

Doves often fly into a field through gaps in trees or a swale in the ground.

"A dead tree that is in one of these flight patterns is a great spot," Pritchert said. "They often land in dead trees before entering the field to feed."

Doves also use power lines for the same purpose. Studying these features and setting up near them makes for a much more eventful day. A poorly chosen spot in a good field leads to frustration when others down all of the doves. It is like watching someone from the opposite end of the boat catch all of the fish. Study and choose wisely.

The first segment of the dove season closes Oct. 24. The second segment runs from Nov. 22 through Nov. 30, while the third segment of the season opens Dec. 29, 2012 and closes Jan. 4, 2013.

The daily limit is 15 doves.

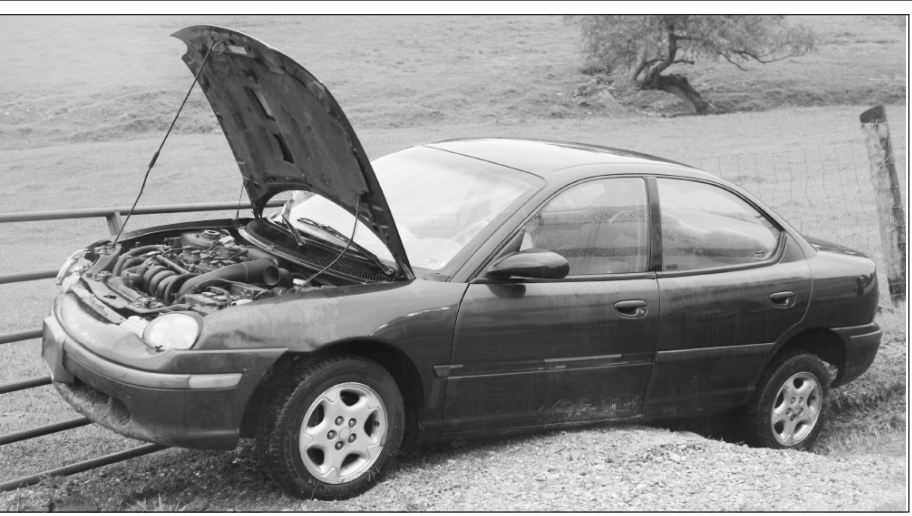

the middle of the pack” of the 174 school districts across the state. “We have to get organized for success in another system,” Pensol said.

EPAS is being used in concert with No Child Left Behind, for which the state received a waiver from the federal government. Under this system, students are ranked for progress against themselves rather than other districts and are tested on college/career readiness skills as opposed to Kentucky Core Content as in past tests.

The new system involves three phases of testing -- Explore, given in the 8th grade; Plan administered in the 10th grade and the ACT given in the 11th grade.

The progress of students who are first tested in the 8th grade is compared to their test scores in the 10th and 11th grades.

Students in the eighth grade scored 14.9 on the composite score of all subjects, as compared to 15.2 for the state average.

In reading, 8th graders scored the same as the state average 14.4; English was 13.8 to 14.3; mathematics 14.8 to 15.3 and science 16.1 to 16.3.

10th graders were a little further back in the composite score 16.3 to 17. In English it was 15.3 to 16.1; mathematics 16.0 to 16.8 and reading 16.1 to 16.6.

11th graders were very close in the composite score for all subjects, 18.8 to 19.0 state average. In English it was 18.1 to 18.4; mathematics 18.5 to 18.8, reading 18.9 to 19.0 and science 19.0 to 19.1.

School board member Mike Burdette pointed out that he felt this test might be more beneficial to students since “ACT scores have more impact on scholarship money for entering college students.” Pensol agreed saying that a tutoring program would be put in place. He also told the board that the school system had a lot of work to do and this was a “stressful time for classroom teachers.”

The 8th and 10th grades took the test on Wednesday with the 11th grade taking the ACT in the Spring of 2013.

In other action, the board met early for a workshop with finance officer Melanie Lyons to go over the current year’s budget.

Lyons told the board that total budget appropriations of \$27,624,627, and expenditures of the same amount, should increase the board’s contingency fund to \$4,254,921 from \$3,803,176 last year.

Once officers approached the vehicle, they could smell a strong odor of alcohol. Upon further investigation, officers noticed Bartley appeared intoxicated while performing field sobriety tests. Bartley also blew a .124 on the breathalyzer, which is .044 above the legal limit of .08 in Kentucky.

Bartley was lodged in the Russell County Detention Center where he was later released on a personal recognition bond.

Commonwealth Attorney Eddie Montgomery said Tuesday no disciplinary actions will be taken by his office against Bartley and that he will continue to work for him as an assistant commonwealth attorney.

“He has been working with me for eight years and I have never had any problem with Jeremy,” Montgomery said. “We all make mistakes, it was on the weekend and he wasn’t on working hours.”

Bartley declined to comment on the matter and said he has hired State Representative Jeff Hoover of Russell County as his attorney.

Bartley’s arraignment date is October 8th at 9 a.m. in the Russell County District Court.

transported by ambulance from the scene to the UK Medical Center where he is currently being treated for his injuries.

Johnson’s mother, Veronica Waddles, 34, of Mt. Vernon said Johnson received a fractured skull and elbow, two broken knees and a lacerated liver as a result of the accident.

Waddles said that since the accident, Johnson has had successful surgeries and been treated for all his injuries he received from the accident. However, Waddles said Johnson still has a long road of recovery ahead of him.

“The doctors told us he is improving at a faster rate than they originally expected,” Waddles said “But they also said even though he’s had all his surgeries, he still has a long road to recovery ahead of him.”

Johnson was taken off the ventilator last Thursday morning. He was also

moved from the ICU into a regular room at the hospital.

Waddles said her son has been talking and recognizes familiar people such as family and friends. However, Waddles said he doesn’t remember much about the accident.

“He knows who we are but at first he didn’t know why he was in the hospital or what had happened to him,” Waddles said.

Waddles said if everything goes as planned later this week, Johnson will be moved to the Cardinal Hill Rehabilitation Hospital in

Lexington where he will receive rehabilitation services.

Waddles said they appreciate everyone’s thoughts and prayers since the accident and they have been encouraging to her family during these trying times.

“We appreciate all that everyone has done. He is improving so quickly and we never expected him to be doing this good so soon,” Waddles said. “It’s just proof that everyone’s prayers are being answered.”

AN ORDINANCE ADOPTING THE CITY OF BRODHEAD, KENTUCKY ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2012 THROUGH JUNE 30, 2013

Whereas, an annual budget proposal and message have been prepared and delivered to the legislative body; and, Whereas, the legislative body has reviewed such budget proposal and modifications have been made accordingly.

NOW, THEREFORE, BE IT ORDAINED BY the City of Brodhead, Kentucky as follows:

SECTION ONE: That the annual budget for the fiscal year beginning July 1, 2012 and ending on June 30, 2013 is adopted as set forth herein:

Rabies Clinic is next Monday at Livingston Fire Department

The Rockcastle County Health Department, along with Dr. James Chism, DVM, are sponsoring a rabies vaccination clinic for dogs and cats. The clinic will be held Monday, September 24 at the Livingston Fire Department from 5:30 to 6:30 p.m. and the cost will be \$7 per vaccination. All animals must be on a leash or other restraint.

Dog and cat owners are encouraged to bring pets to have them vaccinated for the first time or to receive a booster vaccination. Booster shots are required one year after the first shot and then every year or every three years, depending on the vaccine that is given.

A bat sent to the state lab from Rockcastle County tested positive in August. A total of five animals have tested positive for rabies as of June 30 in Kentucky this year: one bat each from Jackson and Lincoln counties, one skunk each found in Garrard and Todd counties and a dog in Green County. Five animals out of 405 tested seems like a small percentage, but yet it

is a prominent reminder that rabies does exist and is a threat to domestic animals, livestock and humans in the Central Kentucky area.

State law requires dogs, cats and ferrets, at least four months of age, to be vaccinated against rabies (902 KAR 2:070). Rabies is spread by wild animals, such as: skunks, foxes, raccoons and bats. Any mammal can get rabies including dogs, cats, horses, cows and humans. Animals that are not mammals, such as birds, snakes and fish do not get rabies.

Rabies is caused by a virus and is spread by contact with the saliva of an animal when it bites a person or another animal. Symptoms of rabies in animals may include a change in behavior, sickness, unable to eat and swallow, increased drooling or salivation or aggression. Wild animals may appear to be tame or sick. Some rabid animals appear to be normal, especially in the early stages of the disease. There is no cure or treatment for rabies. Usually death will occur within ten days of symptoms.

To prevent rabies, people should have their pets vaccinated and avoid contact with stray or wild animals. Teach children to stay away from strange dogs, cats or wild animals. Stray cats and dogs may not have been vaccinated against rabies. Report stray animals to an Animal Control Official. In Rockcastle County, contact the Animal Shelter at 256-1833.

Orlando man arrested for manufacturing meth

An Orlando man was arrested last Tuesday for manufacturing methamphetamine after police raided a home on Maple Grove Road in Brush Creek.

Arrested at the scene was Henry Rufus Haling, 23, of Orlando.

According to the Rockcastle County Sheriff's Department, Deputy Sheriff Matt Bryant responded to the residence after receiving information that Haling was manufacturing meth inside a bedroom at the home.

After receiving consent to search the home, Bryant could smell a strong chemical odor coming from inside the bedroom.

Inside the bedroom and throughout the home, Bryant found various items used to manufacture meth. Upon finding the items, Bryant asked Haling if there was a one-step meth lab nearby and he told him it was inside a closet in the bedroom.

Inside the closet, Bryant found a garbage bag containing a one-step meth lab inside a one gallon pickle jar. Haling also directed Bryant to the back yard of the residence where an active HCL gas generator was found.

Haling was charged with manufacturing metham-

phetamine and remains lodged in the Rockcastle County Detention Center on a \$25,000 cash/property bond.

cludes mostly Hanson Aggregate, Citizens Bank and the new industrial park. Area #2: the original industrial park, and the area housing D&S Computers and Mahaffey's Quick Lube. The smallest Area, #3, includes Save-A-Lot, Dollar General and perhaps a dentist's office. The middle school, located across from the businesses in Area 3 is already in the city limits.

Bryant also said that some property owners, contiguous to the new boundaries, have asked to be annexed and this could be accomplished after the annexation. He also noted that, at the present time, only one or two residences are in the areas and it was not certain if they would still be when a detail map of the areas was drawn.

Council members were presented with a general map of the areas to be annexed and Bryant said a more detailed map would be drawn up by engineers and

an ordinance prepared for passage, perhaps as early as the October regular meeting.

During the meeting, the council also approved a motor vehicle tax rate for 2012 of 16.7c per \$100 assessed value, unchanged from last year and of 16.7c per \$100 of assessed property value, up from 16.6c last year.

The council then spent some time discussing the Renfro Valley Boat Dock lease currently, and for several years, held by Tommy Mullins.

Mullins was granted a six-month extension in May of this year and that extension is due to expire October 31st.

At the time of the extension, Mullins was told the city would be assuming direct operation of the facility Nov. 1st. However, the mayor told the council that, on reflection, he was not sure that would be the best course since it would be almost like creating another department. He said that, to be fair to everyone involved, he recommended rescinding the former motion for the city to assume control and advertising for bids for operation of the boat dock.

The bid will be for five years with one year renewals and an out clause for both parties.

The police department report was presented by

Chief Kevin Fletcher. During August, the department had 478 total calls for service, investigated 16 motor vehicle collision with injuries in 5, 25 total arrests, 17 warrants served, 13 drug charges, 14 traffic violations, 14 other charges (resisting, etc), 15 alarm drop calls for service, 7 funeral escorts, 8 motorists assists, 4 summons/evictions/EPO served, 33 assists to other agencies, 8 domestic violence calls, 7 welfare checks (elderly, etc), 7 requests for extra patrol, 14 public relations community events.

Mt. Vernon Fire Chief David Bales also presented his report for August.

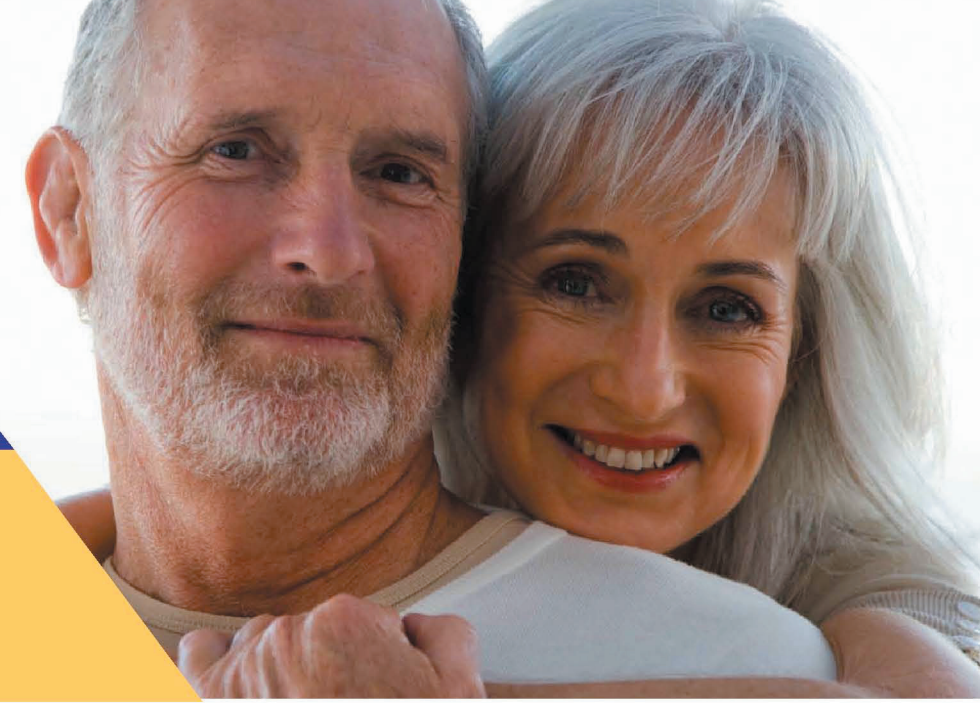
During that month, there were 37 runs made and 4,600 gallons of water used.

Through July of this year, Bales said the department had made 274 runs.

During August, the department were called to: 6 accidents with injuries and possible entrapment; 13 accidents with injuries, 2 EMS assists, 3 structure fires, 2 vehicle fires, 1 brush and woods fire, 2 fire and smoke alarm activations, 1 hazardous situation (transformer on fire), 3 hazardous materials (fuel spills on highway), 1 hazardous material (diesel odor in home), 1 traffic control (hospital bike and run race), 1 decon at meth lab (portable shower), 1 water rescue (subject trying to swim across lake).

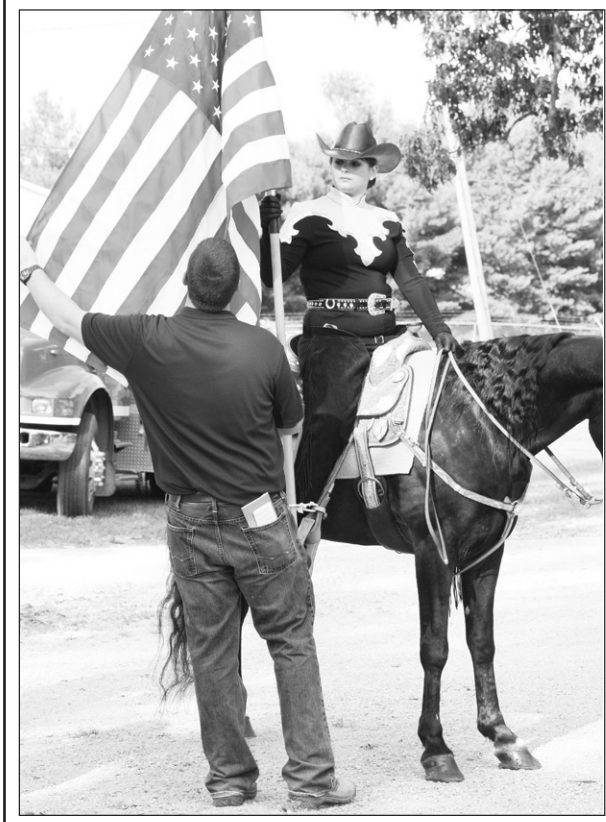

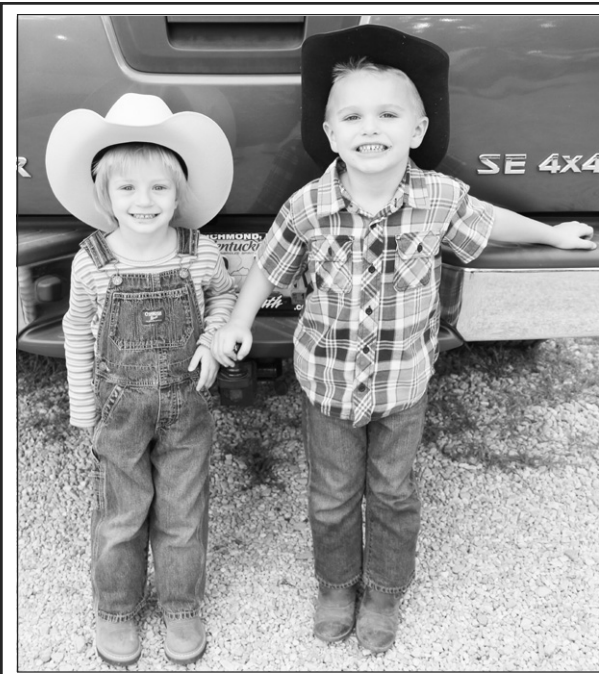
Horse Show raises over \$17,000

Cholesterol is a waxy, fat-like substance found in your body and many foods. Your body needs cholesterol to function normally and makes all that you need. Too much cholesterol can build up in your arteries. After a while, these deposits narrow your arteries, putting you at risk for heart disease and stroke.

High cholesterol usually doesn't have any symptoms. As a result, many people do not know that their cholesterol levels are too high. However, doctors can do a simple blood test to check your cholesterol. High cholesterol can be controlled through lifestyle changes or if it is not enough, through medications.

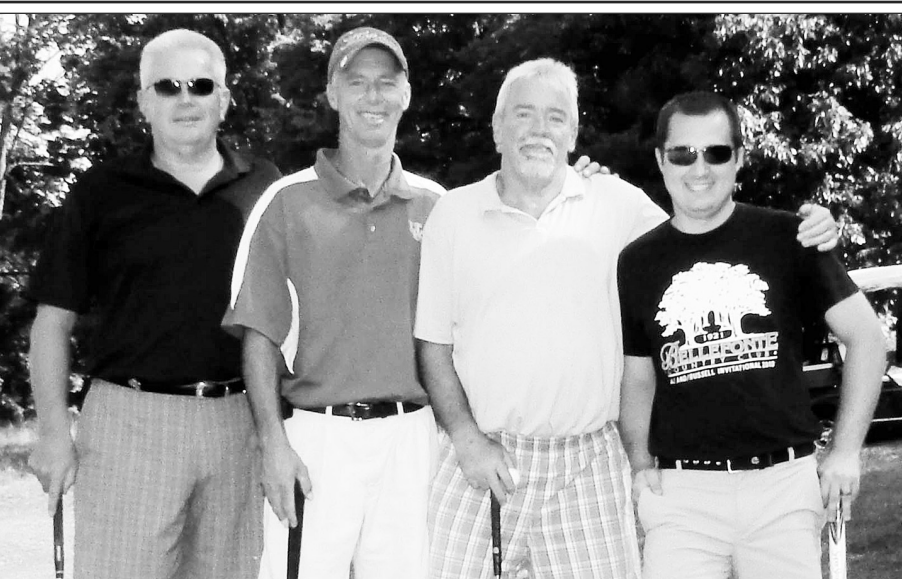

Blast from the Past!!!

This week's photographs are of former Civil War soldiers from Rockcastle County. The top photo is of Sergeant Samuel Smith and his family, wife Mollie and twin daughters Mary and Maggie. Sgt Smith served in Company D, 119th United States Colored Infantry. This picture was taken in 1864 at Camp Nelson, KY. Sgt Smith's enlistment papers stated he had been the property of Mt. Vernon attorney Elisha Smith. Samuel and Mollie are buried in the Walker Newcomb Cemetery on Richmond Street in Mt. Vernon. Pictured at right, brothers Alfred and Barnett Hayes of Company I, 3rd Kentucky Infantry, U.S.A. They were both killed carrying the regimental colors at the Battle of Missionary Ridge, November 25th, 1863. They are buried in the Chattanooga National Cemetery in Tennessee. Their brigade commander, Colonel Henry C. Dunlap mentioned the Hayes' in his official report: "My loss was four enlisted killed: My Color Sargent Alfred Hayes fell and Corporal Barnett Hayes seized and bore it till he fell." This photograph was taken in 1861 at Camp Dick Robinson, KY.


