Mt. Vernon council approves lease for Renfro boat dock

A Richmond couple will be the new operators of the Lake Linville Boat Dock, after their bid was approved by the Mt. Vernon City Council at their regular meeting Monday night.

Lester and Teresa Ratliff, owners of Custom Home Improvements and Roofing in Richmond, submitted the only bid to operate the facility and agreed to pay \$700 a month for the life of the five year lease. The Ratliff's bid was the only bid submitted despite several inquiries received by the city prior to the deadline for submitting a bid, Mayor Mike Bryant said.

Besides how much they would pay monthly for the lease, bidders were asked to submit a business plan for operating the facility.

Ratliff told the council that the dock would be family-operated by themselves and their daughter and they also planned on hiring two full-time and two part time employees.

According to their plan, the restaurant, which would also include basic grocery items and a souvenir/gift shop, would stay in operation with a separate building being erected for

Two arrested for string of burglaries in Mt. Vernon

Local police say they have arrested two people involved in a recent string of burglaries throughout Mt. Vernon last week.

Those arrested were Randy Dean Mink, 47 and Natasha McClure, 27, both of Mt. Vernon.

According to Mt. Vernon Police reports, officers responded to a complaint of a burglary Sunday afternoon at the residence of Faye Harper on 640 West Main Street in Mt. Vernon.

Harper told officers she came home from church Sunday afternoon to find two pry marks on her back door and the bottom window pane of the door busted out.

Upon further investigation, officers reportedly discovered an estimated \$500 of jewelry missing from Harper's residence.

Mink is also suspected of being involved in another burglary last Tuesday at a residence on 45 Lovell Lane in Mt. Vernon.

During questioning by officers about the burglaries, Mink admitted to burglarizing Harper's residence on West Main Street and also admitted to breaking into Larry Mink's Chevy Blazer parked in the driveway next to Harper's house and stealing a green ammo box containing Craftsman tools.

Officers said Mink reportedly stole from the two residences and vehicle in order to sell the items so he

could buy McClure, his girlfriend, her drugs. Mink also told officers that McClure told him if he didn't steal and get money to buy her drugs, she would leave him.

Mink was charged with three counts of burglary and criminal mischief, third degree. McClure was charged with receiving stolen property and burglary, second degree.

Both Mink and McClure remain lodged in the Rockcastle County Detention Center on a \$15,000 cash bond.

14 indicted

Indictments were handed down last week against 14 defendants on charges mostly dealing with drug offenses.

Named in the indictments were:

Freddie Dale Denny, 43 of East Poplar Street in Mt. Vernon and Zachery S. Ramsey, 18 of Deborde Road, Mt. Vernon were named in a joint indictment for four offenses, two for trafficking in a controlled substance (oxycodone) and two for complicity, by Ramsey, to trafficking in a controlled substance. Both men's bond was set at \$75,000 cash/property.

Lisa Ann Reams, 52 of Freedom School Road, Mt. Vernon, was indicted on two offenses of trafficking in a controlled substance

County gets okay for repaving of several roads

After many long weeks of waiting, the Rockcastle County Fiscal Court has finally received the state's approval for the repaving of 13 county roads, including the entire three miles of Lambert Road.

Total cost of the project will be \$609,265 and funds will come from the governor's office's FLEX funds. These discretionary funds are allocated to each county, in addition to the annual distribution of county road aid, and the

amount received by the county for these projects reflects about five years of the allocation, County Judge/Executive Buzz Carloftis told the court. The cost of paving three miles of Lambert Road accounts for over half (approximately

\$345,000) of the total funds available.

Carloftis told the court Tuesday, during a special called meeting to get the court's approval of the Memorandum of Resolution and the Agreement sent by the state, that paving will not begin until Greer Bros. finishes work on I-75. "They're working 24 hours a day on the interstate," Carloftis told the magistrates.

Besides Lambert Road, the other 12 paving projects include:

Mt. Vernon man dies in construction site accident

A Mt. Vernon man was killed in a construction site accident on the Hal Rogers Parkway in Clay County last Wednesday morning.

According to State Police reports, Billy L. Phillips, 65, of Mt. Vernon was walking behind a dump truck when the driver, who was unaware Phillips was behind him, began to back up the truck and hit Phillips.

Phillips was transported by ambulance to the Manchester Memorial Hospital where he was later pronounced dead by the Clay County Coroner's Office.

The accident is still under investigation by the Kentucky State Police and trooper Josh Wilson is in charge of the investigation. Drugs and alcohol are not suspected to be a factor in the accident.

Rockcastle County historian David Owens, the Battle of Wildcat Mountain occurred on October 21, 1861 and was the first Civil War battle fought in Kentucky and was also considered the first Union victory of the war.

At the beginning of the Civil War, Kentucky was considered an important border state as Kentucky never officially declared secession from the United States.

 "It was the best of times, it was the worst of times..." would probably fit well into an expedition I, and several members of my family, made to New York City over the weekend.

This was the third trip for three of us in the last four years and it was probably the least pleasurable of our experiences.

It was sold as an overnight trip to the Big Apple, departing at 7 o'clock on Friday night on a bus with reclining seats so we could sleep the night away, arriving in Times Square at 8 o'clock Saturday morning, spending the day doing touristy things and meeting the bus back in Times Square at 11 o'clock that night to return home in the same comfortable reclining seats.

Sounds good, right? Well, the first rude awakening was when I found that the two seats I tried did not recline far enough to allow me to rest comfortably on the way to New York.

The second was when we discovered that the heat was not working properly in the bus and we were frozen by the time we arrived at 9:30 a.m., instead of the promised 8 a.m. and throwing us into a tizzy to get to our 5 1/2 hour bus tour we had booked which was scheduled to leave at 10 a.m.

You've missed it all if you haven't seen six Rockcastle rednecks scurrying through New York desperately trying to find our tour bus before its 10 a.m. departure.

Actually two of them scurried and two dragged the grandmas --- me and Jamie's mother-in-law -- through the streets. But, I shouldn't lump Alene with me. She had just spent a week in the hospital being treated for pneumonia and still managed a lot better than yours truly and with a lot less complaints.

The bus tour was enjoyable except I kept falling asleep and refused to get off the bus to see most of the sights. Jamie and I also bypassed the boat trip to view the Statue of Liberty, opting instead to find a good restaurant and rest. Our reasoning was that we saw it on our first trip in 2000 and were operating on the theory that

once you've seen the Statue of Liberty...

At the conclusion of the bus tour, we still had about eight hours to kill before getting back on the bus and, following a souvenir stop on Canal Street, proceeded to make another trek through the streets of Manhattan to Juniors, a restaurant known for its cuisine and cheesecake.

Now, I don't like anybody's cheesecake except my own which comes straight from a box and the half hour wait for a table was aggravating but all that paled in comparison to the sight we encountered when we left the restaurant.

On the way there, we had seen a young man standing in the middle of Times Square in nothing but white briefs, a cowboy hat and boots with a guitar posing for pictures with tourists for a small fee.

It was at a distance, thank goodness, but the shock was still substantial. You can imagine my shock when we left the restaurant and were immediately confronted with another young man in the same attire (or lack thereof) very up close and personal. It was helpful that he didn't focus on us -- the two grannies must have been a turn off -- but instead on the occupants of an outside table at Juniors.

It was quite disconcerting to watch a man put his hand on the young man's butt and then slip money into the band of his briefs. All this noted, of course, while I wasn't looking.

I'm all for freedom to be you and me but I often wonder where his freedom to be him ends and my freedom to not have to see it begins. Just saying.

Anyway, we still had a couple of hours to kill before meeting the bus. It was nighttime, I was exhausted and we finally lighted at the seven-story McDonald's in Times Square just to find a place to sit down and wait for our transportation home.

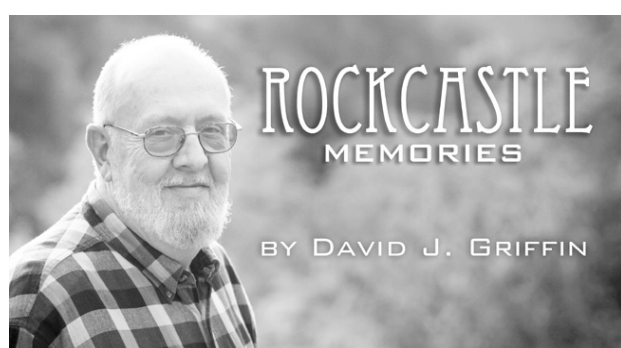
That was another awakening when, after freezing all night and day, we headed south, the temperature began to warm and we discovered the bus's air wasn't working. This in addition to

My Beloved Mother (Bee)

Someone recently asked why I had not written a complete column about my mother. My simple reply: "I am not sure I could do the story justice." You see my mother, in my eyes, was a saint. Even though she has been gone for several years, to me she will always be a saint.

Let me define that terminology as it refers to my mother, whom we all called "Bee." The definition of a saint is one who has been recognized for having an exceptional degree of holiness, sanctity, and virtue. Those descriptions all remind me of Bee. From the time I can remember crawling around on the floor of our small farmhouse, I remember her instructing me how to conduct myself in a Christian manner. She never waivered in her devotion to her Lord, and she did not tolerate her sons moving from that path either.

I suppose she was more successful in her training of my brother Al because at the tender age of 17, he became an ordained Baptist minister. However, she did instill in me the love of the Lord, and along with my grandfather, Pop, they influenced me to understand and subscribe to principles of integrity.

I cannot remember any time in my life when Bee was not reminding me how to treat other people -- young or old -- and the necessity of being honest and trustworthy. On a regular basis, she read the Bible to me, even before I could read on my own. As she read a passage, she would stop and break

down the meaning of the scripture in youthful terminology. Over and over again, I can hear her saying, "Now, David Joe, this means..." I became vividly aware that she was steadfast in her beliefs and that teaching me Christian principles was something she saw as her duty.

One of the first recollections I have of her admonishing me about how to treat my friends was when I was only four or five years old. Kenneth Hansel and I were playing with my Matchbox cars in the yard just outside

Illa Taylor Burns

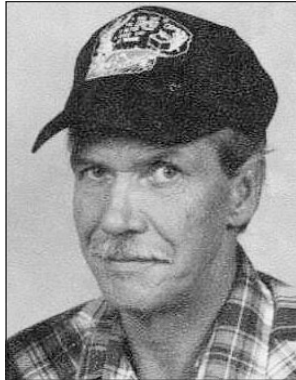
Illa Taylor Burns, daughter of Emmett and Bertie Baker Taylor, died August 16, 2012 at her home in Cumming, Georgia.

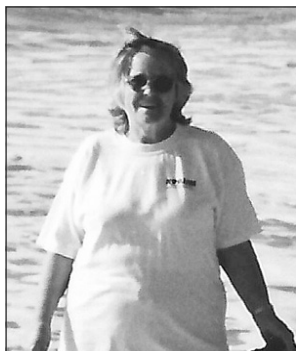

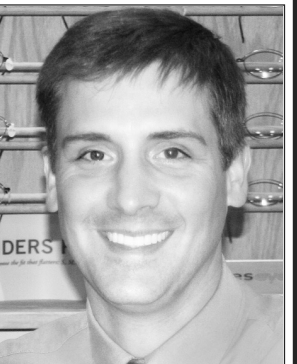

Assistance has always been forthcoming...

Dear Editor,
While I agree with the Brodhead City Council's concerns about the condition of the bridge approach on Chestnut Grove Road, I was stunned that both the city council, and a member of the Brodhead Fire Department, would actually say that whenever they have asked me for assistance, their voices have fallen on deaf ears. The following facts do not bear that out:

- \$26,000 to help the fire department purchase a truck was approved and given to the city on August 23, 2012;
- At the mayor's request, the court approved \$12,000 to help the city of Brodhead with KU power line removal from the city's proposed park in March of this year;
- Every year, the court pays 60% of a loan owed by the BVFD, the most recent payment being in February of this year;
- The fiscal court, on August 17, 2006, approved a list of roads, that were bona fide roads, to be maintained by the Rockcastle Fiscal Court's road department, and submitted that list to the state. At that time, the fiscal court elected to follow KRS 178.337 and deleted that portion of Chestnut Grove Road lying within the city limits of Brodhead while retaining the sections of Possum Kingdom/Cupps Chapel Road and Dix River Branch Road within the city limits. When the court made the decision to delete that part of Chestnut Grove Road inside the city limits, it became illegal for me, as county judge/executive, to order repairs to the bridge approach over Dix River because it had been deleted from the county's official road list. (If you read state news, you have seen some county judges go to prison for such illegal activities).

However, seeing the need to address the problem with the bridge approach, in August of 2011 I drafted a letter for the City of Brodhead seeking assistance from the transportation cabinet, rural and municipal aid. The City of Brodhead declined to sign the letter, leaving me legally helpless to provide assistance until there is an interlocal agreement approved by the city's council members and the court. I have not received such an agreement although I did receive a copy of an official city action delivering that section of Chestnut Grove Road back to the court. The court declined to accept it.

I hope and trust that the city's council members and mayor will contact me so we can work in a constructive manner to resolve any issues they have with the county. I also hope the spokesman for the BVFD will understand that the court's allocations and assistance to our county's fire departments have risen by more than 50 times what they were when I took office and that we, as member of the fiscal court, do have financial restraints which have to be considered when our assistance is sought.

way, through the lawn and into Joe Brown's big pasture which begins directly behind our garage. Turns out that these guys were all members of NAWWWWW and they were housed in the garage simply biding their time and waiting for the asphalt to cool down enough for them to be comfortable while conducting their annual forecasting convention.

Needless to say, they were not pleased about being so rudely disturbed and even in wolly-wormish, the language they were using could not possibly be printed in a family newspaper. I was able, however, to speak with a number of the more-level headed woolies before they departed, like, certain members of the World Wrestling Federation, to parts unknown.

I am at least as sure of the accuracy of the information I was able to gain as I am in that of any journalist who gets his or her news from "confidential, inside sources." So here's what I learned from the high level informants at NAWWWWW who might face serious retaliation if they were identified in the paper.

Look for the coming winter to be pretty much like last year, temperature-wise. In other words; generally mild. the kitchen door. For some reason, I was taking the best cars and only letting Kenneth play with those that were slightly broken or used. Suddenly, the screen door flew open – she marched out of the house, bent down, and gathered all of the toys into her apron, saying, “David Joe, when you can learn to share properly, you can have your cars back.”

I was not even aware that she was listening to our play and was in shock when the cars were taken away. I will never forget how she made me feel at that time. From that point on, my friends were given the opportunity to play with all of my toys, not just the ones that I did not like.

Bee continued to supervise my play time for the rest of my childhood. One afternoon Kenneth and I were playing basketball on a small goal that Pop had made out of a wire coat hanger and hung above the door-facing in our den. I noticed Bee sitting in the corner watching us play as she crocheted something small in her calloused hands. After about an hour, she said, “Why don't you boys take a break and get a cold 7-Up out of the refrig-

erator?” We were glad to stop for that reason and ran to the kitchen. When we returned to our basketball game, we saw that she had made us an addition for our goal by crocheting white, sturdy cord into a perfect basket. From across the room, it looked just like the basketball goals in the high school gymnasium at Mt. Vernon. That was typical of her love for her children.

When I began driving at the age of sixteen, Bee never went to bed until I came up the gravel driveway to our house. Every time I made that trip, I could see her standing in the kitchen door. As I walked through the door, most of the time she would say, “Would you like something to eat?” If I said yes, she opened the freezer door and produced a perfectly shaped hamburger, which she plopped into a small black iron skillet and fried for my pleasure. That was my Bee!

It is impossible for me to know how many times she prayed me out of difficult situations. Prayer was just her nature; it was part of who she was. She was a walking demonstration of the scripture that instructs us to “pray without ceasing.” Whenever I came to her with a problem – no matter how simple or how serious it was – she admonished me to pray about the solution. I considered her to be a prayer warrior! She taught me that no situation was too large or too small to take to the Lord. To her, that was the only way to handle a problem.

Bee loved spending time with her family more than any other form of recreation in her life. Thanksgiving and Christmas were her best days because she knew her boys would be coming home along with her sister, Ruth, and her family. Each year we gathered at Bee's or at Pop and Mommie Katie's house for the finest meal that could be produced.

Bee worked for days getting everything ready for us to enjoy. For a couple of weeks, she aged a jam cake in the refrigerator, which she had carefully prepared for us because she knew how much we loved it. When it was time to come to the table, we shared country ham or turkey, mashed potatoes, sweet potato balls, shuck beans, relish treys,

corn, home made cornbread or rolls, and a variety of desserts, including: pecan pies, fruit cake, jam cakes, apple pies, and ice cream. I can hear the men moaning, rubbing their bellies as they moved to the den to watch football. Both Bee and Mommie Katie were completely gratified if all family members were filled to the brim.

When my mother was in her 80's, she still continued to work the Herald Leader crossword puzzle daily as she drank her morning coffee. She loved the challenge of any crossword puzzle and was almost never stumped.

If she could not sleep at night, she simply got out of bed and moved to her big easy chair in the den to either read her Bible or to write poetry. After she went to be with the Lord, we

found records where she had read the complete Holy Bible from cover to cover 23 times. I love turning the pages of her Bible and seeing the notes she made in the margins. Occasionally, she wrote, “Read this passage again and again!” Each time I read something in her Bible, I get the feeling that she is watching me and is very pleased.

My wife also held her in highest esteem. Kathy often remarks that she never heard Bee say an unkind word about anyone. As a matter of fact, she considered Bee to be hers, too. When we were going through the rocky stages of the first year of marriage, she went to Bee rather than to her own mother. Can you imagine? That dear woman sat and listened to my new wife badmouth her baby

straight to her face! And Bee was so kind to her, consoling her and giving her the strength to go back and deal with me.

Kathy insisted that I also include another aspect of my mother. My parents had divorced when I was only six years of age, and Bee never remarried. (Which is another story all its own.) When my father died, she knew that it would be inappropriate for her to attend his funeral. So what did she do? She stayed in her little apartment in Lexington, took a bath, put on her best clothes, and then sat down in her rocking chair at precisely the time that the funeral was to begin. She had her own private service for him. (I suspect that she really never stopped loving him.)

There are countless sto-

ries of her gentle nature, her kindness, her humility. It would take ten columns to do her justice in my view.

I could never thank my mother enough for her influence in my life and her love for her family, especially her children. I hesitate to consider where I would be now if it was not for her guidance and constant prayers. She lived to be 91 years old and has been gone for ten years now.

There is never a day that I do not appreciate the values she instilled in me. She gave me the gift of optimism and to believe that we have a brighter future waiting for us in the end. Yes, my mother was a Saint, and I miss her every single day.

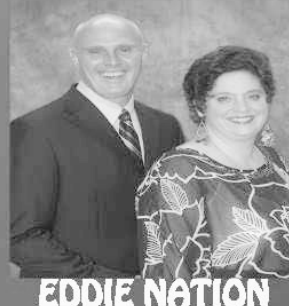

Man arrested after traffic stop on I-75

An Ohio man was arrested for drug possession Sunday morning after the Kentucky State Police made a traffic stop on I-75 southbound at the 55 mile marker in Rockcastle County.

Arrested at the scene was Eric Nelson Tackett, 49, of Waverly, Ohio.

According to state police reports, officers pulled over Tackett after observing his vehicle swerving back and forth, almost hitting another vehicle.

Upon receiving consent from Tackett to search his vehicle, officers found one diazepam tablet in the driver's seat. Officers also found four diazepam tablets and a pipe containing marijuana inside the passenger compartment.

Tackett told officers he had previously taken a Valium about an hour before being stopped by police.

Tackett was charged with possession of a controlled substance, possession of marijuana, drug paraphernalia, careless driving and operating a motor vehicle while under the influence of alcohol/drugs.

Tackett was lodged at the Rockcastle County Detention Center where he was later released on a \$15,000 unsecured bond.

Bullock arrested for promoting contraband

A Mt. Vernon woman, who was out on bond for manufacturing methamphetamine, was arrested for promoting contraband last Thursday after the Mt. Vernon Police Department responded to a complaint on Old Somerset Road in Mt. Vernon.

Arrested at the scene was Tracey Susan Bullock, 43, of Mt. Vernon.

According to Mt. Vernon Police reports, officers received a complaint from a resident on Old Somerset Road that Bullock was driving suspiciously around the neighborhood. Upon further investigation, officers discovered she had a warrant out for her arrest.

After searching the vehicle, officers found a yellow plastic bag in the back seat containing a large bag of "Kentucky's Best" pipe tobacco and a small box of Ziploc bags.

Officers also found a letter inside the vehicle from a current inmate at the Rockcastle County Detention Center instructing Bullock to leave the tobacco and Ziploc bags at the Associates in Dentistry office in front of Save-a-Lot in Mt. Vernon so they could reportedly pick it up. Bullock also admitted to officers that she had intended to leave the items for the inmate.

Bullock was charged with promoting contraband and was lodged in the Rockcastle County Detention Center where she was later released on a \$2,000 unsecured bond.

Bullock was also originally arrested and charged with manufacturing methamphetamine on August 30th after the Rockcastle County Sheriff's Department received information that Bullock, Stacey Dewayne Durham, 48, of Paint Lick and Freddie D. Denney, 42, of Mt. Vernon were manufacturing meth in a rental cabin on Lower River Road in Livingston.

Bullock's preliminary hearing is scheduled for October 31st at 9 a.m. in the Rockcastle County District Court. Denney's arraignment and sentencing is scheduled on October 26th at 10 a.m. in the Rockcastle County Circuit Court.

Durham is scheduled to appear in Rockcastle County District Court on November 14th at 9 a.m. to review his pending resolution in Circuit Court.

Police find more information on hit and run vehicle

Police have discovered more information on the hit and run vehicle involved in an accident last Monday afternoon at the intersection of Hwy 150 and Williams Street in Mt. Vernon.

According to Mt. Vernon Police reports, Davidson Bishop, a sophomore at RCHS, was walking home from school with his sister when a car came skidding across the road and struck him while he was standing several feet off the roadway.

Bishop's sister was able to jump out of the way of the skidding car and wasn't injured. However, the car struck Bishop and he was transported to the Rockcastle Regional Hospital where he was treated for minor injuries and released.

Officer Jeff Harness said the car that hit Bishop was first clipped by another car attempting to turn left onto Williams Street. The car then reportedly fled the scene, traveling west on Hwy 150.

Harness said they recovered a section of the bumper that was lodged in the car it rear-ended. He said they originally thought the section of the bumper had a barcode number of a blue 2003 Chrysler but he said they later discovered the barcode number belonged to a blue 2003 Ford Explorer Sport Trac.

"We received the wrong information and later discovered it belonged to a Ford Explorer Sport Trac instead," Harness said. "Hopefully with this information we will be able to find the driver who fled the scene of the accident."

The accident is still under investigation by the Mt. Vernon Police Department and officer Jeff Harness is in charge of the investigation.

Harness said they are still searching for the hit and run driver. He asked that if anyone has information regarding the hit and run collision to please contact the Mt. Vernon Police Department at 606-256-2121.



BATTLE OF CAMP WILDCAT REENACTMENT

The Laurel Home Guard will host their 23rd annual Civil War reenactment of the Battle of Wildcat Mountain this weekend on Hazel Patch Road off Hwy 25 in East Bernstadt. On Saturday and Sunday the reenactment will be presented for the public at 2 p.m. Admission is free to the public with the battlefield opening at 10 a.m. and closing at 4 p.m. on both days.

Prior to the Battle of Wildcat Mountain, Confederate Brigadier General Felix Zollicoffer moved his troops from Tennessee in an effort to push through the Cumberland Gap into Central Kentucky in order to gain military control of the state.

Zollicoffer had an army of approximately 5,400 men who occupied the Cumberland Gap and also took position at the Cumberland Ford near present day Pineville in order to counter the Union sympathizers' activity in the area. As the Confederate military campaign progressed, Zollicoffer's troops defeated home guard troops located in Barbourville during the Battle of Barbourville on September 19, 1861.

Alarmed by the Confederate invasion, Union Brigadier General George H. Thomas sent a regiment under Colonel Theophilus Garrard from Camp Dick Robinson in Lancaster to Rockcastle County in order to stop Zollicoffer's advance into central Kentucky.

Thomas would later send 7,000 troops under Brigadier General Albin Schoepf to reinforce Garrard's regiment. Thomas ordered both Garrard and Schoepf to

have their men establish a camp on the heavily forested Wildcat Mountain and also obstruct the Wilderness Road to prevent easy access to the area by Zollicoffer's Confederate army.

The Union and Confederate armies clashed during a skirmish on October 20, 1861 at the foothill of Wildcat Mountain. On the morning of October 21, Zollicoffer's Confederate army attempted to advance on Wildcat Mountain and was repelled several times due to the Union army's fortifications on the mountain.

After repeated attacks and repulses, Zollicoffer's army withdrew during the night and retreated to the Cumberland Ford, giving the Union army the victory.

As a result of the battle, Union General Schoepf reported 4 soldiers killed and 18 wounded. Confederate General Zollicoffer reported 11 soldiers killed and 42 wounded or missing.

Owens encourages everyone to use the opportunity this weekend to experience the reenactment of the Battle of Wildcat Mountain as the battle was considered one of the Civil War's monumental early battles which took place in our own backyard.

"This battle was a major turning point for the Union because if the confederates had won the battle, the road to Frankfort would have been unprotected and Kentucky could have possibly become a Confederate state," Owens said. "To think about that is amazing to me, it's hard to believe such a decisive battle during the Civil War happened just miles down the road from us."

Dallas Ray Clifford, 39 of Lower Calloway Loop, Mt. Vernon was indicted for trafficking in a controlled substance (oxycodone) and as a persistent felony offender. His bond was set at \$35,000 cash/property.

Named in another joint indictment were Brittney Mason, 26 of Brooklyn Drive, Mt. Vernon and Jeff

McLemore, 26 of Hill Street, Mt. Vernon.

Mason was indicted for the offense of promoting contraband into the Rockcastle County Detention Center and McLemore was indicted for complicity to promoting contraband by aiding Brittney Mason.

Their bond was set at \$25,000 cash/property each.

Mason and McLemore were also named in another joint indictment, along with Jennifer Thomas, 31 of Mt. Vernon.

Thomas was indicted for the offense of promoting contraband into the Rockcastle County Detention Center and McLemore and Mason were indicted for complicity in aiding Thomas.

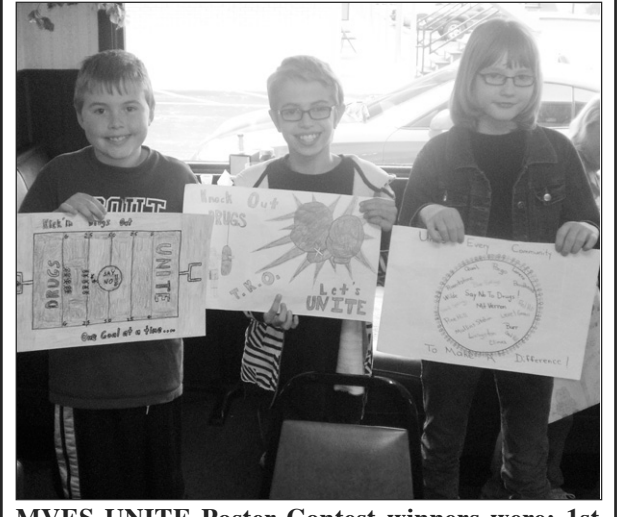

When the vote on Bryant's motion was taken, Bullock abstained and Shelly Lewis and Cliff Mullins both voted yes.

In other business, Bryant told the council that an engineering firm had been engaged and that the area would soon be surveyed and mapped. "I think we are going to be able to do this pretty quickly," Bryant said. The Mayor said he had not contacted the businesses involved, opting instead to wait until the areas were mapped.

As to the water tanks project, Bryant told the council that he had been told by Eddie Brown of Environs, the engineering firm for the project, that some expensive and time-consuming Environmental Protection Agency studies might not have to be done because the sites selected for the tanks were not an issue. Bryant also said that a survey, to get the exact location of the tanks, was underway and that some property, in the Northside Baptist Church area, would probably have to be purchased.

As the last item of business, Councilman Cliff Mullins asked Chief of Police Kevin Fletcher if his officers were the law enforcement that was setting up road blocks in the Renfro Valley area, around the time that shows were being let out at the RVEC.

Fletcher said it was not his officers conducting these roadblock but probably the KSP or sheriff's department. Fletcher agreed to try to find out which department was setting up the road blocks.

Fletcher also gave the council a report of his department's activities from September 18th through Oct. 15th.

If anyone is interested in attending the regional finals, they will be held October 20th at Bourbon County High School. These students have worked very hard in their performances and came in

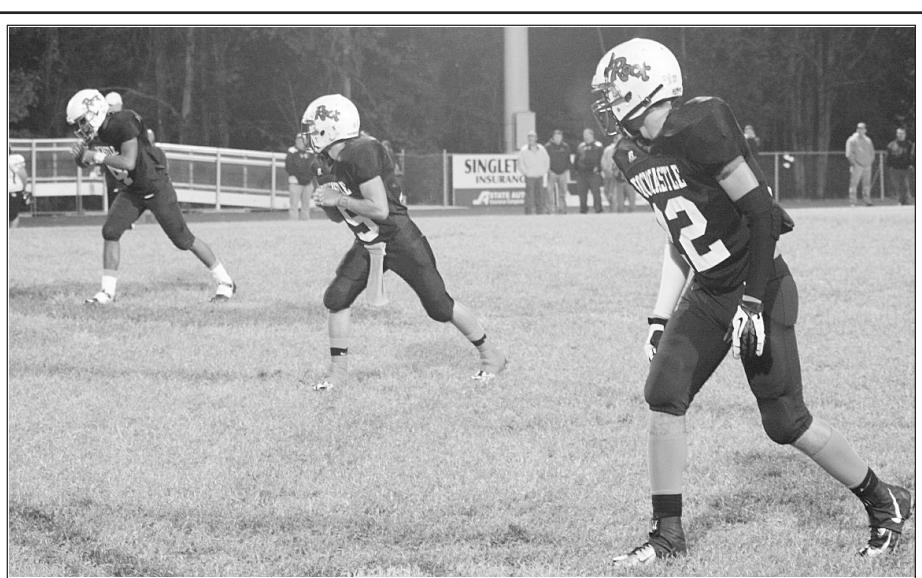

Rockets lose fifth straight to Knox Central, 47-14

The Rockcastle County Rockets dropped to 2 and 6 on the season and 0 and 2 in district play after a 47-14 loss to the Knox Central Panthers last Friday night.

Last Friday night's game was also the fifth consecutive year the Panthers have defeated the Rockets in football.

The Rockets were first to get on the board, scoring on their first possession of the game on a 19 yard touchdown run by junior tailback Jacob Bussell. The extra point attempt was good giving the Rockets an early 7-0 lead.

But the Panthers struck immediately on offense with a 19 yard touchdown run by All-State running back Jonathan Gist. The extra point attempt was good, tying the score 7-7 late in the first quarter.

In the second quarter, the Rockets momentum stalled as the Panthers put up an unanswered 33 points against the Rockets making the score 40-7 at halftime.

After halftime, the Panthers were first to score on a 19 yard touchdown strike from quarterback Devon Evans to receiver Matthew Barger. The extra point attempt was good extending the Panthers lead to 47-7.

In an attempt to save face, the Rockets scored on their next possession with an 8 yard touchdown pass from quarterback Corey McPhetridge to receiver Eli Haddix. The extra point attempt was good cutting the lead to 47-14 in the final seconds of the third quarter.

The fourth quarter proved to be a defensive battle between the two teams as neither offense put any points on the board.

The Rocket offense was led by McPhetridge who finished the game 10 out of 18 passing for 131 yards and one touchdown with one interception. McPhetridge also rushed for 13 yards on five carries.

Bussell led the ground attack with 36 yards and one touchdown. Sophomore running back Chance Ansardi rushed for 36 yards on four carries and senior fullback Tommy Shaffer rushed for 15 yards on eight carries.

Junior wide receiver Tyler Harper led the receiving corps, catching two passes for 63 yards. Haddix also had a big night offensively gathering in two passes for 17 yards and one touchdown.

Other Rockets making receptions were senior Tyler Smith with one catch for 33 yards, junior Brandon Jones with two receptions for 10 yards, freshman John Hughes with one for 4 yards and Shaffer with one for 4 yards.

Sophomore Austin Spoonamore had the best game of his career, leading the Rockets defensive effort with a total of seven tackles as well as two sacks. Sophomore Kyle Denney also had a big night defensively with a total of three tackles and one interception.

Other Rockets picking up tackles and assists were Bussell with eight, Smith with seven, Shaffer and

Zach Lunsford with six each, Jared Lake with four, Jones with three and Haddix, Hughes, Koty Benge and Austin Collins with two each. Ansardi, McPhetridge, Boone Saylor, Tyler Langford, Justin Hughes, and Jeremiah Brown were also credited with one tackle each.

Head Coach Scott Parkey said the difference in the game was when the Rockets didn't take advantage of their opportunities to score on offense during the first half.

"We had four or five solid opportunities to make plays on offense early, but we just didn't," Parkey said. "The things we practice day in and day out are what let us down in this game."

Parkey said the Rockets played better fundamentally in the second half. However, he said the large deficit in the score was too big to overcome.

"We did better on both sides of the ball in the second half but we had spotted them so many points in the first half it was just too much to overcome," Parkey said.

Parkey said he believes the players are getting better each week but he said the frustrating thing as a coach is regardless of how much they improve, it's still not showing up in the Rockets win/loss column.

"The players are working so hard in practice and improving each week, but unfortunately it is just not showing up on the scoreboards," Parkey said. "These players will never quit, never give up and never stop trying."

The Rockets will travel to Manchester this Friday night to take on the Clay County Tigers. Kick-off is at 7:30.

Civil War enthusiasts visit Camp Wildcat

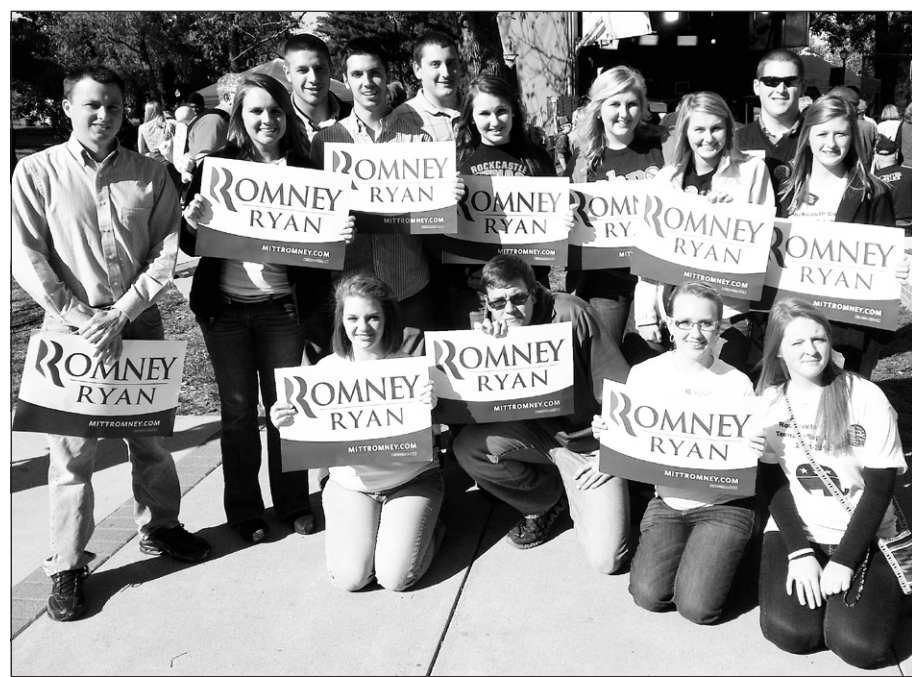

Halloween eye wear may damage eyes

As people begin shopping for the perfect Halloween costume, the Kentucky Optometric Association (KOA) urges consumers not to wear decorative contact lenses without a prescription from an eye doctor.

These non-corrective lenses, which are designed only to change the appearance of the eyes, are easily accessible to consumers and are especially popular around Halloween.

"Decorative contacts are a concern all year long, but Halloween is a time when people use them most as a way to enhance costumes," said Dr. Steve Compton, an optometrist in Franklin, Ky. "People who purchase lenses without a prescription or without consultation from an eye doctor put themselves at

risk of serious bacterial infection, or even significant damage to the eye's ability to function, with the potential for irreversible sight loss."

Since 2005, federal law requires the Food and Drug Administration to regulate decorative lenses as medical devices, similar to corrective lenses. However, decorative lenses continue to be illegally marketed and distributed directly to consumers through a variety of sources, including the Internet, beauty salons and convenience stores. Consumers also report purchasing them at retail outlets, where they are sold as fashion accessories.

Risks associated with the improper use of decorative contact lenses include conjunctivitis (pink eye), swelling, allergic reaction and cor-

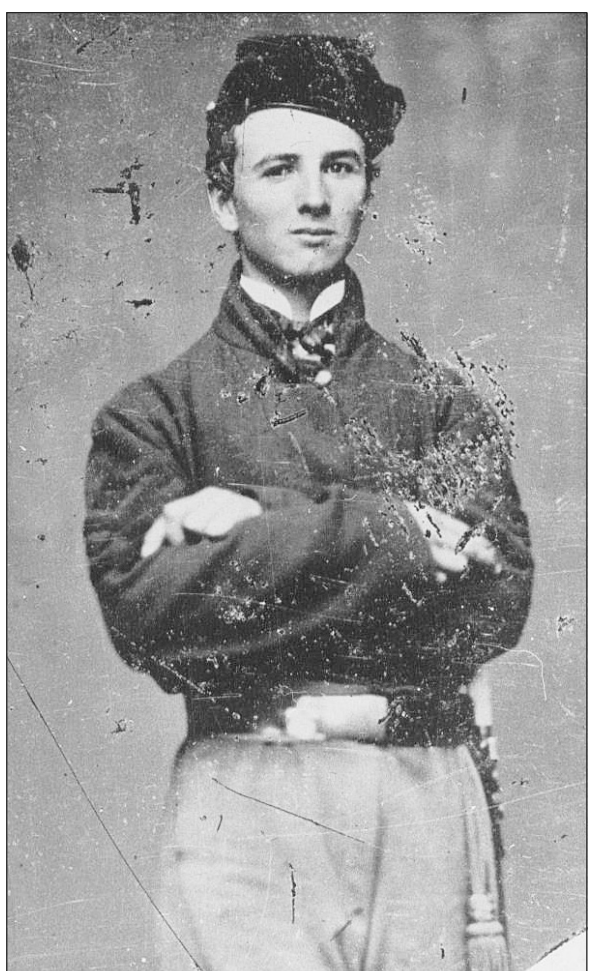
neal abrasion due to poor lens fit. Additional medical problems may result in a reduction of sight and other general eye and vision impairments.

Only a medical eye and vision evaluation from an eye doctor can determine whether patients are capable of wearing lenses without problems and ensure the lenses fit properly, Compton said.

"Even though they carry no prescription and may be worn for short periods of time, decorative contact lenses have risks," Compton said. "Because of this, it's important for consumers using these lenses to familiarize themselves with the information available from an eye doctor to reduce the risk of infection."

The KOA offers the following recommendations:

- Wear contact lenses only if they are fitted and prescribed by an eye doctor.
- Do not purchase contact lenses from gas stations or any retail vendor not authorized by law to dispense contact lenses.
- Never swap or share contact lenses with anyone.
- Make sure contact lenses are properly cleaned and disinfected as instructed by your eye-care professional.
- Make sure you wash your hands before handling and cleaning your contact lenses.
- Never sleep while wearing contact lenses unless they are extended-wear lenses specifically designed for that purpose.

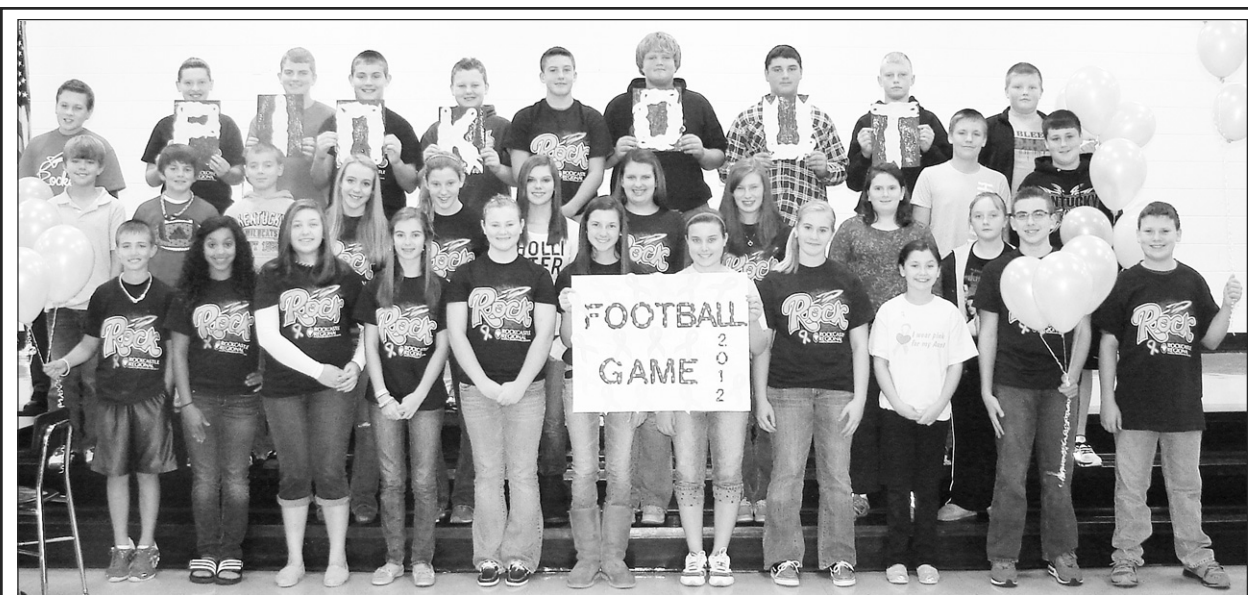



Money Tips for Students Repaying student loans

If you finish college in May and have student loans, it's almost time to begin repaying them. These tips from the Kentucky Higher Education Assistance Authority (KHEAA) may help.

One of the smartest things you can do is pay more than your scheduled payment amount. The extra is applied to the principal, so you will pay less interest over the life of your loan.

As a student loan borrower, you should let your lender know if you change your name, address or phone number; if something changes your status, such as going back to school; or if you have problems making your payments.

You have several repayment plans from which to choose. The standard repayment plan calls for equal monthly payments over 10 years. The minimum monthly payment is usually \$50. Other options include:

- Graduated repayment, which starts with lower repayment amounts that get higher over the maximum 10-year period.
- Income-sensitive repayment, with monthly payments based on gross income.
- Income-based or income-contingent repayment, with monthly amounts based on income and family size. The maximum period is 25 years, with any balance remaining at the end of 25 years forgiven.
- Extended repayment, which lets you take up to 25 years to repay your student loans if you borrowed more than \$30,000 and none of your loans were made before October 7, 1998.

You will pay more interest over the life of the loan if you use any option other than standard repayment.

If you are having trouble making payments, contact your lender immediately. You

may qualify for a deferment or forbearance, which can let you make lower payments or stop making payments temporarily.
