A lot of improvements have been made to the Lake Linville Boat Dock since Lester and Teresa Ratliff of Richmond recieved the bid and became the new operators. Since receiving a five year lease from the Mt. Vernon City Council for \$700 a month, the Ratliff's have blacktopped the parking lot, remodeled the restaurant and erected a separate building for the bait and tackle shop. They have also organized a list of fishing tournaments for Lake Linville during the 2013 fishing season. Mt. Vernon city workers are currently working on building a sidewalk to connect the two main fishing docks. Other projects the city plans on doing are erecting a flag pole, putting safety rope on all docks and building an outdoor deck that is attached to the restaurant. Once the deck is completed, customers at the Lake Linville Boat Dock will be able to dine outside. The projects are being funded out of the Mt. Vernon/Rockcastle Tourism restaurant tax fund.



Fiscal Court votes to proceed with Little Egypt Heritage Trail project

The Rockcastle Fiscal miles which would connect Court Tuesday voted to proceed with the Little Egypt Heritage Trail project by passing a Resolution of Sup-Hartwood, a public land advocacy organization, made a presentation of what the project entailed.

Scheff said there would be two trails involved, one a hiking trail of about 4

with the Livingston trails and Climax Horse Camp. The other rail would be a multi-use trail which would about one mile.

Scheff told the court of the beauty of the area. He said there were trees to be seen that were 200 to 300 years old and a seasonal waterfall with about an 80 foot

Scheff and County Judge/Executive Buzz Carloftis met with national forest officials recently to discuss the project and, Carloftis said, were told that the county's support was vital to the project being approved by the forest service.

Scheff said he was optimistic about the length of time it will take to get the project approved and underway. "I hope it will only take a year to a year and a half to complete," Scheff

Rockcastlle County Industrial Development Authority's Executive Director, Holly Hopkins, was at the meeting to give the court a check and provide an update on SourceCorp HOV.

The check presented to the court was for \$16,500 and represented repayment, by the City of Brodhead, for reimbursement to the county for money fronted to obtain grants to the city.. An additional \$3,500 is expected to be repaid to the court, Hopkins said.

The executive director also told the court that five companies would now be operating from the SourceCorp HOV building, all involved with data entry for the Veterans Administration. The five companies are

now expected to max out at 450 employees who will be working two shifts at the fa-

Representatives of the Department were on hand to request \$30,000 from the court to buy a 1993 GMC Class A pump truck. The court approved the purchase, contingent on the truck being powerful enough to service the mountainous area included in Livingston's coverage.

The court also voted to name James Ballinger and Zach Gentry to the Exten-

Brodhead Elementary School recently installed a new security buzzer and camera system at their main entrance.

When I started college my relationship with God became progressively worse as I went months without praying or attending a church service. It came to a point to where I was living as if God didn't exist at



took a winter vacation to the Great Smokey Mountains. We stayed in a condo with a great view of the snow-covered peaks in the distance. Our idea of a vacation in Pigeon Forge or Gatlinburg may be different from many visitors to the area. We are not shoppers; we spend very little time walking up and down the main drag in Gatlinburg stopping into the multiple businesses. We generally take several trips into the park to look for wildlife, visit the arts and craft shops in the area, and eat at our favorite restaurants. This time was no exception.

One morning we decided to sleep in and have a late breakfast. We were able to find a restaurant that served breakfast at any time, and this particular café had a roaring fire burning near our table. When I opened the menu, I immediately noticed one item that caught my attention – they actually had "lasses" and biscuits as a choice. I pointed out my selection to Kathy, and we had a lengthy discussion about what I had ordered. The 'lasses and a robust cup of coffee' were just enough to return me to my childhood days in Rockcastle County.

As a young man living with my grandparents (Pop and Mommie Katie) in Mt. Vernon, sorghum molasses was a normal staple found on the table for almost every meal. It was Pop's request that the sweet condiment be available every time we had homemade biscuits. And we had homemade biscuits a lot.

I can see him now as he prepared his favorite biscuit topping. He always began with a small saucer and fresh butter to start his formulation. Into the saucer he placed a large hunk of butter; then he covered it with molasses. He proceeded by taking his fork and mixing the two ingredients until they were thoroughly blended into a yellow jellylike consistency. This concoction was then carefully layered on top of a hot biscuit and devoured by my grandfather. I am certain that it was his favorite morning

Pop had a friend in the neighborhood who owned a team of mules. Pop had this gentleman turn his garden each year, and they became friends. On several occasions, Pop took me with him to watch his friend make sorghum molasses. As anyone can imagine, I was thoroughly impressed with the process.

press as the team of mules turned the huge wooden wheel. The juice that was extracted was boiled to concentrate and crystallize the sugar. The result of this boiling process is called "first molasses," which contains a very high sugar content. If it is boiled again, the extraction is slightly bitter and is called "second molasses." If it is boiled a third time, the resulting liquid is called "blackstrap" molasses, which has a robust flavor and high concentrations of calcium, magnesium, potassium, and iron. It has long been sold as a health supple-

After Pop and I watched the molasses-making process, we always took several iars of the sweet, brown liquid home with us. I can never remember being without sorghum in our pantry. It truly was a staple in our home. My mother (Bee) and Mommie Katie both also loved the taste of "lasses" for breakfast, and, on occasion, at other meals.

Each year, sorghum molasses is produced at Gladie, which is found in the Daniel Boone National Forest in Powell County. Kathy and I have watched several times as the process unfolds by those demonstrating their techniques. Watching the cane sugar being boiled makes my mouth water because I immediately recall the process as a young man.

Odors can contain very strong prompts of certain memories, and this is certainly one of them. I find that I cannot leave the area without purchasing a couple of jars of the brown delight. My wife is not much of a fan of molasses, but I have long been hooked on the taste and smell of the sugary mixture. Just like Pop, I mix my blend with butter to produce the thick, sweet, composite

know why Saylor couldn't make it to the swearing in ceremony. The council went on to say that they informed Saylor of the ceremony and that they were also shocked when he didn't come.

Kentucky state law KRS 83A.040 states if a vacancy occurs in a legislative body office that the remaining members are required to fill the vacancy by appointment within thirty days. However, the law also states that if a vacancy is not filled within thirty days after it occurs that the Governor has to fill the vacancy.

Bussell said the council will call a special meeting within the next couple of weeks to appoint someone to Cash's vacant seat. Bussell also said that she will notify the governor's office about Saylor's vacant seat and that their office will be in charge of appointing someone since the thirty day time limit has already lapsed.

Cash said Mayor February's council meeting would not be rescheduled because of the lack of new

Dale McNew, finance officer for the sheriff' department, told the court that with an additional \$2,000 from the county, Sheriff Mike Peters could cover the remainder of the assessment and the \$250 fine. This amount was approved by the court. In other action, the court

approved 60% of the payment (\$3,146) to the Brodhead Fire Department for their share of a yearly payment on a fire truck purchased several years ago; approved 90% (\$1,743.12) of the utilities for the Pongo Fire Department, from July through December of 2012; approved a payment of \$9,118.47 to Adam Edelen, State Auditor for the sheriff's settlement for 2011 taxes; approved payment of \$19,500 to Hopkins Concrete for the Cass Bridge; approved payments of \$32,998.39 and \$9,415.43 to Elmo Greer for work on Clontz Road and Mag Pie Road; appointed Tim Siler of Lincoln County as electrical inspector for the county and approved a payment of \$1,253.16 to Data Design for delinquent/reminder tax notices for the sheriff's department for 2012 taxes. The court also approved the purchase of 10 tickets to the Farmer's Businessman Banquet at a cost of \$170.

As a final item of business, the court approved the transfer of \$75,000 for the jail from the general fund and \$100,000 for the general fund from the occupational tax account.



Head Coach Benny Blanton said despite the losses to Corbin and Whitley County, he is still proud of his team's strong win against Garrard County on senior night.


"I knew we would probably beat Garrard County but I didn't know we would beat them by that big of a margin," Blanton said. "That was definitely a special win for our team on senior night."




