## Elderly man accused of killing sister sentenced to ten years

An elderly man, who was charged with murdering his sister on a Rockcastle County roadway, was sentenced in court last Friday. Clyde White, 79, of Corbin was sentenced to ten years in prison for second degree manslaughter after entering an Alford Plea during his pre-trial in March. Under the Alford Plea, White maintained his innocence but acknowledged there was enough evidence to convict him. It's commonly referred to as the "I'm guilty but I didn't do it plea." According to state police reports, White was originally charged with murdering his sister, Dorothy Whitaker, 83 of Lexington in August of 2011 after he chased a van she was riding in along I-75 into Mt. Vernon. White's brother, Lawrence White, 82, of Lexington was the driver of the van that eventually wrecked on Hwy 461 in Mt. Vernon after Clyde White rammed it several times.

## Two arrested for marijuana trafficking

Vernon. According to Mt. Vernon Police reports, Assistant Chief Barry Adams responded to Hornsby's residence at Ramsey Trailer Park, after receiving complaints of her selling marijuana from her home. Once Adams arrived at the residence, Hornsby told him that he couldn't come inside her home and that he needed

## Court okays road aid and LGEA plans; approves funds for park at Brodhead

At a special called meeting of the Rockcastle Fiscal Court Tuesday, the public hearing for the use of County Road Aid and LGEA funds was held. No one was present for the hearing so the budget for these two appropriations was approved.

\$1,256,644 is expected from the state for county road aid this year, up from \$1,144,015 last year and expected LGEA funding amounts to \$180,000, up from \$133,000 a year ago. Part of that increase comes

from the county being moved to a coal-producing county, instead of coal-impacted, according to County Judge/Executive Buzz Carloftis.

During the meeting, the court also approved a resolution dealing with a grant for phase 2 of City of Brodhead's new park.

Carloftis told the court that the grant would be for a total of \$40,000 but would involve \$20,000 in in-kind participation by the city. He

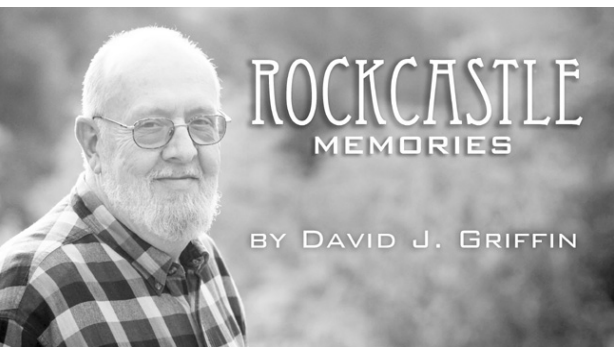

# ROCKCASTLE MEMORIES

## '54 Buick Roadmaster Convertible

When I was about to enter my teenage years, I was spending a lot of time at the Gulf station which was located where the Dinner Bell Restaurant (which became one of Mt. Vernon's favorite teenage hangouts) would eventually be. The station was owned and operated by Burgess Stokes, who was my grandfather's nephew. Burge had three children: John Coleman, Charles Shannon, and Gail. John and Shannon were both a few years older than I was, and Gail was a member of my class in elementary school.

I loved being around the Stokes family because they treated me like I was supposed to be there. I actually called Burge my uncle, because he allowed me to clean automobile windshields while he pumped the gasoline and checked the oil for his customers. Occasionally, Uncle Burge gave me a couple of dollars for my assistance. He also allowed me to have free Cokes from his "pop" machine. I thought I was something because this was really my first "job" away from my chores on our small family farm.

Uncle Burge was the ultimate automobile lover; he always kept his cars immaculately clean and in good working order. One afternoon, I stopped by the station and noticed a brand new 1954 Buick Roadmaster Convertible that was in the parking lot. The top was down, and I stood for a long time drool-

ing over that spectacular blue car. I walked all around it, looking at each of the features to be found on such an awesome auto. Uncle Burge noticed me looking at his new car, and he came over in order to show me the engine.

As he raised the hood, I noticed it had a Roadmaster, 322-cubic-inch, overhead valve, V-8 engine. It was rated at 200 horsepower. It was also equipped with Buick's smooth Dynaflo automatic transmission—complete with power steering, breaks, and windows. One feature that I had never seen before was a small button on the floor that allowed the driver to change stations on the pushbutton AM radio.

The outside of the new car sported wire, chrome wheels, tinted glass, white-wall tires, an electric antenna, and its famous vertical grill bars. Straight from the factory, it looked as if it had been customized, like many of the hot cars cruising the streets of Mt. Vernon. Needless to say, I was completely overwhelmed with Uncle Burge's new ride.

One Saturday afternoon, I noticed that Shannon had a few of his friends hanging around the station, so I asked, "What's going on?" He told me that the guys were going to take the Buick to Greenfish Hill in order to see if the car would actually do 120 miles per hour, which is what the speedometer registered. He asked if I wanted to accompany

Do you ever sit around and wish you could do stuff like the masters do or did them?

Write a novel Ernest Hemmingway? Pick a flat top guitar like Doc Watson? Drive a race car like Dale, Jr.? Hit a golf ball like Tiger Woods? Bake a loaf of sourdough bread like Charlie Gruen?

At my age, and given my physical limitations, Charlie's bread would top the list so, right now, you're probably scratching your head saying to yourself, "But who on earth is Charlie Gruen?"

Charlie Gruen is my neighbor who lives about a mile down the road in Metropolitan Paint Lick, as opposed to out here in the suburbs. He and his wife, Linda, are as fine as neighbors get.

Back in January Loretta had to have big time shoulder/rotor cuff surgery that left her suffering intense pain and unable to move her right arm for several weeks. I was simultaneously engaged in a very serious conflict with Mr. Parkinson so both of us were pretty darned helpless.

Loretta was all for keeping her surgery quiet and certainly out of the newspaper because we'd already had a public pity party when she'd undergone a complicated thyroid operation just a few months earlier.

But word got out and the day after Lo came home, neighbors began showing up at our front door on a daily basis with big dishes of food. We have no idea who coordinated the "Feed the Adamases Campaign" but it was too well organized to have just happened by itself.

I've lost track of who brought what and when and if I tried to list everybody who participated it would take all the space I have left in this column. Soups, pasta dishes, casseroles, chili, burritos, sandwich salads, barbecue, veggies, chicken. Suffice to say that Loretta and I both gained weight because this went on for weeks.

Among the gifts of food was a big loaf of home-baked sourdough bread

from Charlie Gruen. I didn't even know that Charlie could bake but this was easily the best bread I've ever tasted. Absolutely perfect texture and that wonderful, semi-sweet, sour dough flavor with just a hint of garlic. Most serious bakers that I know only dream about reaching the level of perfection Charlie has mastered.

Early in February I ran into Charlie at Friends of Paint Lick where I raved about and praised his bread in front of a dozen women. This was the first time Loretta had been able to get out of the house, post-surgery, and she was saying amen to every compliment I offered and throwing in a few of her own.

The very next day, Charlie showed back up at our house with another loaf of sourdough bread except this one was flavored with the absolute perfect hint of mixed herbs. A few days later along came a loaf with vanilla and nuts, then almond, then beer, then onion, more garlic, etc until I am now addicted. Since day one, not a single crumb has gone to waste in our house. I even eat the heels, which may, in fact, be the best part of any given loaf.

I've asked Charlie for his recipe but he is elusive at best. He claims he doesn't have one. "You just have to have good starter and you throw in some flour and stuff and bake it at about 350 until it's done and that's about all there is to it," he claims.

Over the last several weeks, much to Loretta's dismay, I've searched the internet and copied off several dozen sourdough bread and starter recipes. I've even read a book on the subject. But, while I have been able to make the kitchen smell oh so appetizing on numerous occasions, I have

# Strange... But True?

There'll Be a Hot Time in the Old Town Tonight: A Story of Spontaneous Human Combustion, Part II

In the last column of "Strange but True?" we took a look at a very rare human occurrence known as Spontaneous Human Combustion, or "SHC". It is the spontaneous combustion of primarily the human torso of the body. The body is completely incinerated from unknown sources. Several have commented who are familiar with cremation that the body's remaining ashes appear to have burned even hotter than the crematorium could produce. The victims are usually alone at the point of combustion. The head is often reduced to the size of a grapefruit or orange. There are a variety of possible causes for the event.

During the decades of the 1950s through the 1980s there have been only fifty-three known cases worldwide. The 1950s saw eleven cases and the 1980s saw twenty-two cases, so evidently the number of SHC episodes are increasing.

From further study in another source I've found that not all SHC victims simply burst into flames. Some victims have been known to have several burns on their body with no obvious source or they may have smoke coming from their body when there is no noted fire. Not all of the SHC victims

have died but have actually survived the experience. All of this is according to the source, science.howstuffworks.com.

The latest case of SHC occurred in September 2011. It was the first noted case in Ireland. It was the case of an elderly man found lying near the furnace of his apartment. Coroners determined, however, that the furnace was not the source of the fire. The body produced no sign of foul play. There were no indications of burn marks near the body.

The first ever recorded case of SHC was that of Polonius Vorstias, an Italian knight who lived in the late 1400s. On one particular evening he consumed quite a bit of a very strong wine. He soon began to vomit flame, and then burst into flames entirely according to bystanders. The wine didn't disagree with the other people and the incident left them baffled as to how this happened.

Other noted and historic cases included Countess Cornelia DiBaude, who was a victim in the 1700s. She had two candles in her room at the time of her incident and the tallow melted, but left the wick.

The only case of SHC to be witnessed is that of a mentally disabled girl being cared for by her father. He noticed a flash of light from his daughter who had just

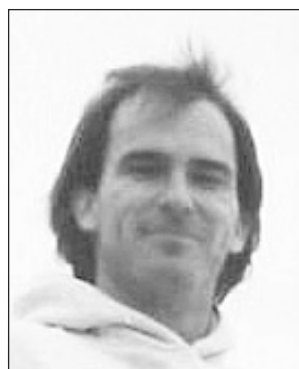

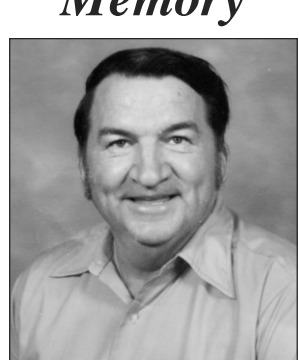

# Agricultural News

**Direct and Counter-Cyclical Payment Program (DCP) - 2013**  
 The American Taxpayer Relief Act of 2012, enacted on Jan. 2, 2013, amends the Food, Conservation, and Energy Act of 2008 and provides for a one-year extension of the Direct and Counter-Cyclical (DCP) program. To be eligible for direct and counter-cyclical payments, producers must enroll their farms in DCP during the sign-up period which began on Feb. 19, 2013 and ends on Aug. 2, 2013.

**Crop Acreage Reporting**  
 Farm Service Agency (FSA) reminds agricultural producers of the acreage reporting requirements that must be met prior to receiving program benefits. Filing an accurate acreage report

for all crops and land uses, including failed acreage and prevented planting acreage, can prevent the loss of benefits for a variety of programs. July 15th is the final date to certify all crops, except small grains.

Producers must report acreages to maintain eligibility for Price Support Programs, Noninsured Crop Assistance Program (NAP), Conservation Reserve Program (CRP) and Direct and Counter-Cyclical Program (DCP). All cropland on farms must be certified to remain eligible for these programs

**CRP Sign-up**  
 Kentucky Farm Service Agency (FSA) will conduct a four-week Conservation Reserve Program (CRP) general sign-up beginning May 20, 2013 and ending on June 14, 2013. CRP addresses critical resource issues. In addition to erosion control, CRP provides significant water quality ben-

efits including reduced nutrients and sediment loadings and adverse consequences associated with floods as well as expanded and enhanced wildlife habitat.

CRP is a voluntary program available to agricultural producers to help them safeguard environmentally sensitive land. Producers enrolled in CRP plant long-term, resource-conserving covers to improve the quality of water, control soil erosion and enhance wildlife habitat. Producers that are accepted in the sign-up can receive cost-share assistance for planting covers and receive an annual rental payment for the length of the contract (10-15 years).

This time, Shannon got a run at the vertical highway, and I noted that his gasoline foot was firmly placed on the floor. All I could see was a maze of telephone poles flashing by the windows. I have to admit that I was scared out of my wits. When we leveled off, Shannon an-

## A Place to Remember, Mourn and Heal Memorial Dedication set for May 6th at Frankfort

An idea born of one woman's grief will soon become a reality, a place where people can go to remember, grieve and heal over the loss of children to miscarriage, still birth or abortion.

The dedication of the Kentucky Memorial for the Unborn will be held on Monday, May 6th at 5:30 p.m. at Frankfort Cemetery. Most Rev. Ronald W. Gainer, Bishop of the Catholic Diocese of Lexington and Rev. Wayne Smith, Retired Pastor of Southland Christian Church, will speak at the event. Both Gainer and Smith have spoken in support of the project since its inception and were present at the groundbreaking on September 22, 2009.

Kathy Rutledge, whose own search for healing from an abortion at the age of 18 inspired the project, says the memorial is a place where mothers, fathers and families can go for healing and to seek peace with the past.

Located in a secluded section of the cemetery, overlooking the Palisades and the Kentucky River, the memorial was designed by Lexington landscape architects, M2D Design, and based on a modern interpretation of the historic Wailing Wall in Jerusalem.

The native limestone and granite wall emerges from the enfolding landscape and sweeps along a graceful arc forming a subtle enclosure like a womb. A biblical passage begins the experience

Naming lost children also provides healing, she adds. "We want people to be able to put those names in stone, so their children are never forgotten."

to get a search warrant. However, Adams told Hornsby that he could smell marijuana smoke coming from inside the residence and Hornsby told him that she had “just smoked some.”

Adams asked Hornsby where the marijuana was and she told him it was in her purse. While Hornsby was searching through her purse, Adams noticed a large zip-lock bag that contained several small zip-lock baggies inside. Hornsby then gave Adams the large zip-lock bag that contained twelve smaller zip-lock baggies of marijuana.

After receiving consent from Hornsby to search her purse, Adams found two packs of rolling papers, a pair of scissors and another large zip-lock bag that contained two smaller zip-lock baggies of marijuana. Inside Hornsby’s purse, Adams also found \$164 in cash and a spiral bound ledger that included several drug transactions on two pages.

During questioning, Hornsby told Adams she had been selling marijuana and that she sold a small zip-lock baggie of marijuana for \$5 each. She also told Adams that she was selling marijuana to help pay for her medication.

Hornsby was charged with trafficking in marijuana and drug paraphernalia. She was lodged in the Rockcastle County Detention Center and later released on a \$2,000 unsecured bond.

A Mt. Vernon man was

arrested for marijuana and drug trafficking last Friday morning after the Mt. Vernon Police Department raided a home on New Brodhead Road in Mt. Vernon.

Arrested at the scene was Kevin Ray Whitaker, 29, of Mt. Vernon.

According to Mt. Vernon Police reports, Assistant Chief Barry Adams and officer Ryan Messenger responded to the residence after receiving information that Whitaker was selling marijuana from his home.

Once officers arrived, Whitaker met them at the door and put his hands in his pants pockets, which led officers to believe he was trying to conceal something. Upon receiving consent to search Whitaker, officers found a Hydrocodone pill inside one of his pants pockets.

After receiving consent from Whitaker to search his residence, officers found one large zip-lock bag of marijuana, two sets of digital scales, marijuana cigarette roller, a Tylenol bottle containing five and one-half hydrocodone pills, another zip-lock bag of marijuana marked BOZZ, glass smoking pipe, a wallet containing \$311 cash, two zip-lock bags of marijuana seeds and two packs of rolling papers.

Officers also discovered several text messages on Whitaker’s cell phone telling people to pick up marijuana and pills at his residence. Officers also observed another text message on his cell phone telling someone that he had “just purchased 10 cheap pills.”

Whitaker admitted to officers that he was selling

marijuana to his friends and that he also gave two pills to one of his friends.

Whitaker was charged with trafficking in marijuana and trafficking in a controlled substance, second degree. He was lodged in the Rockcastle County Detention Center where he was later released on a \$5,000 unsecured bond.

Both Lawrence White and Whitaker were airlifted from the scene to the UK Medical Center. White was treated for minor injuries and released and Whitaker later died of her injuries.

Clyde White fled the scene of the crash and was arrested shortly after near the intersection of Hwy 461 and Hwy 150 in Mt. Vernon.

Commonwealth Attorney Eddy Montgomery’s Office said prosecutors agreed to an Alford Plea because White suffers from several mental illnesses, including dementia and depression, which is why prosecutors recommended ten years imprisonment for White during his sentencing hearing last Friday.

asked the court to provide the in-kind portion which would consist of work release prisoners cleaning the area, county equipment being used where needed and materials for landscaping, sowing, etc. On a motion by Carloftis., seconded by Bill McKinney, the court approved a cash contribution of up to \$15,000 and pledged work release prisoners and county equipment usage.

The court also had to approved the transfer of \$2,000 to the CSEPP fund. The state CSEPP department currently owes the local CSEPP account over \$60,000 which has been owed since March 3rd.

The court also approved payment of \$28,924 to Lumber King for 32 windows replaced in the courthouse. The county was awarded a grant for upgrades to the courthouse which will cover the cost.

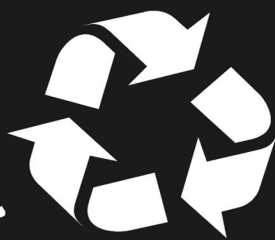

### FRUIT COCKTAIL CAKE

2 cups all-purpose flour  
2 teaspoons baking soda  
1 and 1/2 cups white sugar  
1/2 teaspoon salt  
1 can (15 ounce) fruit cocktail, not drained  
2 eggs  
1/2 cup brown sugar  
1 cup chopped nuts  
Preheat oven to 350°. Butter a 9 x 13 cake pan. Mix flour, soda, white sugar and salt. Add fruit cocktail and beaten eggs; pour into prepared pan. Mix brown sugar and nuts; sprinkle over batter. Bake for 35 to 40 minutes.

### GLAZE:

1 stick butter  
1 cup evaporated milk  
1 1/2 cup white sugar  
1 teaspoon vanilla  
Boil for 3 minutes; pour over cake while cake and glaze are still warm.

### ORANGE JUICE CAKE

This recipe came from a cousin on my father’s side of the family, but it was also one of Mamaw’s favorites to make for a quick Sunday

dessert. There were never any leftovers for the next day.

### CAKE:

1 box (3 ounce) orange jello  
1 cup boiling water  
1 box (about 14 ounce) yellow cake mix  
1/2 cup water  
3/4 cup cooking oil  
4 eggs

### GLAZE:

1 and 1/2 cups powdered sugar  
1/2 cup orange juice  
Preheat oven to 350° degrees. Dissolve jello in 1 cup boiling water and set aside. Mix yellow cake mix, 1/2 cup water, 3/4 cup cooking oil, and 4 eggs until well blended. Add dissolved jello and beat for 3 minutes. Pour batter into a greased and floured 13 x 9 pan and bake 35 to 38 minutes. Mix glaze until powdered sugar is dissolved. Set aside.

When cake is done use a fork or tooth pick to poke holes in it and then pour the glaze on and let it soak into the cake.

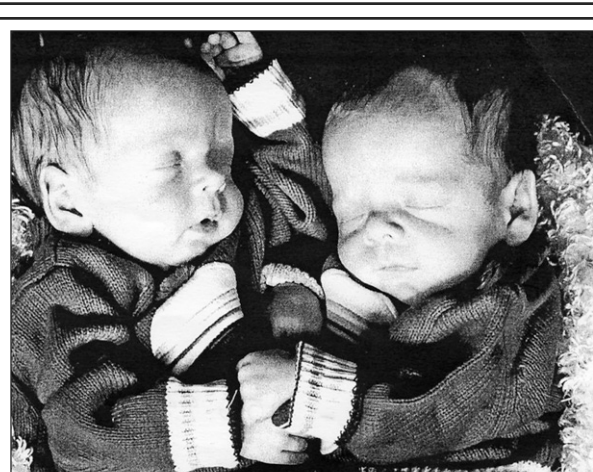

## Bible Talk

We want to study this month about the exalted name of Jesus, a name that is above every name, Phil.2:9-11. In our culture we do not think of names as they did in biblical times. We choose names because of the way it sounds. Names in the Bible often have a meaning and they signify the character and nature of a person. In Ex.34 when God "proclaimed the name of the Jehovah," was He merely proclaiming a pronunciation of a name? No, He proclaimed Jehovah's character, "And Jehovah passed by before him, and proclaimed, Jehovah, Jehovah, a God merciful and gracious, slow to anger, and abundant in lovingkindness and truth, keeping lovingkindness for thousands, forgiving iniquity and transgression and sin" Ex.34:6-7a. (Praise God for his marvelous character and nature!)

**Isaiah 9:6** - In Is.9:6 we read, "For unto us a child is born, unto us a son is given: and the government shall be upon his shoulder: and his name shall be called Wonderful, Counsellor, The mighty God, The everlasting Father, The Prince of Peace." Notice that it says "his name" not "names." All 5 of these phrases signify qualities or characteristics about the coming Messiah, Jesus.

**Wonderful** - He is called Wonderful, because he is marvelous and unique like a miracle.

**Counsellor** - He is called Counsellor, because he directs, advises, gives the guidelines for our life.

**The mighty God** - He is called The mighty God, for this signifies his divinity. Our JW friends, who deny his divinity, point out it does not say "Almighty." True, but notice Is.10:20-21, "And it shall come to pass in that day, that the remnant of Israel, and they that are escaped of the house of Jacob, shall no more again lean upon him that smote them, but shall lean upon Jehovah, the Holy One of Israel, in truth. A remnant shall return, even the remnant of Jacob, unto the mighty God." Thus, Jehovah is called "the mighty God" so they do err in their reasoning in this text.

**The everlasting Father** - Jesus is called the everlasting Father in our text. Now our oneness friends err in saying Jesus and God the Father is one person. No, the word "father" signifies the idea of protector, sustainer. Notice in Gen.45:8, "So now it was not you that sent me hither, but God; and he hath made me a father to Pharaoh, and lord of all his house, and a ruler throughout all the land of Egypt." Now did Joseph begat Pharaoh? No, but Joseph did act as a protector and sustainer for Pharaoh as a father would for his children.

**The Prince of Peace** - Jesus is called the Prince of Peace, for He makes peace between God and man, "Therefore being justified by faith, we have peace with God through our Lord Jesus Christ." Rom.5:1. He also makes peace between Jew and Gentile in the one body, "For he is our peace, who hath made both one, and hath broken down the middle wall of partition between us; Having abolished in his flesh the enmity, even the law of commandments contained in ordinances; for to make in himself of twain one new man, so making peace;" Eph.2:14-15. 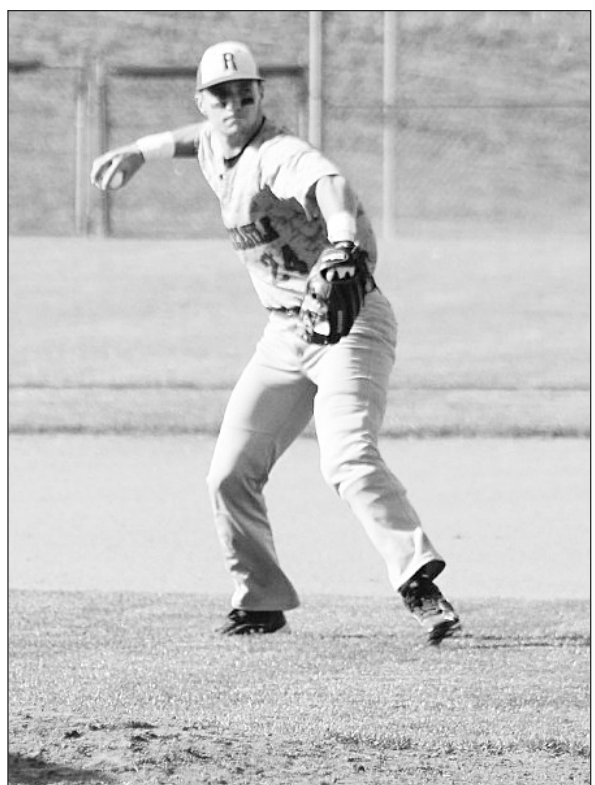

Fresh off a solid sophomore season that saw her lead her team to the NCAA championship game, being named Sophomore Female Athlete of the Year at U of L and named to the third Team all Big East, Rockcastle county native Sara Hammond has received an official invitation to tryouts for the USA National team. Only 35 players from colleges across America are invited. Tryouts are May 16-19 at the US Olympic training facility in Colorado Springs, CO. Should Sara make the 12 player roster, she will travel with Team USA to participate in the World University Games in Russia in July.

## Kentucky Afield Outdoors: Early May is the start of the best fishing for bluegill, redear sunfish

Early May in Kentucky is not only a good time to set out tomato plants in backyard gardens, but it's the start of the best fishing of the year for bluegill and redear sunfish. When water temperatures approach 70 degrees, these two native sunfish species move into the shallows of ponds, small lakes and large reservoirs in preparation for spawning. "If I was to pick a time here it would be the second week in May," said Paul Rister, western district fishery biologist for the Kentucky Department of Fish and Wildlife Resources, who manages fish populations in Kentucky Lake and Lake Barkley. Both lakes support excellent populations of the sunfish species. "When they are spawning, generally the redear sunfish will be out from the banks in a little deeper water than the bluegills," said Rister. Anglers should try to time their fishing trips to coincide with rising or stable lake levels. "By the time bluegills and redears go on the bed, both lakes are usually stable at summer pool," said Rister. The ideal fishing area is a shallow embayment that has flooded vegetation on the mudflats, close to gravel shores. Rister said meal worms and crickets are the preferred live baits for redear sunfish, while red worms and crickets are tops for bluegills. The recommended strategy for both species is suspending the bait under a float. "Redears want the bait close to the bottom, with as little weight (split shot) on the line as possible," said Rister. Bluegill strike bait suspended a little shallower than redears, along weed lines. Light wire, long-shank hooks in size # 8 or #10 are recommended for both species. These sunfish spawn in colonies, their saucer-shaped nests clustered together. Spawning can continue into June, if water conditions are ideal. The redear sunfish (Lepomis microlophus) is commonly called the "shellcracker" because it likes to feed on mussels, snails and insects on the bottom. A special plate of teeth in the back of the fish's

throat enables them to crush shells. The preferred habitat for redear sunfish is clear water where rooted aquatic vegetation often grows. On Aug. 27, 2004, the Kentucky Fish and Wildlife Commission voted to give the redear sunfish sport fish status, and protected populations from overharvest by creating a statewide 20-fish daily creel limit. Other Kentucky waters that support quality populations of redear sunfish include Beaver Lake in Anderson County, Elmer Davis Lake in Owen County, McNeeley Lake in Jefferson County and Pan Bowl Lake in Breathitt County. The bluegill (Lepomis macrochirus) is arguably the most popular panfish in Kentucky. An abundant species that's present in all the state's river drainages, bluegill are easy to catch and their white flesh is sweet and firm. Bluegill thrive in ponds and small lakes across Kentucky. Statewide, there's no daily creel limit on bluegills, but Fishing in Neighborhoods (FINs) lakes have restrictions on the number of bluegills and redears that can be kept. Redear sunfish and bluegill are willing strikers all day long, perfect for introducing a child or adult novice to fishing. The license year expired Feb. 28, 2013. You'll need to buy a new fishing license, available in the sporting goods section of department stores and tackle shops, to fish now. Licenses and permits may also be purchased online from the Kentucky Fish and Wildlife homepage at fw.ky.gov or by calling 1-877-598-2401. - Young Entrepreneur (for businesspeople who are 25 years of age and younger)

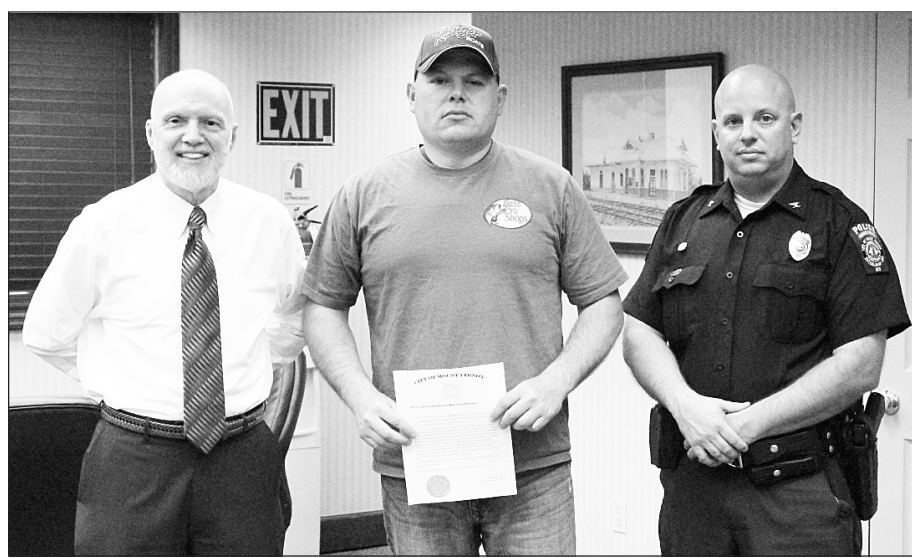

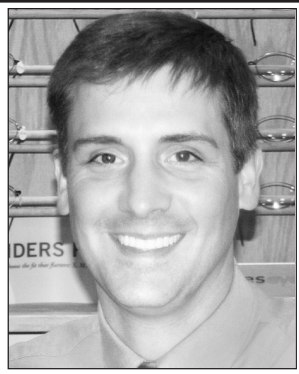

Great Saltpetre Cave Preserve will hold its annual Open House on Saturday and Sunday May 18 & 19, 2013 from 10:00 am to 4:00 pm each day. Guided tours of the Cave are given by members of the Greater Cincinnati Grotto, the Blue Grass Underground and the Dayton Underground Grotto all weekend. Admission is free

but donations are always appreciated.

There will be free soup beans and cornbread at the Shelter. Livingston Fire Department will be grilling up and selling their hamburgers and hotdogs along the Creek. You can sit in the shade of the trees or under the shelter. Wander down the creek to the living his-

tory encampment and visit with the folks portraying life on the frontier.

Great Saltpetre Cave Preserve (GSP) is a 306 acre Karst Preserve along Crooked Creek near Mt. Vernon, Kentucky that contains the primary entrance to Great Saltpetre Cave. It has long been a landmark in the community as a primary site for the production of saltpetre between 1801 and 1815. Later between 1938 and 1985 it was operated as a commercial cave and occasionally as a site for the Renfro Valley Barn Dances. The Great Saltpetre Cave Preserve is closed to the general public. Nonetheless, the Preserve is open to visitors annually during the weekend after Mother's Day. In conjunction with Greater Cincinnati Grotto, GSP has been hosting school field trips in the Spring and Fall to help local teachers bring the elementary science curriculum to life.

GSP is owned by Rockcastle Karst Conservancy, a 501(c)(3) non-profit, local volunteer organization dedicated to protecting Kentucky's karst environments and supporting access to caves in the Rockcastle County Region. RKC's goal is to become the leading non-profit organization in owning and protecting significant cave and karst resources. RKC manages each cave resource to support continuing enjoyment by the community through wise stewardship and ownership. 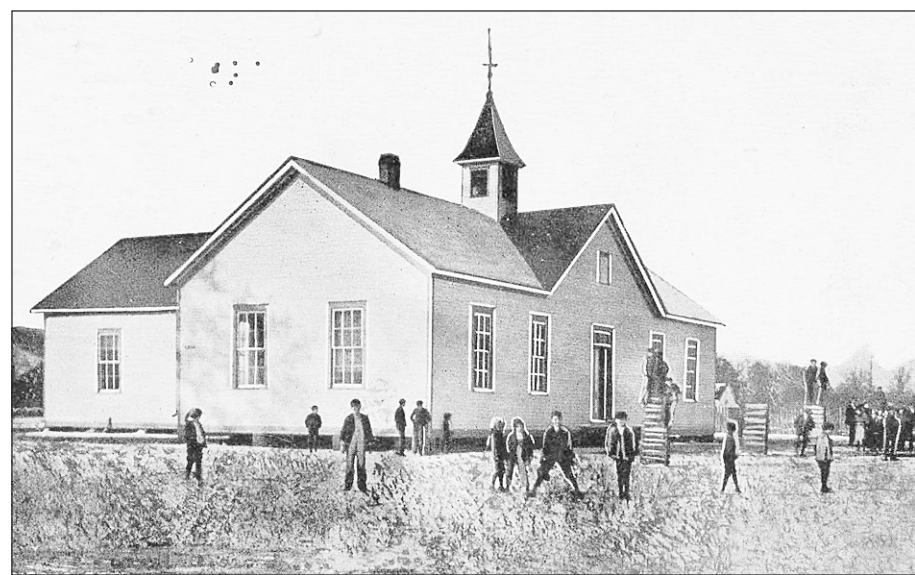

The Battlefield is located about 10 miles north of London on US 25 via the Hazel Patch Road, or off I-75 at exit 49 and follow the signs.

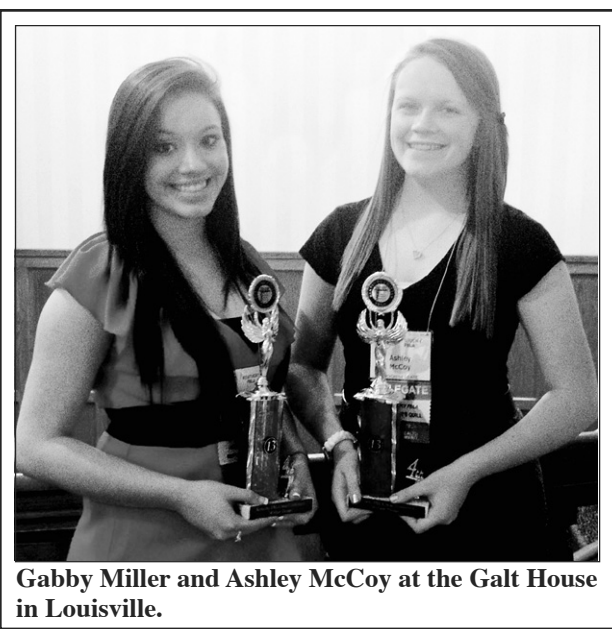

## INSPECTION PERIOD FOR THE PROPERTY TAX ASSESSMENT ROLL

The Rockcastle County real property tax roll will be opened for inspection from May 6 through May 20, 2013. Under the supervision of the property valuation administrator or one of the deputies, any person may inspect the tax roll.

This is the January 1, 2013 assessment on which state, county and school taxes for 2013 will be due about September 15, 2013.

The tax roll is in the office of the property valuation administrator in the county courthouse and may be inspected between the hours of 8:30 and 4:00.

Any taxpayer desiring to appeal an assessment on real property made by the PVA must first request a conference with the PVA or a designated deputy. The conference may be held prior to or during the inspection period.

Any taxpayer still aggrieved by an assessment on real property, after the conference with the PVA or designated deputy, may appeal to the county board of assessment appeals.

The taxpayer can appeal his assessment by filing in person or sending a letter or other written petition stating the reasons for appeal, identifying the property and stating the taxpayer's opinion of the fair cash value of the property.

The appeal must be filed with the county clerk's office no later than one work day following the conclusion of the inspection period.

A taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representative, will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.

Appeals of personal property assessments shall not be made to the county board of assessment appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132.450(4) and shall have the protest and appeal rights granted under the provisions of KRS 131.110.

The following steps should be taken when a taxpayer does not agree with the assessed value of personal property as determined by the office of property valuation administrator.

- (1) He must list under protest (for certification) what he believes to be the fair cash value of his property.
- (2) He must file a written protest directly with the Department of Revenue, Office of Property Valuation within 30 days from the date of the notice of assessment.
- (3) This protest must be in accordance with KRS 131.110.
- (4) The final decision of the Department of Revenue may be appealed to the Kentucky Board of Tax Appeals.

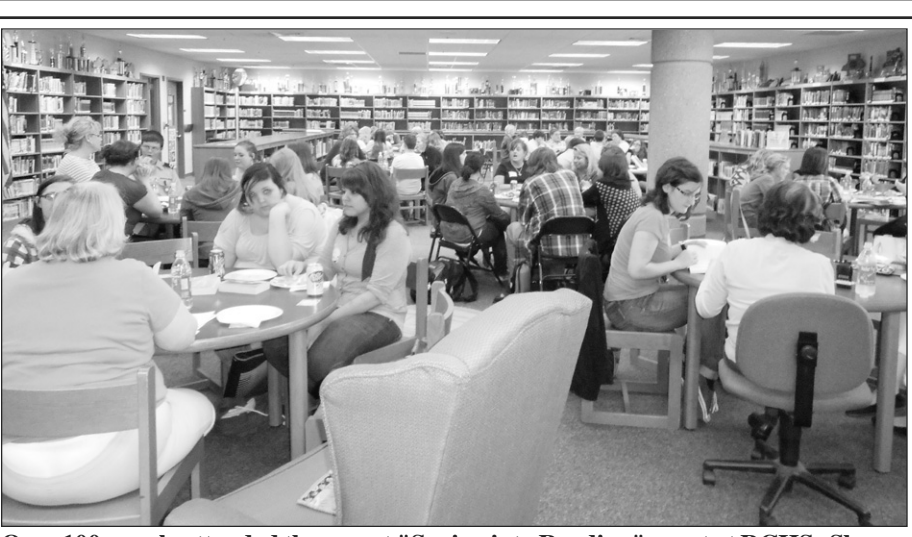
