**Thinking About Cleaning Your Carpet? Some things to think about...**

## Bids opened for CVFD at Fiscal Court Meeting

Bids for hanging and finishing drywall for the Climax Volunteer Fire Dept. were opened at last Friday's meeting of the court. However, the three bids received were not bid the same so the court tabled awarding the bid.

One bid was from Keith Bullock who bid labor only for hanging firewall drywall (\$15 sheet) and regular drywall (\$12 sheet) and \$12 for taping and finishing both types. A bid was received from James Nicely of \$6,100 for labor and materials for hanging, taping and finishing and, the third, was from Roy Cope of Berea for \$3,000 for labor only.

The court did accept the only bid received for labor and materials for five 12 ft. garage doors (commercial grade) for \$11,000 from Economy Garage Door of Brodhead for CVFD.

The court also approved final payment of \$10,000 for concrete work by New Ideal Construction for the fire department. They also approved payment of \$4,000 to Tim Sizemore Construction for installation of bumper posts and concrete porches at Livingston Volunteer Fire Dept.

Also on the agenda was a request by the City of Livingston for a trailer to transport bikes and gear to the top of the mountain for trail riders. The court approved the \$2,090 request

and the trailer will be donated to the city. Magistrate Bill McKinney questioned this practice, saying "It's a thin line when the county buys something and gives it to a city and this may cross it."

The court also heard a report from Deputy Jailer Howard Haddix who said that upgrades on six show-ers in the detention center were nearing completion. The remodeling will cost the county \$20,000. Haddix also told the court that the vents had been replaced by courthouse maintenance supervisor Gene Cromer.

County Judge/Executive Buzz Carloftis made the magistrates aware of a grant the county had received from a private donor. The \$8,267.43 grant will enable people who adopt animals from the shelter the option of having them spayed/neutered at no cost to them as long as funds last.

The court also approved a salary for a temporary/part-time worker for the Rockcastle Co. Library from the Cumberland River Mental Health/ Mental Retardation organization. The cost to the county will be about \$30 week and will give the person chosen work experience.

The court also heard from Hal Holbrook, CSEPP Director who said that

## HMB engineer meets with Livingston City commissioners

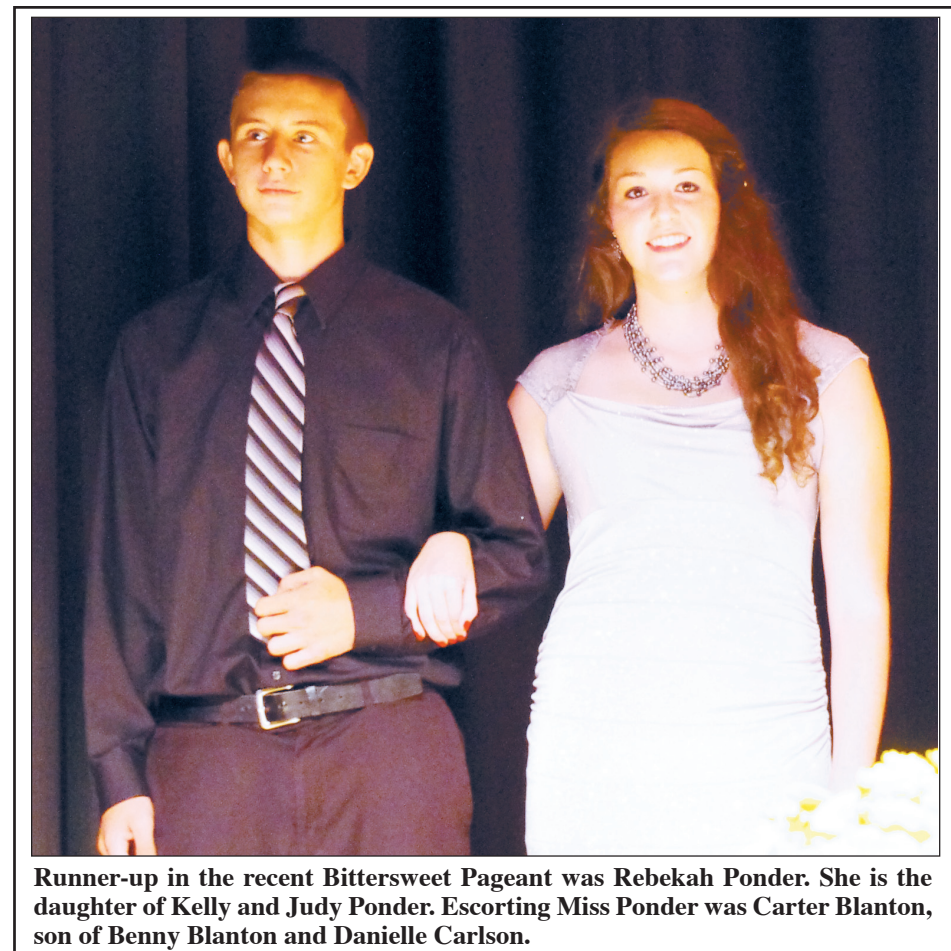
Joe Grider, an engineer with HMB Engineering met with the Livingston City Commissioners Monday night to discuss the sidewalk project that has been in the works since 2008.

Native Americans consider white buffalos to be holy so maybe we're getting some godly woolly worms in the mix and maybe we're getting set to have a holy winter.

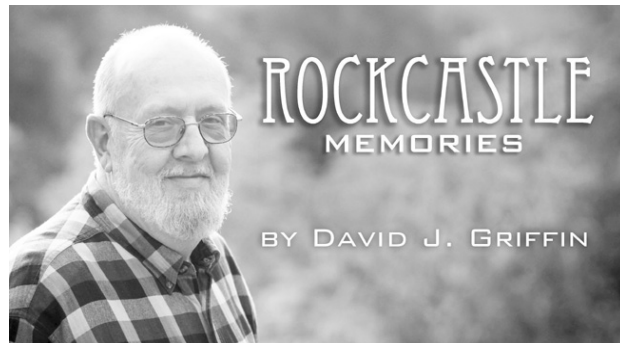

### The 1962 Flambeau

While leafing through my 1962 Mt. Vernon High School (MVHS) yearbook, I became amused by some of the candid photos and genial clubs in which my classmates were members. One of the most amusing photos that caught my eye was the class photo that was made outdoors in the center of the school's courtyard. # On Call

I am going to finish up this week with the heat component of the fire tetrahedron, but first let's answer last week's question. How many ways can you transfer heat from one body to another? The answer is three. Heat can be transferred through conduction, convection and radiation. I'm going to explain all of these and tell why it is important to firefighters to know.

Heat moves from warmer objects to cooler objects. The transmission or transfer of heat from one point to another is basic to the study of fire behavior. I am going to look at all three ways that heat can be transferred.

First there is conduction. Conduction is the transfer of heat from one object to another by direct contact. Conduction occurs when a material is heated as a result of direct contact with a heat source is another way of putting it. Here is a good example. If you have a metal pipe heated by a fire on one side of the wall, the heat conducted through the metal pipe can ignite the wood framing in the wall and other combustibles on the other side of the wall. Say you have clothing hanging from the pipe; those clothes can

ignite from the heat. Insulating materials help to slow down the conduction process. Some materials have a better thermal conductivity than others. For example, copper is seven times more conductive than steel. Wood is the least able to conduct heat. Say you have a piece of wood on fire from a campfire most often you can pick up the end of the stick and move it around the fire. Now say your welding a steel beam and you put your hand on the steel a foot down, it's probably hot to the touch and may result in the burning of your hand. Even with a glove on your hand would still be able to feel that heat.

Convection is the transfer of heat by the movement of heated gases usually upward. As the fire grows the air in the fire is heated. The hot air and products of combustion become light and begin to rise. During a fire you will see firefighters enter a burning structure on their hands and knees and crawl to the fire. This is because the hot air rises and the cooler air stays low.

Finally we have the transfer of heat through radiation. As the fire grows in

## UNITE HOPE Wall on display in Pulaski

"When everything seems like an uphill struggle, just think of the view from the top."

That quotation, from an unknown person, is used by Operation UNITE to help describe its new HOPE Wall, which will be on display at the Pulaski County Judicial Center from October 14-25.

"This wall inspires people to believe that anything is possible. Once they start believing that, you can see people become free of addictions," said Circuit Court Judge Jeffrey T. Burdette. "The faces on this wall remind us that we're all on the scrimmage line together – there's no one better or worse than the other – and all fighting against addictions."

Burdette, who along with Circuit Court Judge David A. Tapp oversee Pulaski County's Adult Drug Court programs, was on hand as the HOPE Wall was set up Monday morning.

Created to celebrate sobriety from addiction and give others struggling through this addiction hope to reclaim their lives, the 20-foot long HOPE Wall features photos of individuals who are now in recovery and living clean and sober lives. The wall demonstrates that addiction has no boundaries, and that all walks of life are affected.

"In the midst of those cries for help we're beginning to hear more tears of joy and triumph," Fifth District Congressman Harold "Hal" Rogers said during the wall's unveiling in August.

"We know that individuals and families struggling with addiction are experi-

encing a lot of pain and believe they have nowhere to turn for help," said Amy Yates, UNITE's treatment director. "Once you make a decision to turn away from the destructive path of drugs and begin your recovery journey it is possible to find hope and rebuild your life."

"It won't be easy," Yates continued, "but there are a lot of people who will assist and guide you along the way."

Pulaski County is the first stop for the wall, which will be displayed in courthouses throughout southern and eastern Kentucky on a scheduled basis.

size to almost its fullest potential, radiant heat becomes prominent. Radiant heat transfer plays a significant factor in fire development and spread. When you have houses close together and one house has a significant fire, you will be able to see evidence of radiant heat. If you have vinyl siding on your house and your neighbor's house is on fire, your siding will begin to melt and sag from the radiant heat. Eventually your house can begin to catch fire if exposed long enough.

I may have spent some time on heat but truly heat and the spread of heat is the basic study of fire behavior. Firefighters must know this in order to apply the proper firefighting techniques to put the fire out. Next week I am going to try to finish up the fire tetrahedron. This week's question is over fuel the next component of the fire tetrahedron. Can gasoline, diesel and fuel oil float on water? The answer and explanation next week.

I mentioned previously that five members of Brodhead Volunteer Fire Department were going to go through a Structural Collapse Technician training course starting on September 30th. I am proud to say that all completed the training although extremely sore and exhausted. This training was both mentally and physically exhausting. We left tired and sore everyday but grateful for the knowledge we gained. This course taught us how to properly support a collapsing building to remove a victim, how to get through ten inches of solid concrete without the slab of concrete doing further damage to the victim, how to maneuver and work together in a confined space so small you have to work from your back to breach a wall above you. It taught us how to move concrete a 50 feet away safely with a crane and safely using only wood and steel piping. I say all of this because we want to gather this knowledge to better protect not only this county but others nearby that may need our help. It has been a grueling and exhausting 80 hours over 8 days, but well worth it. Thank you to our families for their continued support. All of us not only took this class but worked their jobs at night. Our wives took care of our children while we were in training and it was exhausting for them as well, so thank you for taking care of the household. Thank you for being there for you firefighter husband, your support is truly appreciated. ## Money Tips for Students Plan may help repaying federal student loans

Kentuckians who are having trouble repaying their federal student loans may want to check into the Pay As You Earn plan, according to the Kentucky Higher Education Assistance Authority (KHEAA).

The Pay As You Earn plan generally has the lowest monthly payments of all the repayment plans offered by the U.S. Department of Education (ED). It can be used by borrowers who have what ED calls a partial financial hardship. That means that the amount borrowers would pay under the standard 10-year repayment program is higher than what the borrower would pay under the Pay As You Earn plan.

Not everyone will qualify. Only three types of federal student loans are eligible:

- Federal Direct Stafford Loans.
  - Federal Direct PLUS Loans made to graduate or professional students.
  - Federal Direct Consolidation Loans that do not include a Federal PLUS Loan made to a parent.
- In addition, borrowers must have received one of those loans after Sept. 30, 2011. Borrowers who are repaying loans received before Oct. 1, 2007, are not eligible.

Loans received through the Federal Family Education Loan Program cannot be repaid under the Pay As You Earn plan. However, they will be used to decide if borrowers have a partial financial hardship.

Borrowers who make 20% of payments under the Pay As You Earn plan will have the rest of their eligible loans forgiven. They may be required to pay taxes on the amount that is forgiven.

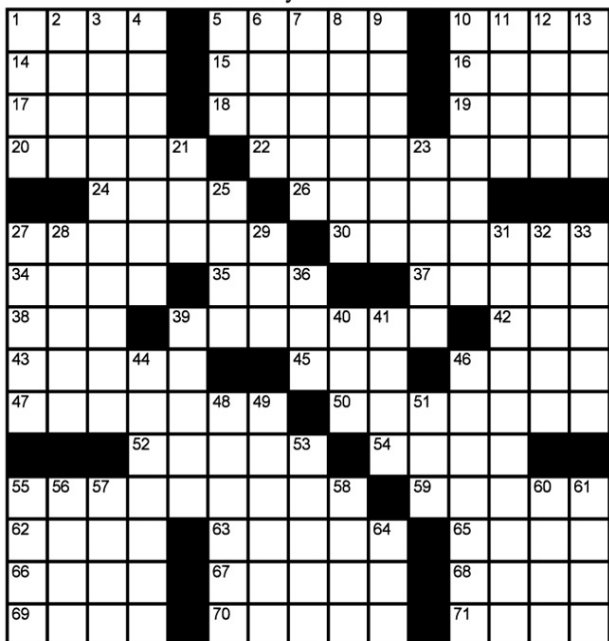

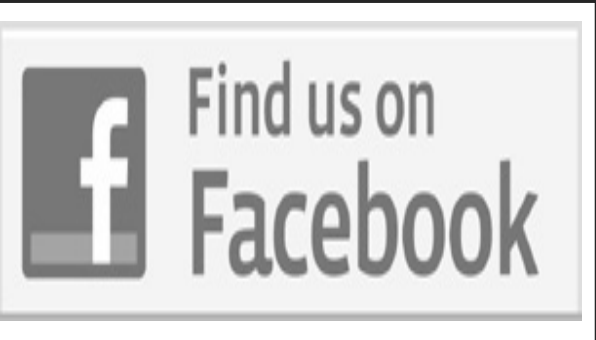

# Strange... But True?

## The Hope Diamond: A Cursed Jewel

The Smithsonian Natural History Museum in Washington, DC, is in possession of the most famous and beautiful diamond ever known, but...is it cursed? In this column of the "Strange...But True?" series, we will look first concerning the history of the stone, then its curse, if any.

The story is said to have begun when the stone, quite larger than its present form, was stolen from the eye of an Indian goddess sculpture, Sita, the wife of Rama, the seventh avatar of Vishnu. The possessor of the cursed stone is said to be cursed, as is anyone that ever touches it. Many believe the "curse" was invented in the 20th century to increase the sales appeal and add mystique.

The 45.52 carat diamond has changed hands several times on its path from India to France, Britain, and then, the United States. It is known as "the most famous diamond in the world". It appears blue in color, but will glow red for a time after being illuminated by ultraviolet light, which adds to its curious reputation.

Its first owner, Jean-Baptiste Tavernier, obtained the stone by purchase or possibly by theft in 1640-1667, and sold it to Louis XIV of France in 1668 or 1669, along with other stones. Louis XIV had the stone reset as a 67.125 carat stone, which he wore as a pin supported by a ribbon, to most ceremonies. His successor, King Louis XV, had the stone, "The French Blue", reset in 1749, and it became the "The Order of the Golden Fleece". Later, the stone became the property of his grandson, Louis XVI.

On September 11, 1792, while Louis XVI and Marie Antoinette were imprisoned during the French Revolution, the diamond was stolen during a five-day looting spree. Some of the royal gems were recovered, but not "The French Blue". It disappeared from history for a time. Louis and Marie Antoinette were guillotined, and this may have been the origin of the curse.

The jewel was smuggled into London about 1792, after being recut in a "butcher job" and now was in two pieces. The larger of the two became "The Hope Diamond". This wasn't confirmed until 2005 after rediscoveries in the French Natural History Museum.

The diamond found its way to Duke Karl Wilhelm of Brunswick about 1805. He was under attack by Napoleon, and had the stone cut again when fleeing to Britain in 1806 to hide its identity. He joined his daughter, Caroline of Brunswick, who was the wife of George IV of England. The diamond was "under cover" until 1830. King George IV had it until his mistress, Lady Cunningham stole it, or it was sold in private channels to cover the king's debt when he died.

Thomas Hope, a banker, retained the diamond for \$65,000 to \$90,000. His nephew, Henry Phillip Hope, came into possession of the gem and he died in 1839. His only daughter, Henrietta, was wife of the Duke of Newcastle. In 1884, the diamond went to her younger son, Henry Francis Pelham Clinton in 1887.

In 1894, Henry met an American singer, May Yohe, and they married later. He went bankrupt and had to sell the diamond to Adolph Weill, who sold it to Simon Frankel, who took it to New York. Frankel fell on hard times, and sold the diamond to Selim Habisle, a Turkish diamond collector on behalf of Sultan Abdulhamid of the Ottoman Empire. The stone was sold to settle the debt in 1909 for \$80,000.

The jewel made its rounds until falling to Pierre Cartier for \$150,000 in 1910. He sold it to Washington DC socialite, Evelyn Walsh-McLean, whose dog, a Great Dane named Mike, wore it to parties in the 1920s. Harry Winston bought the stone from the McLean grandchildren. He donated it to the Smithsonian in 1958. Winston sent it in a box insured for \$145.29, paying \$2.44 for postage. The Smithsonian had it insured for \$250,000,000.

Now that the history of the Hope Diamond as been reviewed, we will look at it's curse next week.

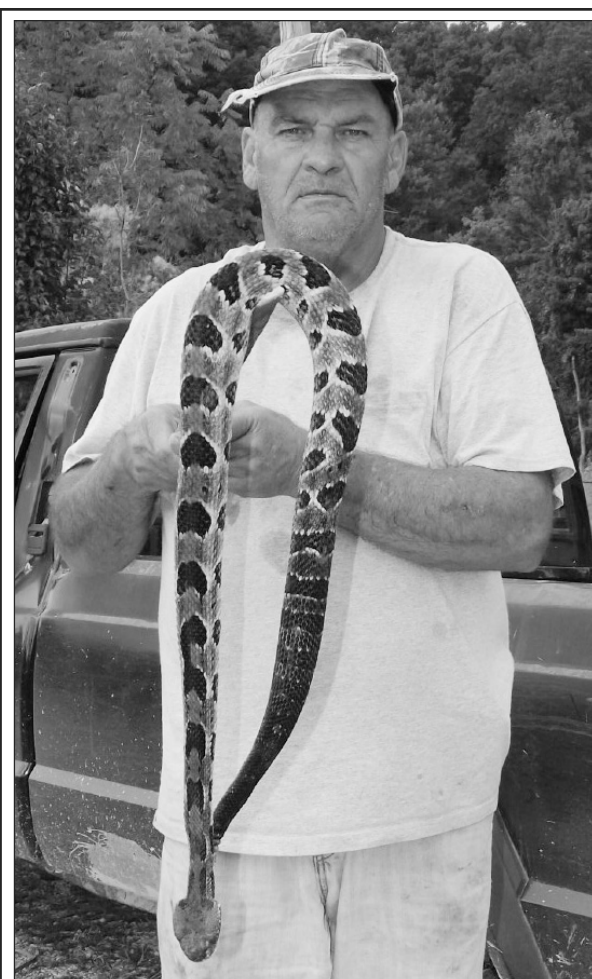

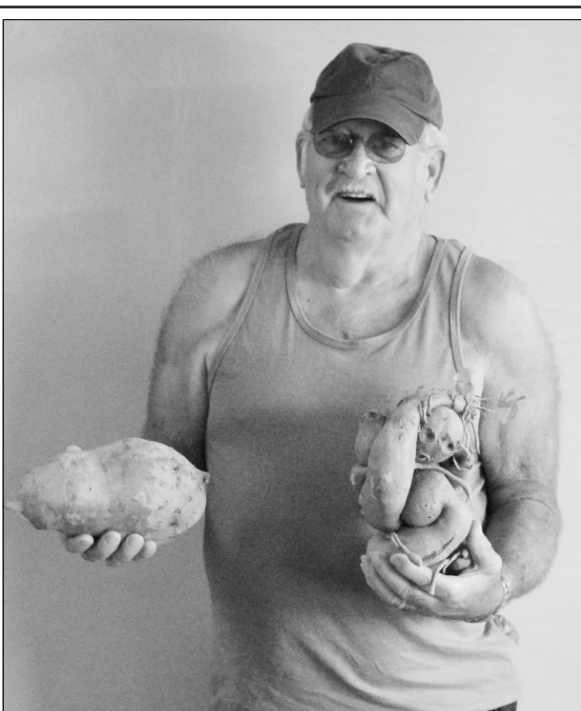

# Rockets lose to Russell, 47-13, in district opener

The Rockcastle County Rockets lost their district opener and homecoming game to the Russell County Lakers 47-13 last Friday night.

The Rockets dominated the Lakers in the time of possession category as their offense was on the field for 27 minutes and 35 seconds compared to the Lakers 20 minutes and 25 seconds.

However, several other factors went against the Rockets during their first district loss but none was more significant than the

average starting field position. The Rockets average offensive drive started on their own 30 yard line while the Lakers average drive started on their own 49 yard line. The Rockets also had eleven penalties for a loss of 70 yards compared to the Lakers four penalties for a loss of 20 yards.

The Rockets were first to get on the scoreboard when quarterback Corey McPhetridge connected with receiver Kyle Denny for a 16 yard touchdown pass. The extra point attempt was no good giving the

Rockets the early 6-0 lead.

The Lakers answered on their next possession with a 9 yard touchdown pass from quarterback Austin Smiddy to receiver Nick Coffey. The extra point attempt was no good tying the score 6-6 at the end of the first quarter.

The Lakers scored again on their next possession—a 5 yard touchdown by running back Evan Fletcher. The extra point was good making it 13-6 at the beginning of the second quarter.

But the Rockets put the ball in the end zone on their next offensive drive, after

McPhetridge connected with receiver Chayse McClure for a 22 yard touchdown pass. The extra point was good once again tying the game 13-13.

However, the Lakers managed to score again in the final minutes of the second quarter when quarterback Blake Ellis connected with Fletcher on a 28 yard touchdown pass. The extra point attempt was no good extending their lead 19-13.

After halftime, the Rockets would never see the end zone again as the Lakers took over the game and put up an unanswered 28 points making the final score 47-13.

The Rockets were led on offense by McPhetridge who was 10 out of 22 passing for 172 yards and two touchdowns with four interceptions. McPhetridge also had a big night rushing with 30 yards on nine carries.

Freshman Devon Robinson led the Rockets in rushing with 39 yards on six carries. Other Rockets picking up rushing yards were junior Isaiah Adams with 7 yards on four carries, McClure, 3 yards on seven

carries and junior Chance Ansardi with 3 yards on three carries.

Senior Tyler Harper led the receiving corps with two catches for 68 yards. Other Rockets catching passes were Denny with 3 catches for 37 yards and one touchdown, senior John Hughes with two catches for 25 yards, McClure with one touchdown grab for 22 yards, Adams with one catch for 22 yards and senior Brandon Jones with one reception for four yards.

The Rocket defense was led by Adams with seven tackles and one sack. Other Rockets picking up tackles and assists were Ansardi with 6, Jared Lake with five including one sack and a fumble recovery, R.C. Kirby and McClure got five each, Austin Mills four, Brandon Jones and Austin Emery three each, Dylan Rowe with two tackles and one interception, Hughes and Denny with two each, Hunter Hines got one and Koty Benge with one tackle and one fumble recovery.

Benge led the Rockets special teams with six punts for a total of 208 yards and

an average of 34.7 yards a punt.

Head Coach Scott Parkey said that despite the loss, he was happy overall with the Rockets performance, especially on defense.

“A lot of times the defense is judged solely by the scoreboard but that is not always indicative of how well they are playing,” Parkey said. “Coach Josh Martin puts together super game plans each week. But this one for Russell County couldn’t have turned out better for them as our offense put our defense in a short field for much of the second half.”

Parkey said that Russell County had an extremely talented team and that he knew the Rockets were going to have a hard time moving the ball, especially with their running game.

“We tried to get our ground game going right after half time but the Lakers continued to play it strong,” Parkey said. “But we continued to play with heart and guts the entire game. I

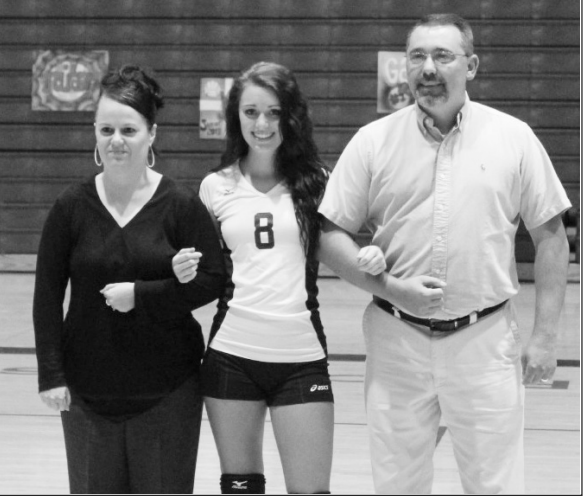

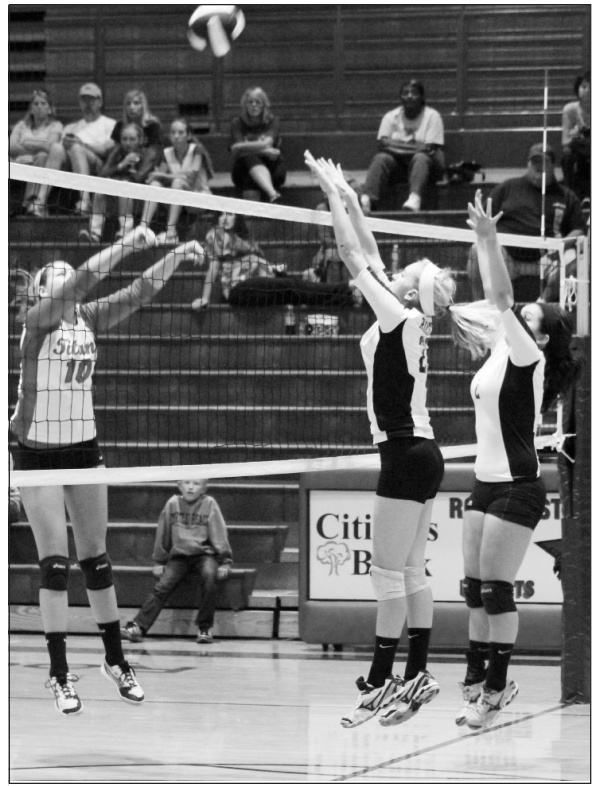

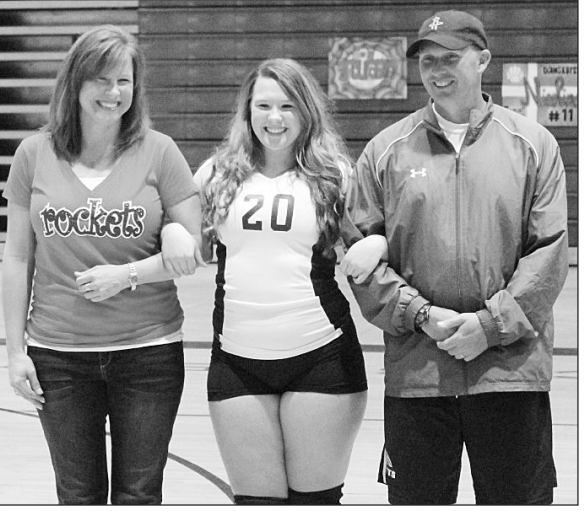
couldn't be happier with how our players prepare, practice and play.”

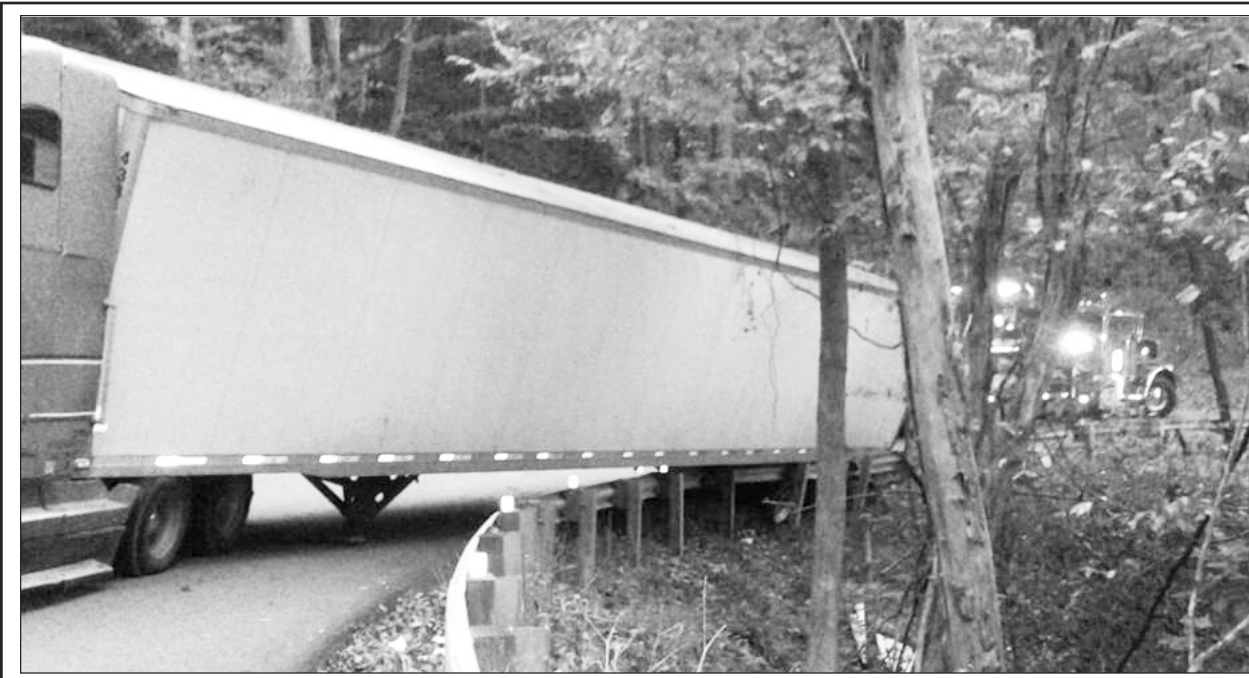

Codell Construction, managers for the new emergency services building being built in Rockcastle Business Park South, had requested an increase in their management fee since the project had ballooned from \$1.5 million to over \$1.9 million.

Holbrook said that Codell agreed on a \$115,000 fee originally but was requesting that it be raised to \$145,700. However, Carloftis, and the magistrates, decided that because Codell signed a contract setting their fee at 7% of the project that the amount should be \$138,394 and this was all the court approved.

The court also approved payment of an assessment levied by the Kentucky Association of Counties in the amount of \$22,977.20. The levy came about primarily because of an increase in the payroll for road paving/maintenance drivers from \$223,000 to \$415,000. Carloftis said that KACo had picked up a figure from the 90s for the payroll for road department employees, causing the error.

As one of the last items of business, the court approved the transfer of \$200,000 from the occupational tax fund to the general fund.

just have to realize that a lot of things they have been told will happen aren't going to." For instance, Medley said there would not be any new sidewalks installed on side streets.

The project cost estimate, presented to the commissioners by Grider, showed a total project cost of \$449,732 but Mayor Jason Medley said this would have to be trimmed back to the original \$390,000.

Grider pointed out that the project total included \$31,563 for contingencies and that figure might be considerably lower, depending on what change orders or unexpected expenses happened during construction.

However, Medley asked that the project, when ready for bid, not include the light fixtures or a section of the sidewalk between Church St. and Livingston Motors in the base bid. Instead, these two parts of the project, should be included as added alternatives, Medley said.

The cost of the 10 light fixtures was estimated at \$62,000 in the project cost estimate.

The city will have to come up with approximately \$78,000 as their part of the project but a lot of that cost can be taken up with the use of work release inmates furnished by the county. Medley said the fiscal court had already helped the city out by paying the first two invoices received for engineering design for \$17,000 so the project could get underway. Of course, there will be an 80% reimbursement from the state grant for these funds.

Grider told the commissioners that the next step would be to get the plans approved by the District 8 Highway Dept. after which construction funds will be programmed by the state and the project can be let for bids. Grider said that would probably be no sooner than January of 2014.

In other business, the commissioners discussed the recent Alumni Banquet held at the former Livingston School House, Commissioner Katha Carpenter said the attendees loved the setting for the banquet. A tour of the school was given the alumni during the event and 60 memorial lanterns were released.

The commissioners also discussed the new ordi-

nances, recently put in place. Police Chief Carl Swanigan told the council that all the ordinances were being obeyed with the exception of the dog ordinance which deals with dogs running loose in the city. "The dog ordinance has to be enforced," Swanigan told the commissioners. Medley agreed saying that all avenues to resolve the problem would be exhausted but that he had contacted the dog warden who said that he would come and get the dogs after they were caught.

Medley also reported on negotiations he is having with CSX for 19 acres adjacent to the river trail. The city wants the area for parking, camping and access to the river for canoes. Medley said that CSX was resisting selling the property to the city because of environmental concerns. "I have been talking to CSX officials at their Jacksonville, Fla. headquarters," Medley said, but added that little progress had been made.

The financial statement presented to the commissioners by City Clerk Trish Doan showed a balance in the general fund of \$15,190.26, \$4,878.42 in the operation and maintenance fund, \$3,656 in the water works depreciation reserve fund and \$3,471.34 in the LBEA and road fund.

During questioning, Northern denied being "high" and said he had driven from Berea Walmart to Mt. Vernon McDonald's without any problems. Northern told officers that he used a Suboxone strip and smoked a marijuana cigarette earlier in the morning and that he took a Xanax the night before his arrest.

The one-year-old child was taken into protective custody and social services placed it with a family member.

Both Northern and Kirby were arrested for endangering the welfare of a minor. Northern was also separately charged with DUI and Kirby was charged with public intoxication.

Northern and Kirby were lodged in the Rockcastle County Detention Center. Northern was later released on a \$2,000 unsecured bond and Kirby was released on a \$1,000 10% bond.

Cash suggested postponing the vote until everyone could be present at the meeting. Cash also said that he believes they should see how many respond to the delinquent tax letter they recently mailed out to those owing city taxes.

"I'm anxious to see what response we have from the letter before we create a new ordinance," Cash said. "Some of those amounts are as little as a few dollars. But there is still some large amounts in there as well. But I believe we need to see how many formulate a payment plan before we issue a new ordinance."

Cash also said that a lot of the city's citizens are struggling financially and that he wants to avoid having their names publicized in the local newspaper. However, he did say that it is the city's responsibility to

collect city taxes.

Buras agreed with Cash that it's the citizens' responsibility to pay city taxes and, he said, it's the city's responsibility to collect taxes.

"The law states that the city has to tax property. It's also the law that people pay taxes and the city collect taxes," Buras said. "If we don't do this then we are not abiding by the law."

Buras went on to say that this would only be considered a first reading of the proposed ordinance. He said the second reading would be during the next meeting when all council members hopefully are present.

Buras also proposed a new ordinance establishing working sessions for the mayor and council members to meet and discuss city issues. However, Buras said if they don't publicize it and make it known to the public, that they would be breaking state law by violating the open meetings act.

"Any informal meeting where council members discuss how they are going to vote on a measure constitutes a public meeting under the open meetings act," Buras said. "I think it's beneficial but we need to make it legal. When you discuss something that leads to a vote it is illegal unless we do it the right way."

Cash agreed with Buras that the working sessions are beneficial for them and that if they have them it should be legal.

"That way we could publicize the meetings in the

newspaper and people can be informed about what is happening," Cash said. "People have a right to know what we are doing and we want them to even attend the meetings if they can."

Buras made a motion that they adopt the working session ordinance and have them twice a month. He suggested that they have them on the second and fourth Wednesday of every month. The council agreed unanimously.

In the final item of business, Cash asked the council to donate the alleyway off of Maple Street next to Brodhead First Baptist Church's new parking lot. He said it was a ten foot wide alley that empties into a branch behind the church's parking lot.

Cash said the church can use the alleyway to finish their sidewalk and also use it for a drainage system as they can dig a sloping ditch to allow water from the parking lot to empty into the branch. He said the proposal has to run for two weeks in the Signal so that if anyone has any concerns they can contact City Hall.

Buras said he didn't see a problem as the city has never used the small strip of land. He said it would be good for the city too as it's another piece of property they have no use for that would now be maintained.

The council agreed unanimously to donate the alleyway to Brodhead First Baptist Church.

## Rockcastle Health and Rehabilitation Center To Host Annual Car Show

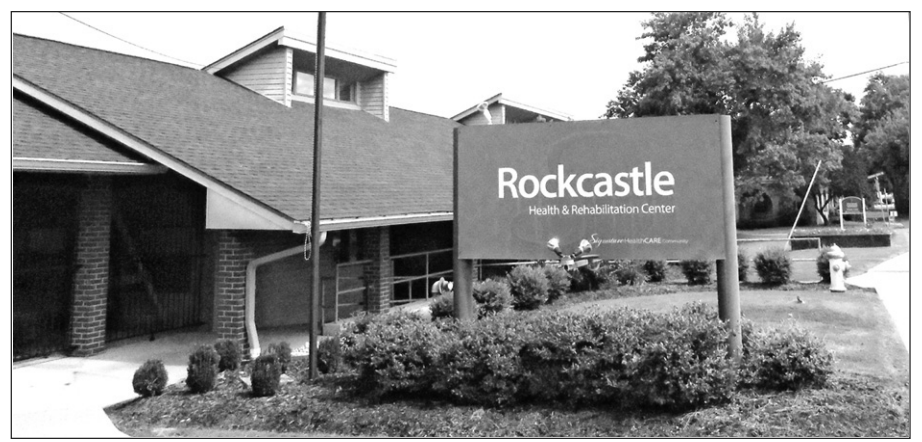

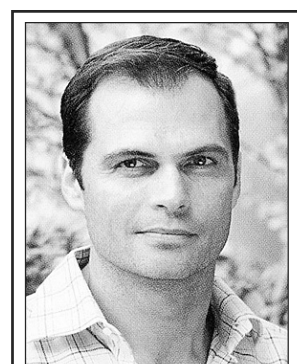

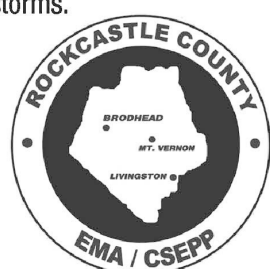

from Tallinn, Estonia. We're

playing mostly traditional bluegrass, including the melodic, acoustic-country part of it. Included are there several gospel melodies, hymns and spirituals, some bluegrass-swing and a few traditional old-timey pieces.

Depending on the audience we usually have two thematic divisions: Traditional American Bluegrass and Gospel or Gospel songs and hymns in Estonian, using, however, the same instrumentation and bluegrass instruments and having the same traditional bluegrass/country sound as a result.

We don't have newgrass or modern bluegrass sound. And by the way, since the roots of Estonian modern folk music are deep in German tradition even the basic melodies turn out to be quite similar as played on bluegrass instruments.

Through these years of our existence we have played in churches and at Christian events, in public houses and at some gospel-, country-, bluegrass or other festivals. Mostly in homeland Estonia, but also frequently in Finland, several trips and tours to Scandinavian Countries and some to Central Europe, including European World Of Bluegrass Festival 2001, 2002, 2004 and 2006 in Voorthuizen, NL and 2002 in Kolin, CZ and 2007 in SouthEastern FRANCE, La Roche sur Foron.
