**Thinking About Cleaning Your Carpet? Some things to think about...**  
 What is the best way to clean my carpet, should I use the old technology of steam cleaning or the new technology of dry foam?  
 Test results from Consumer Report, 2008.  
**Option 1: Steam Cleaning-How does it work?**  
 A. Steam Cleaners saturate your carpet and floor pad with hot (150° degree) soapy water containing lye and bleach to help dissolve stains.

## UNITE Hope Wall on display at Courthouse

The recently unveiled UNITE Hope Wall will be on display next to the Circuit Court Clerk's Office at the Rockcastle County Courthouse until next Friday.

UNITE Treatment Director Amy Yates said the Hope Wall contains more than 150 pictures of people across southeastern Kentucky who have overcome their drug addictions and remained sober for more than eighteen months. She said the wall was created to show that recovery is possible for anyone who is struggling with a drug addiction.

"The Hope Wall is meant to symbolize those who have fought and struggled with addiction but have won the battle and regained their lives," Yates said. "It was also designed to inspire all humanity to persevere in their struggle no matter what their hurdles might be."

The Hope Wall was unveiled in August at a large ceremony in Manchester. Since it's unveiling, the wall has been on display at the Pulaski County Judicial Center in Somerset for two weeks before traveling to Rockcastle County. The wall will also be displayed in the future at courthouses throughout southeastern Kentucky on a scheduled basis.

Yates said that there are currently seven pictures of people from Rockcastle County on the Hope Wall and that they are expecting to have more Rockcastle County residents added to the wall in the near future.

One of the seven Rockcastle Countians on the Hope Wall is Eddie Todd, 35, of Mt. Vernon. Todd said he first started using drugs when he was 14-years-old during his freshman year of high school.

"I had injured my shoulder and had to have surgery. The doctors sent me home with some narcotics and I

can remember liking the way they made me feel," Todd said. "It helped me to hide my insecurities and gave me more self-confidence around other people. During these young stages of my addiction it made me feel normal in a sense."

Todd said he can't remember when he crossed the line of recreational use to addiction. However, he said anyone that uses drugs only once will have a risk of becoming addicted.

"Anyone that uses drugs for the first time runs a risk of crossing a line that they may not be able to turn back from," Todd said. "I tell people all the time that abstinence from drugs is the only answer to never run the risk of crossing that line."

During the struggle with his addiction, Todd said he was ashamed of the person he had become and where he was heading with his life. He said there was many times he wanted to quit but that it seemed almost impossible to break the stronghold of his addiction.

"I felt like I had nowhere to turn until my parents did for me what I could not do for myself. They showed me true love by tough love and washed their hands of me," Todd said. "I was put in a spot where I had to do what the courts said and that's when I went to Willingway Hospital in Georgia and they helped me break my addiction."

Todd said he has been sober from alcohol and drugs for twelve consecutive years and has had a successful career in the residential construction industry. Todd said he hoped that other people struggling with drug addictions can see his picture on the Hope Wall and realize they can overcome their addiction as well.

"The two pieces of advice I would give to someone struggling with addiction is they need to realize their recovery won't be easy and that they need to accept

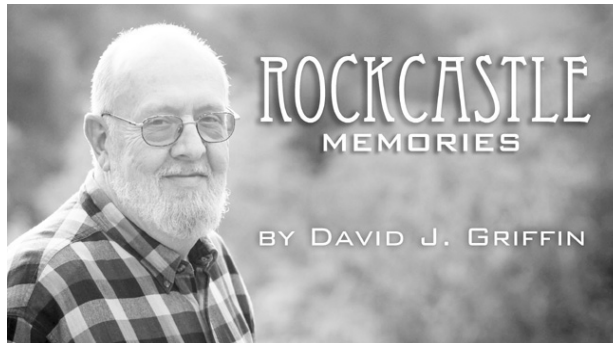

### *That Dreaded Cod Liver Oil*

Does anyone remember that tall, brown bottle of Cod Liver Oil that parents and grandparents stored in the ice box/refrigerator? That is a common memory for many of us who were children during the 40's and 50's. And I tell you, I most certainly remember!

I vividly recall that nasty taste because each morning before leaving for school, I was administered a large spoonful of it by my mother (Bee). Even after chasing the foul, fishy tasting elixir with a glass of orange juice, the flavor still lingered for what seemed to me was a terribly long time. For the next twenty minutes, I spat, coughed, and gaged until the oily liquid was finally absorbed. Even when the aftertaste had subsided, I could not help but immediately begin to dread the next dose to come.

Bee was staunchly persuaded that cod liver oil was a necessary vitamin supplement that would boost our resistance to childhood diseases. It also contained large amounts of vitamins A and D. Since these vitamins were known to prevent such diseases as rickets and were also supposed to aid in the reduction of joint pain and cardiovascular disease, Bee was convinced that the liquid was essential for her son's development. It was universally accepted as necessary for good growth, strong bones, and illness resistance. Her mind was made up, and she was diligent in her administration of the potion.

Back in those days, people swore by the old wives' tale that cod liver oil aided in everything from aching muscles, rheumatism, coughs, strengthening of bones, digestion, brain functions, and even staying "regular." Even the government recommended the daily consumption of one spoonful of the dreaded cod liver oil.

Evidently our parent's beliefs might actually have held some validity. In addition to the abundance of fat-soluble vitamins, cod liver oil is high in omega-3 fatty acids, which may reduce the risk of heart disease and aid in the prevention of arthritis. Studies have shown that a daily dose of cod liver oil may reduce feelings of depression as much as 30 percent. Researchers also claim that cod liver oil can aid in the prevention of: asthma, immune function, cardiac arrhythmia, ulcerative colitis, rheumatoid arthritis, high blood pressure, Crohn's disease, and bipolar disorders. Since I am in the winter of my life and

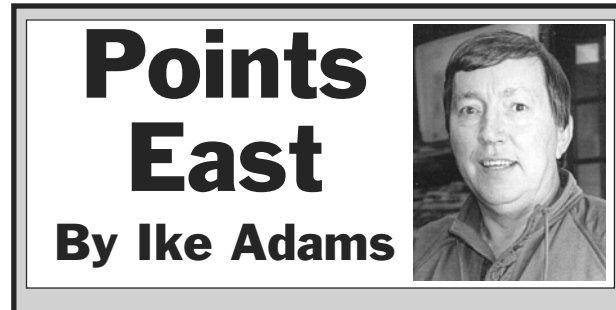
take no prescription medications, I suppose Bee may have been at least partially correct in her assumption that the horrid elixir had some long term benefits.

In addition to cod liver oil, there were two other homeopathic remedies that my mother administered to me as a child. One of them was Castor Oil, which was used as a laxative. Because I was a very active child and spent most of my free time running in the woods behind our house, it was rare for me to need such a treatment. However, that was not the case for my grandparents. They used the foul-tasting oil on a regular basis for constipation. The United States Food and Drug Administration has categorized castor oil as "generally recognized as safe and effective" for over-the-counter use as a laxative. I hated the taste of that oily liquid and used every method known to man to avoid having to take this home remedy. A daily dose of castor oil won't keep the doctor away, and modern medicine still hasn't backed up claims that it also treats skin conditions, eases pain, or cures infections.

The other home remedy that Bee used on a regular basis was Vick's Vapo Rub. Since that ointment is an oil-based medication, it shouldn't be used under or inside the nose, inside the mouth or swallowed. It is indicated for use only on the chest and throat for cough suppression due to the common cold or on muscles and joints for minor aches and pains. Apparently, Bee never bothered to read the instructions on the little blue bottle because she often put a "dollop" in each of my nostrils, and I even had to hold a small amount on my tongue with the instructions, "David Joe, do not swallow. Allow the Vicks to slowly melt in your throat."

As the salve melted and ran down my throat, I thought I might die on the spot. That home remedy was even worse than the dreaded cod liver oil. After the lubricant coated my esophagus, I could hardly breathe. I begged and pleaded for some pleasant tasting liquid

I suspect that Register Editor, Bill Robinson is behind this arrangement and that he is secretly hoping Dick will teach me how to write. But that's not gonna happen because Dick is being sprung from here on Monday and I can tell you for sure that if he hasn't published a column before you read this one, it's not because he is unable to do so.

In fact I'm finding it difficult to get any rest because all the women who work here keep coming in an kissing the bald spot on top of his head, making loud smacking noises, and then telling him how much they're gonna miss him.

If I get a send-off like that Loretta will try to pawn me off on one of them. But Dick has been here for over five weeks and I'm hoping that it will not take me that long to get my legs back under me. On the other hand if I

have to be institutionalized for a spell, I can think of few other places I'd rather be and none where I'd expect to receive better care. I am already planning on emailing a certain hospital to suggest they send their cooks to Telford Terrace so they can learn how to prepare edible food.

I'm not much of a complainer, but I did make frequent snide remarks to the nurses while I was in the hospital.

Loretta often teaches nutrition classes and she has a little case full of little rubber food items--eggs, bacon, sausage links, hamburger patties and name any fruit or vegetable--that she uses to illustrate when she is explaining their nutritional values and calorie content. So I told the hospital staff that I was sure that Lo's rubber goods tasted better than the stuff they were trying to force feed me. I know for sure the rubber stuff looks better.

Finally, fed up with my whining, one of the nurses told me that she didn't know anybody who had ever checked into a hospital because they were looking for a good place to eat. I must confess that I didn't have a come-back to that one.

Anyway, by the time you see this piece in your newspaper, I hope that I'm out of rehab or at least packing up to leave. I'll take all the loving the women here want to give me when the time comes to say good bye, but I hope they don't shave the top of my head to make a bald spot they can kiss on. Of course they didn't have to shave Dick Ham.

Unlike the Rockets, Wayne County had a great night offensively, gaining a total of 347 yards on the night with 164 yards on the ground and 183 yards through the air.

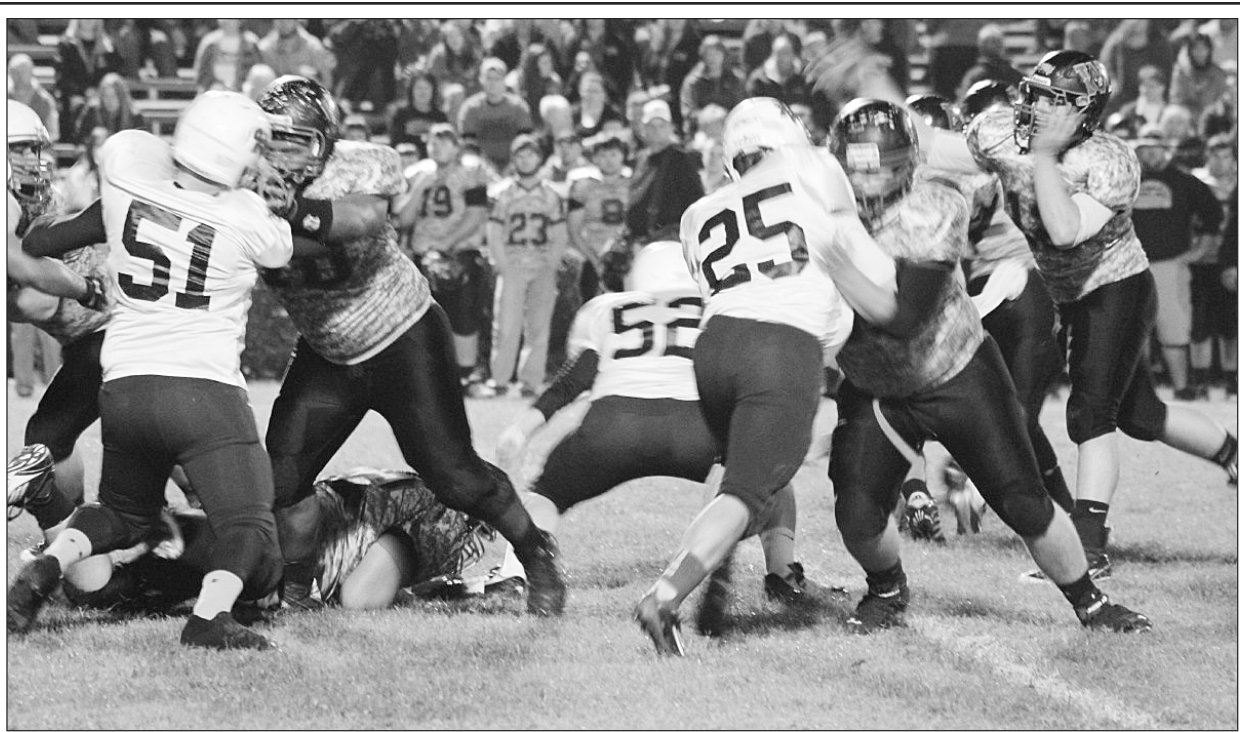

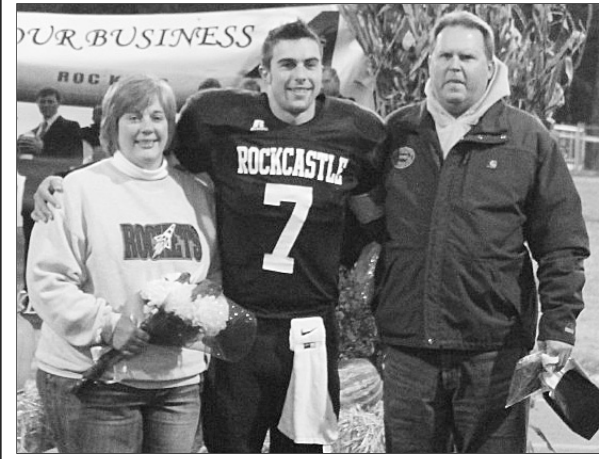

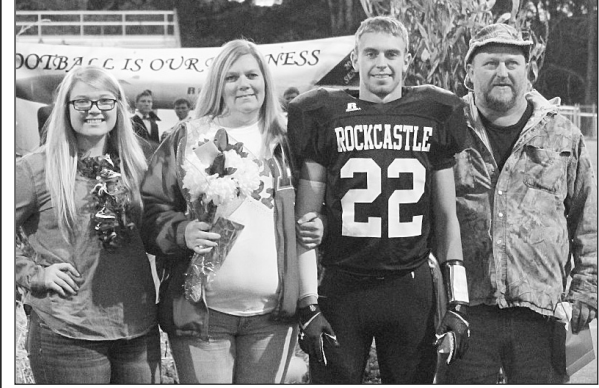

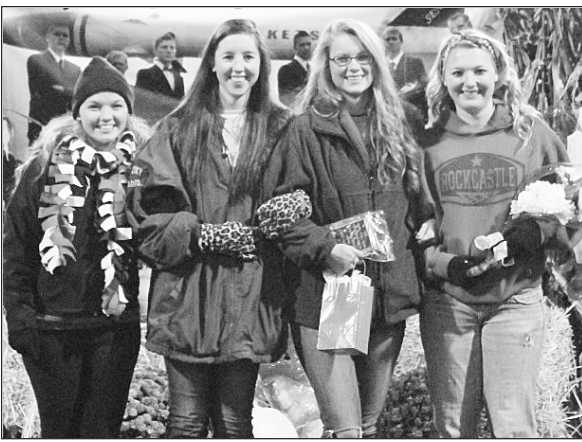

15. The win for Wayne County marked the first time in the program's 44 year history that the Cardinals went undefeated in a regular season.

Despite the loss, it was also a record-breaking night for McPhetridge who finished the regular season last Friday night with 2064 passing yards and 4061 career passing yards. McPhetridge also finished his career in third place for career passing yards for a Rocket quarterback behind Matthew Burkhart who had 4571 and Aaron Anderkin who had 4618 career passing yards.

Offensively, the Rockets were led by McPhetridge who was 11 out of 27 passing for 174 yards and two touchdowns. McPhetridge also rushed for 3 yards as well.

Junior running back Isaiah Adams led the ground attack for the Rockets, rushing for 11 yards and junior fullback Chance Ansardi rushed for 6 yards. Freshman Chayse McClure and freshman Dalton Rowe both tallied rushes for 3 yards each.

Senior receiver John Hughes had the best night of the receiving corps grabbing five passes for 98 yards. Jones caught 3 passes for 54 yards and one touchdown, Rowe hauled in two passes for 14 yards and Harper caught one touchdown pass for 8 yards.

On the defensive side of the football, McClure led the way for the Rockets with seven tackles. Other Rockets picking up tackles and assists were Ansardi and freshman Austin Mills with 6 each, junior Kyle Denny and Rowe with five each, freshman Devon Robinson and freshman Austin Saylor with four each and junior Justin Hughes and freshman Lucas Jones with two each and Adams with two and one fumble recovery. Senior Koty Bengé, freshman Logan Coffey, John Hughes, Jones, senior R.C. Kirby and senior Jared Lake were all credited with one tackle each.

Ansardi led the Rockets in sacks with one and two, respectively, assisted sacks. Mills had two assisted sacks and Bengé had an assisted sack as well.

Head Coach Scott Parkey said after the game that when his team plays a very talented team like Wayne County, they can't afford to make the mistakes the Rockets made in the first quarter.

“In the first quarter we made several mistakes that led directly to points for the Cardinals,” Parkey said. “We fumbled on two of our first three offensive possessions then we allowed them to recover a squib kick. We were down four scores before the quarter ended.”

Parkey said that the offense did not do a good job of protecting the quarterback and establishing the running game.

“We miscommunicated and allowed a couple of their defensive linemen to come free most of the night. That was the biggest disappointment to me,” Parkey said. “We had been doing well with pass protection all year but not in this game. We knew they were good up front but we made them look a lot better.”

Parkey went on to say that the offense put the defense in bad situations throughout the game.

“Our defense had their back against the wall all night, especially with the turnovers in the first quarter,” Parkey said. “Despite the situations they were put in they continued to play hard throughout the game.”

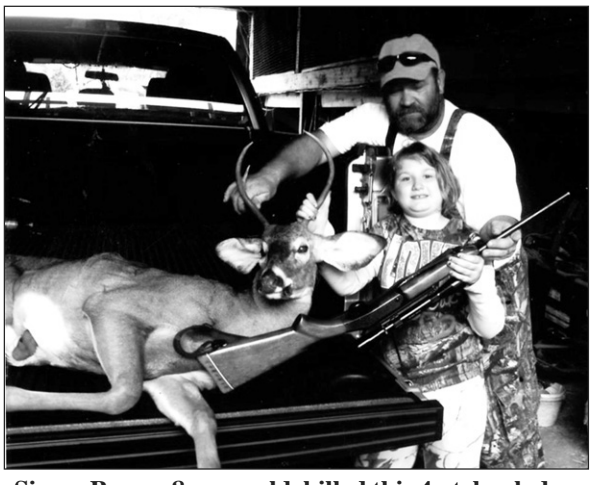

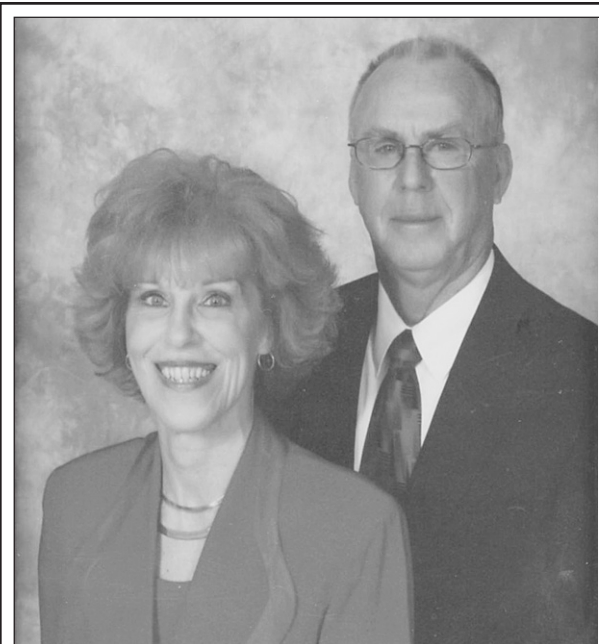

The company presently has 23 employees and plans to expand their workforce. There is room for expansion in the present facility, Salazar said, and there is already a 25,000 square foot pad in place for future expansion construction.

Plastisud is having problems with the scarcity of workers who are C&C Mechanics, Salazar said. The available of trade school, which provide the basics of the trade, was discussed. IDA Executive Director Holly Hopkins told the board that there was presently a movement afoot to try to recruit some of the 6,000 miners, who have lost jobs in that industry and have mechanical skills, into the trade. Hopkins said the pay range for a C&C Mechanic is between \$20-\$30 an hour.

dence that the items had previously been loaded inside the vehicle since stray ammunition and cartridge primers were found inside.

While Dean was speaking with the subjects and checking them for outstanding warrants, Dooley fled the scene on foot. Dean and Peters searched the surrounding area for several minutes and were unable to locate Dooley.

Peters then took Sheldrick into custody and transported her to the Rockcastle County Sheriff's Office in Mt. Vernon for further questioning. While assisting Sheldrick from his vehicle in the parking lot, she fled on foot, still handcuffed. Peters pursued Sheldrick and saw her enter a residence on Floyd Street near the sheriff's office. Peters arrested her at the residence.

After being transported back to the sheriff's office and being Mirandized, Sheldrick told officers that she and Dooley were out driving around when he told her to pull off at the church into the field to help him load the stolen ammunition into the vehicle.

The recovered ammunition and reloading equipment was later identified by Donald Adams as the same items that were stolen from his residence last Tuesday. Police recovered approximately seventy-five percent of the items and approximately twenty-five percent of the loot is still reported as missing.

Police are asking local pawn shops, sporting goods stores and gun shops to no-

tify them if anyone tries to sell a large amount of ammunition, primers or reload casings.

Sheldrick was charged with escape, fleeing or evading police and receiving stolen property \$10,000 or more. She remains lodged in the Rockcastle County Detention Center on a \$10,000 cash/property bond.

Police are also asking for anyone who has information on Dooley's whereabouts to contact Rockcastle 911 or the Rockcastle County Sheriff's Department at 606-256-2043. Dooley is described as 5'6", approximately 160 pounds with brown hair and blue eyes.

the Lord Jesus Christ as their savior," Todd said. "I feel it's my job as a recovered addict and Christian to help someone find a relationship with Jesus and find a local church to attend. There will be many struggles to overcome but I want them to realize they can overcome them and that there is hope."

Yates went on to say that Todd's story is a prime example of the hope and success they want to show people who are currently struggling with an addiction.

"We know that individuals and families struggling with addiction are experiencing a lot of pain and believe they have nowhere to turn for help," Yates said. "But once you make a decision that you want to turn away from the destructive path of drugs and begin your recovery journey, we want people to know it's possible to find hope and rebuild your life just like the people displayed on the Hope Wall."

during the Saturday Night Barndance and included many surprises for Pete.

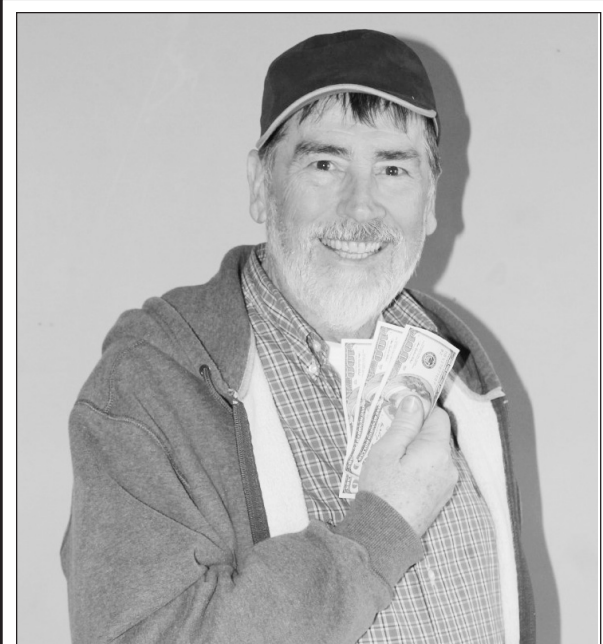

## American Cancer Society Great American Smokeout set for November 21st

As the American Cancer Society celebrates its 100th year in the fight to end cancer, it is encouraging smokers to use the Great American Smokeout on November 21 to make a plan to quit smoking and help finish the fight against tobacco. While smoking has decreased significantly since the 1950s, more than 43 million Americans - nearly one in five adults - still smoke, according to the Society.

"We've made substantial progress in the fight against tobacco since 1954, when an American Cancer Society study confirmed the link between smoking and lung cancer," said Brooke Cary Whitist, Relay For Life specialist with the American Cancer Society. "However, tobacco use remains the single largest preventable cause of disease and premature death in the United States. Quitting smoking can save your life, and the Great American Smokeout is a great way to start."

Since the 1950's, Society funded-research has helped scientists understand the role of tobacco in cancer development. Working tirelessly in the fight against

tobacco to educate consumers on the dangers of smoking, the Society provides support to those who want to kick the habit and mobilizes communities to implement public policies that save lives.

From 1965 to today, cigarette smoking among adults in the U.S. decreased from more than 42 percent to around 19 percent. Currently, smoke-free workplace laws protect 49 percent of the U.S. population from the dangers of second-hand smoke. Yet about 43.8 million Americans still smoke cigarettes. Smoking-related diseases remain the world's most preventable cause of death. Every six seconds, someone in the world dies because of tobacco use.

The American Cancer Society created the trademarked concept for and held its first Great American Smokeout in 1976 as a way to inspire and encourage smokers to quit for a day. One million people gave up smoking for a day at the 1976 event in California. Now, the Great American

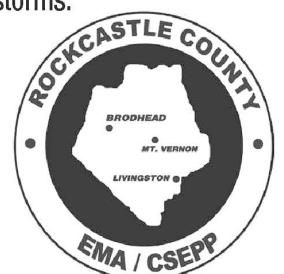

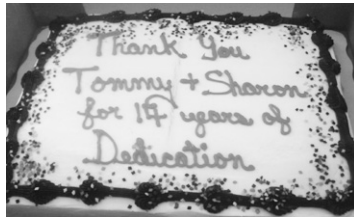

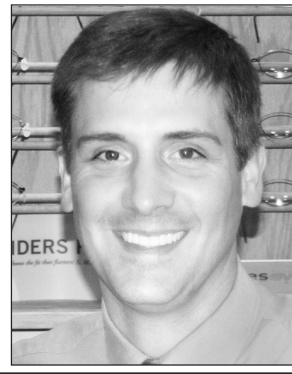

## Daniel Boone Community Action Agency, Inc. Low-Income Home Heating Program

The cost of home heating is a problem for many low-income Kentuckians.

Your Community Action Agency, Daniel Boone Community Action Agency, may be able to help. If you live in Rockcastle County, you may apply at the Daniel Boone Community Action Agency located at 105 Main St., Mt. Vernon, Ky. for the Home Energy Assistance Program (HEAP). Applications will be taken by the last name of the head of the household from November 12 through December 19, 2013. See the list below for your assigned day.

You will need to bring with you (1) Social Security cards for everyone living in the household; (2) proof of your household's income for the preceding month. You must present award letters, NO copies of checks etc.; documentation from the local DCBS office will not be accepted, with the exception of zero income households receiving food stamps and KTAP; (3) Your most recent heating bills or verification from your landlord that the heating expenses are included in your rent. All customers that apply for assistance must present an electric bill at the time of application. If electric bills are in someone else's name other than the applicant, documentation will be required from the person whose name is on the utility bill. Dwellings that are not connected to a meter ARE NOT eligible for assistance. All eligible households that apply will receive assistance. Gross monthly income must be within the guidelines listed below, and with limited liquid resources. Households not receiving food stamps with no income will be required to fill out a self-declaration form prior to sign up date. DBCAA will assure that persons who are working or commuting during the agencies typical business hours 8:00 - 4:30, may apply for LIHEAP. Call Tamara Cox at 606-256-5315 for more information. DBCAA does not discriminate because of race, religion, color, national origin, sex or age.

## Bible Talk

Our study this month is on authority in religion, from heaven or from men?

**Authority: From Heaven or of Men?-** In Matt.21:23 we read, "And when he was come into the temple, the chief priests and the elders of the people came unto him as he was teaching, and said, By what authority doest thou these things? and who gave thee this authority?" The people asked two related questions in this text: 1) They wanted to know by what authority and 2) who gave him this authority to do the things he was doing. Jesus took their questions about authority very seriously. Jesus went on to ask them, "I also will ask you one thing, which if ye tell me, I in like wise will tell you by what authority I do these things. The baptism of John, whence was it? from heaven, or of men?" vss.24-25. Jesus is showing that authority comes from either heaven, or from men. The baptism of John illustrates this point the Lord was making. These folks would not give an answer to his simple question, for if they did, they would get themselves in trouble to answer either way, vs.25b-27. Of course if they had loved the truth and wanted to do what was right, they could have answered it very easily. Ask yourself: the things we practice in religion, does the authority come from heaven, or from men?

**Examples** -Jesus tells us that the things people do in religion have authority either from heaven or of men. If it is from heaven, then we can give the **book, the chapter, and the verse** from the Bible that will prove it is authorized from heaven. However, if we cannot, we must concede it is from men. Take for instance sprinkling and pouring for baptism: is this from heaven, or from men? Answer: it is from men. There is no authority from scriptures on this practice. Baptism that is an immersion: is this from heaven or of men? Answer: from heaven, Col.2:12, Rm.6:3-4. Praying to Mary: is this from heaven, or of men? It is from men. Nothing is in the word of God to authorize this practice. Using instrumental music in worship today: is this from heaven, or of men? Answer: it is from men. There are no verses in the N.T. to authorize its use in worship. Somebody may ask, "But what about Psalm 150? Doesn't that authorize instrumental music for us?" Answer: Psalms is O.T. law. Today we are to listen to Jesus, not to Moses and the prophets, Matt.17:1-5. What about the practice of church social and recreational activities such as church gyms, church ball teams, etc.? Is this from heaven, or of men? Answer: it is from men, for there is no authority from heaven to justify these projects. Understand, beloved, things that are NOT authorized are termed as "iniquity" in scripture, Matt.7:23. Iniquity will cause us to lose our souls, 2 Jn.9, Matt.15:8-9. Let us ever seek the authority of Jesus in his word the Bible.

### Independent Auditor's Report

#### Report on the Financial Statement

We have audited the Rockcastle County Sheriff's Settlement - 2012 Taxes for the period April 17, 2012 through April 15, 2013 - regulatory basis, and the related notes to the financial statement.

#### Management's Responsibility for the Financial Statement

Management is responsible for the preparation and fair presentation of the financial statement in accordance with accounting practices prescribed or permitted by the laws of Kentucky to demonstrate compliance with the Commonwealth of Kentucky's regulatory basis of accounting as described in Note 1. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statement that is free from material misstatement, whether due to fraud or error.

#### Auditor's Responsibility

Our responsibility is to express an opinion on the financial statement based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America, the standards applicable to financial audits contained in Governmental Auditing Standards issued by the Comptroller General of the United States, and the Audit Guide for Sheriff's Tax Settlements issued by the Auditor of Public Accounts, Commonwealth of Kentucky. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statement is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statement. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statement. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

#### Basis for Adverse Opinion on U.S. Generally Accepted Accounting Principles

As described in Note 1 of the financial statement, the financial statement is prepared by the County Sheriff on the basis of accounting practices prescribed or permitted by the laws of Kentucky to demonstrate compliance with the Commonwealth of Kentucky's regulatory basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The effects on the financial statement of the variances between the regulatory basis of accounting described in Note 1 and accounting principles generally accepted in the United States of America, although not reasonably determinable, are presumed to be material.

#### Adverse Opinion on U.S. Generally Accepted Accounting Principles

In our opinion, because of the significance of the matter discussed in the Basis for Adverse Opinion on U.S. Generally Accepted Accounting Principles paragraph, the financial statement referred to above does not present fairly, in accordance with accounting principles generally accepted in the United States of America, the financial position of each fund of the County Sheriff, as of April 15, 2013, or changes in financial position or cash flows thereof for the year then ended.

#### Opinion on Regulatory Basis of Accounting

In our opinion, the financial statement referred to above presents fairly, in all material respects, the taxes charged, credited, and paid for the period April 17, 2012 through April 15, 2013 of the Rockcastle County Sheriff, in accordance with the basis of accounting practices prescribed or permitted by the Commonwealth of Kentucky as described in Note 1.

#### Other Reporting Required by Government Auditing Standards

In accordance with Government Auditing Standards, we have also issued our report dated September 26, 2013 on our consideration of the Rockcastle County Sheriff's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts and grant agreements, and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Rockcastle County Sheriff's internal control over financial reporting or on compliance. This report is an integral part of an audit performed in accordance with Government Auditing Standards in considering the entity's internal control over financial reporting and compliance.

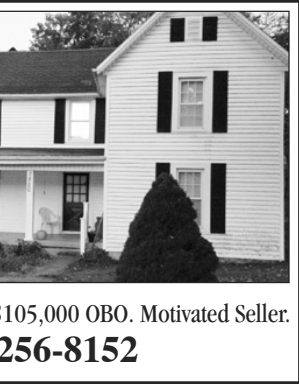

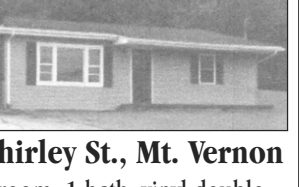
