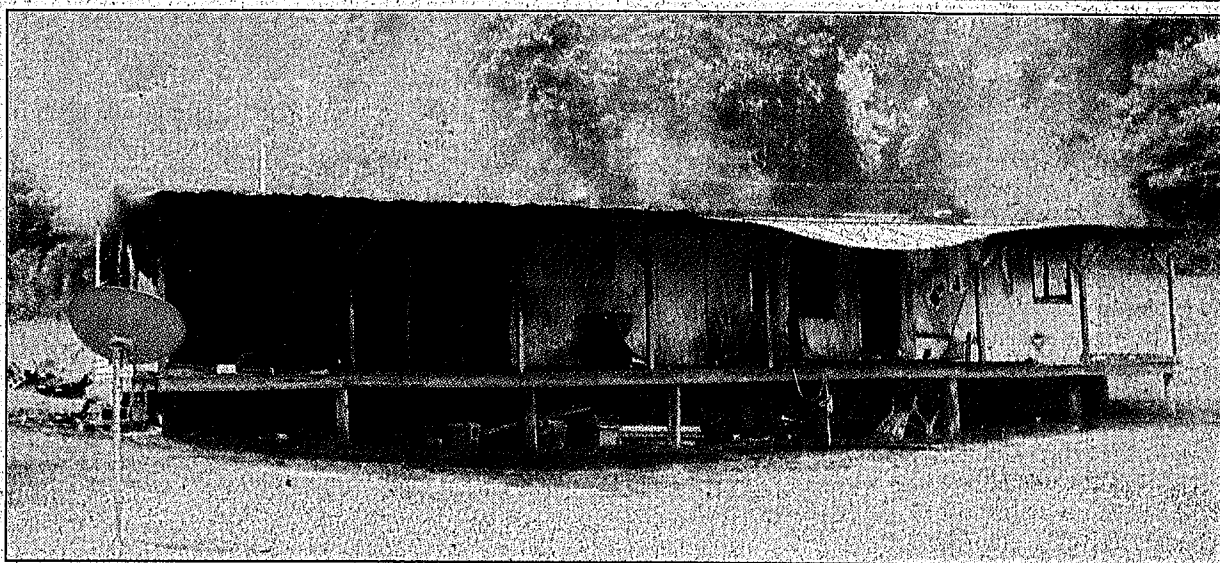

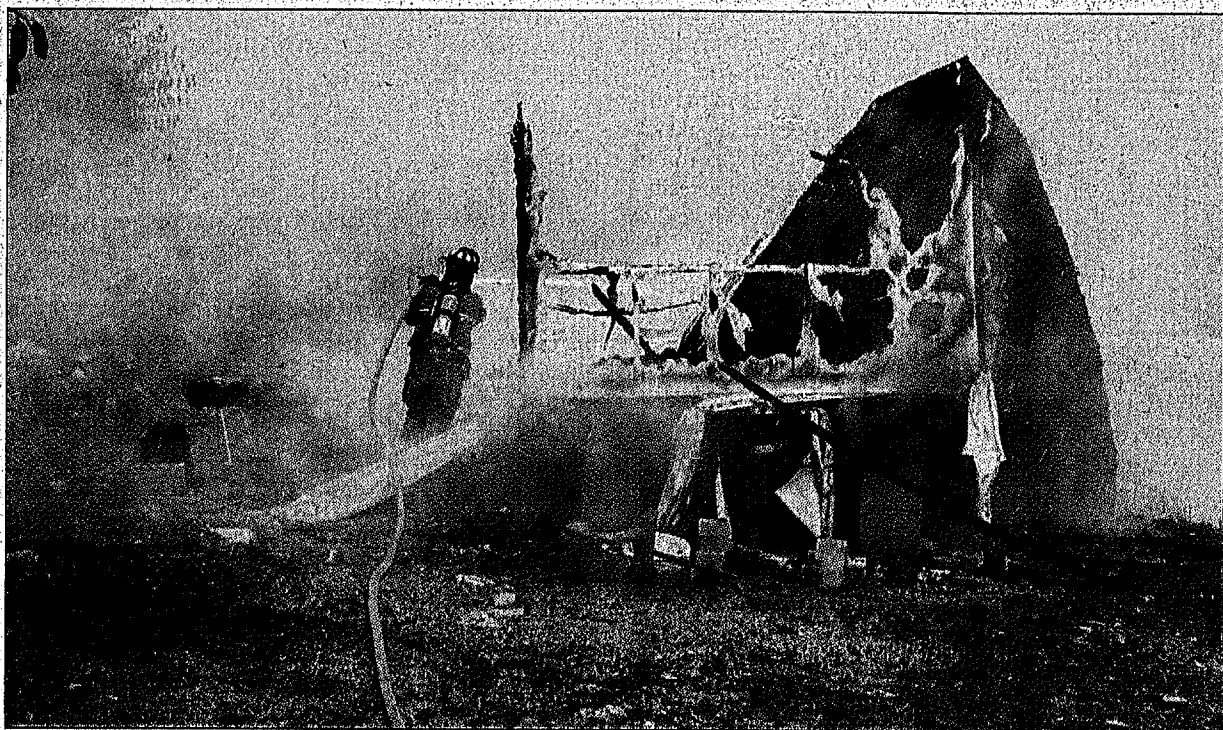

City of Mt. Vernon terminates current Lake Linville Boat Dock lease

Several items of business were discussed at the monthly Mt. Vernon City Council meeting Monday night, including termination of the Lake Linville Boat Dock lease with current operators Lester and Teresa Ratliff.

The Ratliffs have been operating the Lake Linville Boat Dock since October 2012 when they agreed to pay \$700 a month during a five year lease with the City of Mt. Vernon for the right to operate the facilities.

Mayor Mike Bryant said the current operators got off to a good start, after attaining the lease in 2012. However, he said some unfortunate circumstances arose with the Ratliffs that has created a "divided situation" and that the city has terminated the lease because of default by them on the terms of the lease.

Bryant said that the Ratliffs have been informed of the lease termination and that they were given a thirty day notice which started last Friday.

Bryant went on to say that the council has several options on how they can begin the search for new operators at the city's Lake Linville facilities.

"One option is we can lease it and put it out to bid. The second option is the city could take over the entire operation. The third option is we could lease the restaurant only while the city operates the boat dock and campground," Bryant said. "There are good prospects who have already expressed interest in the restaurant only and not the boat dock or campgrounds. But we have also had some successful business people who only expressed interest in the campground."

Tax Administrator Josh Bray said he could construct the details of the lease to whatever the council approved.

"I can write up the bid for the lease however you all want and leave an option to combine or not combine the restaurant, boat dock and campgrounds," Bray said. "After we get the bids back there might be someone offering a higher lease amount but there might be someone with a better success record offering a lower amount. We can go with whoever you all want and we can go with whatever term limit you all want too."

Councilmember Jamie Bryant said she thought a long term lease was not a good idea for the city or the operators. She made a motion to lease the restaurant only on a one year renewal lease and for the city to take over operation of the boat dock and campground.

Mayor Bryant said the lease needed to include specifics of what was considered a renewal. He said if someone is operating a suc-

Smoke alarm saves local man's life

A smoke alarm is credited with saving a local man's life after his home caught fire early Monday morning on South Wilderness Road in Mt. Vernon.

According to Mt. Vernon Fire Department Chief David Bales, his department was notified about the house fire around 3:10 a.m. on Monday. He said once firefighters arrived, they discovered the home was engulfed in flames.

Bales said the home be-

longed to James Gray, 59, of Mt. Vernon. He said Gray told him that he was awakened by his smoke alarm.

"He said he heard the smoke alarm going off while he was asleep and that it woke him up," Bales said. "He said that he escaped the residence just in time before the smoke and flames started spreading throughout the entire home."

Bales said Gray was the only one home at the time of the fire and that he was not injured. He also said the home was a total loss and the cause of the fire remains unknown.

Bales said the residential fire was a reminder to them of how important it is for homeowners to have working smoke alarms in their

homes. He said smoke alarms at least need to be installed near every sleeping area of a home.

"It's recommended that homeowners change the batteries in their smoke alarms during both time changes in the year or whenever they start chirping or beeping," Bales said. "Homeowners also need to have a smoke alarm outside and inside each bedroom. If

it's a multi-level house it's important to have them on each level as well."

Bales went on to say that having properly working smoke alarms in a home decreases the number of injuries and fatalities in a house fire. He said if Gray hadn't had working smoke alarms in his home, the outcome of his home catching fire

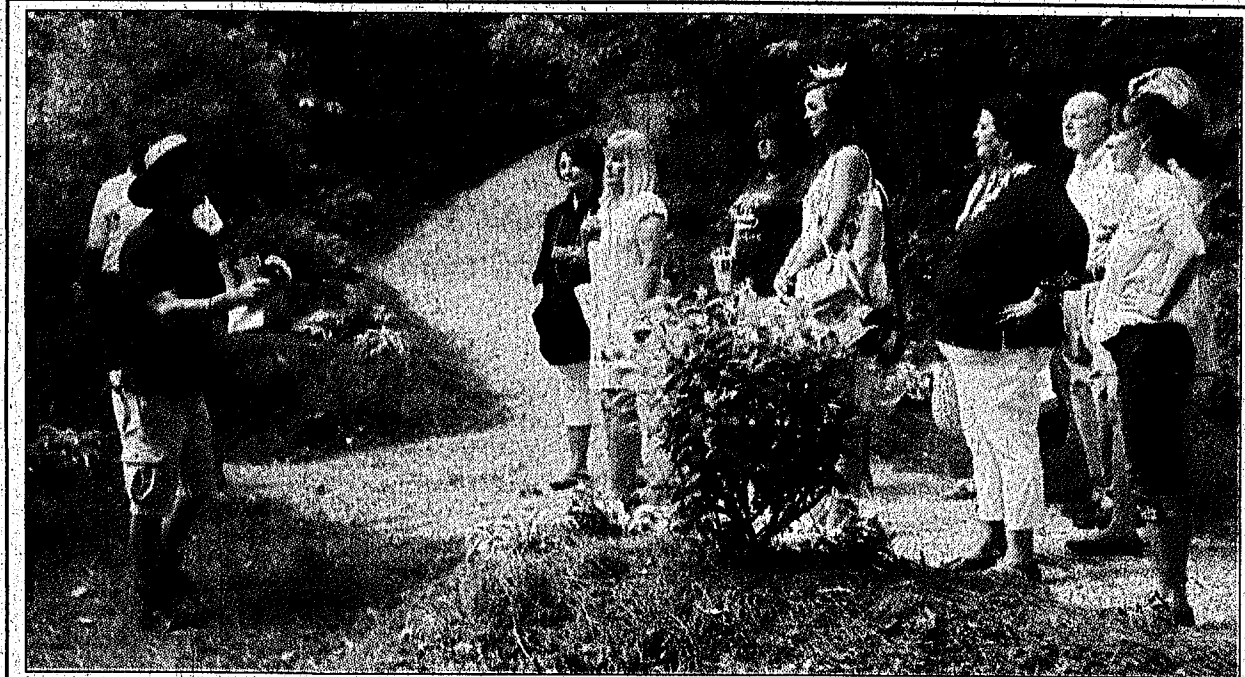
Boil water advisory still issued for ERWA

The Eastern Rockcastle Water Association has issued a Boil Water Advisory for customers in the Sand Springs and Big Cave Road areas as a result of an issue at the Mt. Vernon Water Treatment Plant.

Mt. Vernon Water and Sewer Superintendent Dennis McClure said they had a 24-inch valve "blow out" at their treatment plant last Thursday. He said they had to shut off the water to repair the main valve and that they had it repaired last Thursday afternoon.

McClure said the ERWA, Western Rockcastle Water Association and Brodhead Water Works all

Reading over this, it's pretty pathetic that I am reduced to writing a column about my dogs. You talk about needing a life!

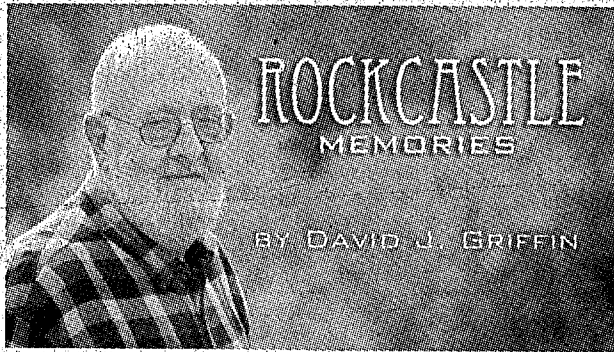
Please be aware of what is going on in our country.

Duck and Cover
 Anyone recall the "Duck and Cover" drills that we experienced at Mt. Vernon Elementary School (MVES) in the early 50s? I remember being in the first and second grades when our teachers had us practice this drill in preparation for a potential nuclear attack from missiles aimed at the United States by the Soviet Union. The idea that we could be annihilated in a matter of seconds was a pretty difficult concept to consider for such young children. To say the least, it was unsettling, but at the same time it was also somewhat surreal.

The development of what was to become known

as the Cold War was disturbing to all of us in elementary school! Because of these drills, we thought war with Russia was surely coming soon.

My wife and I have been watching the television programs describing the events of D-Day and the fall of Nazi Germany. Actual footage of the Normandy attack was shown, bringing along with it the anxiety of the times. It made me remember the fear that we had in the first and second grades.

Our teachers at MVES tried their best to stay calm and conduct the drills with us so that we might feel safe during the first few moments of a nuclear attack. The duck-and-cover drills were supposed to somehow provide safety from the initial shock of a nuclear attack by protecting children from flying glass particles resulting from the blast wave that would cause glass implosions. As a result, we honestly believed that there was real protection available to us by such behavior. Seems absurd to even acknowledge that such an idea was truly entertained by adults, much less children.

The drills were actually the result of an act of the federal government. Civil Defense Information Bulletins were mailed to schools. The prescribed drills were mandated for educators to train children what to do in case of an attack. My friends and I were in constant fear of the imminent war that we believed was coming. The CD bulletins provided the following information.

"Under the conditions of a surprise attack, immediately after the flash of light, children are directed to stop what they are doing and get on the ground under some cover -- such as a table, or at least next to a wall -- assume a prone-like position, lying

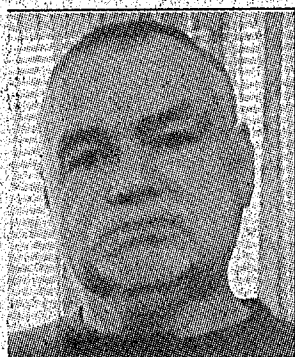

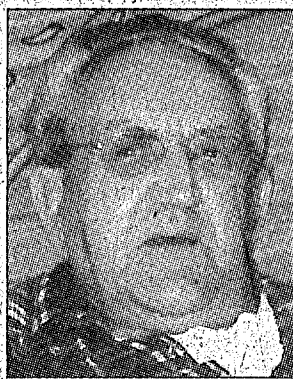
William Jerry Ayers

Road not on county system...

Dear Editor,
Several weeks ago, a letter to the editor asked if I would order an extension of work on a section of Crooked Creek Road / Goochland Cave Road. The section of road the writer asked be worked on by the County has not been considered a "publicly maintained" roadway by the Kentucky Transportation Cabinet for decades.

Unfortunately—and prior to my tenure here in office—the fiscal courts many years ago failed to maintain or even police that portion of roadway. This lack of action was probably taken by the fiscal courts at that time to cut expenses to the county road department.

Had the fiscal courts at that time simply ordered an employee to only drive over the road ("policing") or had simply moved a single stone in the road (state law does

not define what a fiscal court must do in order to 'maintain' a road), the section of road the writer asked about could have remained within the public domain and, therefore, been a part of the Rockcastle County Road System as recognized by the Transportation Cabinet.

Now, however, in order for the fiscal court to begin maintenance on this section of road, the County would be required to have proper easements drawn up by the county attorney's office, have them presented to the fiscal court for consideration, and the road would be required to meet any County requirements for a 'new' road—even though this is, obviously, an old roadway.

This is why I have been diligent to maintain and personally 'police' some of the roads in our county that have few—if any—residents and little traffic.

face-down and covering any exposed skin including the back of their heads.

We now know that within a considerable radius from the surface of the nuclear fireball (approximately 3 miles), such "ducking and covering" would offer negligible protection

against the intense heat blast and prompt radiation following a nuclear explosion.

During the 1950s, television emerged as the most powerful news medium since the invention of the printing press, and America was gripped with terror and anxiety about the possibilities of war, especially a nuclear attack. Television led this paranoia, reflecting and perpetuating fear and hysteria during the Cold War period. It was a pivotal moment in modern history. And, like most families, it kept mine informed about all of the potential communist threats to our wellbeing.

I can remember going home and expressing my fears to my mother (Bee). She was always calm, as if she was in control of the impending situation. Bee instructed me to completely follow the directions of my teachers. She said, "David Joe, your teachers have your best interest at heart, and you should do exactly what they say in a situation such as this." Because I trusted her emphatically, I always felt better after talking to her.

The 1950's were a fearful time for Americans. The Cold War, which began after the end of World War II, was a period where Americans were extremely concerned about the threat of Communism. Because I was so young and my teachers were so emphatic about our safety, my friends and I were constantly aware of the threat.

I must admit that our parents and teachers handled the situations fairly well. They did not appear to be afraid and always remained calm whenever the drills were at hand or were a subject of conversation. Of course, it made a big difference to children who were watching and listening carefully. We didn't end up scarred by fear, just particularly wary about foreign relations. In that regard, I suppose that you could say that there was some real benefit to those duck-and-cover drills after all.

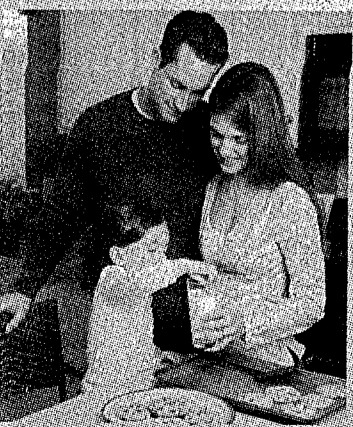

CORN PUDDING

My cousin Joyce tells me that this recipe is the main dish my family requests and Tony's in-laws request when I join them for Thanksgiving. Funny thing though, it's a recipe that I got from Stephanie's mother-in-law. So it's all in the family. I don't recall Mom ever making corn pudding. She always had corn from the garden in the freezer that she would fry and it was soooo good! I like to use the frozen white corn or the mixed yellow and white corn if I don't have fresh corn.

3 beaten eggs
3/4 cup melted butter or margarine
3/4 cup sugar or Splenda®
1 and 1/2 cups milk
1 teaspoon vanilla
2 tablespoons flour
2 cups corn
Dash salt
Dash or 2 of nutmeg
Preheat oven to 350°. Mix and pour into a baking dish. Bake 45 minutes or until it sets.

Tomatoes
Croutons
Mozzarella cheese
Preheat oven to 350°

Dice fresh tomatoes, enough to cover the zucchini. Spread 1 to 2 handfuls of croutons (your choice) over tomatoes.

Spread mozzarella cheese over tomatoes. Make another layer of zucchini, tomatoes and croutons.

Bake covered for 1 hour or until zucchini is desired doneness.

Remove cover and spread a layer of mozzarella cheese on top and bake until melted and starting to brown.

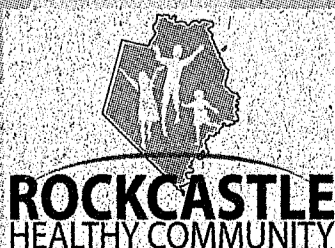

A late spring following a brutally cold winter caused some hit and miss stream smallmouth fishing this past spring. With the warm winds of June now here, stream smallmouth are settling into their summer patterns with water temperatures stabilizing in the mid 70s.

Years of perfect flow conditions for reproduction bequeathed a quality cohort

of smallmouth bass 14 inches and longer in Kentucky streams.

"We saw good numbers of 14-, 15- and 16-inch smallmouth this spring in our Elkhorn Creek population sampling," said Jeff Crosby, central fisheries district biologist for the Kentucky Department of Fish and Wildlife Resources. "We saw fish up to 18 inches and the overall catch rate

was the highest since the mid-2000s."

Those who love to catch stream smallmouth bass are blessed to live in Kentucky. Many flowing ribbons of smallmouth water course through our state. If a local stream has a rocky bottom, pools and riffles and water at least waist deep in some holes, it likely holds smallmouths. You can jump across many productive smallmouth streams in Kentucky in spots. Most get little fishing pressure.

Stream smallmouth fishing boils the pursuit down to its essence and that is the beauty of it. No electronic sonar units, GPS maps nor expensive boats needed. Just a handful of lures, a light to medium-light power spinning outfit spooled with 6-pound line and an ability to read flowing water is all you need. Choose a rod with a forgiving tip and a strong butt section. Noodle rods don't cut it for stream smallmouth.

Wading is a cheap and highly productive way to fish these streams. Wading boots or a worn out pair of hiking boots protect the feet while wading. Avoid open-toe sandals or flip flops as your feet need a buffer from sharp rocks, glass or pieces

of barbed wire deposited in the stream bed during the last flood.

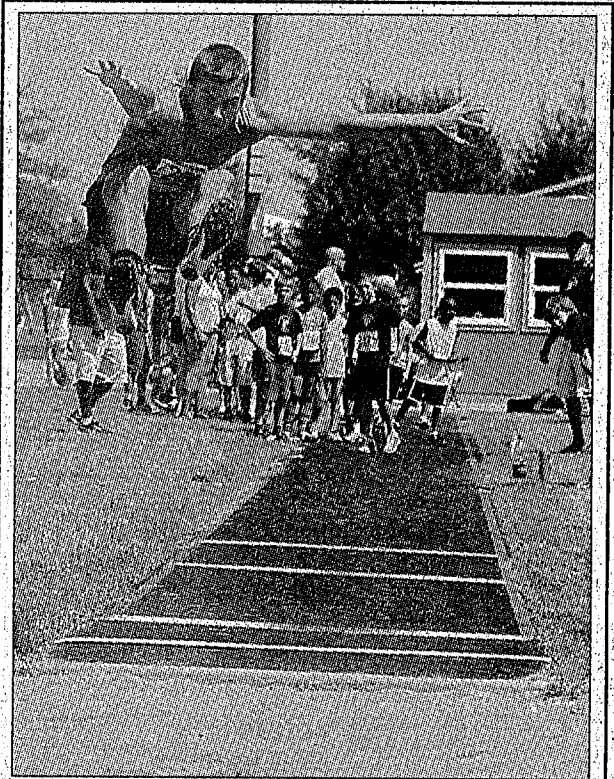
Stream smallmouth bass reside in three main places in summer: the flowing areas upstream and downstream of a riffle and in the flowing shoals. The tranquil areas in deep holes hold fish at rest, not those actively feeding.

The seam water where fast water meets slow just downstream of a riffle is one of the highest percentage spots to try in summer. Smallmouth bass will hang behind a rock, log or undercut bank near these spots and scarf any disoriented baitfish, crawfish or sculpin that comes tumbling downstream.

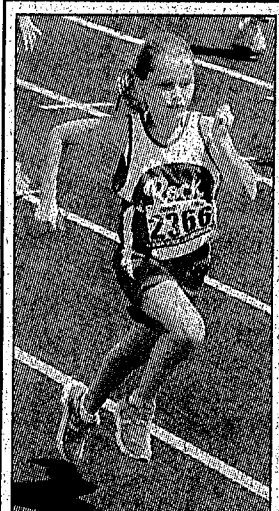

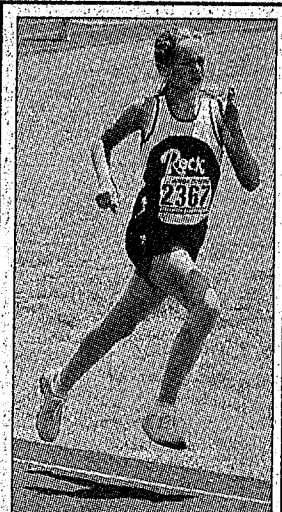

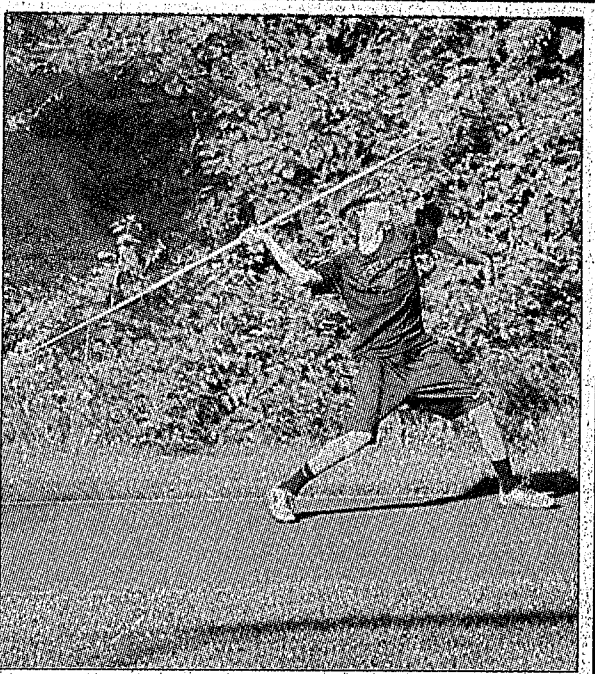

Competing in the 8 & under age group, Lexi had a state runner-up performance in the 100-meter dash and followed that shortly thereafter with an awesome state championship title win in long jump. Later in the afternoon, she won the 800-meter run state title, dominating her nearest competitor by over 12 seconds.



Rockcastle 6th grader Tori Dotson won three individual state championship titles today at the KTCCCA Elementary School State Track & Field Championships. Competing on the 11-12 year old age group, Tori won the 1500-meter run state title with a new RCMS record time of 5:22.61 while shattering the old record by 18 seconds. She was only 4 seconds away from the all-time Rockcastle record in the event regardless of age. She followed that with a state title win in the 400-meter dash with a personal best time of 1:09.55 and another state title win in the 800-meter run with a time of 2:38.87, nearly setting another personal best in the event.



RCMS 6th grader Autumn Courtney had several outstanding performances in the USATF Junior Olympic State Championships at Christian Academy of Louisville. She's only 12 but had to compete in the 13-14 year old age group. She won the Junior Olympic state title in long jump and finished as state runner-up in triple jump, as well as state runner-up in the 100-meter and 200-meter hurdles. She ran an awesome personal best time in the 200-meter hurdles (36.68) and came close to personal bests in each of her other three events.



RCMS 7th grader Jonmark Loudermilk had several great performances at the USATF Junior Olympic State Championships at Christian Academy of Louisville. Competing in the 13-14 year old age group, Jonmark won the Junior Olympic state title in javelin with an awesome new personal best throw and RCMS record of 84'2". He also won the long jump title with a personal best effort and picked up Junior Olympic state titles in both the 100-meter and 200-meter dashes, getting close to personal bests in each race.



Rockcastle 5th grader Hannah Davis had three outstanding performances at the KTCCCA Elementary School State Track & Field Championships. Competing in the 11-12 year old age group, Hannah started off with an awesome 4th place finish in the 100-meter dash and followed that with an impressive 6th place finish in the 400-meter dash and a superb 4th place finish in the 200-meter dash. Hannah came very close to her all-time personal bests in all three events.



Rockcastle 4th grader Karalinn Loudermilk had several outstanding performances at the KTCCCA Elementary School State Track & Field Championships held at the Christian Academy of Louisville. She competed in the 11-12 year old age group despite being only 10. Karalinn placed 3rd in long jump and 5th in the 100-meter dash with awesome personal best performances in both events. 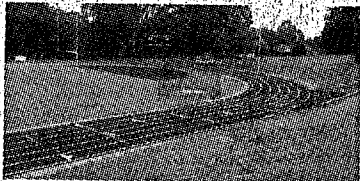

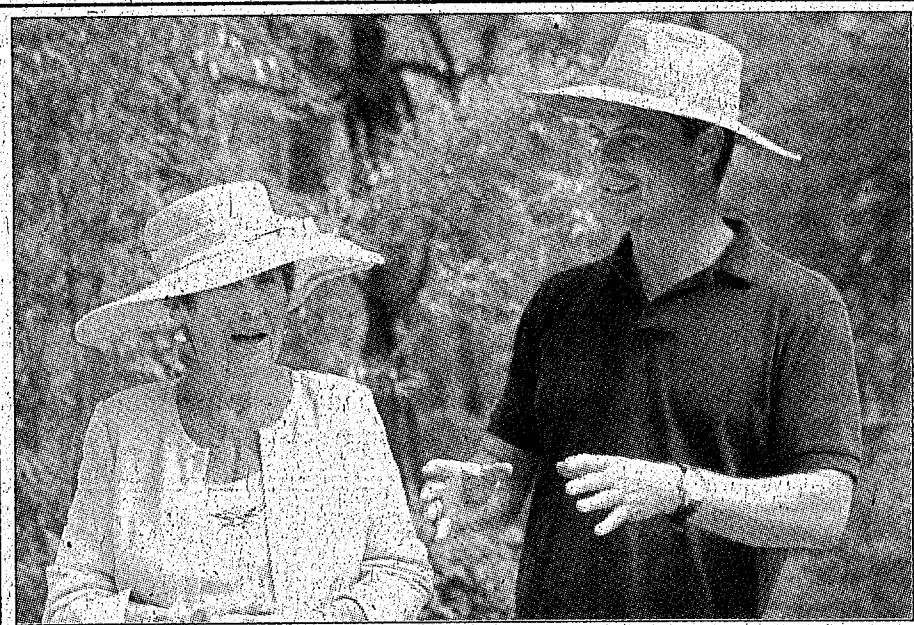

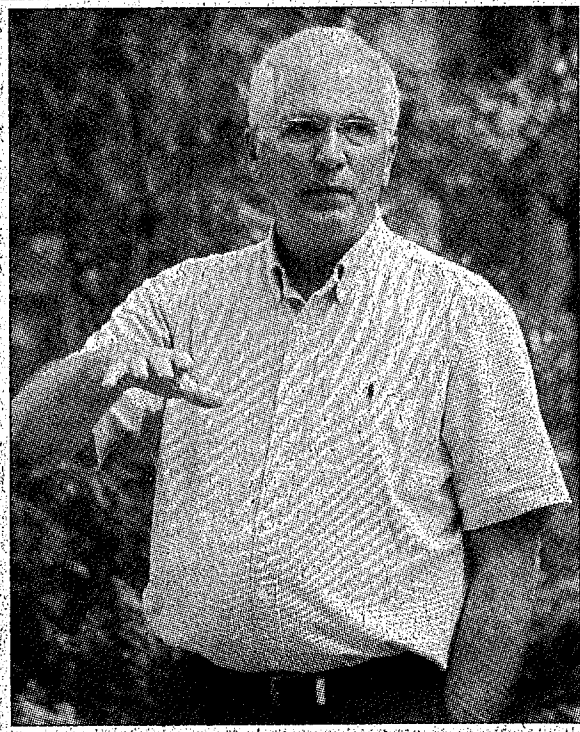

Mt. Vernon man arrested for drug possession

A Mt. Vernon man was arrested for two counts of drug possession Monday night after police raided a home on Sally J Road in Mt. Vernon.

Arrested at the scene was David Robert Madden, 58, of Mt. Vernon.

According to Mt. Vernon Police reports, Assistant Chief Barry Adams and officer Joe Rush responded to the home after receiving a complaint of drugs possibly being sold at the residence.

Once officers arrived and received consent to search the residence, they found a metal tin box that contained marijuana seeds, a plastic bag of marijuana and a pill bottle that contained 26 Carisoprodol muscle relaxer tablets.

Officers also found a plastic bottle containing 15 hydrocodone pills on Madden at the time of his arrest.

Madden told officers that he takes the pills for his own personal use and that he doesn't sell them. He also admitted to officers that he smokes marijuana.

Madden was charged with two counts of possession of a controlled substance, possession of marijuana and drug paraphernalia. He was lodged in the Rockcastle County Detention Center where he was later released on a \$4,000 unsecured bond.

purchase water from the City of Mt. Vernon which is why the majority of people in Rockcastle County were under a boil water advisory last weekend.

McClure went on to say that they sent water samples to the laboratory to be tested last Thursday after the valve was repaired and that their advisory was lifted when they received the test results back from the lab last Saturday.

However, McClure said state regulations require the City of Mt. Vernon to have their water tested before ERWA, WRWA and the City of Brodhead can send their water samples to the lab to be tested. might have been different. "Having working smoke alarms in a home saves lives and prevents serious injuries," Bales said. "The outcomes are always better when we respond to house fires that have smoke alarms."

Work a black 4-inch finesse worm in this seam water by simply letting the current move the worm. Use enough weight so the worm gently strikes bottom occasionally. A 1/8-ounce leadhead is a good start, but switch to a 1/16-ounce if the current isn't moving the worm and imparting a natural presentation.

A smoke-colored 3-inch curly-tailed grub worked in the same fashion draws strikes as well as Beaver-style creature baits in the green pumpkin color. After working the seam water below the riffle, wade upstream above the riffle and cast these lures. Current breaks created by rocks, logs and stumps should be probed as well as any small pocket holes.

Flowing shoals pocked with rocks, cracks in the bottom and scour holes hold stream smallmouth all summer long. Shoals with a good undercut bank running along one or both sides of the stream is all the better. Rapala-style floating/diving crankbaits are deadly in flowing shoals.

Work them with a steady retrieve or with an aggressive pause and jerk. In low water, a gentle twitch fol-

lowed by a long pause works best. This lure draws them out from behind in-stream rocks and undercut banks.

Topwaters worked along undercut banks in flowing shoals make the most exciting stream smallmouth fishing. The Rapala-style lures work well in this situation, but chuggers and the cigar-shaped lures designed for the walk-the-dog retrieve work better. Yellow and red colored deer hair poppers cast on a fly rod along these banks also brings great sport.

Wade with stealth in the low and clear conditions of summer. Wear drab clothing and move slowly. Don't create pressure waves from your body moving through the water too quickly as these can spook smallmouths. Slide your feet along the bottom to avoid lifting rocks with your toe that might slam the bottom when you wade.

Taking extra classes will help finish college quickly

If you take 12 hours each semester, you'll need five semesters to finish an associate's degree and 10 semesters to finish a bachelor's degree.

But what if you take 15 hours per semester? Most colleges won't charge you any more for 15 hours than they do for 12 hours. Taking 15 hours means you'll

finish an associate's degree in four semesters and a bachelor's degree in eight semesters. And that can save you hundreds, even thousands of dollars in tuition and fees.

cessful restaurant they don't need the constant threat that the city will “pull the rug out from underneath them” every year.

Bray said he could design a five year lease that stated the terms of the lease could be negotiated between the city and the operators after the bid is accepted.

“We can design it where it would be an automatic yearly renewal for five year unless there is reason for discussion,” Bray said. “That way it can be negotiated to however the city and operators agree. It gives both parties leeway and all kinds of options.”

Councilmembers Sharon Saylor, Shelley Lewis, Clifford Mullins and Bryant all agreed to start taking bids on the restaurant only under a five year annually renewal lease. Councilmember Wayne Bullock voted against the motion stating that he would only vote for a one year lease. The motion passed with a majority vote.

Rockcastle County Development Board Director and Revitalize Mt. Vernon Director Lynn Tatum informed the council about some sudden grant opportunities with TourSEKY. She said the organization has some remaining funds in their budget and that competition for these grants will be high.

Tatum first asked for the council's approval to submit a \$25,000 grant request for a splash pad at the Lake Linville Recreational Facility. The splash pad would consist of a concrete pad with jets that spring up water, a bucket that fills/dumps water and an arch that shoots water. She said the splash pad will be a 30x30 concrete pad and located next to the Coon Club building near the Space2Create facility.

“This would be a great location adjacent to the Coon Club building to leave us the opportunity in the future to build restrooms, dressing rooms, concessions, etc. Splash pads have become very popular around the world and it can provide relief for people during these hot summer days,” Tatum said. “The other benefit is it doesn't run all the time and is only activated when people step on it. This way you are not wasting money or water.”

She said the \$25,000 grant will only cover the equipment and that the city will still have to pay for the installation of the splash pad. She said she was still getting quotes for the installation but she said the estimated installation costs would be around \$10,000 and that the Fiscal Court would discuss helping fund some of the costs at one of their future meetings.

Tatum also presented the council with the option to install 18x24 signs in front of Mt. Vernon's historic buildings in the city's downtown area. She said one side of the sign would have an original photograph of the building and the other side of the sign would have the building's historical information.

The council agreed unanimously to allow Tatum to pursue and submit both grants.

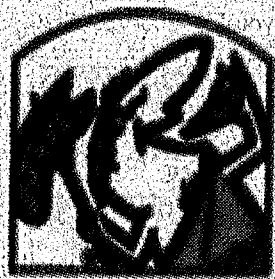

Hidden Among Us

The American Revolutionary War Patriots of Rockcastle

To celebrate and honor the county's American Revolutionary War Patriots and to enlighten the community about the service and sacrifice of these brave men, on behalf of the Rockcastle Chapter of the

Daughters of the American Revolution, I have compiled highlights of the service of the known patriots living in the county and who applied for a pension between the years 1818 and 1842. All information was taken from the patriot's

own account from his pension application and other historical documents. More information can be found on each patriot at the local library or the Rockcastle Historical Society. (Copyright pending). Elijah Denney
North Carolina

Elijah Denney was born about 1757-59; place unknown and died in Rockcastle County, KY 26 April 1868. According to his pension application, Elijah gave the following account of his service on 12 September 1832 in Rockcastle Co. KY:

He volunteered in the Army of the United States Militia in the North Carolina troops in 1779 for the term of six months in Wilkes County, NC, where he was living at the time. He served in Captain Richard Allen's company. They marched to Charleston, South Carolina where he was placed in a regiment commanded by Colonel Lytle, a regular officer, after about five months. He was at the siege of Charleston and he was surrendered by General Lincoln in 1782. He served three months, under Captain Allen and finished the remaining balance of the time under Captain George Lowman. His Lieutenant was a man by the name Bradley.

About twelve months after his parole being exchanged in Wilkes County, NC, he enlisted as a

Sergeant in Captain Gordon's company North Carolina state line. He was commanded by Major Joel Lewis. He stated that he was not in any major battles except for the Siege of Charleston. In his last enlistment, he marched to different parts of North Carolina and was not out of it except for once to Georgia to guard some ammunition. He received his discharge at Salisbury, NC from Major Lewis.

There some sources that say Denney fought and was wounded in the Battle of King's Mountain and participated in the other battles such as Camden. Being a prisoner of war after the Siege of Charleston, Denney was paroled and would have been in danger of being put to death if captured if he did not wait the allotted time before reenlisting. According to Denney's pension, he complied by waiting twelve months before relisting. Also, there is no record to verify his service in the Battle of King's Mountain. There is an Elijah Denney who fought in that battle but was killed during the fight. Denney himself states in his pension application that he was not in any engagements besides the Siege of Charleston.

After the war, Elijah lived in Wilkes County, NC until about 1802, when he moved to Rockcastle County, KY. On 24 April 1855 in Pulaski Co. KY, Elijah, at the age of 98, resident of Rockcastle Co. KY filed for his bounty and entitlement.

He was allowed a pension in 22 August 1833 at

a rate of sixty dollars per year.

Elijah does not mention a wife or children in his pension papers. He was married to Mary Owens and later to Susannah Simpson and had at least ten children. He is buried in a marked grave at Mt. Pleasant Cemetery in Pulaski County, KY with Susannah and some of his children.

The known children of Elijah are: Simeon Denney (8 December 1787 Wilkes Co. NC-24 October 1890 Rockcastle Co. KY) married Eliza Jane Pumphrey about 1843 Rockcastle Co. KY. He is buried at Friendship Cemetery in Rockcastle Co. KY. They had five children: Zachariah, John, Elijah M., Andrew and Mary. Levi Denney (1789 Wilkes Co. NC-14 March 1854 Rockcastle Co. KY). Levi served as a private in the 11th Regiment, Kentucky Mounted Volunteers, in Captain Johnston Dysart's Company during the War of 1812. He married Delilah Cummins 17 January 1814 in Rockcastle Co. KY. They are buried at Mt. Pleasant Cemetery, Pulaski Co. KY. They had ten children: Simpson, Milford, Wilson, Nelson, William, Susan, Elizabeth, James, Vincent and Ballinger. Levina Denney (17 June 1796 Wilkes Co. NC-2 December 1869 Rockcastle Co. KY). Buried at Mt. Pleasant Cemetery, Pulaski Co. KY. Levira Denney (11 August 1791 NC-14 January 1892 Rockcastle Co. KY) married Adams Crawford on 15 March

1842 in Rockcastle Co. KY. Adams served in the 7th US Rangers in the War of 1812. They are buried at Mt. Pleasant Cemetery, Pulaski Co. KY. Levica Denney (19 August 1794 Wilkes Co. NC-16 January 1866 Rockcastle Co. KY). Never married. Buried at Mt. Pleasant Cemetery, Pulaski Co. KY. Lucinda Denney (10 June 1792-20 November 1874 Rockcastle Co. KY) never married. Buried at Mt. Pleasant Cemetery, Pulaski Co. KY. Minerva Denney (1801). Winifred Denney "Winnie" (June 1803 Wilkes Co. NC-8 March 1868 Rockcastle Co. KY) married Martin Owens (Reverend) in 1843 Pulaski Co. KY. They are buried at Mt. Pleasant Cemetery Pulaski Co. KY. They had one child, Simeon. Malinda Denney (18 April 1801 Pulaski Co. KY-6 January 1892 Rockcastle Co. KY) married Hiram E. Sowder about 1831 Rockcastle Co. KY. Buried at Mt. Pleasant Cemetery, Pulaski Co. KY. They had four children: Alexander, Simeon, Susan and Sarah. Elijah Denny II (About 1818 Rockcastle Co. KY-Pulaski Co. KY) married Catherine Haggard on 25 December 1841 Lincoln Co. KY. Buried at Mt. Pleasant Cemetery Pulaski Co. KY. They had thirteen children: Rice, Cynthia, Elijah, Levi, Esau, Susan, Henry James, David, John, Elizabeth, Katherine, M.C. and Weiden.

Elijah Denney is a recognized patriot of the Daughters of the American Revolution.

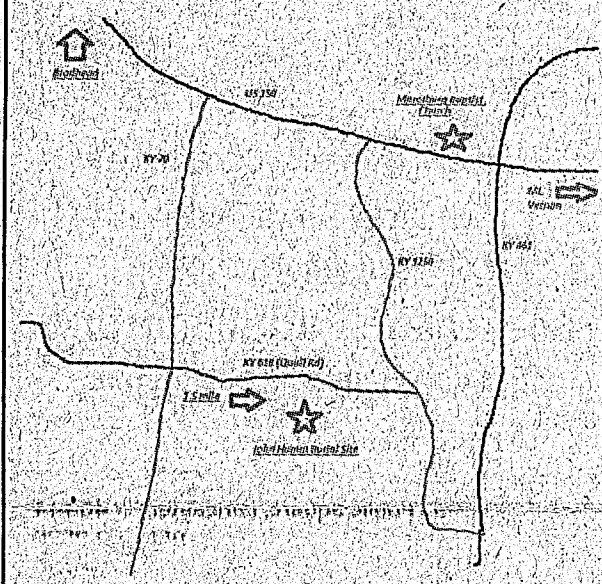

An encouraging word:

An Important Ideal

By Howard Coop



An anonymous individual wrote, "You can fool some of the people some of the time, but you can't fool mom." Moms seem to have eyes that see in every direction, and they seem to know everything.

Just after my eighth birthday, my mother died at a very young age. I don't remember a lot about her, but I do remember some things very well. To the best of her ability, she tried to instill within me high moral principles, for she wanted me to grow up knowing what the right thing to do was in any situation I would face in life.

Many times during those early years, when I acted a certain way, she would say to me, "Your conscience is hurting you, isn't it? You know better than that." When I heard those words, I knew I had done something wrong, and I knew something else: I knew that my mother knew what I had done.

There are several ways to define conscience, but two are important. One is: "Conscience is intense thoughts or feelings," and the second one is: "Conscience is a knowledge or sense of right and wrong, with a compulsion to do right; it is moral judgment that opposes the violation of a previously recognized ethical principle that leads to feelings of guilt if one violates such a principle."

Our conscience, shaped in our early years by those who nurture us, is the moral compass that guides us through all of the experiences we encounter along the road of life. We may have knowledge to do many things, but as Ben F. Lehmborg wrote, "Knowledge alone is not sufficient." In everyday life, intelligent individuals do evil things. So, Lehmborg went on to say, "Knowledge which is divorced from conscience becomes a curse, a danger, a dagger held at the heart of civilization."

For almost two-thousand years, an important ideal has been kept before us: "strive always to keep (the) conscience clear."

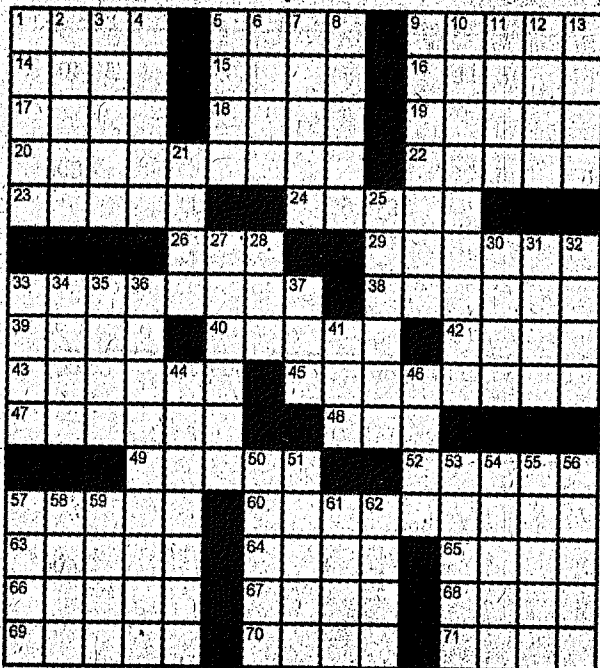

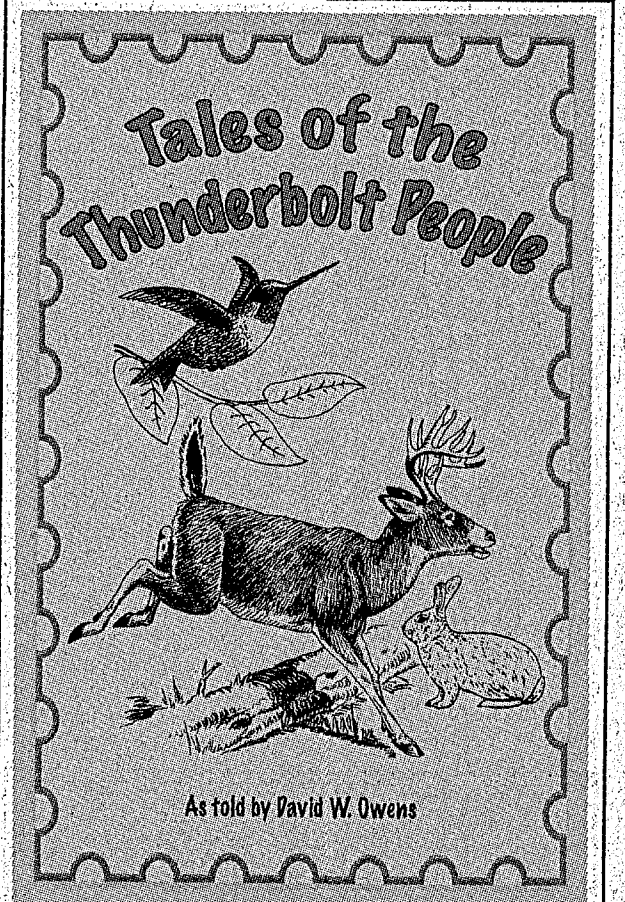

Rockcastle family celebrates 80th annual family reunion

Scores of local and far-flung descendants of Bessie Lovell Payne Cummins will gather for the 80th annual Cummins family reunion at 11 a.m. Sunday, June 29, at the Quail Community Park, 5067 Willailla Road (Hwy. 70) in Brodhead.

The tradition began simply in 1934, as a 50th birthday party for the beloved family matriarch, known affectionately as "Ma," or "Grandma," Cummins. Bessie's eight children had planned a surprise picnic, but Bessie was said to have uncovered the secret when she noticed that canned goods, a favorite chicken and other food items had gone missing. As the number of in-laws, grandchildren and great-grandchildren grew over the years, the annual birthday party for Ma Cummins transformed into a reunion and was looked forward to as a way of keeping family roots strong. Although Bessie died in 1976, at the age of 92, her gentle yet powerful presence continues to be felt year after year, a legacy of her impact on generations of Cumminses, Noes, Scotts, Paynes, Graves, Godbys and DeBordes.

Several Cummins family members still live in the surrounding area, but the picnic has become a pilgrimage back to Rockcastle County for many of Bessie's descendants, who have followed work opportunities and life events to locations throughout the state, nation and world. There are now seven generations of Bessie

Cummins descendants, totaling a clan of some 400 members. They include farmers, managers, medical professionals, performers and artists, military members, emergency personnel, manufacturing workers, engineers and business owners. However, teaching has been the singular Cummins family profession. Bessie Cummins had her own formal schooling cut short due to family hardship and limited access, but she spawned generations of educators, ranging from preschool teachers to college professors.

This year, the reunion is expected to draw Cummins family members from Florida, North Carolina, California, Washington, New Mexico, Texas, Tennessee, Ohio, Indiana, and Wisconsin. Some descendants come nearly every year; others only sporadically. For a few, this will be their first reunion. Sadly, this momentous occasion will also be marked by loss; several faithful reunion attendees will be missing, including a couple whose annual attendance dates to the very beginning of the tradition.

For the 75th annual reunion, in 2009, family members published a collection of personal stories, genealogical information, photographs, reunion reflections and favorite recipes. 75 Years of Family, Food & Fellowship celebrates the importance of tradition, reveals the story of Appalachia through the experiences of a single family, and underscores the power of one individual to shape generations.

Farm Service Agency County Committee Nomination Period Begins June 15

The nomination period for the Rockcastle County Farm Service Agency (FSA) county committee begins Sunday, June 15, 2014.

To be eligible to serve on an FSA county committee, a person must participate or cooperate in a program administered by FSA, be eligible to vote in a county committee election and reside in the local administrative area where the person is nominated.

Farmers and ranchers may nominate themselves or others. Organizations representing minorities and women also may nominate candidates. To become a candidate, an eligible individual must sign the nomination form, FSA-669A. The form and other information about FSA county committee elections are available at www.fsa.usda.gov/elections. Nomination forms for the 2014 election must be postmarked or received in the local USDA Service Center by close of business on Aug. 1, 2014. Elections will take place this fall.

While FSA county committees do not approve or deny farm ownership or operating loans, they make decisions on disaster and conservation programs, emergency programs, commodity price support loan programs and other agricultural issues. Members serve three-year terms. Nationwide, there are about 7,800 farmers and ranchers serving on FSA county committees. Committees consist of three to 11 members that are elected by eligible producers.

FSA will mail ballots to eligible voters beginning Nov. 3, 2014. Ballots are due back to the local county office either via mail or in person by Dec. 1, 2014.

Newly elected committee members and alternates take office on Jan. 1, 2015.
