Investigators said Kissee was buried for approximately two or three hours before he was discovered and that they have several persons of interest in the case. ### Man found beaten inside abandoned rock quarry

A Pulaski County man was found severely beaten last Wednesday night at an abandoned rock quarry on Mullins Station Road in Mt. Vernon.

According to the Rockcastle County Sheriff's Department, two men were walking around outside the abandoned rock quarry around 9:30 p.m., searching for brass bullet casings, when they heard a faint moaning sound coming from inside one of the caves.

After the two men went inside the cave to investigate the sound, they found Derek Kissee, 23, of Somerset severely beaten and completely buried under several large rocks. The two men immediately called Rockcastle 911 and uncovered Kissee before emergency personnel arrived.

Kissee was transported by ambulance to Rockcastle Regional Hospital and later airlifted to the UK Medical Center where he is being treated for multiple skull fractures. Kissee is currently listed in stable condition.

The incident remains under investigation by the Rockcastle County Sheriff's Department and Deputy Sheriff Matt Bryant is in charge of the investigation.

Bryant said that Kissee was stoned with large rocks then buried under large rocks and left for dead. He said there was also evidence of Kissee being held against his will and then dragged.

### Man accused of attempting to scam people at Rockcastle and other hospitals

arrested last Wednesday and is accused of scamming people at Rockcastle Regional Hospital and several other hospitals throughout Kentucky.

According to UK police reports, Gary L. Goodman, 36, of Winchester was arrested last Wednesday after police responded to a panhandling complaint at the UK Medical Center in Lexington.

Once officers arrived, **UK Medical Center security** told officers that Goodman was attempting to panhandle families at the hospital by reportedly telling a hardluck story about his mother dying and how he didn't have any money.

Officers also noted that the UK Medical Center has had several issues with Goodman panhandling in the past and that he was advised in 2013 to stay away from the hospital unless he was seeking medical treat-

Goodman told officers that he didn't mean to aggravate people but he was homeless and needec

Goodman was charged with third degree criminal trespassing and was lodged in the Fayette County Detention Center where he was later released on a \$50 unsecured bond.

Goodman has reportedly been seen at several different hospitals and businesses throughout Kentucky, including Rockcastle Regional Hospital.

Rockcastle Regional Hospital Community Relations Director Jana Bray said they are aware of Goodman and his panhandling scams. She said their

I've recently been trying to keep up with the news about Malaysian Airlines Flight MH17 that crashed last Thursday in eastern Ukraine near Russia's bor-


Since last Thursday, regular TV programming has been interrupted by the mainstream media whenever investigators found another piece of the plane, a country pointed a different finger at another country,



My brother Al always introduces me to his friends as his "baby brother." It does not surprise because, when I was a child, he used that term on a regular basis. The driver made the fatal mistake of passing a car in the middle of a curve. He hit a pick-up truck head-on. killing both my son and his best friend. The driver was not seriously injured and basically walked away from the accident.

Even though it has been 22 years since Todd's death. it sometimes seems as if it were yesterday, Had he lived, he would be age 37. But, to us, he will always be a budding teenager. Memorial Day is a holiday that my wife and I always dread, and we usually do something to commemorate Todd in some

Todd was a remarkable young man. He was an excellent student and had expressed to me his desire to become a pharmacist. He was a member of his high school soccer team and was extremely active in his church's youth group. At Todd's funeral, his Youth Director said, "You certainly do not have to worry about Todd because he was a fine Christian boy." He also explained that Todd loved to lead the group in prayer at their meetings and was a frequent volunteer to do so. It is an understatement of some portion, but I am so grateful that Todd was wellrounded and valued Christian ethics.

Like many young boys, Todd loved to play in the woods, which he had the







ing to house the bait and tackle shop which should be delivered in two weeks, Mayor Mike Bryant said.

Mullins is also supervising the property at the lake, assisting fishermen and campers and working with the health department to bring everything up to standard. "It will take a while to get everything in shape but I believe the area will be better than it has been in a while," Bryant told the council. He added, "We had to work through some issues at the boat dock but we want the public to know that the facility is family-oriented and any problems will be addressed.'

The council also discussed the splash pad, scheduled to be installed near the playground area of the lake. The city had hoped to get a grant to cover the cost of the project but it was not approved. However, they decided to go ahead with the project with funds the tourist from commission's restaurant tax and, Bryant said, he hoped the splash pad would be installed at least by the end of the season.

The council did get approved for a grant that will provide six benches on Main Street and some signage denoting the historical significance of Main St. buildings.

Councilwoman Shelley Lewis brought before the council a request that a letter be sent to the tourist. commission asking their intentions for the land they purchased for a tourist site in the Renfro Valley area. Lewis that the commission might be considering putting the property on the market since payment on the \$600,000 note consumes so much of the commission's revenue from the restaurant tax.

The motion passed unanimously.

In other action the council-accepted Green Bros. alleres blacktop bid for \$80 a ton and approved a revised fire department manual.

Police Chief Brian Carter gave the council his department's activity report for June which showed:

beaten path." Chad said the oddest but most appreciated encouragement comes from older adults who grew up having ice cream trucks driving through their neighborhoods. He said they are constantly commenting on how the ice cream truck reminds them of their childhood and a simpler time years ago.

"One afternoon we pulled up to this group of adults sitting on a porch in Livingston and asked them if they wanted to buy an ice cream," Chad said. "This one woman originally said no but when we started to leave she told us to wait: She said she hadn't bought anything from an ice cream truck since she was a kid and that she wanted to buy something for old times sake. She said it reminded

Pennington and social service workers responded to the residence after receiving several complaints of people using drugs in the presence of three children at the

Once Pennington arrived, he saw Cope attempting to flee out the back door of the home. However, when Cope saw Pennington she ran back inside the resi-

After searching the residence, Pennington found a plate, a razor blade and a plastic baggie containing a white powdery substance that field tested positive as methamphetamine. Pennington also found two used needles in the driveway of the residence.

Pennington also found a Suboxone strip on Gadd at the time of her arrest. The three children were taken into protective custody by social services.

Gadd and Cope were both charged with meth possession, tampering with physical evidence and possession of drug paraphernalia. They both remain lodged in the Rockcastle County Detention Center on a \$7,500 cash bond.

to our home on Furnace Mountain. He often took our Cocker Spaniel with him when he walked in the wooded area. After his death, Kathy and I purchased that portion of woods from our neighbor and dedicated the area in his memory. Over the past twenty years, we have developed a casual, shaded, circular path through the area. At the very back of the walk, Kathy placed a concrete bench that previously belonged to her late father, who lived in Mt. Sterling. We also have bird feeders. small animal figurines, and manicured areas that look over the mountain toward Lexington in the distance. Kathy and I often say that we have a modest home with a "million dollar" view. Todd used to stand in this area and stare into the distance for long periods of time. I think he loved the area as much as Kathy and I

A few years ago, we purchased an engraved, cedar sign saying, "Todd's Walk" and mounted it at the entrance of the circular path. Our friends and neighbors often comment how wonderful it is to casually stroll through the path. Because it is completely covered with a canopy of old oak, popular, maple, and hickory trees, the temperature is considerably lower there than it is anywhere on rest of our property. The path is almost completely covered with lush, green moss. Every time I walk in the area, I feel the presence of my son. It almost feels as if he is walking with me.

Todd, like his father, was a people person. He loved to talk to everyone with whom he came into contact. I don't think he ever saw a stranger. Jordan.

the phone to let somebody know that, "Ike's come in. You ought to come by and see him.'

Invariably somebody will ask, "Which way did you come?" Because there is a standing argument as to which is the best and quickest way to get there from up here or down here or whichever it is. One side will argue for taking the Mountain Parkway and coming up Highway 15 to Hazard and the other maintains that taking the Daniel Boone straight in is the best route. I much prefer the Daniel Boone, but now that 15 has been pretty much rebuilt, it may, in fact, be a quicker to get back home. Old habits die hard.

About ten years ago the eastern Kentucky politicians sucked around and renamed The Daniel Boone to Hal Rogers Parkway because they figured The Prince of Pork might send more sausage up their way if they massaged the Congressman's ego. I'm told now that' there is another sneaky movement afoot to rename The Daniel Boone Forest 'Hal's Wood Patch" and yet another bunch of county judges want to call Boone's Trace, "Rogers' Footpath" in hopes that he'll repay them with a mess of baby back ribs. Personally, I think they

should have called the road exactly what they wanted it to be; "Lard Truck Highway". As the ranking member of The House Appropriations Committee in Congress, Hal is generally first in line at the Pork Barrel. What the eastern Kentucky pols don't seem to

### The American Revolutionary War Patriots of Rockcastle

To celebrate and honor the county's American Revolutionary War Patriots and to enlighten the community about the service and sacrifice of these brave men. on behalf of the Rockcastle Chapter of the Daughters of the American Revolution, I have complied highlights of the service of the known patriots living in the county and who applied for a pension between the years 1818 and 1842. All information was taken from the patriot's own account from his pension application and other historical documents: More information can be found on each patriot at the local library or the Rockcastle Historical Society. Thomas Gadd

Maryland Thomas Gadd was born in 1760 in Baltimore, Maryland and died after 1834 in Rockcastle County, KY. According to his pension application, Thomas gave the following account of his service on 25 February 1833 in Rockcastle Co. KY at the age of seventy three. He was called out as a private militia man in Baltimore Co. Maryland under Captain Stausberry, Colonel James Giddins, and William Parrish, Ensign. He was then marched from what was then called the Manner Church to the city of Baltimore and stationed there to defend the city, remaining from four to five weeks at a time. He served six or seven of these tours and could not recollect the precise length of his service, but he knewhe did not serve less than six months actual service. He stated that he was drafted and never received a written discharge. Although Thomas never mentions any injury during his

service, the Maryland Revolutionary War records show

thatThomas was wounded at some point. The type of wound or when he received

it is not mentioned. Thomaswas living in Baltimore County, MD at the time of his service. Later, he moved to Franklin County, VA. He then moved to Lincoln Co. KY, becoming later RockcastleCounty where he resided at the time of his application. Thomas received a government pension in the amount of twenty dollars annually on 5 May 1833 until his death sometime after 1834. He is buried in the Gadd Cemetery in an unmarked grave in Rockcastle Co. KY.

Thomas does not mention a spouse or children in his pension application but according to the Census and property deeds, he was married and had children..

# Practice safety at the shooting range

The cooler temperatures and lower humidity that spread across Kentucky this week made it feel more like early fall than the dog days of summer.

Fall hunting season seems closer with a crispness in the air in mid-July. And in reality, it isn't far off. Early fall squirrel season in Kentucky opens in less than a month,

Spending time at the shooting range now not only is fun but it's also a surefire way to ensure you'll be ready when it counts this fall.

"Ranges are established places where people go to shoot rifles, pistols, shot-guns, even archery," said Bill Balda, Hunter Education' Supervisor with the Kentucky Department of Fish and Wildlife Resources. "Rarely are all of these done at the same time and at the same range,"

Kentucky Fish and Wildlife has public shooting ranges (tube, trap and skeet, and archery) on select wildlife management areas in Kentucky. A complete list is available online at fw.ky.gov.

These public shooting ranges are self-serve – trap and skeet ranges are open to organized clubs or groups and must be reserved 30 days in advance – and users must comply with the posted rules. Some of the guidelines are based on courtesy; the majority focus on safety.

"When you get to a range, there should be a sign that clearly marks what the range is for," Balda said. "Be aware of what you can and cannot use on each range because these ranges are placed and have safety

zones according to the firearms they're designed to handle."

The basic rules of firearms safety still apply at the range:

• Treat every firearm as if it's loaded. Keep the action open and the firearm unloaded until you're ready to fire.

• Make sure you point the firearm in a safe direction. At a range, that's designated as toward the target. Never point it at yourself or others.

• Keep your finger off the trigger until you're ready to shoot.

• Know your target and what's in front of or behind

"Probably the most common thing I see on rifle ranges is people still handling a firearm on the firing line while people are down range," Balda said. "For safety and courtesy that's something you shouldn't do when people have gone down range to work on targets."

The same applies for shotgunners.

"From time to time people need to go down to the trap houses and reload the thrower," Balda said. "Again, you should not be handling your firearms when someone does that. Most shotgun ranges are pretty good about having a rack to put your shotgun in when you're not shooting."

Aside from proper handling of firearms, there are two other safety measures to keep in mind.

Eye and ear protection are required at all times.

Depending on the weather, an anti-fog lens cleaner may need to be applied to safety glasses.

"Another thing that helps keep your glasses from fogging up is to take off your hat." Balda said.

Hearing damage is irreversible, and the sound of your firearm going off should not be the signal to protect your ears.

Balda advises wearing ear plugs and ear muffs when shooting anything other than a .22 caliber firearm.

"With a .22, I recommend one or the other," Balda said.

As more people visit the shooting range with the fall hunting season drawing closer, be even more aware of what's going on around you. Don't be bashful about calling for a cease fire if you observe a potentially dangerous situation.

"Everyone should stop shooting and figure out what's going on and fix it," Balda said. "It's not a big deal. Just get it done. If someone gets hult then it's a big deal."



When Mike Raney needed advice on how to make his home more energy efficient, he turned to his co-op.



Kentucky began its elk restoration program in 1997. Hunting began in 2001 with the issuance of 12 permits. Since that time, Kentucky's elk herd has grown past 10,000, making it the largest east of the Rocky Mountains.



Those Lazy, Crazy, Hazy, Days of Summer Dear Journal,

Well, here it is, mid-July and the summer is about half gone. The morning sun is slower in rising but quicker to fade in the evening. Last winter and spring, I had such great plans-several projects I wanted to complete or at least get started. Oh, the paintings I wanted to paint, the quilts I wanted to quilt, the books and poems I wanted to write (and read), the yard I wanted to work in and of course, the smart phone I wanted to learn to use. The list goes on and on. Where does the time go? Well, I'll tell you. It goes to cleaning a house that in two days, maybe the next, looks like it was never touched. Then there are an endless string of meetings to attend: Then there is always shopping to do, family sicknesses and emergencies, unexpected obligations, and my particular favorite: "My God, I'd have to feel better to die, I can't possibly do anything today...just let me rest...I've already overdone."

Whatever happened to those old lazy, crazy, and hazy days of summer, now long past? The memories of those old summer days seem so precious now. I remember having a feast from the garden every day: the tomatoes, and the beans cooked with the "taters" were so good! Then there were the fresh blackberries and apples baked in pies. There seemed to be plenty of time for everything, from impromptu picnics, visiting neighbors, handwritten letters, and resting on the front porch in the cool of the evening.

Now, these are lost arts When did I write or receive a handwritten letter? Sitting on the front porch was the highlight of the day. The older generations told stories of long ago, and the children spoke of their interests and aspirations for the future. Pretty soon the lightning bugs would come out and maybe even a full moon. We didn't seem to mind the heat and mosqui-

About mid-July, the children would begin to dread school starting, now only a few days away. To look back on it now, it was some of the best days of my life spent there in that old red

brick school. It was built back in the early 1950s and is still in existence. That old school has seen generations of children pass through its doors. I still keep in touch with a few classmates I met there over fifty years ago

The summer brought out relatives I hadn't seen since the year before or even longer. They would come and stay a week or two, or a night or so, as they traveled here or there. Sometimes Mom and I went and stayed a few days with them, too, summer, about Brodhead fair time, we had an influx of relatives arrive at the same time (around thirty or more). There were

One evening, after supper, the subject of religion reared its ugly head and a few sour notes were heard. About half of the relatives were Baptists and the other half, Pentecostals. 




