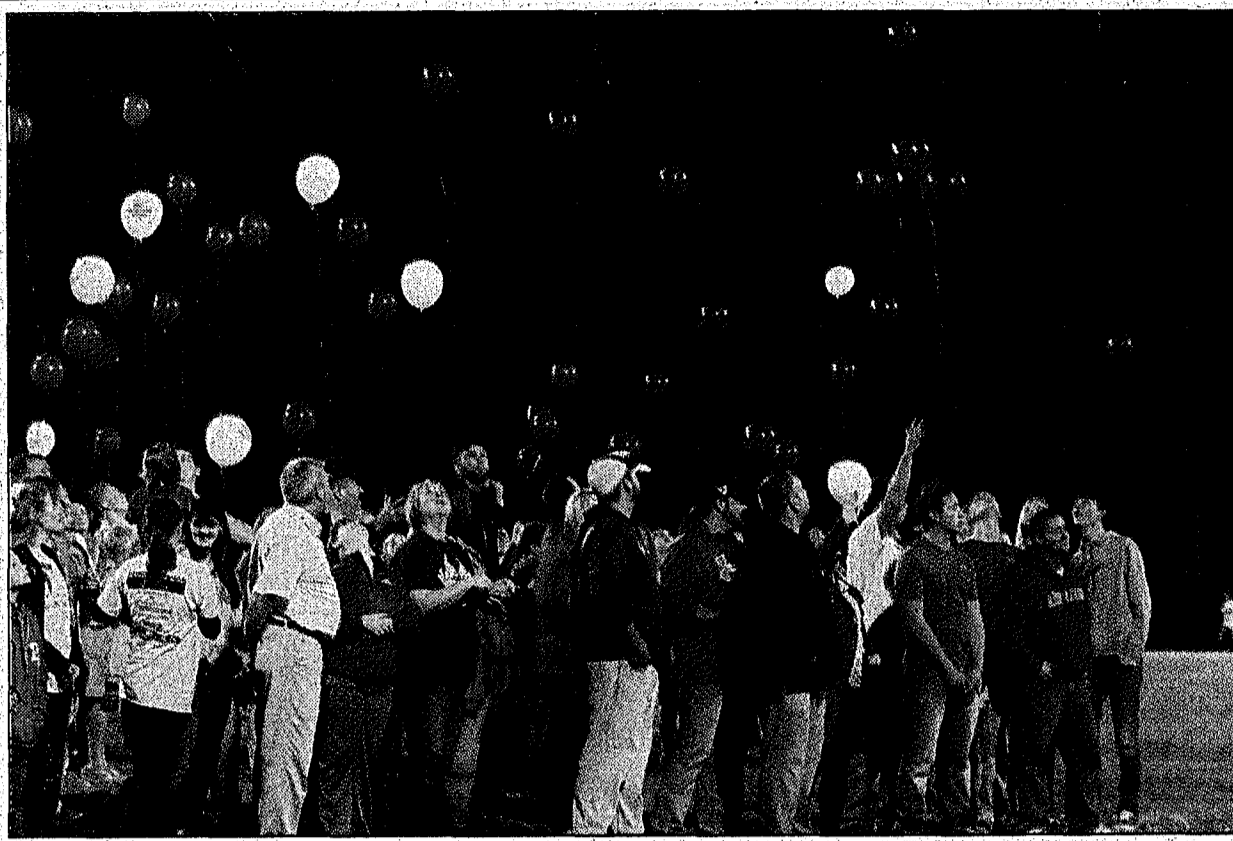

Carloftis files as write-in candidate for county judge

 The 2014 Fall General Election took on a new twist last Friday when County Judge Executive Buzz Carloftis filed as a write-in candidate for the county judge executive race after he was defeated in the 2014 primary election in May. Carloftis (R) originally faced opposition from challenger Doug Bishop (R) in the 2014 primary election. Bishop defeated Carloftis by 428 votes and Bishop also won 10 out of the 15 precincts. With both candidates registered as republicans in the primary election and no democrat candidates in the race, the winner of the primary election was originally believed to be the next county judge executive in

2015. However, the race has now been reopened with Carloftis filing as a write-in candidate. Carloftis and Bishop have a long history. This will be the third race between the two men for the county judge executive position. After Carloftis defeated republican Claretta Hodges in the 2010 primary election, Bishop filed as an independent candidate enabling him to run against Carloftis in the 2010 General Election. Carloftis went on to narrowly defeat Bishop in that election by 183 votes. Of his candidacy, Carloftis said that he has

For 2012 taxes

101 suits filed over delinquent property taxes

A total of 101 suits were filed recently in Rockcastle District Court in an effort to collect delinquent property taxes. The suits were filed by County Attorney Billy Reynolds on behalf of the state finance and administration cabinet. The total amount of taxes due from the bills named in the suits is \$16,761.88 and

range in amounts from \$7.45 to \$684.30. The tax bills are what remains of the 2012 property tax bills that were due beginning November 1, 2013. Many unpaid tax bills were purchased by companies who then add on costly fees and interest, under a law enacted several years ago

Court hires Gibson as county employee

Kimberly Mullins Gibson, who was originally hired by the fiscal court as a contract employee, has now been hired as a regular county employee at a salary of \$35,000, the same as her salary as a contract employee. The action came during a closed session of the fiscal court at the end of last Tuesday's regular meeting and will provide Gibson

with benefits such as health insurance and retirement. Gibson is a certified social worker who expects to receive her master's degree in the field in December. She has been working as the fiscal court's liaison to the circuit, district and family courts to provide assistance to inmates with drug addic-

City of Mt. Vernon's

Water Tank project nears final approval

The City of Mt. Vernon's Water Tank project cleared a hurdle recently with approval by Kentucky Infrastructure Authority (KIA) of the low bid submitted for excavation and construction of the new water tanks.

Brown, with Kenviron, the engineering firm for the project, the only item left before awarding the bids is the review by the legislative oversight committee, from which no problems are anticipated, according to Brown.

Since the lowest bids submitted came in higher than estimated, the city had to go back to KIA for additional funding of just over \$400,000, bringing the total of the loan/grant to \$3,023,310. The funding is made up of 65% loan and 35% grant, so the city will only have to repay \$1,964,950 over a twenty-year period. Mayor Mike Bryant said the additional funding needed would not necessitate any additional increase in water/sewer rates for Mt. Vernon Waterworks customers.

Brown said that the beginning of construction will depend on the weather and the construction firm has until October of 2015 to complete the project.

The council gave Mayor Bryant authority to sign-off on the Notice of Award for the bids, contingent on final approval of the oversight committee and approved the borrowing of additional funds for the project from KIA.

The Mayor also told the council that another police

Two charged with drug possession

Two people were charged with drug possession after police responded to a disturbance last Thursday night at Denny's Restaurant in Mt. Vernon.

Arrested at the scene were William B. Cummins, 29 of Lawrenceburg and Misty Dawn Nichols, 32, of Frankfort.

According to Mt. Vernon Police reports, officers responded after receiving complaints of intoxicated people causing a disturbance at the restaurant.

Once officers arrived, they found Nichols standing outside in the restaurant's parking lot. Cummins was located moments later inside the men's restroom of the restaurant.

Officers noticed that Nichols and Cummins both appeared intoxicated while performing field sobriety tests. Both Nichols and Cummins said they didn't have any I.D. and both gave officers false names.

After searching the couple's vehicle, officers found several needles, suboxone strips and an unlabeled prescription bottle, containing an unknown liq-

uid. Officers also found both Nichols' and Cummins' IDs in the vehicle as well.

Nichols admitted that the officers had the correct ID but Cummins was still denying his ID and continued to give officers the same false name. However, officers later noted that Cummins had his name tattooed across his chest.

Officers found a suboxone strip on Cummins at the time of his arrest and they found a "balloon" of heroin inside Nichols at the time of her arrest.

Both Cummins and Nichols were charged with public intoxication, possession of drug paraphernalia, identity theft of another without their consent and possession of a controlled substance. Nichols was also separately charged with heroin possession.

Cummins and Nichols were both lodged in the Rockcastle County Detention Center. Cummins was later released on a \$10,000 cash bond and Nichols remains lodged on a \$5,000 cash/property bond.

Police still investigating RCHS bomb threat and alleged napalm bomb

 Local police are still investigating two incidents that occurred last week involving a bomb threat at Rockcastle County High School and an alleged napalm bomb that was brought to the Mt. Vernon Police Department.

In the first incident, the Mt. Vernon Police Department are still investigating the bomb threat last Monday morning.

RCHS students and faculty were immediately evacuated to the Rockcastle County Middle School after police notified staff about the bomb threat. A Kentucky

State Police canine was brought to RCHS to search the building and nothing suspicious was found.

MVPD Chief Brian Carter said there are no suspects at this time and that the bomb threat was sent via text message. He said that it's hard to trace the text because it appears to have been sent through an untraceable text messaging application on a Smartphone.

Carter went on to say the bomb threat is still under investigation and that he is in charge of the investiga-



Remembering Ray Charles

I was cleaning out a file drawer in my office when I ran across a notation that I had made on June 10, 2004. It said, "Ray Charles died today." I loved him dearly. It seems impossible that it has been ten years since one of my all-time favorite singers passed away. I cannot tell you how many CD's I have of Ray.

I began to be a fan in the early 60's. But he really hooked me in 1962, when he released his popular album called *Modern Sounds in Country and Western Music*. I literally played that vinyl disk so many times that it finally wore out and had to be replaced before I went to college. It included songs like: "Bye, Bye Love"; "You Don't Know Me"; "Born to Lose"; "You Win Again"; and my favorite, "I Can't Stop Loving You." *Rolling Stone Magazine* named the album one of the greatest of all time. The album achieved Gold status, meaning that it sold over one million copies. At that time, that was a huge number for sales of a record.

I remember putting a

stack of Ray's albums on my stereo at UK almost every night before going to sleep. He even served me well in my dreams.

Several of my friends and I drove to Louisville to see Ray in concert in 1963. I have seen countless live performances during my lifetime, and I still believe that it was one of the best concerts I have ever witnessed in person. He played for over two hours and still came back for an encore. The crowd was delirious with joy. We never wanted him to quit singing.

One of the many reasons that I admired him and loved his music so much was his humble beginnings. Born during the Depression in the Deep South, his family was dirt poor. He was not born blind; it was at the age of six when he lost his sight. He was orphaned at the age of fifteen. The *Dallas Morning News* observed, "Ray Charles was battered by blindness and discrimination, but was never beaten or embittered. He spun his suffering into a golden thread of music inseparable

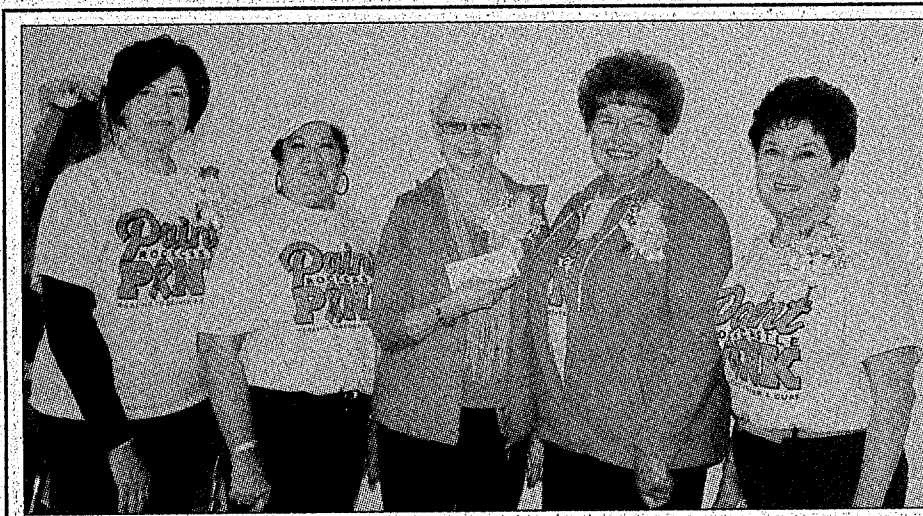

call of duty. I hasten here, to say, that our experience with a crook is the exception, rather than the rule. To be fair, most business are, indeed, trustworthy.

Over the last ten years or so, I've tried to make a point to mention here, from time to time, those businesses that provided me services so exemplary that they stand several inches taller than those who simply meet my normal expectations.

Such was the case when we recently had to find a plumber to solve a problem that a truck load of drain-clearing products had failed to fix. The bath tub, which has been perilously slow to drain for at least 20 years, finally stopped up so tightly that we couldn't force water through it with a plunger.

Our house still has some of the original, galvanized, drain pipes that look like Daniel Boone may have dropped them off here on his way from Cumberland Gap to his fort there on the Kentucky River.

Loretta dug out the yellow pages and got on the phone where she discovered that plumbers are generally pretty pricey. More than one guy told her that he charged 80 bucks an hour plus the cost of any pipe and fittings and that the clock started as soon as he left Berea or Richmond.

We realized, right away, that we were going to be out about \$100 just to pay these guys to get out and ride around and that there was no telling what the actual work might cost. Heck, my family doctor doesn't make \$80 an hour. But, to be honest, he has never worked on my arthritic joints with a pipe wrench and propane torch.

It finally occurred to Loretta, that she had heard several friends and coworkers brag on a lady plumber in Lancaster who had served them well and reasonably priced her work as well.

Robin Hall calls herself "The Plumber Girl" because, she says, that's what about everybody else calls

her. But she is not one of those journeyman plumbers who advertise, "Have Pipe Wrench, Will Travel".

In fact, you will not find her in the yellow pages or even listed elsewhere in the phone book. She pretty much has all the business she can handle from word-of-mouth and grapevine reputation building.

The solution to our problem included removal of a crooked, 8-foot section of the aforementioned galvanized pipe that had been there so long she had to saw it out. It also included a trip to a hardware store, 12 miles away, to buy pipe, fittings and gooey, oozeey, gray stuff that comes in squeeze tubes.

The entire job, including travel time, took up the better part of one whole day last week. But at the end of that day, we could fill up the tub and watch a whirlpool form when the drain was opened. The last few cups of water made a satisfying sucking sound, not unlike that of a baby putting a pacifier through its paces, as it disappeared into parts unknown.

So as I stood there dreading the verdict while figuring that being unable afford to eat out in the foreseeable future was a small price to pay for the convenience of being able to take a hot shower.

Turned out, Robin's total price for the work and parts wasn't very much more than what some of the fellows with whom we had spoken were going to charge for their running around time.

As I said before, I'm not sure that Robin needs any more business and I'm nearly positive she won't drive to London or Harlan to work on your pipes. But she is the best example of "cheerful service with a smile" that I've encountered in many moons and there's no place I know of that doesn't need much more of that.

Robin Hall's telephone number is 859-979-4109, but do not be surprised if you get an answering machine because, most likely, she is going to be under a floor somewhere, getting nasty.

from the fabric of our nation's character. Bless his sweet soul." Amen.

The Herald Leader wrote the following about Ray's influence on American music: "Mr. Charles reshaped American music for half a century as a singer, pianist, songwriter, bandleader, and producer. His playing was inevitably overshadowed by his voice, a forthright baritone steeped in the blues, strong and impure and gloriously unpredictable."

Ray won nine of his twelve Grammys between 1960 and 1966, including the award for "Best R&B Recording" for three consecutive years ("Hit the Road Jack," "I Can't Stop Loving You," and "Busted"). I distinctly remember having a car-load of teenagers in my 1958 Chevy as we sang "Hit the Road Jack" at the top of our lungs, with all of the windows open. (Martha Sowder reminds me of this event nearly every time we are together.)

Of course, one of Ray's most notable and praised compositions, "Georgia on My Mind," was officially adopted as the state song by the Georgia legislature.

His soulful recording of "America the Beautiful" became so legendary that President Ronald Reagan asked him to perform it at his second presidential inaugural. When Ray passed away, B.B. King, Glen Campbell, Stevie Wonder, and Wynton Marsalis each performed musical tributes to Charles during what was described as "a joyous funeral" at the First African Methodist Episcopal Church in Los Angeles.

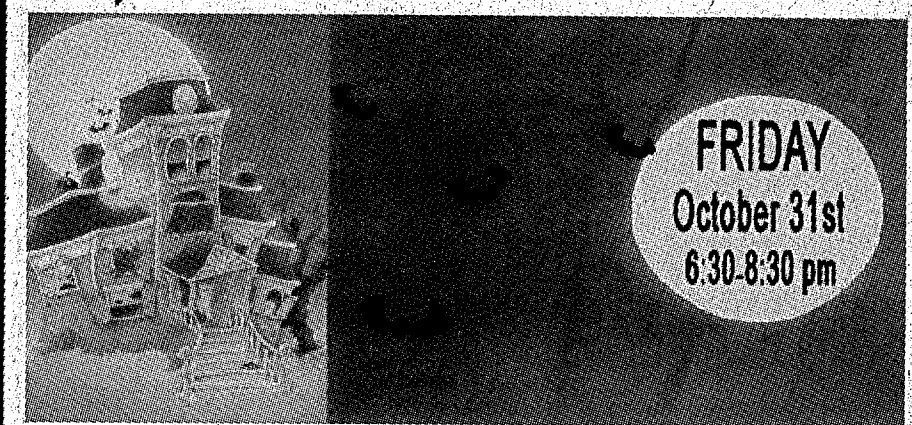

tions in entering a rehabilitation program, as a condition of their probation, thereby, hopefully, reducing the large number of repeat offenders.

The fiscal court hopes this will alleviate somewhat the public spending for the rising number of drug abusers in Rockcastle County.

Jail populations have literally exploded during the past ten years. Rockcastle County jail budget this year is just under \$1.4 million which includes the fiscal court putting \$500,000 of that amount into the budget from the general fund. “Although this hire is an additional cost to our budget, just consider that it costs all of us a minimum of \$13,400 per prisoner per year incarcerated in Rockcastle County’s jail,” said County Judge/Executive Buzz Carloftis.

Beware of prussic acid poisoning as frost approaches

Although prussic acid poisoning can occur anytime during the growing season, the greatest risk is usually associated with the first frost in Kentucky.

The primary cause of hydrocyanic (prussic) acid poisoning in domestic animals is the ingestion of plants containing this potent toxin. Cyanide-producing compounds (cyanogenic glucosides) occurring in living plant cells are converted to prussic acid when cells are crushed or otherwise ruptured.

The prussic acid potential of plants is affected by

species and variety, weather, soil fertility and stage of plant growth. Plants of the sorghum group and leaves of wild cherry trees have a potential for producing toxic levels of prussic acid. There are wide differences among varieties. Some of the sudangrasses are low in prussic acid. Pearl millet is apparently free of prussic acid in toxic amounts.

The risk from potentially dangerous forages may be reduced by following certain management practices.

1. Graze sorghum or sorghum cross plants only when they are at least 15

inches tall.

2. Do not graze plants during and shortly after drought periods when growth is severely reduced.

3. Do not graze wilted plants or plants with young tillers.

4. Do not graze for two weeks after a non-killing frost.

5. Do not graze after a killing frost until plant material is dry (the toxin is usually dissipated within 48 hours).

6. Do not graze at night when frost is likely.

7. Delay feeding silage 6 to 8 weeks following ensiling.

8. Do not allow access to wild cherry leaves whether they are wilted or not. After storms always check pastures for fallen limbs.

1 teaspoon soda
2 cups sugar

Mix all ingredients together. Pour into 9 x 13 inch greased and floured pan. Bake at 350° for 1 and 1/2 hours. Mix some powdered sugar and water to make a thin glaze. Pour over top of cake while still hot.

EGGPLANT PARMESAN
1 medium sized eggplant, peeled and thinly sliced
1 egg, beaten
2 cups Italian bread crumbs
3 cups tomato sauce, divided

1 package (8 ounce) mozzarella cheese, shredded and divided
1/4 cup grated Parmesan cheese
Preheat oven to 350°.
Dip eggplant slices in egg; then cover each piece with bread crumbs. Place in a single layer on a baking sheet. Bake for 5 minutes on each side.

In a 9 x 13 inch baking dish, spread sauce to thinly cover bottom of dish. Place a layer of eggplant slices in the sauce. Sprinkle with mozzarella and Parmesan cheeses. Repeat with remaining ingredients, ending with the cheeses.
Bake for 35 minutes or until golden brown.

Rockets lose to Panthers in UNITE Bowl, 26-7

The Rockcastle County Rockets dropped to 5-3 on the season following a 26-7 loss to Knox Central during the UNITE Bowl last Friday night.

The inability to get the ball into the end zone and

several missed opportunities proved to be the deciding factors in the Rockets loss.

The Rockets offense had a total of 225 yards on offense with 182 rushing yards and 43 passing yards. Freshman tailback Brent Lovell scored the Rockets only

touchdown in the game after he broke free for a 67 yard touchdown run in the second quarter.

But the Rockets had several stalled drives on offense, including one stalled drive before halftime when the time clock ran out while they were in the red zone. The Rockets also had four turnovers in the game with three fumbles and one interception.

Head Coach Scott Parkey said last Friday night's game was a hard loss for them and that the Rockets would have been in the game if it wasn't for the turnovers.

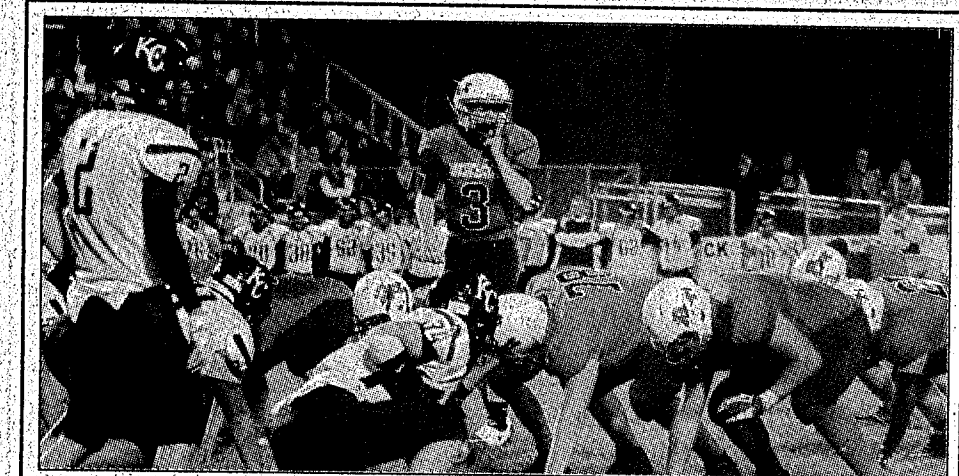
"We made a couple of costly mistakes on offense that killed our momentum. We gave them great field position off our turnovers which made it hard on our defense," Parkey said. "In games like this, the team with the fewest turnovers and better field position is more likely to win the game. That's exactly what happened."

However, Parkey said he was still proud of the way his team played against an experienced team. He said he was also proud of how well the Rockets defense played during the game.

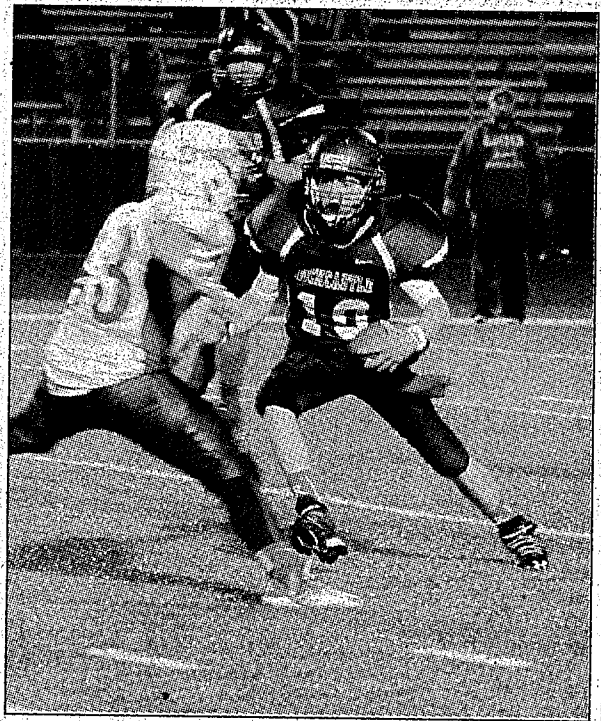
"We were satisfied with how well they played against Knox Central's experienced and big offense. We won't see another offensive line like that until the playoffs," Parkey said. "Our speed was also on display during the game. This is the fastest defensive team we have had on the field in a long time. Even though we had a tough loss last Friday, we learned a bunch about our players' toughness, grit and ability."

Offensively, the Rockets were led by Lovell who had 17 rushes for 109 yards and one touchdown.

Other Rockets picking up rushing yards were sophomore running back Devon Robinson with 12 carries for 46 yards, freshman fullback Holdan Barnett had 3 rushes for 21 yards and senior fullback Isaiah Adams had one



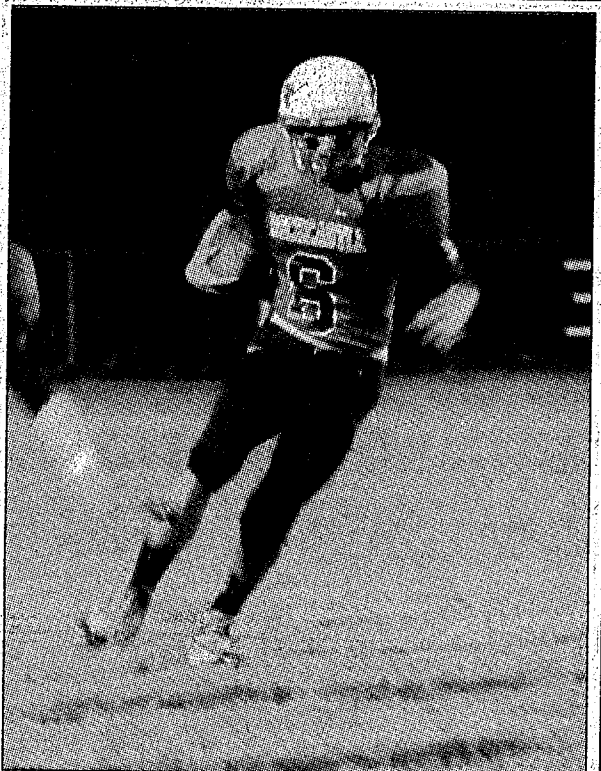

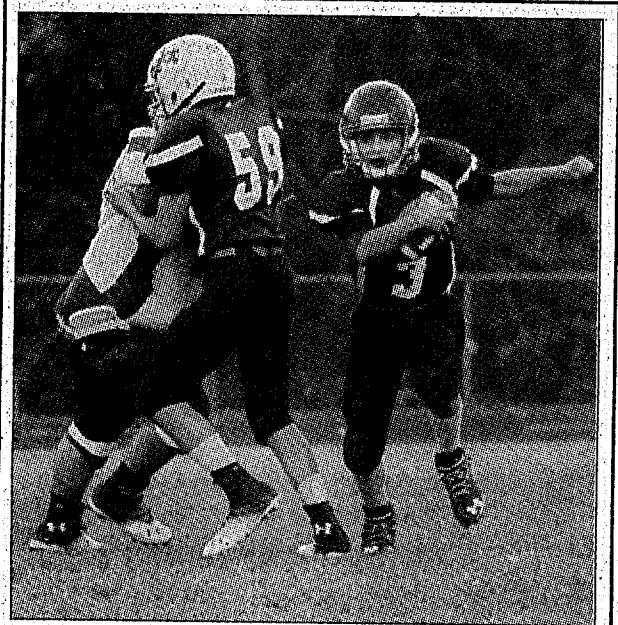

Sophomore quarterback Dakota Bishop finished the game 2 out of 6 passing for 43 yards and one interception. Bishop also had one carry for 3 yards.

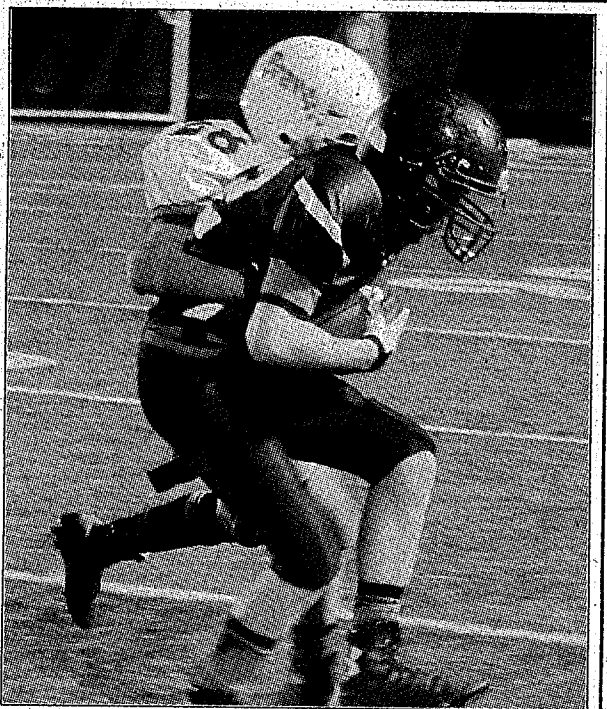

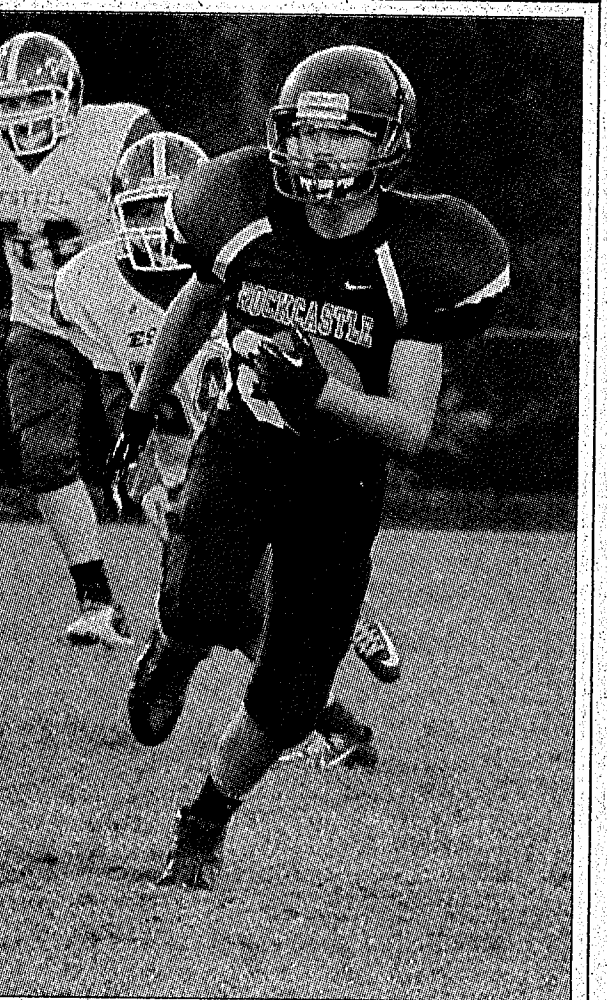

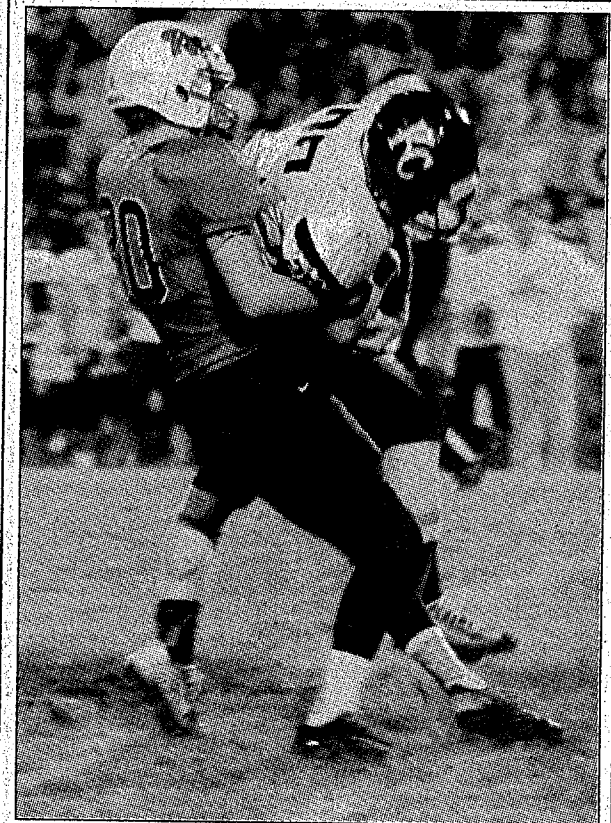
Seventh grader Josh Thacker runs around end of during their 36-8 playoff win against Estill County Monday night. The seventh graders record is 7-2.



Eighth grader Jaydon Payne fights for extra yardage during the loss against Clark Moores.



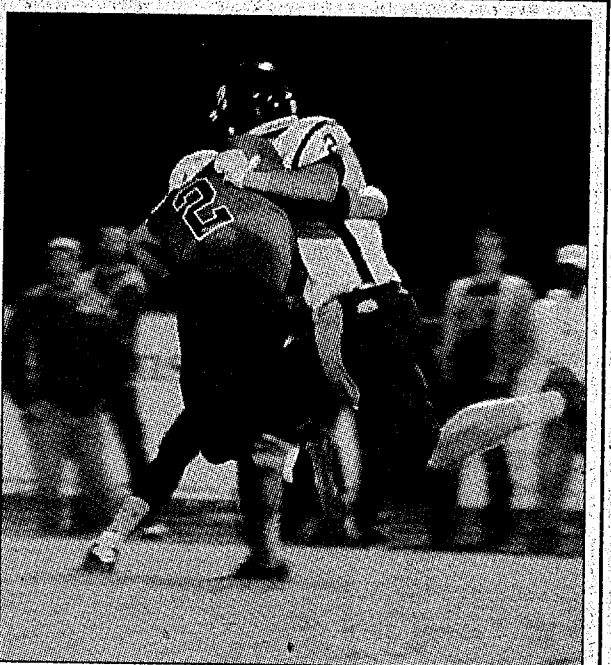

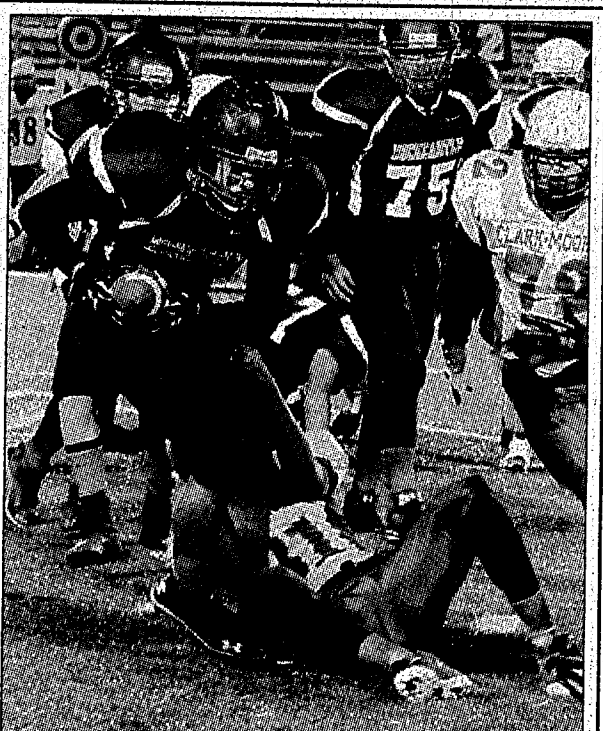

Seventh graders Donnie Thacker and Jaydon Payne bring down a Estill County running back during the Rockets win Monday night.

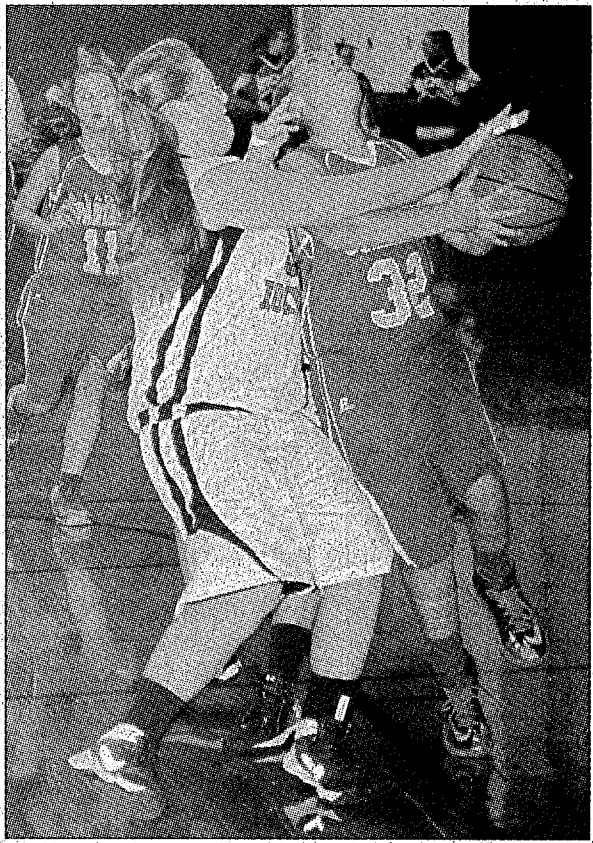

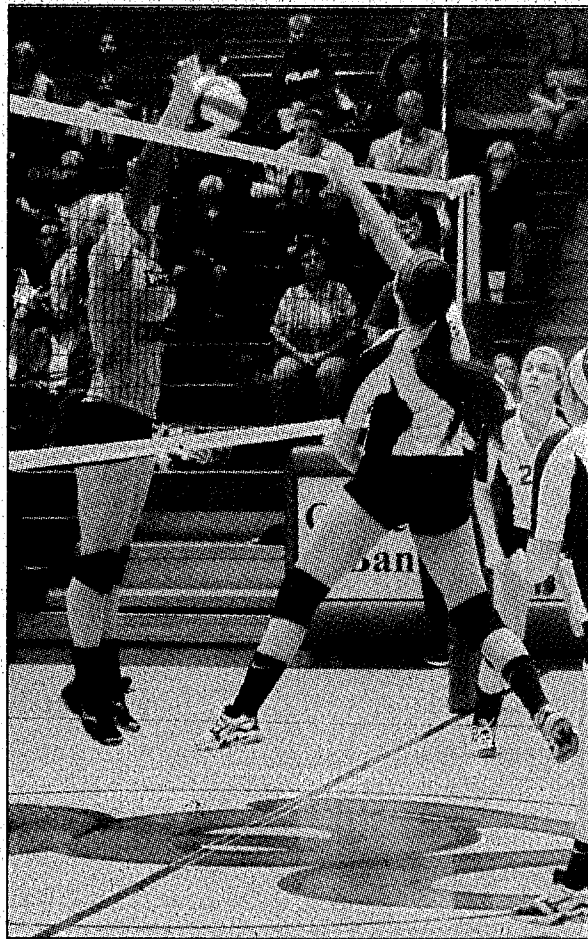

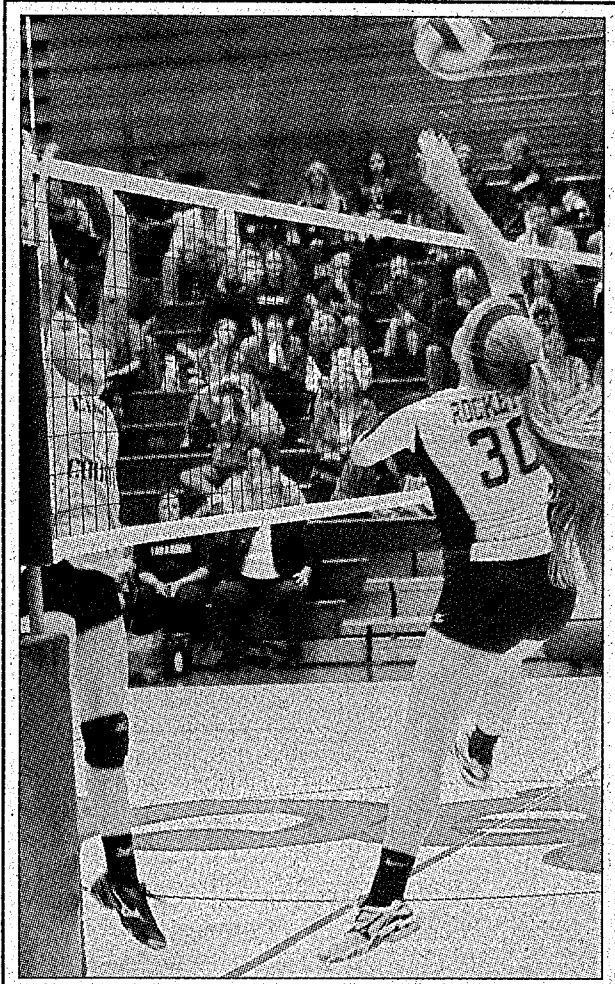

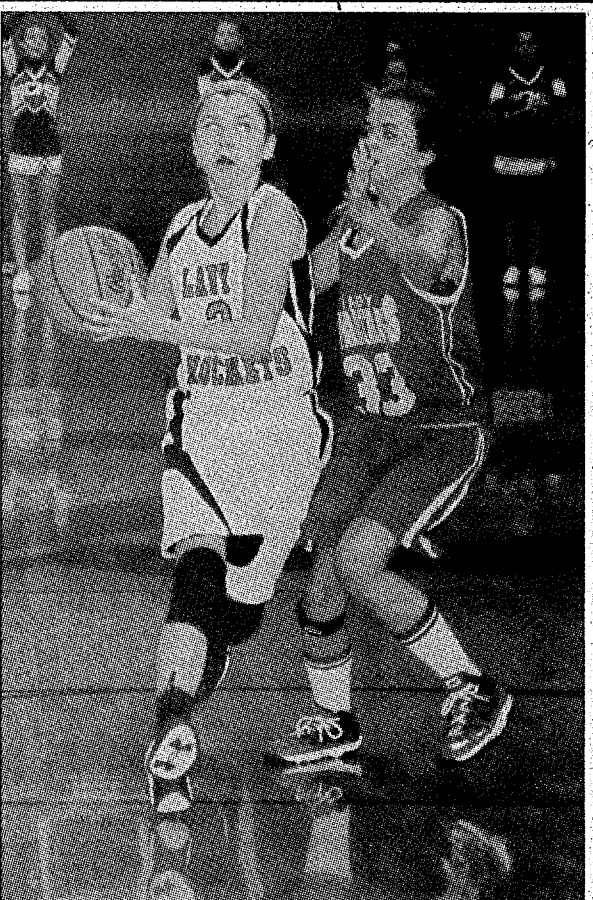

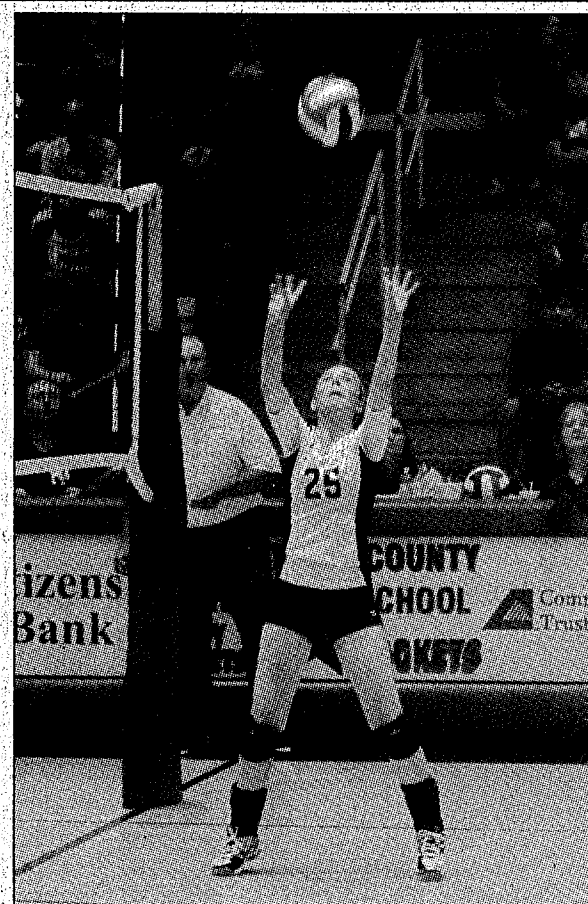
Katie Adams gets a hit during the opening game of the district tournament Monday night. The Lady Rockets lost the game to Casey County 3-0.



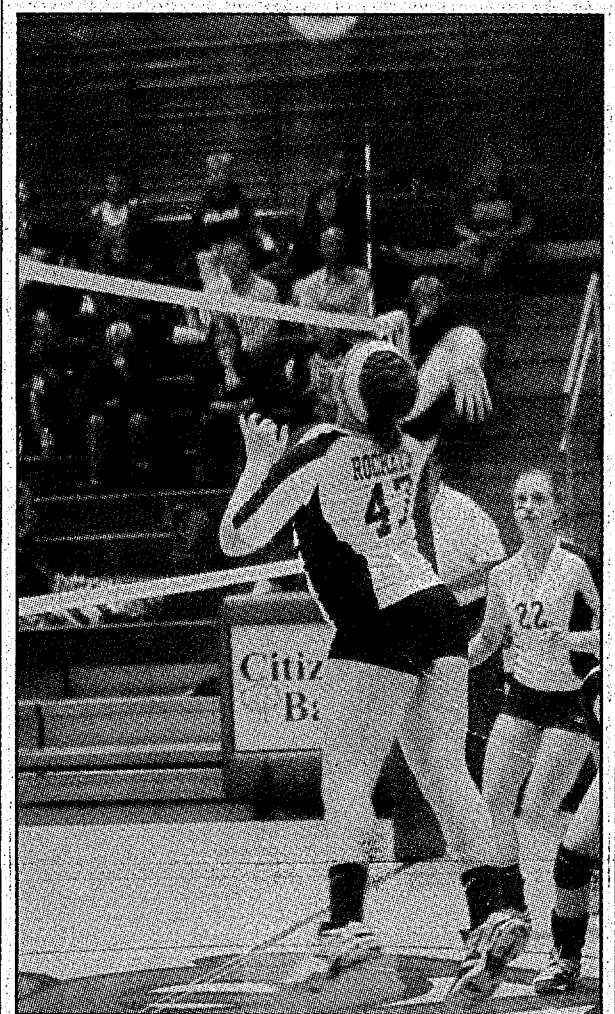

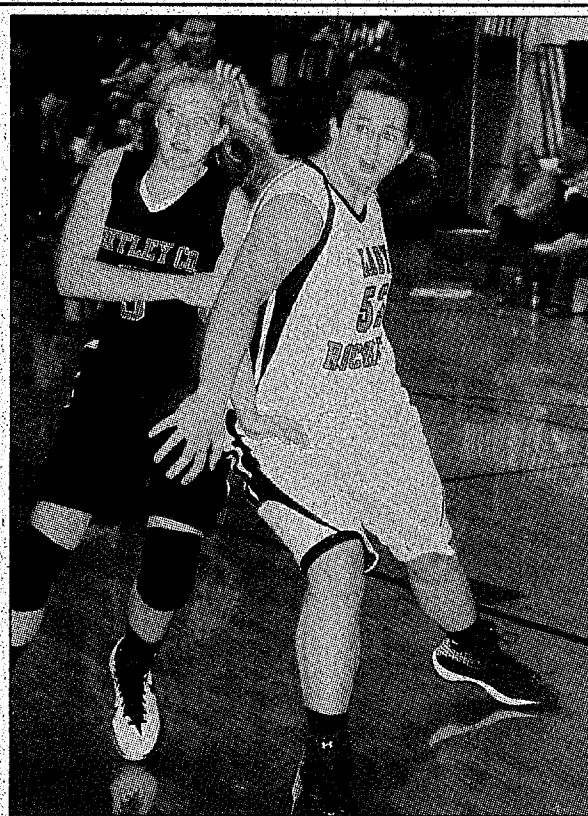
Emily Childress is shown setting a ball for a teammate during the Lady Rockets' 3-0 loss to Casey County in the opening round of the district tournament.

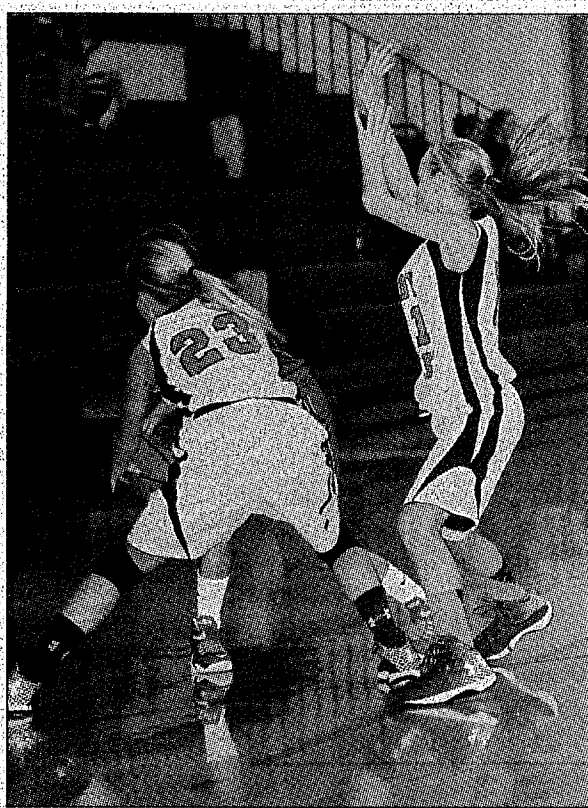

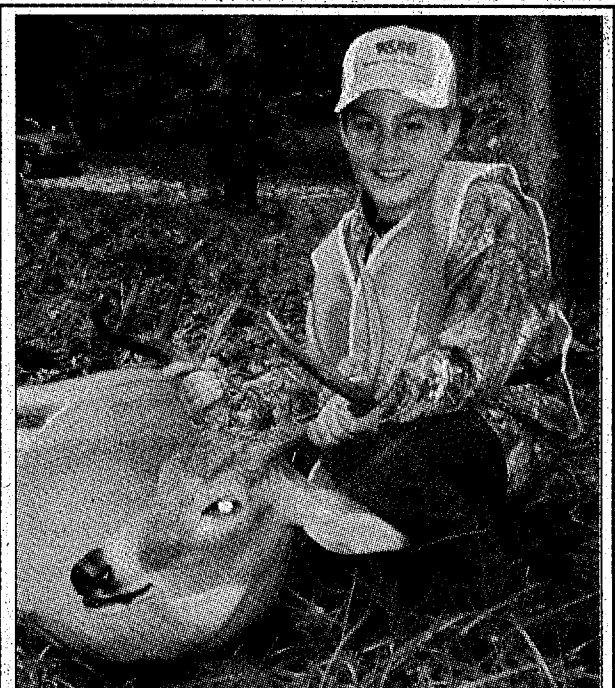

two college degrees in political science and that he knows running as a write-in candidate is a “steep climb.” He said he was simply outgunned and outworked in the primary election.

“I lost and I accepted my defeat. But I was not surprised as I recognized very early that certain well-placed political forces and “bosses” within my own Republican Party had joined forces to remove me from office,” Carloftis said. “They said it was time for me to go and they succeeded. I assure you my loss in the primary is not a consideration in my write-in candidacy. It was other things.”

Carloftis said that Bishop’s ads in the primary race were negative in nature. He said the most disturbing things about the race were inferences or comments made about him and his family not measuring up to his opponent’s Christian standards.

“The day after the election in May, one of his strong supporters called the

office slandering me. That’s just politics, but it shouldn’t be,” Carloftis said. “The subtle inferences made that my family and I fail to live up to their standards hurt my mother and all of us. As a church pianist for 32 years, my Southern Baptist faith has taught me not to ever judge another person’s deeply held beliefs and understand that we don’t have to agree on every jot and tittle in order to sit at the same table of our common faith.”

Carloftis went on to say Rockcastle County has made great strides during his tenure as county judge executive and that no one can honestly dispute that fact. He said that he has served Rockcastle County well and with integrity.

“I’m concerned about our county’s future. My opponent and his supporters who made up his campaign turned our positives into negatives with false accusations and misrepresentations of facts,” Carloftis said. “We have a lot of irons in the fire and I want to continue as your county judge executive. Rockcastle voters elected a judge by write-in in 1939 and we can do it again!”

Bishop said he felt it was

regrettable that Carloftis is disregarding the republican primary to pursue a write-in candidacy.

“I’m working everyday to bring our community together and to avoid division,” Bishop said. “I appreciate the strong support I received and I look forward to restoring conservative principals to the office of county judge executive.”

County Clerk Danetta Allen said the last day to file as a write-in candidate in the General Election is this Friday at 4 p.m. and that those interested have to file in her office. She said the same requirements and fees apply to write-in candidates that applied to registered candidates.

Allen said the name or party affiliation of write-in candidates do not appear on the ballot. She also said votes will only be counted for write-in candidates that have filed in her office.

Allen went on to say that absentee ballots have to be returned or mailed back to her office by next Tuesday in order for them to be counted in the General Election.

According to state law KRS 117.265, the write-in candidate’s first and last names have to be written in in order for them to be counted. The law further states that only writing the candidate’s first name, initials, or nickname will not be counted as an actual vote.

However, the law goes on to state that any minor misspelling of the candidate’s name will be disregarded in determining the validity of a write-in vote as long as the intended candidate can be clearly determined.

According to the county attorney’s office, the procedure now is that property owners have 20 days to file an answer (refuting the claim of taxes due). If an answer is not filed, then a default judgment will be sought and suit could be filed in circuit court asking that the property be sold to satisfy the lien.

Several suits have been filed in circuit court by the companies who purchased unpaid tax bills over the years, to sell the properties, on which taxes have not been paid, at a Commissioner’s Sale.

tion. In the second incident, a concerned parent brought an alleged Napalm bomb to the Mt. Vernon Police Department last Wednesday after she found it while cleaning her child’s room.

According to Rockcastle County Sheriff Mike Peters, the male juvenile’s mother brought it to the Mt. Vernon Police Department because it looked suspicious. He said the bomb was originally believed to be a Napalm bomb but that it’s actually an “incendiary device” instead of a bomb.

“It was a homemade Napalm incendiary device that wasn’t as powerful as we once believed,” Peters said. “He said he was just experimenting with the device after he saw it on the internet. He said he had no intention of hurting anyone with the device.”

Peters went on to say there is no evidence they have discovered during the investigation that suggests the Napalm incendiary device was connected to the RCHS bomb threat last Monday but that everything was still under investigation.

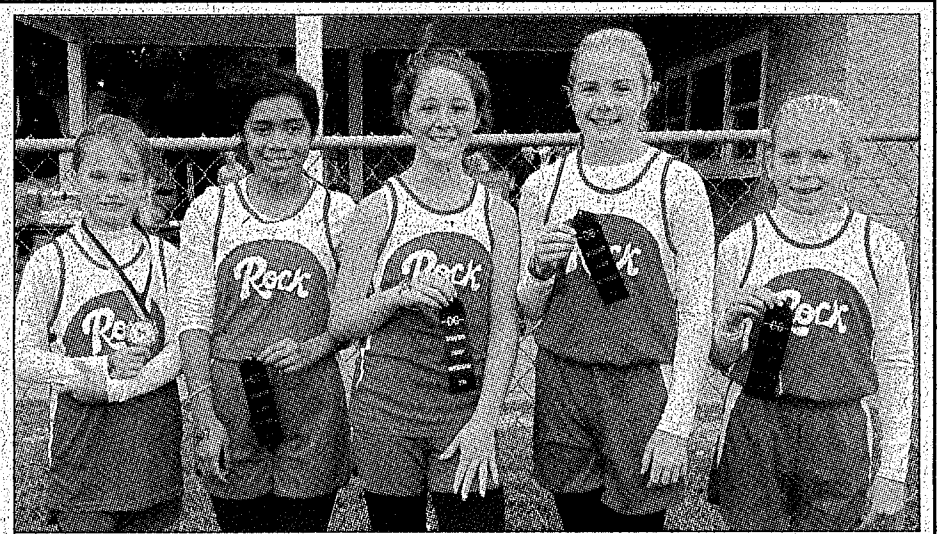

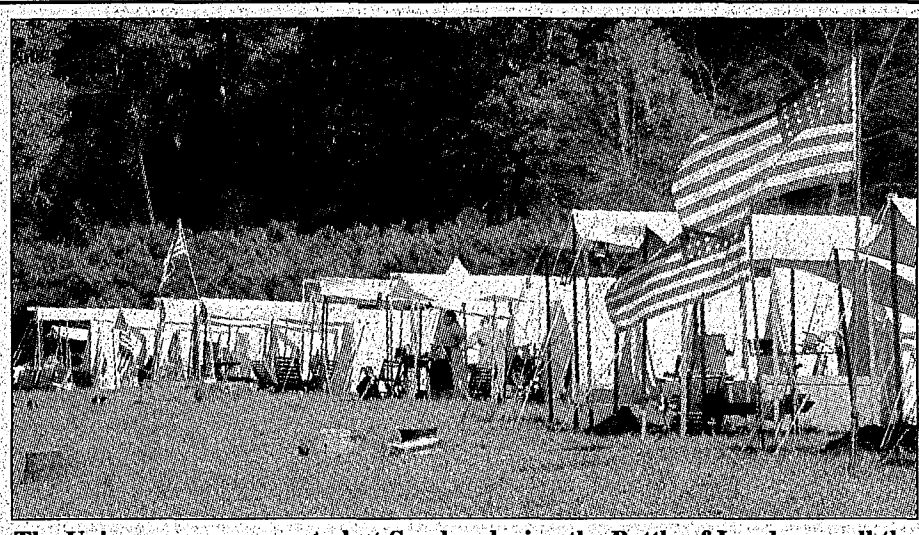

Hidden Among Us

The American Revolutionary War Patriots of Rockcastle

To celebrate and honor the county's American Revolutionary War Patriots and to enlighten the community about the service and sacrifice of these brave men, on behalf of the Rockcastle Chapter of the Daughters of the American Revolution, I have compiled highlights of the service of the known patriots living in the county and who applied for a pension between the years 1818 and 1842. All information was taken from the patriot's own account from his pension application and other historical documents. Reuben Pew
New Jersey-Virginia
Reuben Pew was born on

13 December 1758 in Morris Co. New Jersey and died on 24 August 1847 in Rockcastle Co. KY. According to his pension application, Reuben gave the following account of his service on 11 September 1833 in Rockcastle Co. KY:

In March of 1776, while a resident of Huntington Co. NJ, Reuben volunteered as a private in the Army of the United States in the company commanded by Captain Grunin Dyke in the militia of the state of New Jersey in Huntington County for a period of one month to defend the city of Hackensack. He faithfully served out his term of service and was discharged by Captain Dyke at Hackensack. After four days had passed, Reuben was drafted into the militia for one month under the command of Captain Petty under whom he served at Woodbridge, NJ. He served his term of service and was again discharged by Captain Petty. Only a few days had

passed when Reuben entered the service as a volunteer under Captain Petty and served out one month of service. He was again discharged at Woodbridge, NJ. Only a few days later, Reuben was again drafted under Captain Petty to serve one month partly at Bridgetown and the rest at Elizabethtown, NJ. He was discharged in 1776.

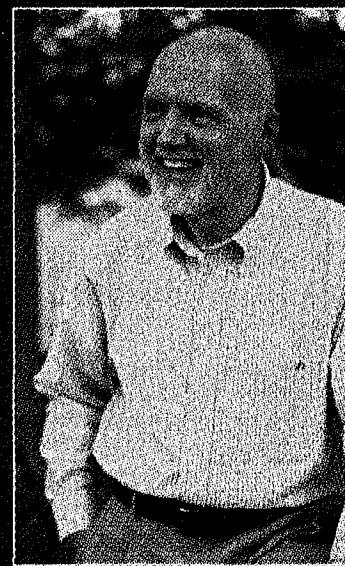
There is an interesting note about Reuben's early service in the militia. According to family tradition, Reuben was left an orphan at an early age and was "bound out" as an apprentice to earn a living. Reuben worked for a man named William Farrow. Seeing that he could not read or write, Mr. Farrow tricked Reuben into signing himself into service for the war, being Mr. Farrow's substitute. He told Reuben that the paper he was signing was only a common piece of writing and could do him no harm.

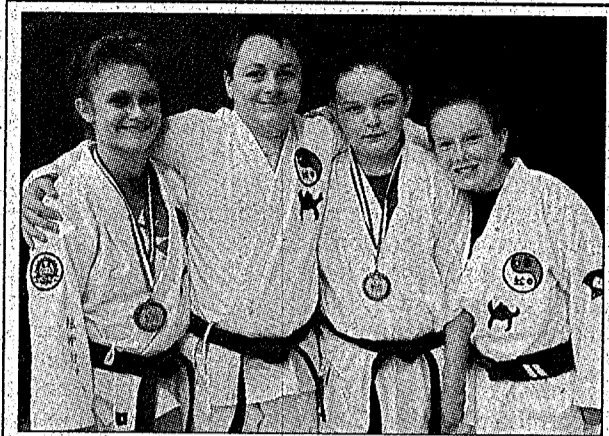

Ordinance #2014-6

An Ordinance levying the annual ad valorem tax on motor vehicles for city purposes in the corporate limits of Mt. Vernon, Kentucky.

Whereas, KRS 83A, 130, 140 and 150 require that the legislative body, by ordinance, provide for sufficient revenue to operate city government, and;

Whereas, KRS 132.487 and 132.488 requires submission to the Kentucky Revenue Cabinet prior to October 1 of each year the annual tax rate to be levied on motor vehicles and motorboats.

Now Therefore Be It Ordained, by the City of Mt. Vernon, Kentucky as follows:

Section One: Tax Levy - Motor Vehicles and Motorboats
 A. An ad valorem tax rate of 16.7 cents on each \$100.00 (one hundred dollars) assessed value of motor vehicles and motorboats subject to taxation under the laws of the State of Kentucky is hereby levied for city purposes.

Section Two: Due Date, Payment, Discount and Penalty
 A. All ad valorem taxes on motor vehicles and motorboats shall be collected by the Rockcastle County Clerk in accordance with the provisions of KRS 134.800 and other applicable statutes.
 B. Ad valorem taxes on motor vehicles and motorboats shall become due and delinquent as set forth in KRS 134.810 and such taxes not paid when due shall be subject to the penalty and interest as specified therein.

Ordinance #2014-5

An Ordinance levying the annual ad valorem tax for city purposes in the corporate limits of Mt. Vernon, Kentucky

Whereas, Kentucky Revised Statute (KRS) 92.280 requires that the legislative body of each city annually levy an ad valorem tax for city purposes, and,

Whereas, KRS 92.330 requires that all taxes be levied by ordinance, and,

Whereas, KRS 83A.130 requires that the legislative body, by ordinance provide for sufficient revenue to operate city government, and,

Whereas, the city has calculated the tax rate(s) for real and personal property in accordance with KRS chapter 132.

Now Therefore Be It Ordained, by the City of Mt. Vernon, Kentucky as follows:

Section One: Tax Levy - Real estate and personal property
 A. An ad valorem tax rate of 16.9 cents on each \$100.00 (one hundred dollars) assessed value of real property subject to taxation under the laws of the State of Kentucky is hereby levied for city purposes.
 B. An ad valorem tax rate of 16.9 cents on each \$100.00 (one hundred dollars) assessed value of personal property subject to taxation under the laws of the State of Kentucky is hereby levied for city purposes.

Section Two: Due Date, Payment, Discount and Penalty
 All said taxes shall be due and payable at the City Offices as set forth on the tax bill. Taxes paid prior to the due date shall receive a two percent (2%) discount. Taxes paid up to thirty (30) days after the due date shall be at the face amount. Taxes paid more than thirty (30) days after the due date shall be charged a ten percent (10%) penalty.

Section Three: Effective Date and Use Thereof
 This ordinance applies to the 2014 calendar year tax assessment and all receipts shall be used for city purposes and accounted in the 2015 fiscal year and subsequent fiscal years in reference to delinquent collections.

 Our responsibility is to express an opinion on the financial statement based on our audit.  In our opinion, because of the significance of the matter discussed in the Basis for Adverse Opinion on U.S. Generally Accepted Accounting Principles paragraph, the financial statement referred to above does not present fairly, in accordance with accounting principles generally accepted in the United States of America, the financial position of each fund of the County Sheriff, as of December 31, 2013, or changes in financial position or cash flows thereof for the year then ended.

Opinion on Regulatory Basis of Accounting
 In our opinion, the financial statement referred to above presents fairly, in all material respects, the revenues, expenditures, and excess fees of the County Sheriff for the year ended December 31, 2013, in accordance with the basis of accounting practices prescribed or permitted by the Commonwealth of Kentucky as described in Note 1.

Other Reporting Required by Government Auditing Standards
 In accordance with Government Auditing Standards, we have also issued our report dated July 10, 2014 on our consideration of the Rockcastle County Sheriff's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts and grant agreements, and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Rockcastle County Sheriff's internal control over financial reporting or on compliance.
