

## Court gets "working budget" for 2015-16 at special meeting

At last Thursday's special called meeting of the Rockcastle Fiscal Court, the majority of the time was taken up with the court reviewing the working budget for 2015-16 presented by County Treasurer Joe Clontz.

Clontz told the court that it was a "conservative" as far as revenue projections and he had based them on current and previous years.

The budget in total income is down considerably because, Clontz said, last year's budget included three million in funds for the new emergency management building which has been al-

most completed.

In the budget presented Thursday, income in the general fund is expected to be \$3,057,368 plus \$250,000 estimated carryover from 2014-15 and \$583,164 in transfers out, mainly to the jail fund of \$510,570 for a net estimated revenue of \$2,724,214.

Clontz said the carryover from 2014-15 will change if the court elects not to pay the \$300,000 they received from Anchor for their early out penalty directly on the note the county incurred when they purchased the building. The \$250,000 carryover in the working budget reflects the \$300,000 being paid directly on the note and repayment to the road department of \$150,000 borrowed by the general fund last year, which of course, has to be repaid by law.

Clontz said he increased revenue to the county from the occupational tax by \$125,000 bringing the total expected revenue to \$1,500,000. The treasurer told the court that the insurance tax revenue continues to increase, estimated at \$480,000 for 2015-16, he assumed because of increases in insurance premiums.

However, Clontz said he had been notified that the

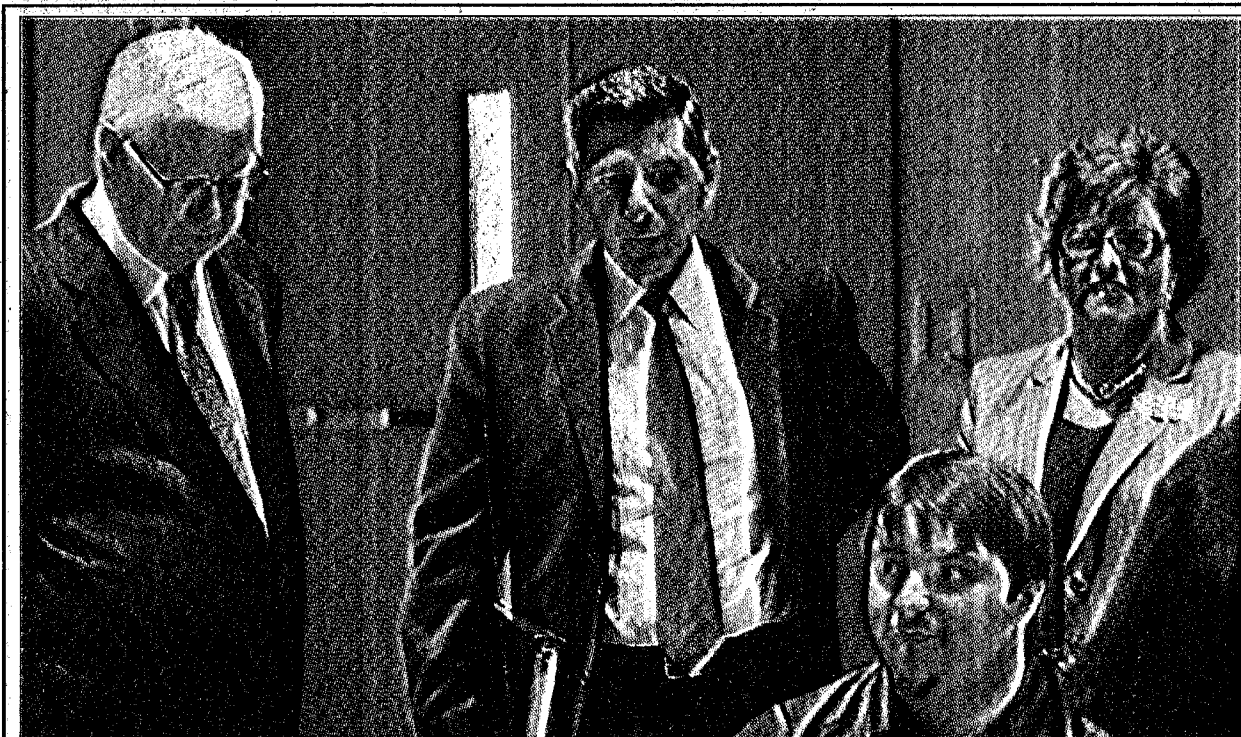
## Rockcastle Regional awarded five-star rating

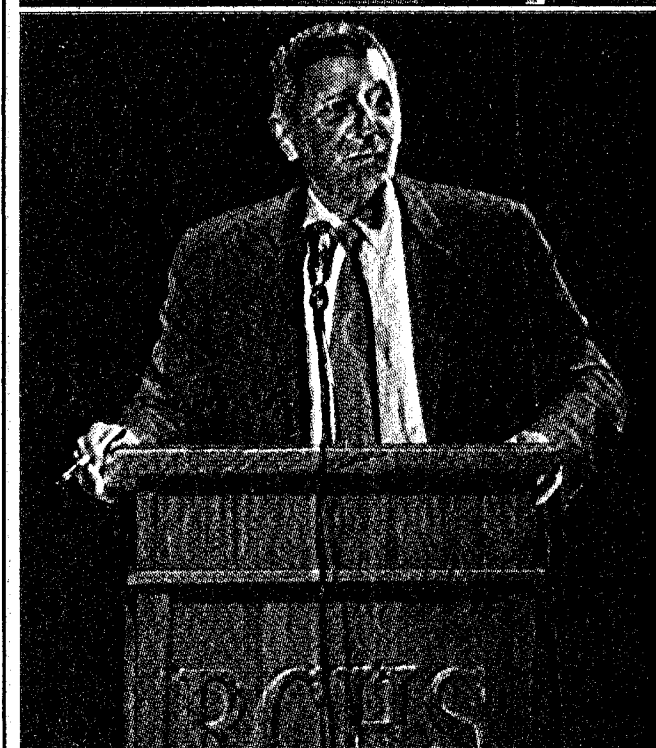
The rating is based on

The Rockcastle County Industrial Authority Board (RCIDA) approved the 2015-2016 budget at their monthly meeting on Monday.

### I-75 reduced to one lane for 24 hour periods

The Kentucky Transportation Cabinet has increased their current nighttime lane closures to 24 hour periods.

I-75 northbound and southbound will remain reduced to one lane between the 65 and 68 mile markers as state road crews continue to make pavement improvements.

The work will take place on Sunday through Thursday for 24 hour periods. No lane closures will occur between 7 a.m. on Fridays through 6 p.m. on Sundays.

The pavement improvement work is scheduled to

day. The 2015-2016 budget shows expected receipts of \$564,197 and appropriations of the same amount. The budget also includes a total revenue of \$485,197.

The largest amount of receipts and revenue comes from the SourceHOV lease at \$324,000 and \$160,575 from the county government, which is slightly up from last year's budget amount of \$156,240.

Appropriations include salaries of \$85,800 (including benefits), \$67,825 for operating expenses, \$86,572 for administration and \$324,000 for total debt services.

The board unanimously approved the budget for 2015-2016.

I am also amazed at how a lot of people (including news outlets) take the news and "adjust it" to fit their own biases. These people only hear what they want to hear, read what they want to

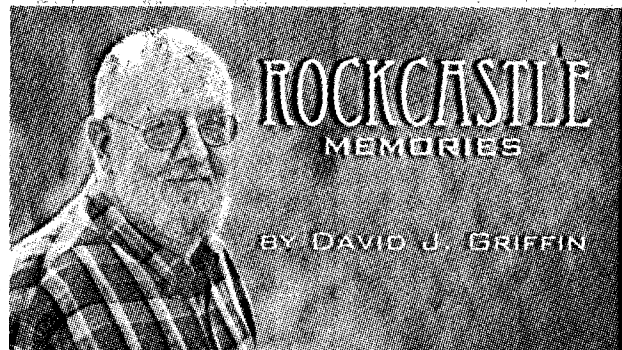
read and see what they want to see.

### Family Cook-outs

The warm spring days that are escorted in along with the greening of America always remind me of cook-outs in my grandparents' backyard during the 50s. We knew the time was near when my grandfather (Pop) traded in his "long handles" for cooler summer underwear. And Mommie Katie looked forward to spring outdoor meals so that she could observe her new flowers in the yard. In their view, spring was the sign that life had been renewed and the family should rejoice in the yearly ritual.

My grandparents had the perfect backyard for such celebrations. The huge old

trees provided the shade needed for outside dining. Pop made sure the grass was cut and raked, and Mommie Katie's early flowers set the scene appropriately.

Once Mommie had determined the proper date, she began to call the members of our family to make certain that everyone could be in attendance. The first call was to my Aunt Ruth and Uncle Charles in Lexington. If the date worked for them, then Mommie Katie began calling the family members who lived in Mt. Vernon. The next call was to Lena and Charles Machel, who were my sister-in-law's parents. Eva and my brother Al were away for much of my teen years because he was pastor of several churches located in other cities. Mommie Katie loved to include Eva's grandparents, who were also members of the First Baptist Church and were good friends of hers.

Pop set up two-by-ten boards on sawhorses for tables. He also retrieved the lawn chairs from all the porches for seating. His final chore was to get out the charcoal grill and clean it up for the coming season. Pop was in charge of getting the fire ready, and Mommie Katie did the cooking, along with my mother's (Bee) assistance. They were the two best cooks ever.

Aunt Ruth was always in charge of bringing the deserts for our gatherings. She usually brought pies or the fixings for homemade ice cream. That was my favorite dessert we ever had. It was all fresh ingredients, and the cream was hand cranked, usually by me. On special occasions, fresh bananas or strawberries were

## Points East

As most, if not quite all of you know, a month ago this week, I wrote this column soliciting reader sponsorship for Team TKO's participation in the Step Out Walk to Stop Diabetes, scheduled for the morning of May 30 at Keeneland Race Track in Lexington.

This event is, by far, the largest diabetes fundraiser held in our state and the Lexington Walk is usually one of the most successful events of its kind in the nation. I'm not sure how long it has been happening, but this is Loretta's, myself and the rest of our family's third consecutive year of intense involvement and I sure hope to be around for many more in years to come.

Diabetes has hit our family pretty hard over the years. I have type 2, which is scarcely more than a nagging aggravation at this stage of my life, but our adult son, Christopher, has had type 2 since adolescence, more than 20 years. Chris is insulin dependent and requires two or three injections daily.

I heard him muttering, just last night, that his out-of-pocket co-pay just for insulin, syringes, blood test strips and stuff like that was over \$3,000 a year and that doesn't include visits to the doctor. His monthly run to the pharmacy costs him more than his car payment. In other words, diabetes is a pretty pricey proposition.

I have no idea what our daughter Jennifer and son-in-law, Kevin Ochs are out of pocket for their 6-year-old son, Tyler Kane, who has had type 1 since he was 3. Tyler wears an insulin pump taped to his lower abdomen where a needle is inserted. It only has to be changed every 3 days which is far better/less painful than hav-

ing to take a minimum of 6 shots every day. The pump also enables his body to absorb insulin as it's needed throughout the day.

Our Step Out team (TKO) is named in honor of Tyler, but in actuality, he is the most physically active and energetic member of our group. I promise you, faithfully, that if you spent half an hour with him, you would get physically tired just watching his antics and you would never believe that a kid pulling the stunts he pulls could possibly have an insulin pump with a needle inserted into his belly.

Anyway, several people have inquired as to how Team TKO is doing, so far, in its fundraising drive this year and the answer is not quite as well as well as we were doing at this point in previous years. We have, to date had 18 donors for a total of exactly \$900. Last year we had 32 donors and topped \$2,000 by this time. We finished with nearly \$5,400. I have forgotten how many total donors we had, but I do know that over 50 of them were readers of this column.

Our family is on this bandwagon because we absolutely believe that The American Diabetes Association has spearheaded the efforts to make diabetes easier to treat that have led to such things as Tyler's insulin pump and the fact that I can take oral medication instead of having to do daily insulin shots. We also believe that cure and disease prevention medications will be developed and that ADA will provide the impetus to make those things happen.

They may not happen in my life time, or even in Chris or Tyler's but we believe they are well worth (Cont. to A4)

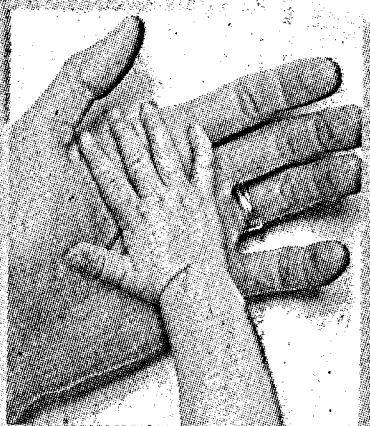

cut up and tossed into the ice cream mix — a wonderful concoction that “modern” ice cream could never duplicate. (In my personal opinion, any child who has never tasted homemade ice cream has truly been denied one of life’s greatest pleasures.)

Bee had the task of making potato salad, along with her special baked beans. She was also in charge of making sure that the necessary silverware and dinner plates were placed on the big wooden table.

When Pop had the fire just right, Mommie Katie began placing the previously prepared hamburgers on the hot grill. She care-

fully watched over them in order to be certain that each burger was cooked “just right.” She also put a few hot dogs on the edge of the grill for the kids who were in attendance. Everyone sat around in lawn chairs and visited while the meal was being prepared.

When everything was all set, Mommie Katie would announce, “Everyone gather around the table so we can pray.” Saying grace was usually left up to Brother Al, Uncle Charles, or Charles Machel. Never was a meal served without the proper prayer first.

Bee and Mommie Katie waited on everyone and only fixed plates for themselves after the rest of the family was seated and had every little thing that they

wanted or needed. Even then, Mommie Katie kept walking around, making sure that everyone’s ice tea glass was filled and contained enough ice.

All of these festivities occurred on Saturday or Sunday afternoons at approximately 1:00 pm. After the meal and the dessert were consumed, the chairs were moved from the table into the protection of favorite shade trees. The men would create a circle where they made themselves comfortable to begin the many conversations that would develop throughout the afternoon. Some topics included politics, sports, or the most often discussed, religion. Each of these men were actively involved in their respective churches.

Often these discussions became very opinionated; nevertheless, they were enjoyed by all.

About the middle of the afternoon, Pop would initiate his favorite part of the cook-out. He summoned everyone to the big tables in the back yard where he placed at least two watermelons which he had just fetched from his cellar. In preparation for the day, the melons had been placed there the day before in order to cool them to the desired temperature. Pop

sliced enormously sized pieces of the melons, placed them on a plate, and individually served each one in the group. The seeds were spit out and left in the yard.

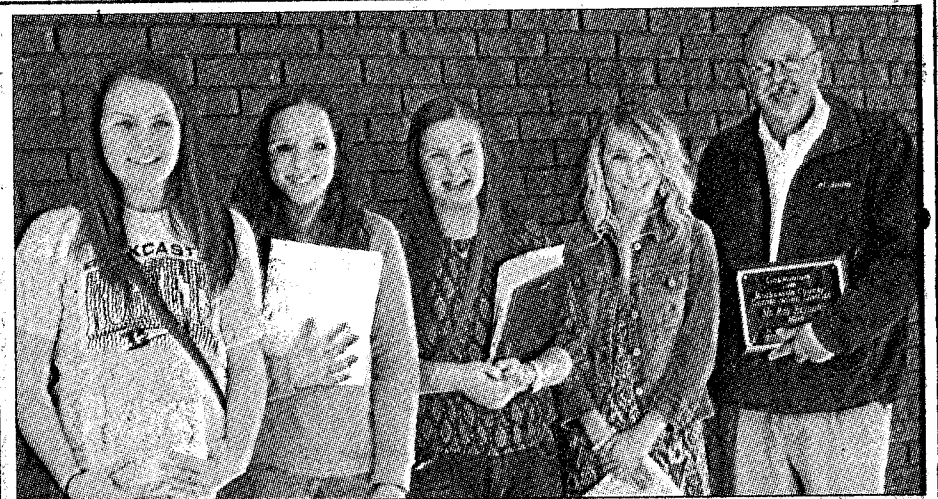
The serving of the watermelons marked the official end of the cookout, and everyone began to make preparations to leave. Afterwards, Mommie and Bee would begin cleaning up and washing the dishes, while Pop and I disassembled the “dining area.” And every bit of it was a labor of love.

These days, families are so busy and relatives are so scattered that it almost takes an act of Congress to get them all together for an afternoon. I find that fact to be very sad. If people cannot find enough time for a family cook-out, then they are simply too busy—and they are missing the kind of memory-making experiences that stay with you for life.

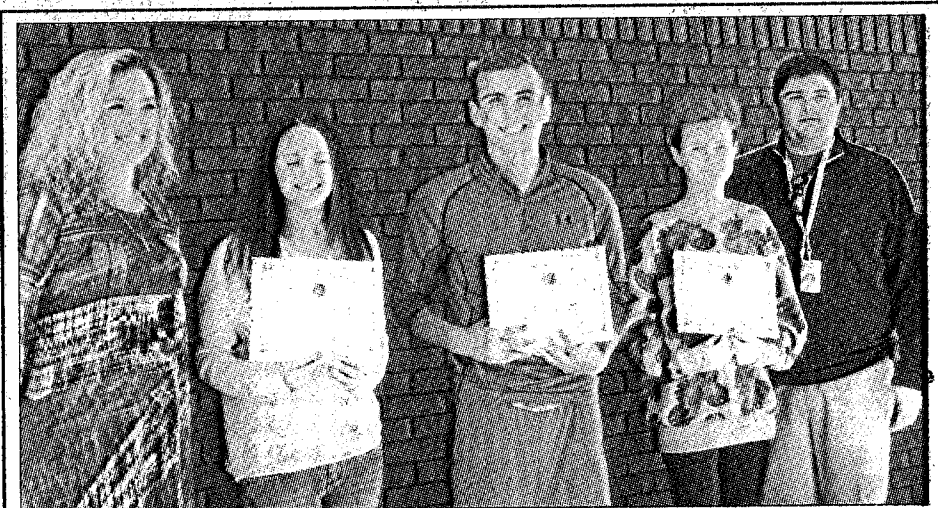

**Good Mothers Deserve More**

Mother's Day will be observed on Sunday, May 10, 2015.

This is one hundred seven years after the first Mother's Day observance was held in Andrews Methodist Episcopal Church in Grafton, West Virginia.

That first observance was at the request of Anna Jarvis, a social activist and a woman defined by her faith, to honor and remember her mother, an active member of that congregation, who had died three years earlier. From her home in West Chester, Pennsylvania, Miss Jarvis sent 500 white carnations to be distributed to those in attendance. In a telegram to the church, she directed that each person present "be given a white carnation; mothers will be given two, in memory of the day."

In that rather long telegram, Miss Jarvis stated what, in her mind, was to be the purpose of the observance: "To make us better children by getting closer to the hearts of our good mothers. To brighten the lives of good mothers. To have them know we appreciate them, though we do not show it as often as we ought." Then, she went on to suggest that the day should "be a singular possessive (Mother's Day) for each family to honor its mother, not a plural possessive (Mothers' Day) commemorating all mothers of the world." That makes Mother's Day personal.

After that first observance on May 10, 1908,

the idea of Mother's Day grew rapidly. The Methodist Episcopal Church, at its General Conference in 1912, called for Mother's Day to be an annual observance, and President Woodrow Wilson, on May 8, 1914, signed a resolution declaring the second Sunday of May to be observed as Mother's Day throughout the United States of America. Now, at least eighty countries around the world observe Mother's Day on the second Sunday of May.

A good mother is one of the more significant influences in human society. While she deserves all the recognition she receives on this special day, she deserves more because her influence is incalculable. Ralph Waldo Emerson said, "Men (and women) are what their mothers make them."

**Bible Talk**

Our study for this month is on the popular doctrine of premillennialism.

**Defining** - The word "premillennial" itself is derived of two components: "pre" signifies before, and "millennium" denotes a period of one thousand years. The theory thus suggests that the return of Christ will happen just prior to a one thousand-year reign here on earth in Jerusalem. The theory asserts that Jesus was rejected by the Jews in the first century, so he could not set up his kingdom at that time, thus postponing it to a future time.

**A Distortion of the Scriptures** - Some think that is only a mild disagreement on Revelation 20:1-6. Yet in truth, there is a myriad of texts throughout the scriptures that are being distorted to cater to this doctrine. Many of the Old Testament prophecies are twisted to fit this teaching of premillennialism as well as Rev.20:1-6.

**The Rule of Christ** - Jesus came to establish his kingdom in the first century. "The time is fulfilled, and the kingdom of God is at hand; repent and believe in the gospel." Mark 1:15. He promised in Mark 9:1, "Truly, I say to you, there are some standing here who will not taste death until they see the kingdom of God after it has come with power." If the kingdom was not established in the first century as the theory states, then there must be some really old people in the world that are still living from the first century. For Jesus said that some would be still living when the kingdom came with power! Paul speaks in Col.1:13, "He has delivered us from the domain of darkness and transferred us to the kingdom of his beloved Son." How could the Colossian brethren been transferred into the kingdom, if the kingdom has not been established? Jesus has been, and is now, on his throne for almost 2000 years.

**You Can Enter the Kingdom Today** - Our Savior teaches us that we can be born into the kingdom of God in Jn.3:5, "Jesus answered, Truly, truly, I say to you, unless one is born of water and the Spirit, he cannot enter the kingdom of God." county road aid program funds would decrease by \$250,000 to \$1,010,772 because of the expiration of a 5¢ per gallon gasoline tax which expires this fiscal year and was not renewed by the legislature.

The road fund is expected to receive \$1,267,486 with \$100,000 in carryover from this year for \$1,367,486 in total revenue; the jail fund's revenue is estimated at \$847,626 plus \$25,000 in carryover and \$510,570 estimated to be transferred in from the general fund for a total of \$1,383,196; the LGEA fund's estimated budget is \$270,650, with \$20,000 in carryover and \$71,929 transfer in from the general fund for a total of \$362,479 and the 911 revenue is estimated at \$286,050 including \$25,000 in carryover.

The CSEPP estimated revenue is \$312,122 which comes entirely from the federal government. The Forestry fund revenue is estimated at \$15,000; fairgrounds, \$16,000 and LEPC \$2,700.

The official budget has to have two readings by the court before approval and then be sent to the state for their approval by June 30th.

In other action, the court approved the purchase of a new bobcat skid-steer loader with attachments and trailer to be bought under the state bid at an approximate cost of \$50,000. The equipment will be paid for from the general fund so that it can legally be used for work other than the road department.

During the meeting, County Judge/Executive Doug Bishop also announced the appointment of Sam Hampton to the RCIDA board.

Hampton thanked Bishop for the appointment and told the court he looked forward to working to “get jobs in here” and serving the citizens of Rockcastle County.

Hampton, a 1985 graduate of RCHS also graduated from Eastern Kentucky University with a bachelor's degree in computer science and an associate's degree in computer electronics.

He has a long resume of working in the computer industry with several large companies, including NACCO in Berea where he implemented a new computer software system across their entire company,

General Cable Corporation, Systems Software Associates of Chicago, i2 Technologies and Viewlocity.

He currently operates his own company, Momentum Courier, which he founded in 2004 in Alexandria as a small package expediting company. Momentum Courier serves mainly the medical and service parts industries and has expanded to serve the entire state and bordering states.

Hamilton is married to the former Dana Singleton.

annual continuation charge of \$5,000 to CSX for the maintenance of the railroad track and switch in the Rockcastle Industrial Park. She said she talked to a CSX representative and they told her the RCIDA won't be charged the \$5,000 once the former Anchor Packaging building is leased again by another organization.

Hopkins said SourceHOV is currently going through the process of

giving their employees the option of taking a layoff or switching their work hours. She said the option is a result of SourceHOV removing their weekend shift and only working employees on day and night shifts.

Hopkins said that 30 employees opted to take a layoff were not fired. She said that SourceHOV is still in the process of switching their working shifts and if the 30 employees want to come back they will be the “first considered.”

Hopkins said that she has shown the Anchor building to two potential clients in the last month. She said that both were industrial companies and that both companies are currently weighing their options and haven't made a decision.

The RCIDA board members also welcomed Sam Hamilton who was recently appointed to the RCIDA board by County Judge Executive Doug Bishop. Hamilton replaced former board member Robert Lawson who resigned from the board after being arrested and charged with theft by deception.

“Hopefully, I can bring some of my experiences to the RCIDA where I had moved outside of the county for a while,” Hamilton said. “I hope I can bring my industry experience in to bring more industry and jobs into the county.”

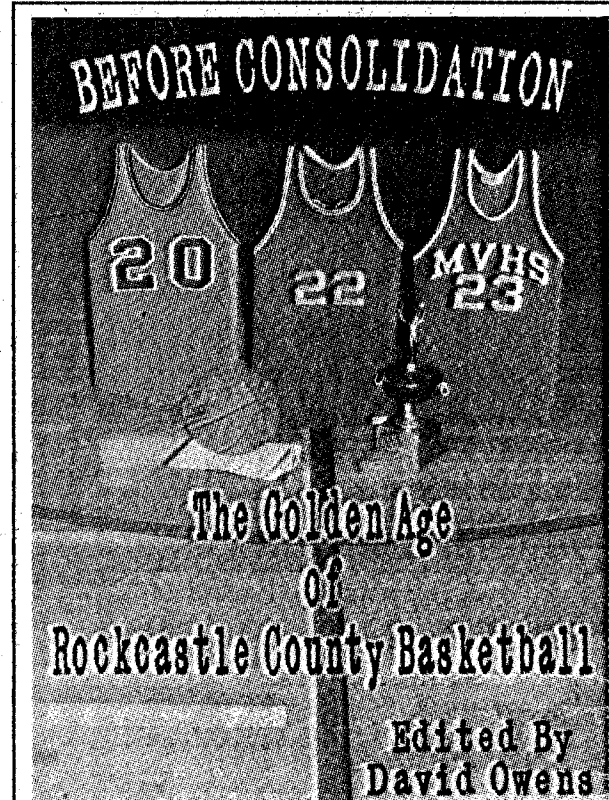

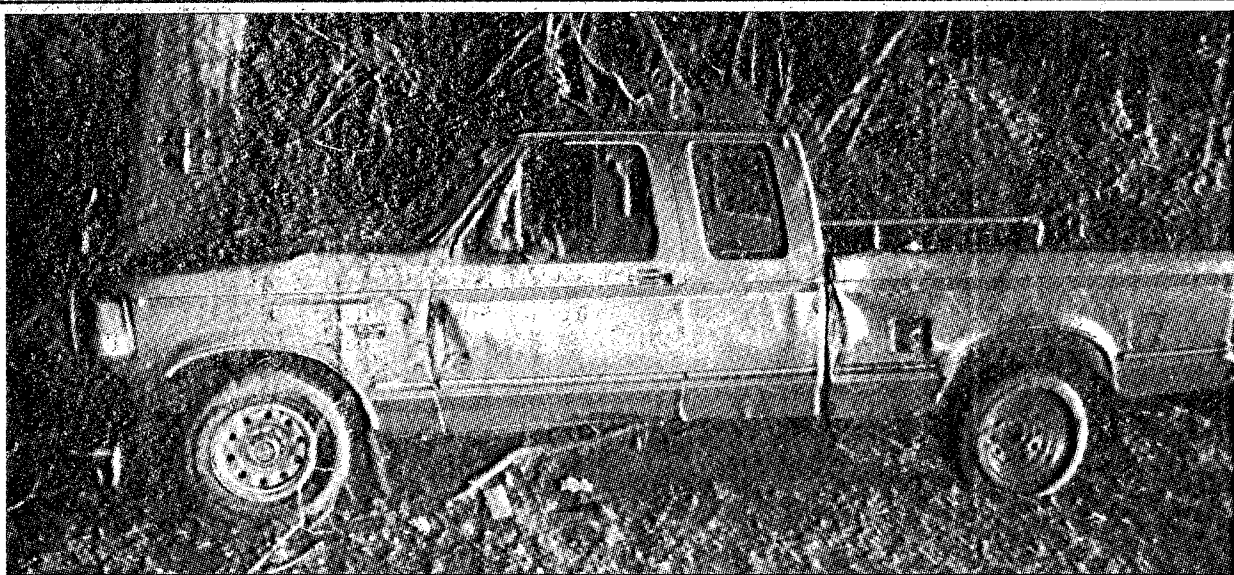

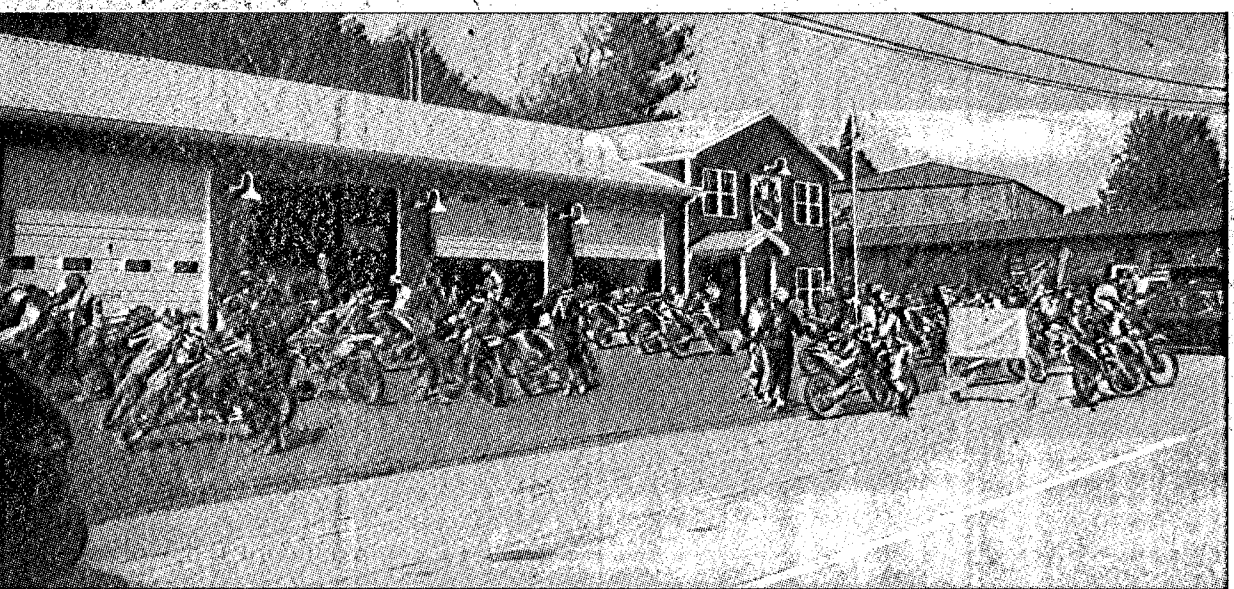

**Money Tips for Students**

**Dealing with debt collection**

If you're having trouble paying your student loans and other debts, you may be contacted by a debt collection agency.

Don't try to dodge a collector. It's in your best interest to work with the agency to work out a payment schedule so you can

pay your debts and start to reestablish your credit.

Most collection agencies abide by the law, but you may be contacted by one that doesn't. In that case, you should know your rights and responsibilities, according to the Kentucky Higher Education Assistance Authority (KHEAA).

The agency must tell you the amount requested and the name of the creditor, as well as what to do if you don't think you owe the money.

An agency trying to collect a debt may not make threats, use tricks to try to get someone to pay or make calls late at night.

If you think a collection agency has violated the law, you can file a complaint with the Consumer Financial Protection Bureau at [www.consumerfinance.gov](http://www.consumerfinance.gov).

KHEAA is the state agency that administers Kentucky's grant and scholarship programs, including

the Kentucky Educational Excellence Scholarship (KEES). It provides financial literacy videos at <http://itsmoney.kheaa.com>. 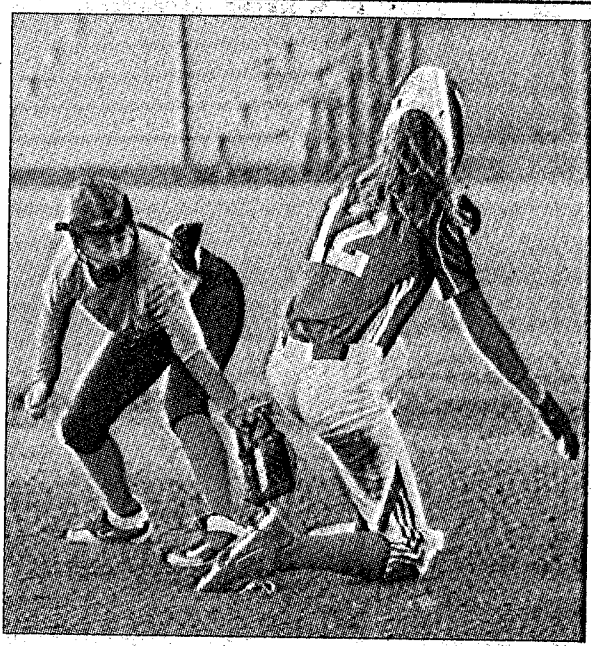

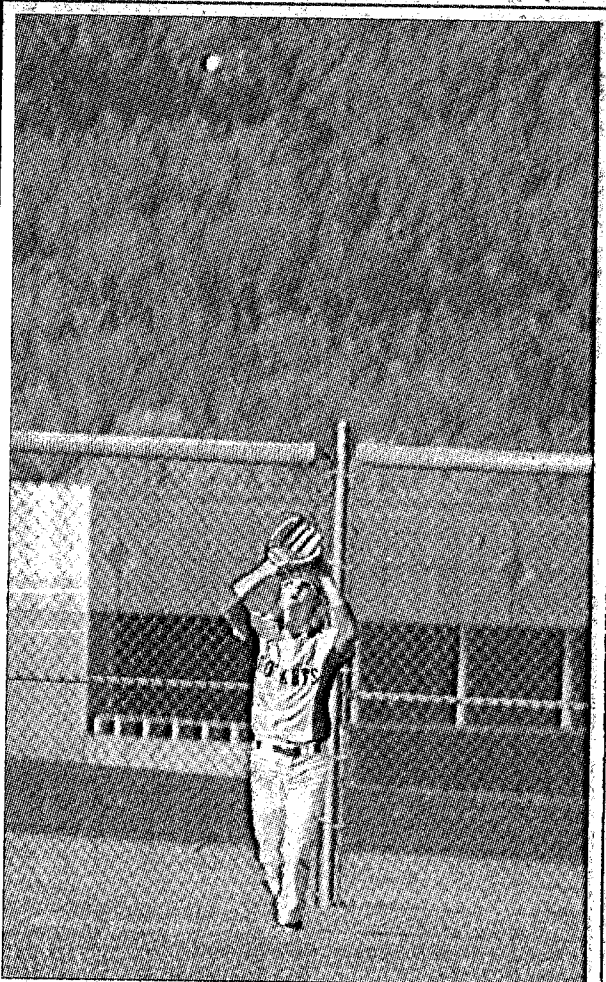

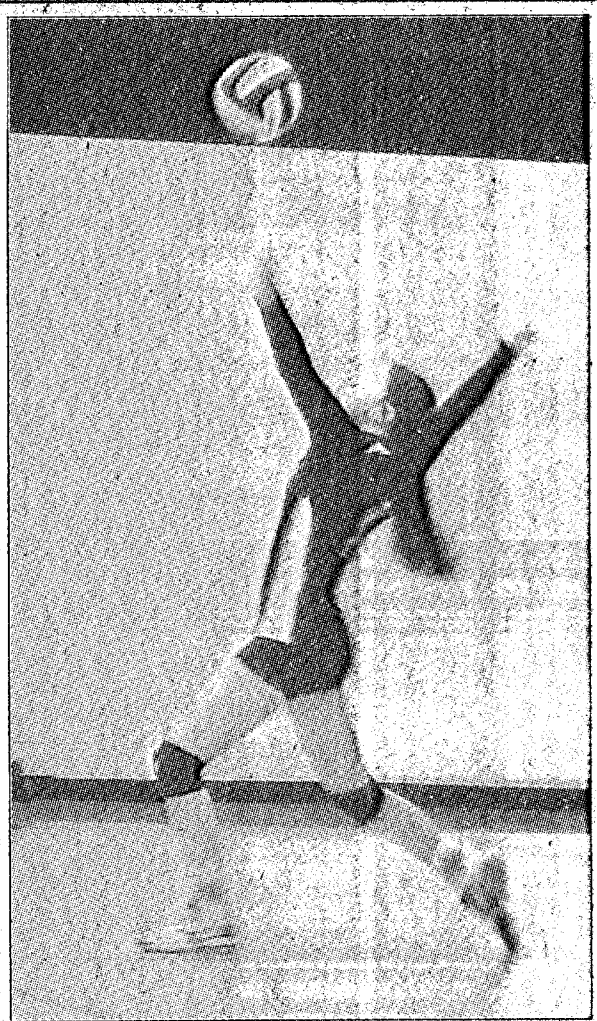

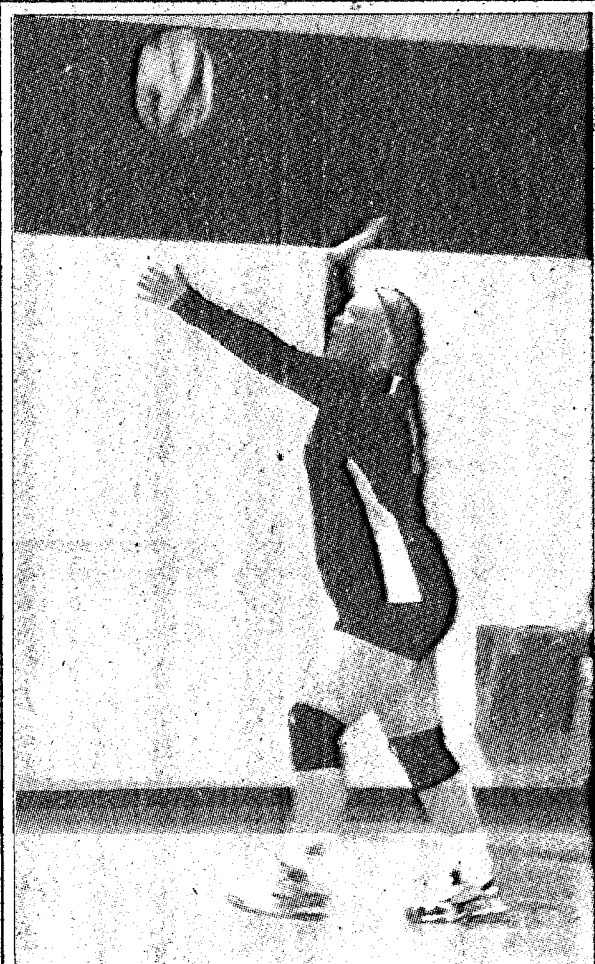

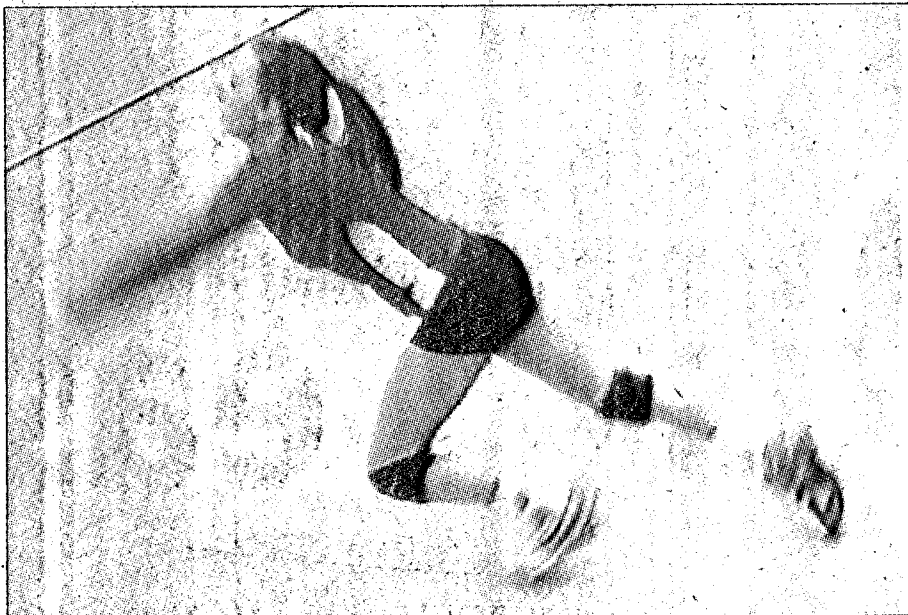

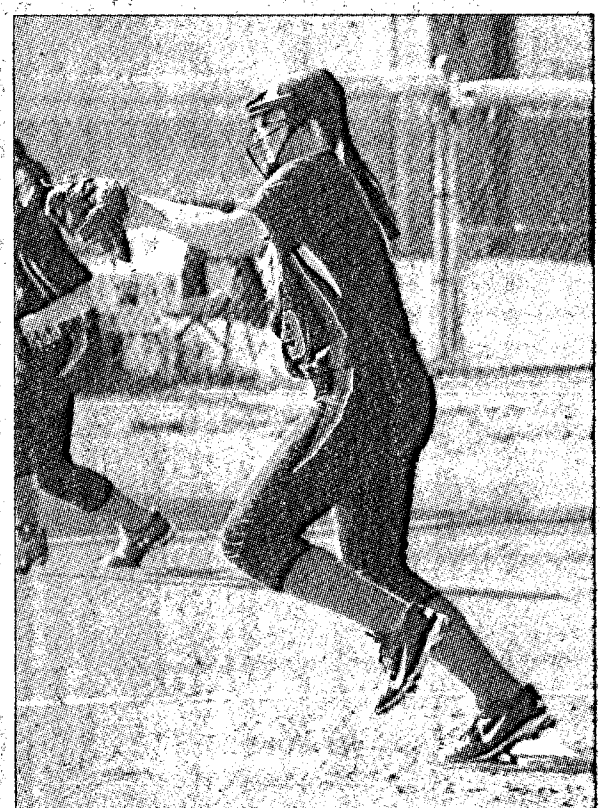

## Hidden Among Us

### The American Revolutionary War Patriots of Rockcastle

To celebrate and honor the county's American Revolutionary War Patriots and to enlighten the community about the service and sacrifice of these brave men, on behalf of the Rockcastle Chapter of the Daughters of the American Revolution, I have compiled highlights of the service of the known patriots living in the county and who applied for a pension between the years of

1818 and 1842. All information was taken from the patriot's own account from his pension application and other historical documents. More information can be found on each patriot at the local library or the Rockcastle Historical Society. (Copyright Pending). **William Henderson**  
Virginia  
William Henderson was born about 1766 in Virginia and died in 1816 in Lincoln Co. KY. According to the widow's pension application, Elendor Henderson a resident of Rockcastle County, KY aged 88 years gave the following account of her husband's service on 6 October 1851. She was the widow of William Henderson, deceased, who as a soldier in the American Revolution and that he entered service in Augusta Co. VA and served a tour of duty in the Army under Colonel Christopher and Captain Lewis. He served other tours under different officers (names she did not know) and her husband was at the Siege of Yorktown and others not recollected.

Mrs. Henderson was married to William by B. ... in Lincoln Co. KY

on 2 July 1790 and that her maiden name was Elendor Clarke. She said her husband died in the year 1816. She had never remarried and was still a widow of William Henderson.

On 6 November 1851 in Rockcastle Co. KY, Mrs. Mary Noake gave testimony that she was the daughter of William and Elendor Henderson and that she had always understood that her father entered the service from Augusta Co. VA about the year 1779 under Colonel Christopher and Captain Lewis and served until the spring of 1782. He served in the Western division and was at Yorktown when Cornwallis surrendered.

A letter written on 3 Dec. 1853 from S/Ro Johnson, Auditor discusses a settlement that was made on the 23 Oct. 1784 in the name of William Henderson as Corporal of Infantry and evidence of the indebtedness of the state to him was L63.14.10, delivered to Colonel Towles but as the original settlements or copies thereof were not to be found in the Auditor of Public Accounts Office-Richmond, the term of service embraced could not be stated. Mrs. Henderson's application was rejected on the grounds that the term of service could not be established.

William died in Lincoln Co. KY in 1816 and his

widow, Elendor died in Rockcastle Co. KY on 12 November 1853. As to date, no descendant of William Henderson as joined the Daughters of the American Revolution.

The children of William and Elendor: William Henderson. He married Elizabeth Lewis. Patsy Henderson (1795KY-after 1870 Rockcastle Co. KY). Lucinda Henderson (1803 Lincoln Co. KY-After 1880

Rockcastle Co. KY) married James Micajah Thompson (1800VA-1877 Rockcastle Co. KY). Children: Joseph, Ellen, Calvin, James and Samuel. Mary Henderson (1790/91-1822IN) married Abraham Noakes (1789KY-1865IN). He was the brother of Patriot, George Noakes, Jr. Children: Andrew, John, Milton and James. Sarah Henderson (1805 Lincoln Co. KY-After 1870).

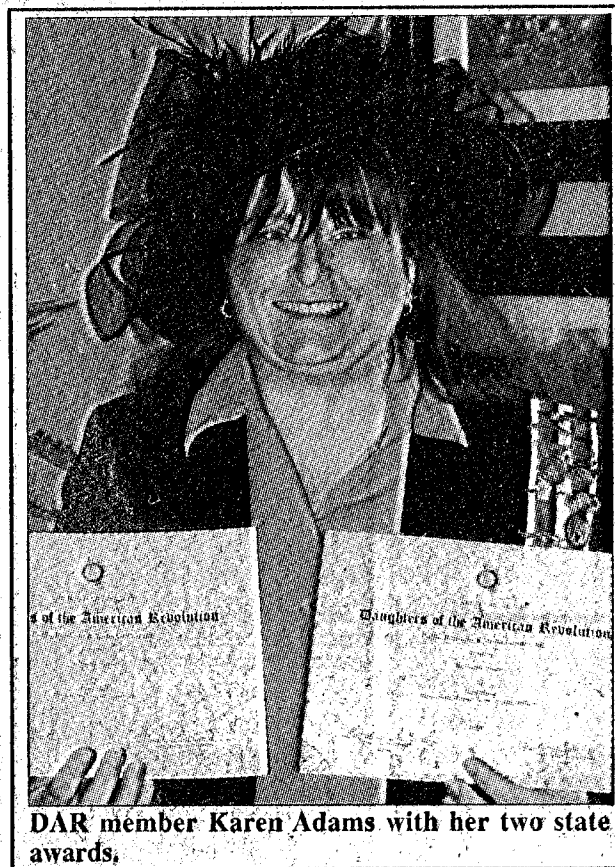


# Rockcastle Chapter DAR honored at State Conference

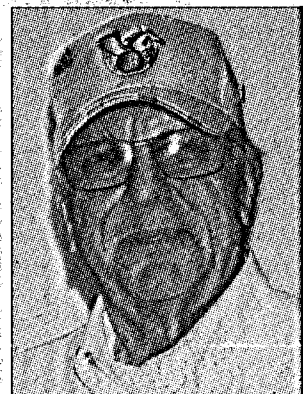

# Mamaw's Kitchen

## VEGETABLE SOUP MIX

Judy, Mum, and Rhonda were visiting me at my dorm when I was a student at Berea College. They had brought me a jar of Mum's home canned vegetable soup mix. Rhonda was about 5 years old and wanted to carry the jar to me. She got excited and started waving at me, forgot about the jar she was carrying, and dropped it. Of course, she dropped it on the sidewalk so the jar broke. She started to cry, but we calmed her. Today she can laugh about it, but at the time it was far from a laughing matter.

8 potatoes, peeled and diced  
4 cups fresh corn, cut off cob  
16 carrots, diced  
4 cups onion, chopped  
8 cups tomatoes, peeled and quartered  
4 cups fresh green beans, broken.  
8 quarts water  
Salt  
Put all vegetables and water in a large kettle. Bring to a boil, reduce heat and gently simmer for 3 minutes. Pack into hot sterilized jars, adding 1 teaspoon salt in bottom of each jar. Seal and process in pressure cooker at 10 pounds pres-

sure for 70 minutes. Remove and cool before storing in a dark, cool place.

**14-DAY SWEET PICKLES**  
Day 1: Wash cucumbers, pack into jars and cover with brine water—1 cup salt to gallon of water. Let stand 7 days.

Day 8: Wash cucumbers and put back in jar. Cover with boiling water. Let stand 24 hours.

Day 9: Drain and cut into desired shape. Add alum (about 1 teaspoon to a gallon of pickles). Cover with boiling water and let stand for 24 hours.

Day 10: Drain and cover with boiling water. Let stand 24 hours.

Day 11: Drain. Mix 2 and 1/2 quarts sugar, 1 bag pickling spices and 2 and 1/2 quarts vinegar; bring to boil and let boil a few minutes. Pour over pickles. Let stand 24 hours.

Day 12: Drain; add 1 quart sugar to liquid. Boil and pour over pickles. Let stand 24 hours.

Day 13: Drain; add 1 quart sugar to liquid. Boil and pour over pickles. Let stand 24 hours.

Day 14: Drain. Heat juice to boiling. Pack pickles in jars. Pour boiling juice over pickles; seal.

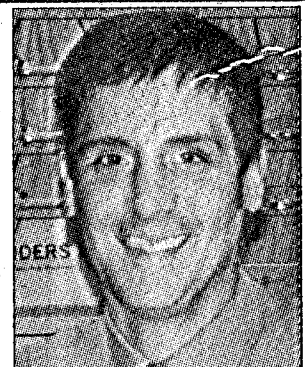

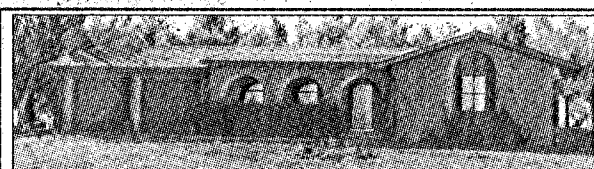
