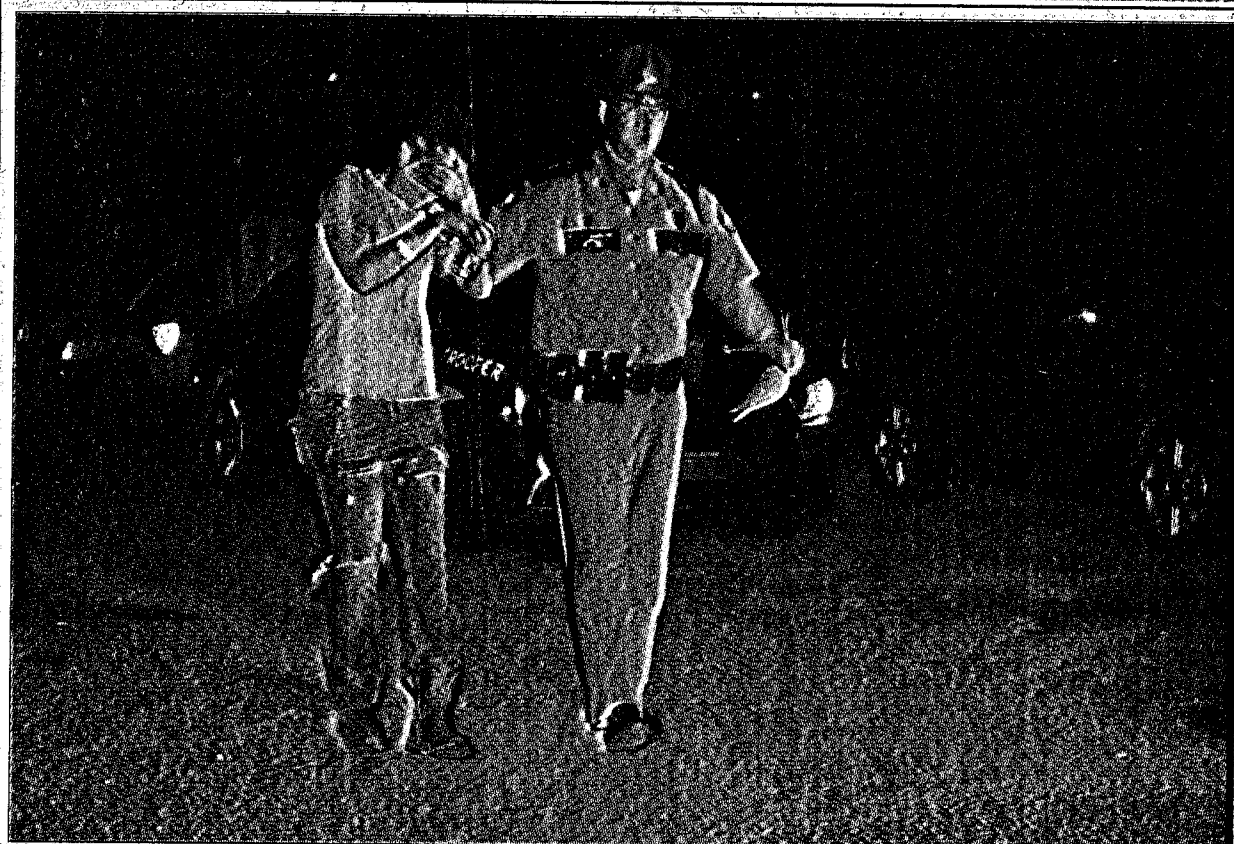

Two Rockcastle County women were arrested last Wednesday night and charged with the murder of Mary A. Hinton, 86, of Livingston, Kentucky. State Police arrested Kimberly Dale Slusher, 35, of Livingston and Tabitha Howard, 30, of Mt. Vernon. Investigators said they have talked to witnesses and found evidence that connects Slusher and Howard to the murder. Both Slusher and Howard pleaded not guilty during their arraignments on Monday. The preliminary hearing for both women will be held Monday, June 22nd at 9:30 a.m. in Rockcastle County District Court. ## Women arrested for murder plead not guilty Monday in District Court

Two women, charged with the murder of a local elderly woman, pleaded not guilty during their arraignments on Monday in Rockcastle County District Court.

Kimberly Dale Slusher, 35, of Livingston and Tabitha Howard, 30, of Mt. Vernon are both charged with the June 2nd murder of Mary A. Hinton, 86, of Livingston.

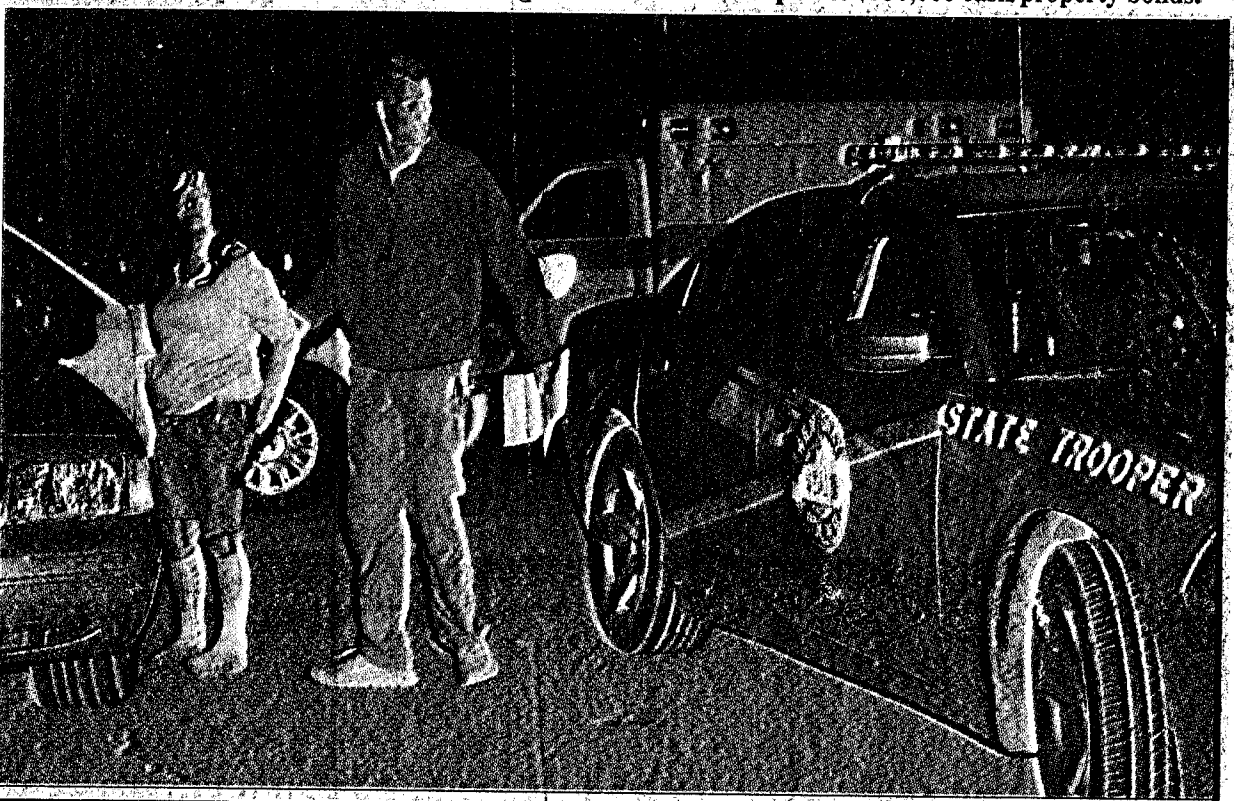
The two women were represented by Public Defender Nathan Shirley. Shirley entered not guilty pleas for both women and he asked that all evidence from the case be "preserved." County Attorney Billy Reynolds suggested that the bond remain the same for

both women and he also agreed that the evidence should be preserved.

District Court Judge Jeffery Scott Lawless ordered that the bonds remain at \$750,000 cash/property for both Slusher and Howard. Their preliminary hearings are scheduled for Monday, June 22nd in Rockcastle County District Court at 9:30 a.m.

According to police reports, a Rockcastle County deputy sheriff responded to Hinton's residence last Tuesday night after receiving a call that led him to conduct a welfare check on Hinton, which is where police are dispatched to a residence to check on the

## Stranded vehicle leads to large drug bust Friday

A man was arrested for possessing a large amount of methamphetamine and heroin after his vehicle allegedly broke down last Friday near the intersection of Hwy 150 and Spiro Road in Mt. Vernon.

Arrested at the scene was Michael J. Kunick, 37, of Louisville.

According to the Rockcastle County Sheriff's Department, Deputy Sheriff Brandon McIntosh was patrolling on Hwy 150 when he noticed a vehicle parked on the side of the road with its emergency lights activated. McIntosh pulled off the road to help the alleged stranded motorist and Mt. Vernon Police Officer Ryan Messinger later assisted McIntosh at the scene.

While officers were approaching the vehicle, they noticed Kunick was extremely nervous and moving around a lot inside the vehicle. Kunick then opened the hood, telling officers that he was checking for "car trouble."

During questioning,

Kunick told officers that he had recently injected a Percocet and officers said Kunick appeared intoxicated while performing field sobriety tests.

After searching the vehicle, officers found seven plastic baggies that contained a crystal rock substance that field tested positive as methamphetamine. Officers also found several small plastic baggies that contained a brown rock and gravel substance that field tested positive as heroin. The meth weighed 19.71 ounces and the combined weight of the heroin was 1.63 ounces.

After further investigation of the vehicle, officers found a box of pseudoephedrine pills and several other items used to manufacture meth. Officers also found a loaded .380 pistol, five cell phones, a small baggie of cocaine and several other drug paraphernalia items inside the vehicle.

Kunick was charged with manufacturing meth-

## Only four dropouts for school year

Several items of business were discussed at the monthly school board meeting on Monday night including the dropout rates for the 2014-2015 school year. Director of Pupil Personnel Becky Issacs shared the

updated dropout rates with the board. According to Isaacs, Rockcastle County Schools only had four total dropouts for the 2014-2015 school year, as opposed to six total dropouts during the 2013-2014 school year.

"All of the four dropouts

were over 18-years-old," Issacs said. "None of them had to have permission from their parents as they were old enough to make the decision."

Issacs said the decline in the dropout rates are due to the district's philosophy of how they work with students or parents of students who are considering dropping out of school. She said students who drop out of

school are encouraged and often go on to get their GED.

Director of Transportation Chris Cornelius presented the bids he had received for five surplus school buses. He said they only received bids from two bidders and suggested that they accept the highest bid for each bus.

## Free Trash Drop-Off Numbers Released

Rockcastle County Solid Waste Coordinator James Renner said 461 Rockcastle Countians participated in the event last month. He said they collected 33 large dumpsters and 34 small dumpsters of trash.

Renner said the county made \$1,326.50 from scrap metal and that the total disposal costs were

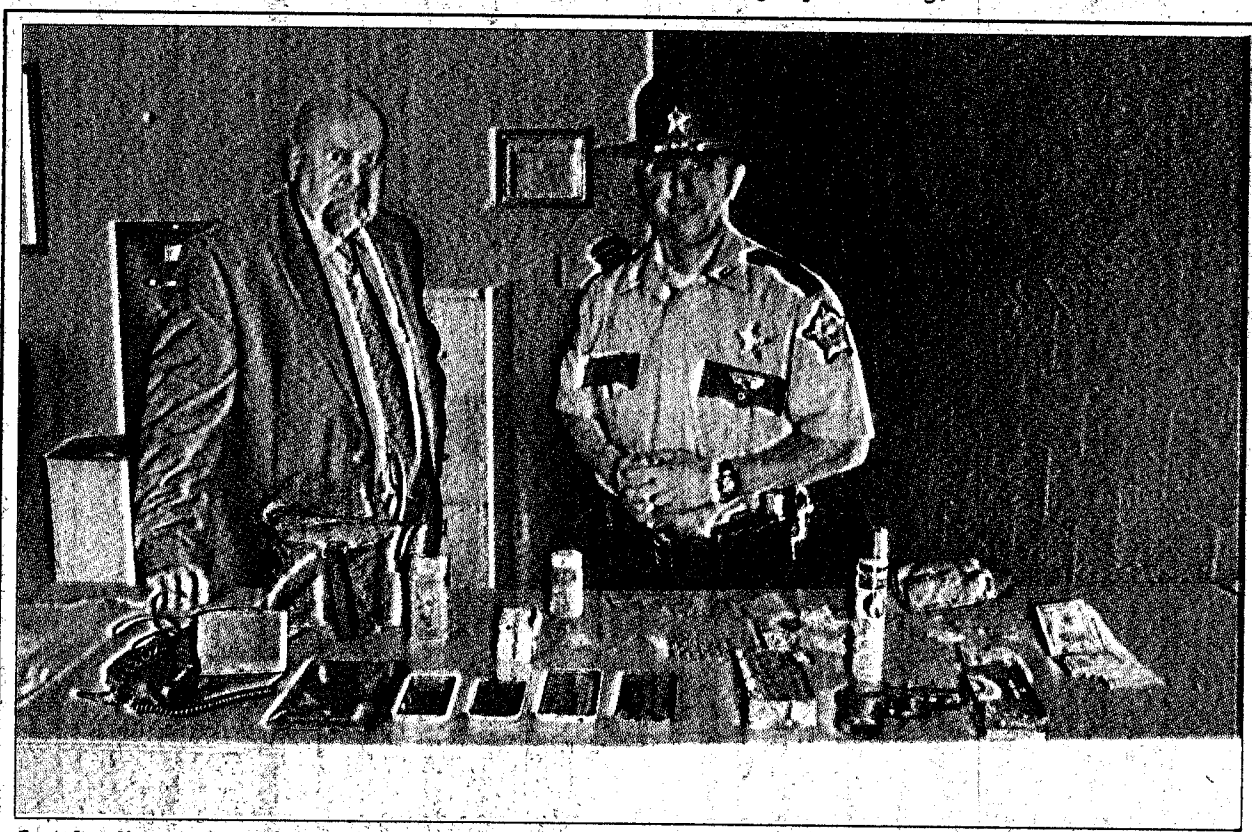

# Points East

No sooner do I brag (last week) about getting up 2 hours before broad daylight on Monday mornings to hit deadlines than I find myself reluctantly crawling out of bed 2 hours after the fact on this one because I spent part of the weekend in a strange bed and found out that I love the one at home a bit more, than I probably should.

Loretta and I are back home after spending a couple of days teaching photography at the Fort Harrod Area Extension Homemakers Craft Camp which took place at the beautiful Lake Cumberland 4-H Educational Center in Jabez, KY. I'm not going to try to tell you how to get there because it would take the rest of the column. Suffice to say that it straddles the Pulaski/Russell County line.

I do, however, encourage you to look it up because the Center is an excellent training/retreat facility that can comfortably accommodate (house and feed) up to 250 people at a time. I have been there for week-long gatherings several times over the decades with groups that had nothing to do with 4-H. Although it is open to the public, this place is still, as far as I am concerned, one of Kentucky's best kept secrets. The web site is or you can simply call 270-866-4215.

Billed as an opportunity to "eat, craft and be Merry", the camp that we attended, hosted by Garrard County Extension Homemakers Association, offered opportunities for adult women "campers" to choose up to 3 craft projects, from over 50 possibilities, they could complete during the camp. Listing all of them would consume the rest of my space. However most of them involved sewing, crocheting, jewelry, wood-working or a combination of those skills.

I believe our photography class was the sole exception unless taking pictures of people involved in those activities counts.

Besides myself 2 other instructors and 2 cooks, there were no other me on the place with, I'm guessing,

over 60 women. Believe it or not, I actually like those odds for relatively short durations but I'm reasonably sure I'd tire of them after a week or so.

Loretta and I have been teaching week-long day camps to 4-H kids for decades. We quickly discovered that it was impossible to condense more than 40 hours of lessons into a few sessions that lasted a combined total of 6 classroom hours. We managed to cheat by talking our participants into getting up 3 hours before breakfast and devoting most of their after dinner time until pitch dark to playing with their cameras when the outdoor, natural light is at its best.

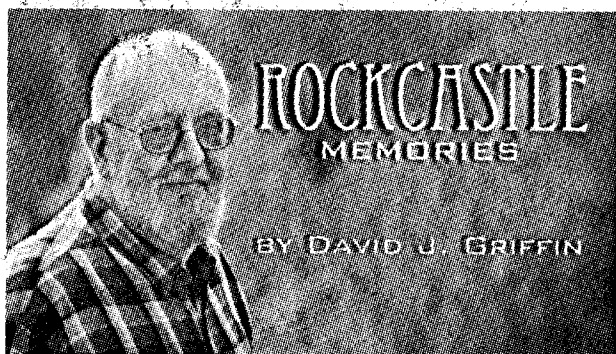
When we started doing this, digital cameras were practically unheard of and certainly not commercially available but it's been at least 10 years since I last touched a film camera, at which point I was trying to sell a \$1,500.00 Nikon film camera for 50 bucks.

When we started, we had to convince a dozen or so "twens" to spend an entire week exposing just one 24 or 36 exposure roll of film because they needed to be economical with the cost of film and processing. The last group with whom we spent a week probably averaged over 1000 frames per roll. The notion of working until you get it right before you hit the shutter release evolved into shooting the subject dozens and dozens of times until you got something you found pleasing to the eye.

That convenience requires a very, very radical change in philosophy in the way one goes about teaching photography because the principle of patience flies right out the window and the bottom line is that it is far more difficult to teach digital photography than it is to teach film because of the difficulty in making kids sit still long enough to grasp a new concept.

However vastly different digital photography is from film, there are still hundreds

### Free Range Chickens

For as long as I can remember, I have been purchasing free-range chicken eggs. I suppose my selection is because that was our choice when I was a youngster in Rockcastle County. My mother and I lived with my grandparents on their hillside farm in the Pine Grove section of the county. (When my wife refers to free-range chickens, she calls them "happy chickens.")

Mommie Katie (my grandmother) had a slew of chickens that had the run of the yard during the day. In the evening, they rambled back to the chicken house to roost. When she did not want them in her yard for some particular reason - company or a special occasion to be outside - she simply closed the gate to the chicken yard, and they stayed inside the fenced in area.

As a family, we used those crazy birds for a variety of reasons. Some of them were "layers," and Mommie Katie babied those as if they were her children. She fed them, made sure they had plenty of water, and collected the eggs every day. Occasionally, she would allow one of the prized hens to sit on a bed of eggs in order to replenish the chickens that we ate for Sunday dinner.

Sunday dinner - a topic that always brings a smile to my face. Is it just in the south or did everyone have fried chicken on Sunday?

My grandparents had different ways of performing the same tasks. If Pop was told to kill a chicken for a meal, he grabbed one, laid its head over a chopping block and cut the head off with an ax. If Mommie Katie was doing the same chore, she snatched one up and "wrung" its head off with a quick twist of her wrist. Either way, the chickens were allowed to flop in the yard until the blood stopped flowing. The bird was then cleaned and brought into the kitchen so that Mommie Katie could perform her magic.

Anyone who is a regular reader of this column already knows that Mommie Katie was probably the best cook I have ever known. Her fried chicken was one of my favorites of her awesome dishes. She took great care to clean and cut up the bird so that each of us could have our preferred piece. Then she retrieved her big old black iron skillet and fried that chicken until it looked like one in a television commercial. Of course, she used bacon grease to fry her chickens. That iron skillet had an iron lid, and you could hear the grease pop-

ping every time she raised the lid to check on her bird.

In order for the chickens to lay fertile eggs, we also had to have a rooster or two in the chicken yard. Those were Pop's prized birds. He took care of them like Mommie Katie did with her hens. He allowed the roosters to live a long time before they became Sunday dinner. Occasionally, one of the roosters would decide to "flog" Pop when he was bent over taking care of his lawn mower or some other chore in the yard. It absolutely infuriated him - the result of which was that he kept that particular bird in mind when Mommie Katie next instructed him to fetch a chicken for a meal. No one ruled the roost on that farm except my grandfather! (Pun intended.) Frankly, I believe that there was a trace of a smile on his face as he chopped off the head of a feisty rooster.

When I was quite young, Mommie Katie allowed me to stand on a stool in the kitchen so that I could watch when she cut up a chicken for a meal. It always amazed me when she found a glob of eggs that were not quite ready to be deposited into the bird's nest. As we all are aware, the egg's shell is hardened when the egg is laid and comes into contact with the air. I was amazed the first time I saw a chicken lay an egg while running in the yard. The shell was rubbery as it hit the ground and actually bounced before the shell hardened. That did not happen often because Mommie Katie had them trained to lay the eggs in their nests. You wouldn't believe how neat and clean those nests were for her prized hens; they were immaculate.

So these days when Kat tells me to pick up a dozen eggs to bring home, I pick through the eggs to retrieve my favorites - brown, cage

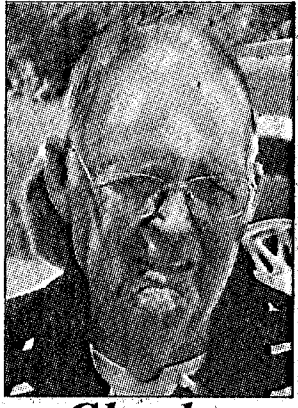
## Ruby Long

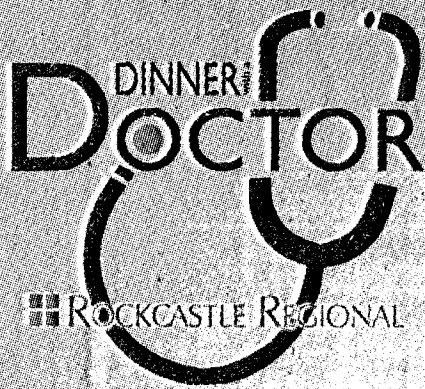

wellbeing of the resident.

Once the deputy sheriff arrived around 11 p.m., he found Hinton dead inside her home. When other officers arrived, they observed that Hinton's residence had been burglarized and that Hinton died from apparent blunt force trauma during an assault.

After further investigation, officers talked to witnesses and found evidence in the home that reportedly connected Slusher and Howard to the murder.

Last Wednesday morning, officers learned that Slusher and Howard were in the Copper Creek community on Jones Lane in Crab Orchard. Once officers arrived, the two women fled into the woods and officers pursued but could not find them.

A Kentucky State Police K-9 and helicopter, were then dispatched to the area to aid officers in the search. Moments later, the K-9 located Slusher and Howard in a briar thicket. Officers noted that the two women would not “come out with their hands up” and that it was also believed one or both of the women had a firearm.

After failing to surrender themselves to police, both women were bitten by the police K-9 and detained moments later. They were both treated for minor injuries.

During questioning, Slusher confirmed that she

was at Hinton's residence during the time of the assault. She also told police that Howard was with her as well.

Slusher went on to admit she had unlawfully entered Hinton's residence and that she had direct physical contact with Hinton while she was still alive. Officers also said that the recovered clothing, belonging to Slusher, had red blood stains on them. Slusher admitted to police that the blood belonged to Hinton.

Officers also interviewed Howard during the investigation. Howard told officers that she went to Hinton's residence with Slusher for the purpose of theft. She also told officers that she unlawfully entered the residence and observed the assault.

Howard further stated that Slusher acted alone in the assault. Officers said that they also found clothing belonging to Howard with the victim's blood on it.

Upon further investigation, officers received information that Slusher and Howard attempted to burn Hinton's purse in the area of Jepp Hill Road in Livingston. Officers believe the women attempted to burn the purse because they knew it could be used against them if they were apprehended.

Officers later confirmed the purse belonged to Hinton. During questioning, Slusher and Howard both admitted that they attempted to destroy Hinton's purse.

County Attorney Billy

Reynolds said that this is a tragic murder that has shocked a lot of people in Rockcastle County.

“It's a horrible and tragic incident that has left a lot of people upset and uneasy in the community,” Reynolds said. “I know there is nothing I can do to bring her back, but I will do everything I can to make sure they are put away.”

Slusher and Howard were both charged with murder, resisting arrest, first degree robbery, second degree burglary, tampering with physical evidence, fleeing or evading police and public intoxication. Slusher was also separately charged with possession of a controlled substance (methamphetamine) and drug paraphernalia.

Both Slusher and Howard remain lodged in the Rockcastle Detention Center on separate \$750,000 cash/property bonds.

pressive 5th place team finish.

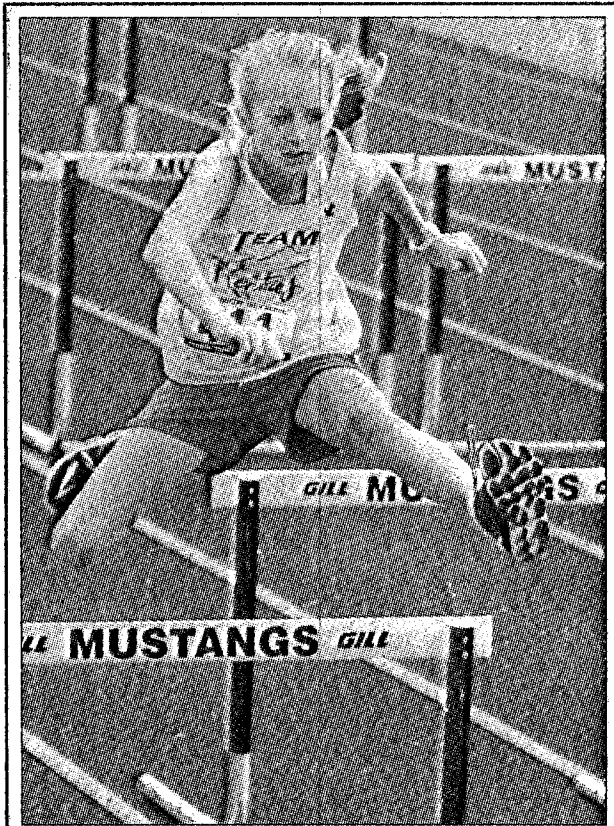

Cornelius went on to say that the five buses had outlived their time of service and that the highest bids on all five buses came to a total of \$10,806.

The board agreed to sell all five buses to the highest bidder for a total of \$10,806.

Finance Director Jason Coguer presented the insurance package for the 2015-2016 school year.

Coguer said the district's insurance producer told them that insurance companies weren't insuring school districts as much as they did in the past. He said that the coverage in this year's insurance package had not changed from last year.

Coguer presented all the quotes to the board. He said the total premium for this year is \$166,579, which is up from \$150,000 last year.

Coguer said the highest quote they received was for \$180,000. He said the premium increase was largely due to an increase in "fleet insurance" across the state.

"The fleet insurance includes the insurance on school buses," Coguer said. "The increase was because of several school bus accidents that have happened throughout the state. It had nothing to do with anything in our district."

However, Coguer said the "bright spot" was the premium for workman's compensation insurance this year will be \$78,000 as opposed to last year's premium of \$111,073. He said this was largely due to employees being "conscious" about safety in the workplace.

The board unanimously passed the insurance package for the 2015-2016 school year.

In the final item of business, the board approved the bid for the boiler replacement project at Mt. Vernon Elementary School.

The project calls for the school's old coal boiler to

be replaced with an electric boiler. ND3 Group Specialist Scott Noel told the board that they received two bids for the project and that the lowest bid was \$281,500.

Noel said they will start preliminary work on the boiler replacement project next week and that they hope to have the project completed in approximately 60 days. He said the project will not interfere with any of the employees working schedules during the summer and that they plan to have the project completed before the start of the 2015-2016 school year.

The board approved the bid for MVES boiler replacement project at \$281,500.

Director of Food Service and Health Jamie Lear said that the district is still waiting to hear from their Community Eligibility Provision (CEP) application. She said they are expecting the results of their application by the end of next month.

Approval of the application would mean that all school children in the district would receive free breakfast and lunch.

Of course, the board would still have to approve participation in the program.

The Superintendent's Personnel Action Report showed five certified hirings of Derrick Bussell as BES principal, Aaron Rupard as RCHS health/PE teacher and assistant girls basketball coach, Vanessa Howard as RCHS health/PE teacher and Amanda Bowling as a RCHS math teacher.

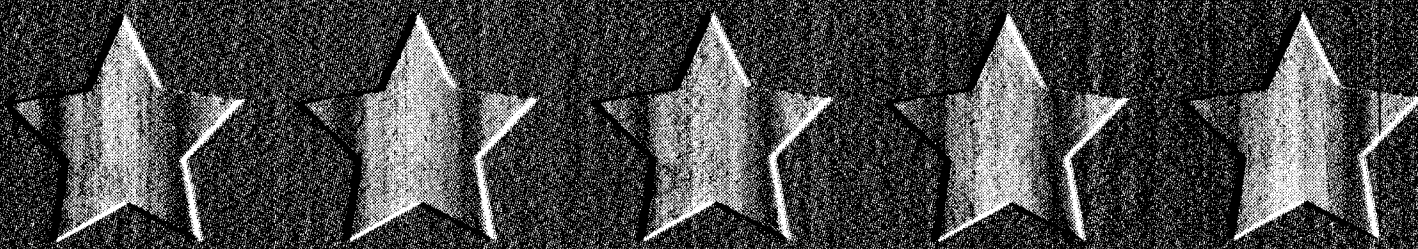

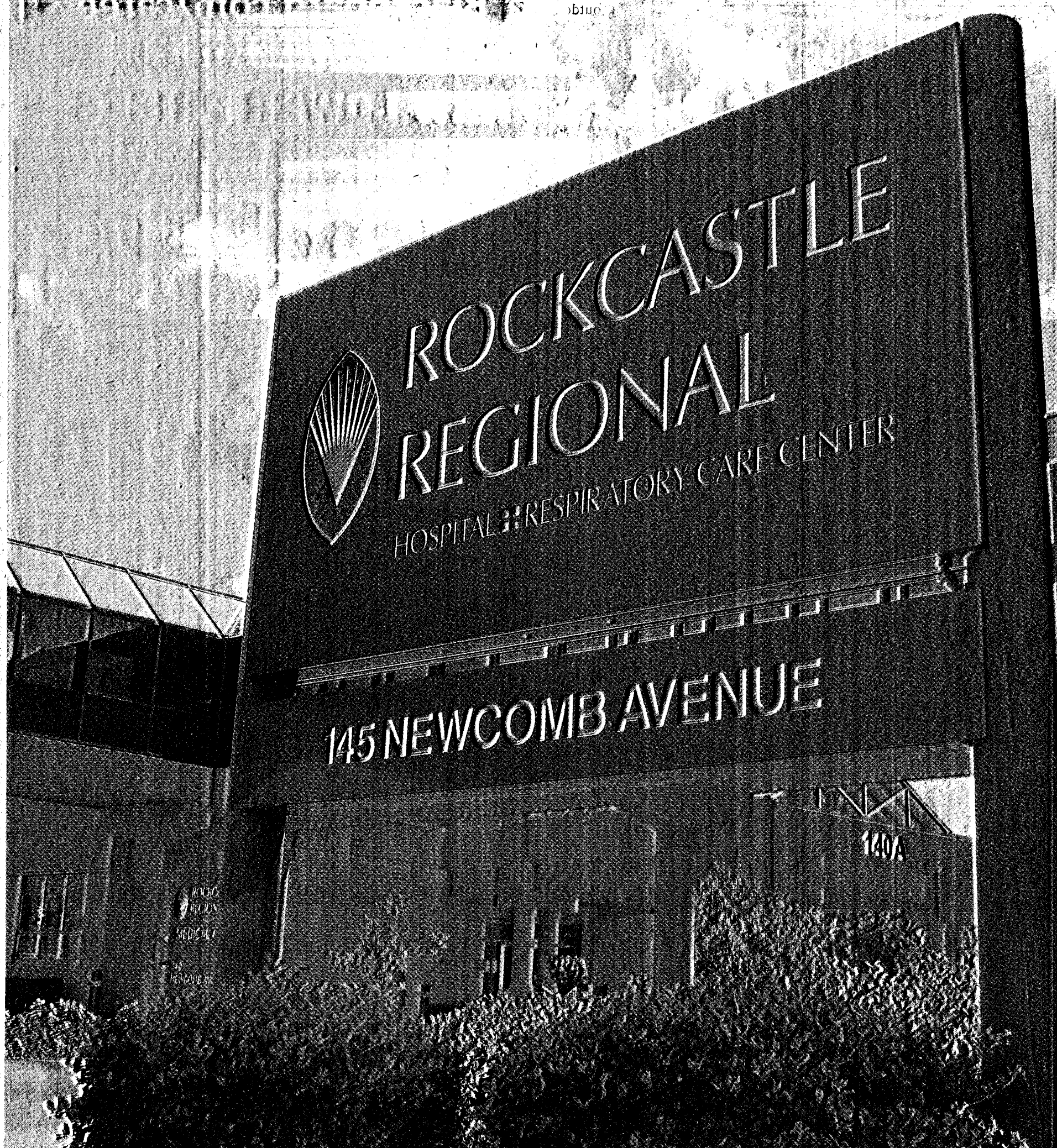

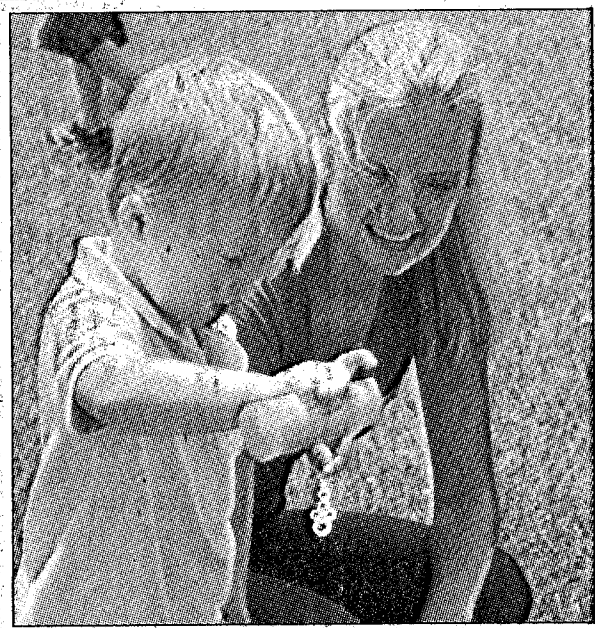
provided by the Community Mission Team and other donors.

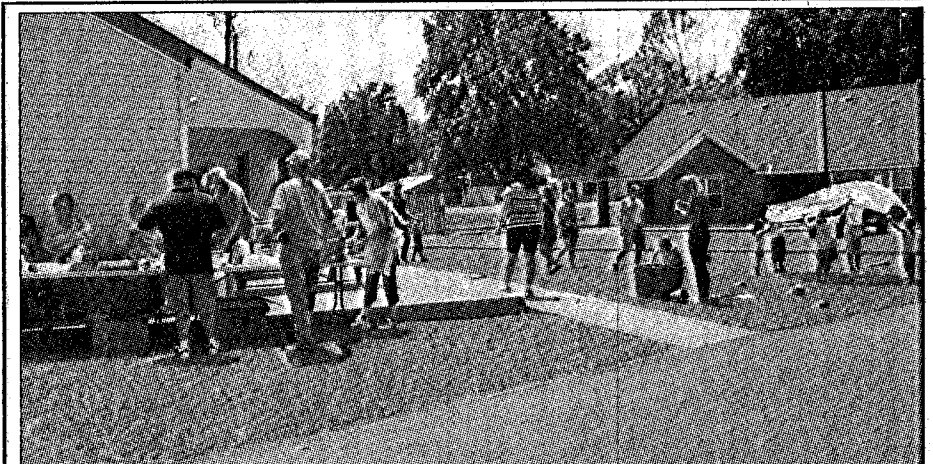

## UNITE Service Corps celebrates successful year

Members of UNITE's Service Corps have been tutors, teachers, mentors and coaches throughout this past school year.  
 "They have educated, they have been role models, and they have served," said Nancy Hale, UNITE president/CEO, during a year-end celebration for the AmeriCorps program on June 4 at the Mountain Arts Center in Prestonsburg.  
 As drug prevention educators "you have been the messenger" to thousands of elementary school students, said Hale, who served as Co-Program Director until earlier this year. "Kids who receive drug education early are far more likely to avoid drugs later in life."  
 "Doing community service not only makes a difference to those who are being served, but to those who provide the service," Hale concluded. "Everything you do, everything you say is going to have a lasting impact forever."  
 For the 2014-15 school

year, the UNITE Service Corps placed 44 AmeriCorps members at schools in Bell, Breathitt, Harlan, Johnson, Knott, Laurel, Leslie, Owsley, Perry, Pike, Rockcastle and Wolfe counties, as well as the East Bernstadt Independent school system.  
 AmeriCorps members provide math tutoring, teach the "Too Good for Drugs" and "Healthy Futures/Take 10" wellness curriculums, and coordinate anti-drug UNITE Clubs. In addition, members participate in their local UNITE Community Coalitions and recruit caregivers who provide thousands of hours for school prevention activities.  
 As of mid-year, the most recent stats available, UNITE Service Corps members had tutored 2,459 students in math and provided mentoring to 3,815 students, said Eugene Newsome, USC Program Director. The overall growth in math test scores was 42.42% -- the highest

rate of success for individual students in program history -- and the average increase in drug education knowledge was 40.53%.  
 "This is a very good day, but also a very sad day," said UNITE Education Director Debbie Trusty. "We celebrate what you have done, but are sad that we say good-bye to so many excellent members."  
 The event was also an opportunity to introduce Melinda Kincer, a retired Rockcastle County educator, as the new UNITE Service Corps co-program director.

Water - Essential for Life

This report is designed to inform the public about the quality of water and services provided on a daily basis. Our commitment is to provide our customers with a safe, clean, and reliable supply of drinking water. We want to assure that we will continue to monitor, improve, and protect the water system and deliver a high quality product. Water is the most indispensable product in every home and we ask everyone to be conservative and help us in our efforts to protect the water source and the water system.

We treat surface water from Lake Linville. Activities and land uses upstream of Mt Vernon Water Works' source of water can pose potential risks to your drinking water. Under certain circumstances contaminants could be released that would pose challenges to water treatment, or even get into your drinking water. These activities, and how they are conducted, are of interest to the entire community because they potentially affect your health and the cost of treating your water. Activities immediately upstream of your water supply intake are of special concern because they provide little response time to the water system operators. An analysis of the susceptibility of the Mt. Vernon water supply to contamination indicates that this susceptibility is generally moderate. Areas of concern are: agricultural activity, septic systems, highways. An assessment of the watershed can be obtained from: City Hall (606) 256-1437, Kentucky Division of Water (502) 564-3410 or Cumberland Valley Area Development District.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects may be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and may pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: Microbial contaminants, such as viruses and bacteria, (sewage plants, septic systems, livestock operations, or wildlife). Inorganic contaminants, such as salts and metals, (naturally occurring or from stormwater runoff, wastewater discharges, oil and gas production, mining, or farming). Pesticides and herbicides, (stormwater runoff, agriculture or residential uses). Organic chemical contaminants, including synthetic and volatile organic chemicals, (by-products of industrial processes and petroleum production, or from gas stations, stormwater runoff, or septic systems). Radioactive contaminants, (naturally occurring or from oil and gas production or mining activities).

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water to provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Some or all of these definitions may be found in this report:

- Maximum Contaminant Level (MCL)** - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG)** - the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Residual Disinfectant Level (MRDL)** - the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

- Action Level (AL)** - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system shall follow.
- Treatment Technique (TT)** - a required process intended to reduce the level of a contaminant in drinking water.
