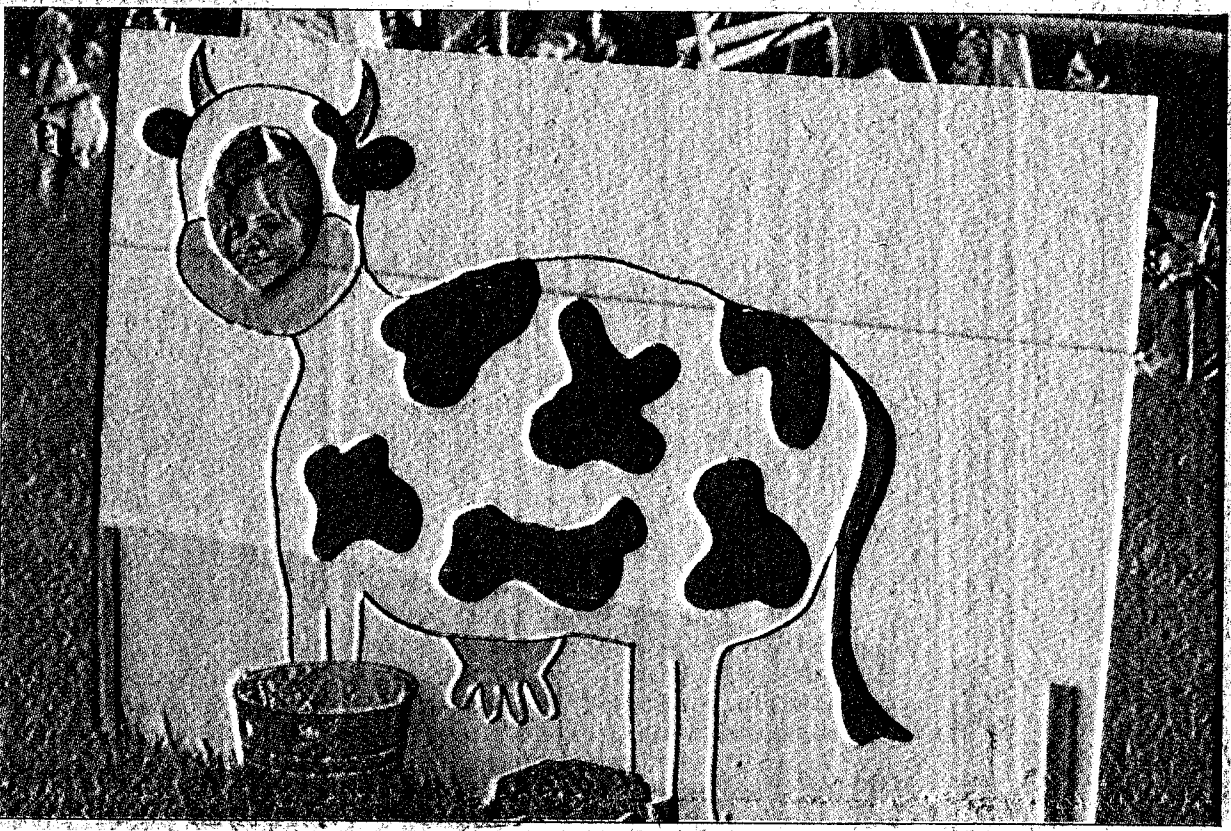

## Judge finds probable cause to hold suspects in murder case

 After a preliminary hearing Monday morning, District Judge Jeffery S. Lawless said there is probable cause to hold trial for Tabitha Howard, 30, of Mount Vernon, and Kimberly Dale Slusher, 35, of Livingston. The two suspects cases are headed to the Grand Jury.

The two are accused of a list of crimes including murder, burglary and robbery in connection with the death of 86 year-old Mary A. Hinton of Red Hill. Hinton was found bludgeoned to death in her home after a welfare check by

Kentucky State Police on June 2nd.

During the hearing, County Attorney Billy Reynolds presented two KSP officers to testify about the events that led to the arrest of Howard and Slusher.

Gruesome details of the attack on Hinton were revealed as officers recounted interviews with the two subjects as well as bloody items recovered at the scene and at a "burn site" where the subjects allegedly tried to destroy items taken from Hinton's residence.

 A Golden Alert has been issued by Rockcastle Emergency Management. According to reports, Gerald M. Chandler, 77, of Livingston, was reported missing yesterday.

I have a massive respect for law enforcement, teachers and all those who work for the good of others. I hope that respect will show through in stories I write for your hometown newspaper.

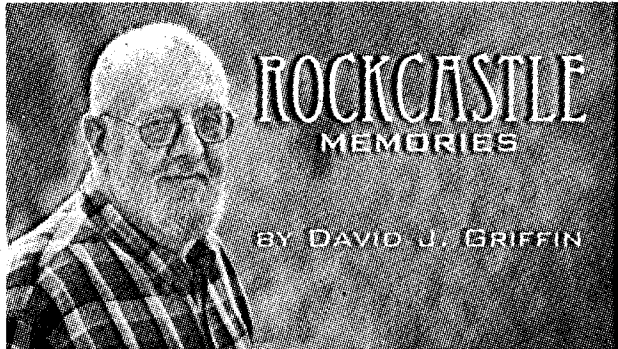
I have a personal lean towards human interest stories and enjoy writing things besides bad news from time to time. I plan to present some of these ideas to those I work with.

### Catalog Takes Me Back

Because my wife and I receive so many catalogs in the mail, the staff of our local post office once dubbed my wife the "catalog queen" of Powell County. Because she does a lot of shopping for ordinary items on the internet, we consistently receive multiple catalogs in the daily mail. We both enjoy looking over them and discovering items that are newly available.

One of my favorite catalogs is The Vermont Country Store. Recently, while glancing through the pages of the most current issue, I noticed that so many of the items reminded me of life in the 50's with my mother (Bee) and my grandmother (Mommie Katie). Some of them are as follows.

The first item that made me recall my youth with my grandmother was an old "heavy duty" oilcloth. The description reads: "This is a wipe-clean real fabric that won't peel or crack." Mommie Katie always used an oil cloth to cover her outdoor tables when we were having a meal under a shade tree. I have no idea how many she had or from whence they came, but they were always used. I can visualize her covering the table and then using a clean rag to wipe down the oilcloth down so that it would be clean enough to eat off of - literally. The one that I distinctly remember was red and white checked. Some people may not even know the difference between the plastic tablecloths of today and those made with oil cloth, but believe me there is a lifetime of difference between the two. Oil cloth will last for decades.

Another item that caught my eye was a floral chenille bedspread because every bed in my grandmother's house had a 100 percent cotton chenille bedspread on it. The same was true for Bee's beds. I remember being absolutely thrilled when Bee allowed me to get a UK Blue spread for my own bed. I thought I had the coolest bed that I had ever seen. Of course, I had been a true-blue fan for as long as I could remember.

A few pages into the catalog, I also noticed something that even reminded me of my grandfather (Pop). The ad stated: "Human-Powered Green Mountain Mower - No noise, No Gas, Good Exercise." My earliest memories of Pop mow-

ing his yard are seeing him use what came to be called a "push mower," that is, it was powered by nothing more than his own muscles. I remember him allowing me to push that mower, but I also recollect that I did not last very long at it. It took some substantial muscle to cut the grass with that mower. And speaking of

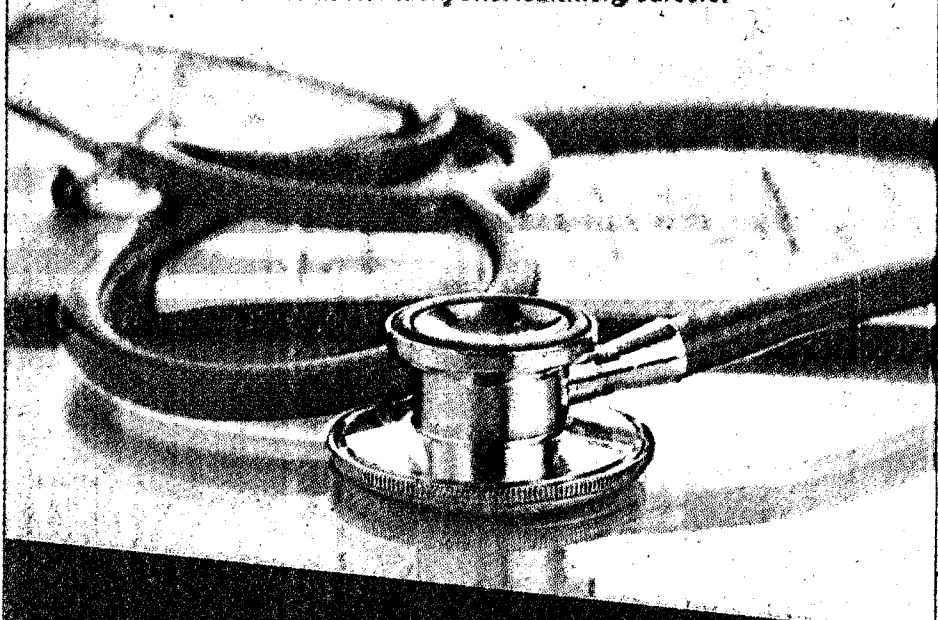

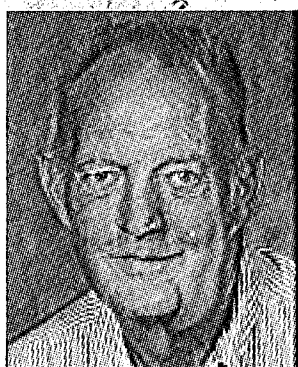

## Oil painting demonstration by Mount Vernon Artist

On Saturday, July 4, artist Carl Von Fischer, of Mount Vernon, will demonstrate his oil painting techniques from 10:30 a.m. to 3:30 p.m. at the Kentucky Artisan Center at Berea.

Von Fischer grew up in Cincinnati, and absorbed creativity directly from his parents. Von Fischer's mother was a basket maker and weaver and his father was a painter and a designer for Gibson cards. Von Fischer can remember taking a bus or streetcar to the Cincinnati Art Museum as a youngster.

"Almost every week, I would spend hours going from painting to painting. The ones that really caught my eye were the great Western paintings. I knew early on - that one day I would paint - where and when I didn't know," he said.

At age 16, he worked in Glacier National Park, affirming his love of the Western landscape.

After graduating from high school, Von Fischer joined the military and was deployed to Germany. Upon his return to Cincinnati, he attended the Central Art Academy, studying commercial art, and graduated with top honors.

Von Fischer then worked for advertising agencies in Cincinnati; Pittsburgh; Denver; and Greenville, South Carolina, before opening his own advertising agency.

After five years running his own business, he sold it to his partner and moved out west to Missoula, Montana. There he began to teach himself to paint in earnest, often painting in the open spaces of the West.

## Safety precautions with fireworks to help prevent eye injuries

Fireworks are a tradition that go hand-in-hand with the Fourth of July.

But all too often, that tradition can lead to injury. That's why the Kentucky Optometric Association is urging families to take precautions to protect themselves and their children against the potential dangers of fireworks.

"Safety should always be the top priority when celebrating with fireworks," said Dr. Aaron McNulty, an optometrist in Louisville. "Children are especially vulnerable to injury from fireworks, particularly sparklers because they are handled at such close range."

According to the U.S. Consumer Product Safety Commission, there are more than 11,000 fireworks-related emergency-room visits annually, and 65 percent of them occurred in the weeks surrounding July 4. Eye injuries account for many of those visits.

To help prevent eye injuries during fireworks season, the Kentucky Optometric Association recommends the following tips to help protect and preserve eyesight during the Fourth of July holiday:

•Don't allow children to handle fireworks, and never leave them unsupervised near fireworks.

•Wear protective eyewear when lighting and handling fireworks of any kind.

•Store fireworks, matches and lighters in a secure place where children won't find them.

•Don't buy sparklers. Heating up to 2,000 degrees or hotter, sparklers are the No. 1 cause of fireworks injuries requiring trips to the emergency room.

•Be aware of your surroundings, and only light fireworks when family, friends and children are at a safe distance.

"If a firework-related eye injury occurs, always follow up with a full optometric eye exam," McNulty said. "An optometrist will help ensure that the injury heals correctly and will continue to monitor for future vision problems."

contribute heavily to tomato health as does powdered neemseed and certain fungicides. Anyway I came up with a way to mix all

these ingredients together into a soluble base a few years ago that allows me to fight insects, fungal disease, blossom-end-rot and feed the plants all at the same time out of the same watering can with the same application.

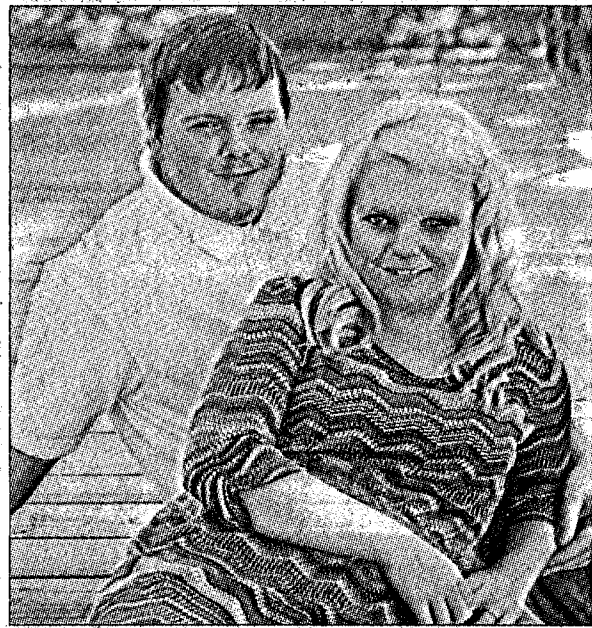

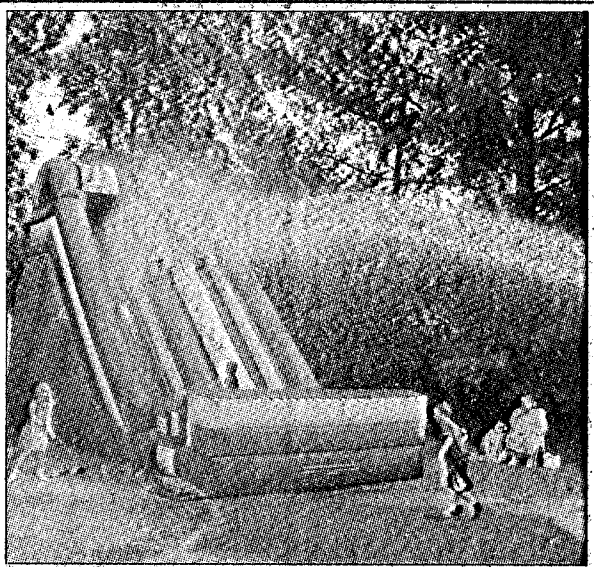

## Mamaw's Kitchen

### DEBBIE'S POTATO SALAD

5 pounds red skinned potatoes (chopped in large pieces)  
 3 or 4 stalks of celery (finely chopped)  
 1 and 1/2 to 2 small bunches scallions (green tops only, finely sliced)  
 1 container (16 ounce) sour cream  
 1 and 1/2 to 2 cups mayonnaise (depending on how wet you like it)  
 2 tablespoons whole celery seed  
 Salt to taste  
 Bring large pot of water to boil. Leave skin on potatoes, clean and cut off any bad spots, chop in large pieces and boil for 25 minutes. After potatoes cook, cool them either in the refrigerator or under cold water (water is much faster). Drain and place potatoes in very large bowl; slice up any large pieces while combining all ingredients well. Refrigerate for at least one hour then enjoy!

1/3 cup sweet pickles  
 1/2 cup Miracle Whip®  
 Salt and pepper to taste  
 Peel and dice the potatoes into a pan. Cover with cold water and bring to boil. Reduce heat to gently simmer for 20 to 25 minutes or until potatoes are tender. Remove from heat and drain. Put back into pan and place on burner that was used to cook potatoes. Leave turned off. Crack one fresh egg into potatoes. Immediately, beat the egg and potatoes together with an electric mixer. The heat from the potatoes will cook the egg. Add rest of ingredients and stir with spoon to mix well. More or less Miracle Whip® may be needed, depending on how creamy you want the salad. Serve warm.

### GERMAN POTATO SALAD

2 pounds small red potatoes  
 2/3 cup finely chopped red onion  
 1/2 cup cooked, chopped bacon  
 1/3 cup white wine vinegar  
 1 tablespoon olive oil  
 1/2 teaspoon salt  
 1/4 teaspoon black pepper  
 1/3 cup chopped parsley  
 Scrub and place potatoes in large Dutch oven, cover with water. Bring to a boil; reduce heat and simmer 10 minutes or until tender. Drain and cool slightly. Cut potatoes into quarters; place in a large bowl. Add onion and bacon. Whisk together the vinegar, oil, salt and pepper. Pour over potato mixture. Toss gently. Sprinkle with parsley. Serve chilled or at room temperature.

Kelley was also awarded the prestigious Colonel Lee B. Ledford scholarship by the Appalachian College Association (ACA) for summer research endeavors.

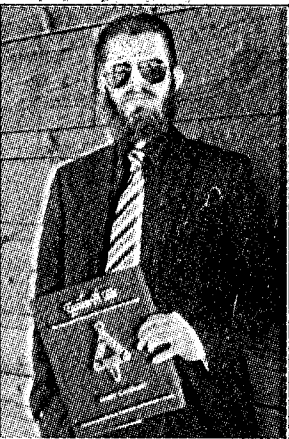

## Local student to attend ELI program in July

Rockcastle County High School student Thomas Burdette is building his business and entrepreneurial skills this summer at The Center for Rural Development's 2015 Entrepreneurial Leadership Institute (ELI).

ELI, one of The Center's summer youth leadership programs, gives participants an in-depth look at what it takes to start and operate their own business venture — from idea development to building a prototype of their business concept.

"We have completely revamped the program to give young aspiring student entrepreneurs the skills they need to become successful business owners and entrepreneurs in Southern and Eastern Kentucky," said Delaney Stephens, youth programs coordinator and community liaison for The Center. Members of the winning student team will earn a \$3,500 scholarship from Eastern Kentucky University.

However, Zane Burton, owner of the winery, said only small farm wineries may apply for an individual business wet/dry vote. Any other wet dry vote would have to be county-wide, he said.

If the vote passes, Burton says he plans to open a wine store in the Village Shops at Renfro Valley. He also said the store would be allowed by law to sell any wines made by small farm wineries in the state of Kentucky but could not sell wines from out-of-state wineries or wineries that are not listed as "small farm wineries."

"The law is rather complicated on this subject," said Burton. "There is a winery license and a small farms winery license. We can't combine the two licenses. As a small farm winery, we cannot have a brewery for beer or sell wine from anyone who is not a small farm winery."

The last wet/dry vote in Rockcastle County was in 2012 when a county-wide

vote failed. For the county-wide vote, there were 1,712 "yes" votes and 3,108 "no" votes. In the east Mount Vernon precinct there were 79 "yes" votes and 139 "no" votes.

This special election will be held in the Mount Vernon Elementary cafeteria on August 4, 2015.

officer Ryan Messinger.

The report says Messinger pulled over the vehicle driven by Rickie Tucker for having no tail lights. Officers noticed three passengers in the vehicle who were "very nervous and appeared impaired."

The officers were given permission to search the vehicle by Tucker, and discovered suspected Methamphetamine under the seat of the vehicle, according to the report. They also found three needles in a bag that also contained personal items belonging to Chasteen.

The report says officers also found a bag containing half of a pill, believed to be Roxicet, in Falin's pants pocket.

Police held separate interviews for the three suspects. According to the report, "Sowder told law enforcement that the drugs belonged to Falin and Falin said that the drugs belonged to Sowder."

Falin is charged with public intoxication-controlled substance, trafficking a controlled substance-first degree-first offense, and possession of a controlled substance-first degree-first offense.

Sowder is charged with trafficking a controlled substance-first degree-first offense, and public intoxication of a controlled substance-first degree.

Chasteen is charged with public intoxication-controlled substance, trafficking a controlled substance-first degree-second offense, and possession of drug paraphernalia.

Det. Darren Allen assisted with the stop and the investigation.

The driver of the vehicle was not charged.

## "Murder"

John Barnett of the London Post of the KSP, authorities first received a 911 call concerning a pile of burning material from Dwayne

Slusher but neither detective knew his relationship (if any) to the suspect. When police arrived and extinguished the fire, they found credit cards and other items that belonged to Hinton, according to Det. Barnett. This is what triggered the welfare check on Hinton's residence. Once at Hinton's home, police discovered her body and information that she had been beaten to death.

Visibly moved bystanders, relatives and friends of Hinton in the courtroom heard details suggesting that the elderly woman had been punched in the throat, beaten in the head with a flat screen television set, and possibly smothered with a pillow.

The two suspects were allegedly caught on a "trail cam" near the residence as well as placed at the scene by several witnesses, according to police.

Det. Barnett told the court that once caught and interviewed, each story from the two suspects matched almost perfectly except for one issue. "Slusher claimed Howard beat Hinton to death and Howard claimed Slusher beat her instead. Most everything else about their stories matched," he said.

Det. Ryan Loudermilk also testified for the prosecution and has worked to assist Barnett on the case. Loudermilk said the three-hour interview he conducted with Slusher, produced information that one could not have known if they had not been in the residence at the time of the murder. "What furniture was moved, which drawers were open and other things that you just couldn't know unless you had been there," said Loudermilk. Barnett said that Slusher claimed to lean down to the floor, hold Hinton's hand and look into her eyes just prior to her death. "She (Slusher) said there was just nothing she could do at that point," he said.

Police also claim the phone lines were cut outside

the home.

According to testimony by both Det. Barnett and Det. Loudermilk, Hinton's credit card was used, after the murder, at six different banks in Mount Vernon and Berea in an effort to get cash. Loudermilk said the bank photos and videos showed Howard using Hinton's card at the ATM machines. Detectives listed names of others in the vehicle with the two suspects as they were driving to the separate banks, and others who had given the two suspects rides on the night in question, but no charges have been filed against any of them.

Cross examinations by attorney's for the defense, attempted to establish an actual murder weapon: After objections by Reynolds, Judge Lawless allowed the line of questioning. Eventually, Loudermilk stated that he believed the murder weapon to be the flat screen television due to the blood and hair found on the device.

Barnett also said he was told by Howard that the two women were after money and drugs. He also listed witnesses that allegedly saw Howard and Slusher on the corner of Hinton's property on the night of the murder.

Loudermilk said that he was informed by Slusher that they had intended to purchase two eight-balls (1/8 of an ounce) of Methamphetamine, in order to use one of the eight-balls and "cut and sell the other."

At the end of the hearing, Judge Lawless said he "finds probable cause" to hold the two accused on multiple charges. Some of the charges may be amended before the trial but as it stands after the hearing, charges of murder, first degree robbery and first degree burglary are not expected to change. Degrees of offense and charges that may change include fleeing, tampering with evidence, public intoxication, resisting arrest and possession of drug paraphernalia.

## Anniversary of missing teen brings renewed search

Two years ago this week, Berea teen Brookelyn Farthing disappeared from a home in Berea. The search for her has not stopped for family, friends and authorities.

In fact, on the two-year anniversary of her disappearance, a renewed effort has begun in an effort to keep the public informed and to keep possible tips coming in.

According to the Kentucky State Police, witnesses said Farthing, now 20 years old, disappeared the morning of Saturday, June 22nd from a home on Dillon Court in Berea. She was 18 at the time.

This home also caught fire the same morning. No human remains were found inside the home but KSP and arson investigators are still trying to determine if the fire is related to Farthing's disappearance.

Reports said Farthing did not live in the home but she attended a party there on Friday night, June 21st. Another friend, who was also the homeowner, said he was with

Farthing before he left his home early in the morning on June 22nd and when he came back Farthing was gone and there was a fire inside the house.

KSP investigators believe that Farthing did not disappear on her own since a lot of her belongings were left inside the home.

Farthing is described as 5'1" with blonde hair and brown eyes.

On the anniversary of her disappearance, Farthing's parents have created a website to help with investigations. Anyone may visit the site at [findbrookefarthing.com](http://findbrookefarthing.com).

The anniversary has also brought renewed media attention to the missing teen as Lexington television news programs and many other newspapers across the state are asking for help in the search this week.



Brookelyn Farthing has been missing since June 22, 2013.

Rumors and tips flooded the area for months after her disappearance and police from many different agencies conducted many fruitless searches based upon those tips. However, authorities are still eager to receive any and all information anyone may have about the missing girl.

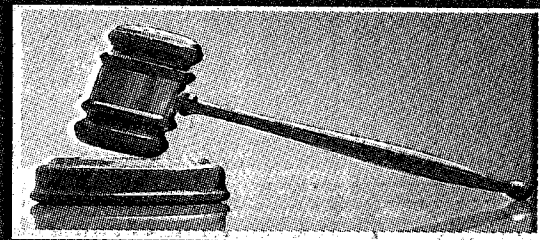

# Use proper eye protection

Every angler has at one time or another forgotten something in their rush to leave for a fishing trip.

It's disheartening when that something is sunglasses. Squinting and shielding your eyes for hours takes some of the fun out of the experience.

"More than just the damage or discomfort from the bright light, you start getting eye strain because you're squinting to make your pupil even smaller because your pupil doesn't get small enough naturally," said Dr. Seema Capoor, an associate professor of Ophthalmology at the University of Kentucky. "The squinting causes brow ache and tension headaches. It's much more comfortable and safer with sunglasses."

However, not all sunglasses are created equal. The best cut glare and make it easier to see into the water but also block the sun's harmful rays.

Amid a sea of brands and styles and lens types and colors at a wide range of prices, it's easy to become overwhelmed by the choices, so stick to some basic criteria when selecting a pair.

"For something like fishing where you've got a lot of reflection off the surface of the water and you're out in direct sunlight my recommendation would be to go with more of the wraparound style of sunglasses," Capoor said. "Get the good UV filter in the lenses and polarization. The anti-reflective coating or mirror coating on the outside surface is also very helpful."

Look for sunglasses that block 99 to 100 percent of ultraviolet rays.

Ultraviolet radiation can affect different layers of the eye and continued exposure without protection may lead to permanent eye damage. Regular use of sunglasses can slow down cataract formation and lessen the risks of macular degeneration. They can also retard the development of pterygium, an eye condition distinguished by a wing-like growth on the cornea that can interfere with vision and affect anyone who spends a lot of time outdoors, Capoor said.

"We know it's associated with exposure to ultraviolet light," she said.

"Fishermen get it a lot. Farmers get it. And closer to the equator where people are at higher altitudes, they get it. It can start out young and then the continued exposure without protection can make it progress and get worse. It can require surgical intervention."

Children and people with light-colored eyes should be particularly mindful about wearing sunglasses.

"Times have changed and there's more penetration of ultraviolet light from the atmosphere than there was 30 years ago," Capoor said. "It is advisable for children, especially blue-eyed or light-eyed children, to be wearing protective sunglasses now."

Composite lenses made from impact-resistant polycarbonate material are lighter than glass and ideal for anglers.

Polycarbonate also is the preferred lens material for shooting glasses. Protective eye wear is required at all shooting ranges on Wildlife Management Areas in Kentucky.

"Things can happen when you're shooting guns," said Mark Marraccini, spokesman for the Kentucky Department of Fish and Wildlife Resources and an experienced trap shooter. "A lot of your automatics, whenever the shell is ejected and it comes flying back, little hot flecks of burning powder may come out with it. They'll get in the corner of your eye and they're painful. Plus, a lot of times, other people on ranges are shooting and there's the off chance that you can get ricochets and deflections or pieces of shot. On pistol ranges, bullets shatter when they hit steel silhouettes and you can get sprayed that way."

It's important to remember that there's a real serious explosion at really high pressure that's happening about three inches in front of your face. When you put it that way, shooting glasses are extremely important.

On the water, polarized lenses are highly recommended for anglers because they sharpen vision by reducing glare from the sun's reflection.

Darker lenses don't necessarily block more UV rays although they may be

preferred by people who are extremely sensitive to light. The environmental conditions can dictate the right lens color.

Gray, brown and green tints are best at providing maximum contrast while maintaining clarity and offering the most sun protection, Capoor said.

Most anglers prefer grey, green or amber colored lenses.

Gray is a good all-purpose lens tint that cuts down on extremely bright conditions and won't distort colors. Green also limits color distortion, reduces glare and improves contrast in bright sun. Brown and amber are versatile tints that cut glare and filter out blue light, increasing contrast and sharpness, especially on cloudy days.

Yellow reduces glare and enhances depth perception and contrast in low light or hazy conditions. It is considered a better option for shooters than anglers.

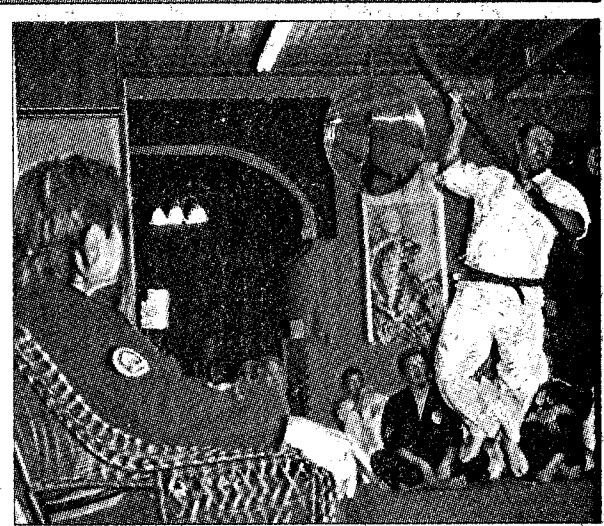
"Different lens colors will help different colored targets stand out better," Marraccini said. "In different lighting conditions, they make the targets even more visible than if you weren't wearing any glasses at all."

We're taught to apply sunscreen liberally and often to protect our skin from overexposure to the sun. Sunglasses and shooting glasses are just as important. Summer is a great time to shop around for the right pair and to remember not to leave them at home. Your eyes will thank you.

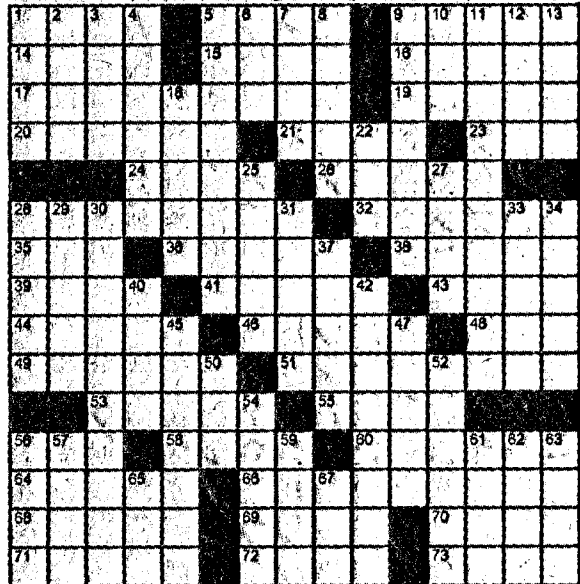

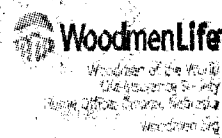


