Slusher gets 50 years for murder of local woman

 Kimberly Slusher, of Mount Vernon was sentenced to 50 years in state prison by Circuit Judge David Tapp Friday for the murder of 86-year-old Mary Hinton in 2015.

Slusher and Tabitha Howard pled guilty to several charges relating to the murder and Howard was sentenced to 24 years earlier this month.

However, Slusher was sentenced Friday in a courtroom filled with family and friends of the elderly Mount Vernon woman who was killed.

Police say Slusher and Howard broke into the home of Hinton, beat her to death and stole several items and later attempted to destroy those items.

Judge Tapp told those in attendance that Slusher had provided him with a written statement before the sentencing. "It is one of the better written statements that I have ever seen," said Tapp.

The judge read part of the statement to the public in which Slusher said Hinton was a "kind and wonderful woman," she offered her "deepest apologies" for her role in the murder.

However, Tapp also read part of a victim impact statement that said, "I can't remember a time without her (Hinton). She was the most loving, giving and Godly woman I knew."

Tapp told Slusher that the murder was senseless. "This woman has cooked for you and you were welcomed into her home. Most anything you stole, she would have given to you if you had simply asked," he said.

The judge continued on to say "there is no justice" in the sense that Hinton cannot be brought back. But perhaps the family may take solace in the fact that her murderer is behind bars.

After the sentencing, Tapp addressed Slusher saying, "I wish you the very best. Good luck," he said.

Fiscal Court discusses veterans park

Members of the Mt. Vernon-Rockcastle County Tourist Commission met with the Rockcastle Fiscal Court in a special called meeting last Friday. The purpose of the meeting was to discuss moving along a plan presented by local resident Kathy Bobo to build a Veterans Park in the Renfro Valley area.

Ms. Bobo and her husband, Rick, both veterans of the US Air Force, are active in local veterans affairs in the community. Ms. Bobo is adjutant of the local American Legion Club and her husband is the post commander.

County Judge/Executive Doug Bishop opened the discussion by telling the tourism commission members that he thought the park would be "great for our community and would bring more people to the area and help tourism." He also noted that, in his opinion, the Renfro Valley area was the best place for the park. The judge added that he felt that young people were not being taught the concept of

"how our country got where we are and who made the sacrifice to ensure our freedom" and this park would be beneficial for that. He also mentioned the veterans park recently built in McKee and what a wonderful asset it was to the community.

Ms. Bobo had originally asked for the area where the Vietnam Moving Wall was displayed last summer but Susan Tomes, director of the Mt. Vernon-Rockcastle Tourism Commission said that area was used to hold necessary fund-raising events. The area behind the Aunt Polly House, two acres +/-, was then requested by Ms. Bobo and Tomes said the only problem with that location was the possibility of needing the area for expanded parking.

Lake Linville park going strong already

 As spring has arrived, the Lake Linville City Park is already bringing families out to enjoy the weather and the many free activities in Mount Vernon, according to City Administrator Josh Bray.

"The park is going very well and provides an excellent place for local families as well as tourists to enjoy the outdoors," he said.

The city is working on a new splash pad that is expected to be completed within a few months. "The splash pad is a great way for kids to run and play in the water on a nice, hot summer

day. And I believe a lot of adults will enjoy it as well," Bray said.

The city has allocated \$19,000 for the materials for the new splash pad and has other money in the budget to upgrade the local park, including new mulch around the swing set and the playground near the lake.

The park has been a great asset for the city, according to Bray. "This is a huge benefit for the city in more ways than one," he said. "Not only is this a comfortable, safe environment for local citizens, but we are able to at-

Two doctor's offices locate here

 Two new doctor's offices are benefiting the communities of Livingston and Brodhead in Rockcastle County.

In Livingston, Dr. Thomas Fowles recently opened offices on Main Street which provides full service care, according to Registered Nurse and wife of Fowles, Amy Fowles.

"Money is not the issue with us," she said. "Of course we want to get paid but we are here to provide a service to the community and our fees for those who don't have insurance are extremely low. It's one way

of giving back to the community."

Fowles' office provides everything from check-ups to emergency care. "We provide stitches, wound care, flu cases, injuries, blood pressure, lab work and many other services," said Amy Fowles.

The office also offers joint injections which Fowles said keeps local residents from having to go to an orthopedic doctor.

Currently, the office is only open on Fridays from 10 a.m. to 6:00 p.m. and walk-ins are welcome.

I'm not sure whether it was April 1987 or '88, but I'm thinking it was '87, thirty years ago come April 17 when we had a late snow that dumped more than a foot of the heavy, white stuff on Harmon's Lick, here in Garrard County.

I do recall, in vivid detail, that we'd had a very mild March and first two weeks of April that year and that I had numerous plants in my garden already as far along, growth wise, as they would normally have been in early May.

In those days I was fond of growing broccoli, cauliflower, Brussels sprouts, cabbage and a host of salad fixings such as spinach, lettuce, radishes, Swiss chard etc. I've since stopped growing most cole crop vegetables because they are so prone to being wormy and I have never been able to organically control the pests. Loretta is so deathly scared that she will eat a broccoli, cabbage or cauliflower worm that she butchers the heads beyond recognition before they hit the steamer.

I'm reasonably sure that I have eaten numerous such worms in my life because I don't waste a lot of time trying to find them but that's another story for another time.

I'm also reasonably sure that I didn't eat any cole worms in the spring of 87 because the big snow destroyed all my plants except for the Brussels sprouts which actually grow much better if all but the top few leaves are stripped off their stalks. And after the snow melted that's all I had left of anything in the garden--

several dozen pale green stalks that, only the day before, would have made a photograph worthy of the cover for the most expensive seed catalogues or gardening magazines.

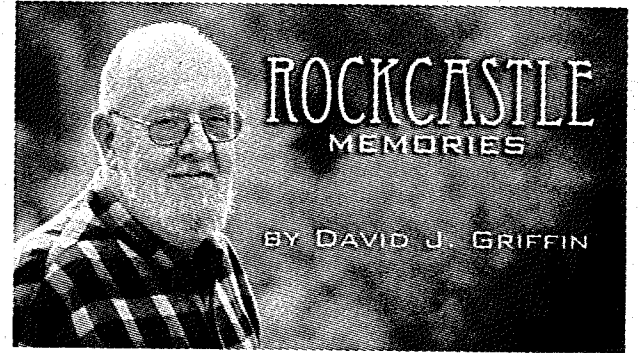
My brother Keith (Keeter) was working a job at the time where he literally had to schedule his vacation a year in advance. He and his family, consisting of wife Nancy, 2 sons younger than 12 and a 7 year-old daughter had long-planned and anticipated a week of April fishing and camping. Daughter Tracy would stay at our place with Loretta and our kids while I went on the big outdoor adventure with Keeter, Nancy and the boys.

They all showed up, bass boat in tow, after dark on the evening before our scheduled departure for the campground just over 100 miles away and situated 200 yards or so below Lake Cumberland's Wolfe Creek Dam.

When we got up to leave the next morning the boat was loaded with at least a ton of the heaviest, wettest snow I have ever experienced that had fallen while we slept and dreamed of live-wells teeming with big crappie. Keeter, the boys, and I managed to get it mostly unloaded with some fire place shovels and a steady stream of hot water made possible by running a garden hose through our bathroom window. We figured it would finish wind-drying on the way to the lake.

When you have spent many months looking forward to a fishing trip, knowing, full well, that you will not have the opportunity again for at least another year, you do not let something as trivial as a blizzard disrupt your plans, especially if you call the bait store located just 8 miles up the road from your campground and learn that they only have about 4 inches of snow there. And, since the campground is sheltered by a forest of towering loblolly pines, clean-

Cry ("cuh-RYE")

I love researching early rock and roll songs, and particularly the performers who made that particular tune stand out in the public's view. One such song was recorded late in 1951, and made its way to the number one spot in both the pop and rhythm and blues charts. I can still hear Johnnie Ray and his emotion-packed rendition of the song, "Cry".

If your sweetheart sends a letter of goodbye

It's no secret you'll feel better if you cry

When waking from a bad dream

Don't you sometimes think it's real

But it's only false emotions that you feel

If your heartaches seem to hang around too long

And your blues keep getting bluer with each song

Remember sunshine can be found behind the cloudy skies

So let your hair down and go on and cry

So let your hair down and go right on and cry...

"Cry" was one of those songs that made you grab the volume-control knob and crank up the intensity until you felt that he was in the room - or in the front seat of your car. It was one of those tunes that always made everyone want to sing along. After all these years, I can still remember every long-lingering word.

Ray continued to record songs that made the Top 25 charts throughout the 50s and beyond. After hitting the number one spot in 1951, he came back in 1953 with the number 14 hit of "Such a Night"; a song that Elvis would revitalize during the 60s. Ray also hit the number 12 spot in 1956 with "Just Walking in the Rain."

"Cry" was penned by Churchill Kohlman, an African-American night watchman, who wrote song lyrics during the day. His lifelong goal was to write a song that would climb up the music charts - that dream that was fulfilled when Ray recorded his song. The musicians in the studio were said to be "breathless" as Ray made the recording.

Ray's entrance into the music charts with his first recording was totally unexpected but there was one particular reason above all others: he was almost totally deaf from the tender age of thirteen. Unbeknownst by most, he always performed wearing hearing aids.

Ray was actually a singer, songwriter, and pianist who was extremely popular for most of the 1950s. He was even cited by noted musicians as being a major precursor of

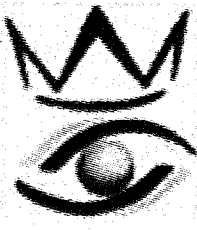

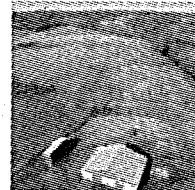

appropriate gowns. They were variations of "I was taking a shower and I heard a knock at the door, so I wrapped this towel around me, and here I am" look. I finally found just "the" one...at about half-price. It was ivory with loads of lace and pearls. It had a cathedral train of about ten feet. There were about twenty some covered buttons down the back in loops and on each sleeve...very Victorian. I had a crew of about three helping me get dressed and all primed. Poor old Stanley really had a hard time getting me out of all those buttons that night. He was thinking about taking his pocket knife to all those buttons. I wore a tiara instead of a veil. The tiara was my borrowed item. It belonged to a great niece who had won it in a pageant and at the time was serving in the Persian Gulf in the Navy and was unable to attend.

I found some bridesmaids dresses on sale, too. They looked nice and were peach. Stanley wore a white tuxedo with a peach vest and bow tie. The best men wore black tuxedos with peach vests and bow ties. The ringbearer's front tooth was loose and his shoes had come too tight but his little tux looked nice and he was so well behaved during the whole service.

It was a twilight service with candlelight, and by the end of the service we were starved. We hadn't eaten since the night before. Unfortunately we had a difficult time in eating...the photographer and everybody wanted our pictures. We finally got to eat, have our first dance, had a toast, and all of the trappings that usually follow. Thank God we had plenty of food...and more than enough cake.

It was a bittersweet time for me, as my mother was terminally ill during the

planning of the wedding and had died twelve days before. We had planned to honeymoon in Gatlinburg, which would be close to home in case she got suddenly

Youth Loans
 The Farm Service Agency makes loans to youth to establish and operate agricultural income-producing projects in connection with 4-H clubs, FFA and other agricultural groups. Projects must be planned and operated with the help of the organization advisor, produce sufficient income to repay the loan and provide the youth with practical business and educational experience. The maximum loan amount is \$5000.

Youth Loan Eligibility Requirements:
 Be a citizen of the United States (which includes Puerto Rico, the Virgin Islands, Guam, American Samoa, the Commonwealth of the Northern Mariana Islands) or a legal resident alien
 Be 10 years to 20 years of age
 Comply with FSA's general eligibility requirements
 Be unable to get a loan from other sources
 Conduct a modest income-producing project in a supervised program of work as outlined above
 Demonstrate capability of planning, managing and operating the project under guidance and assistance from a project advisor. The project supervisor must recommend the youth loan applicant, along with providing adequate supervision.
 Stop by the county office for help preparing and processing the application forms.

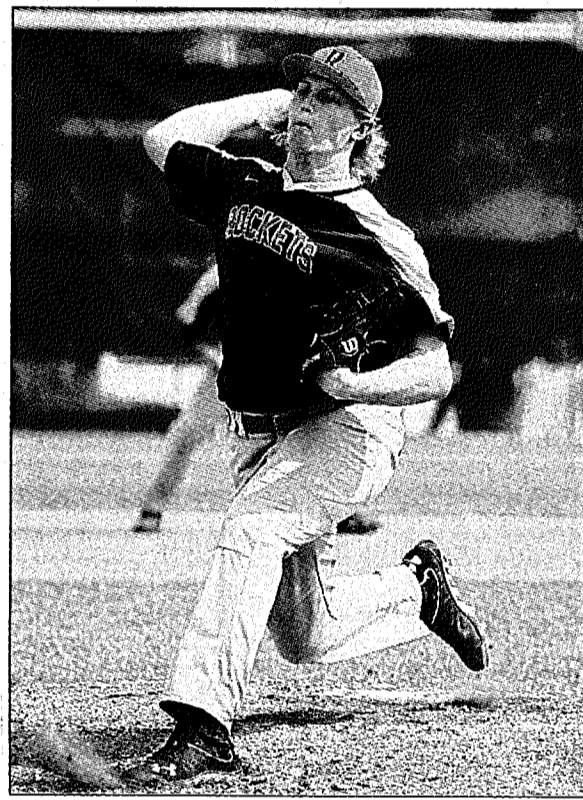

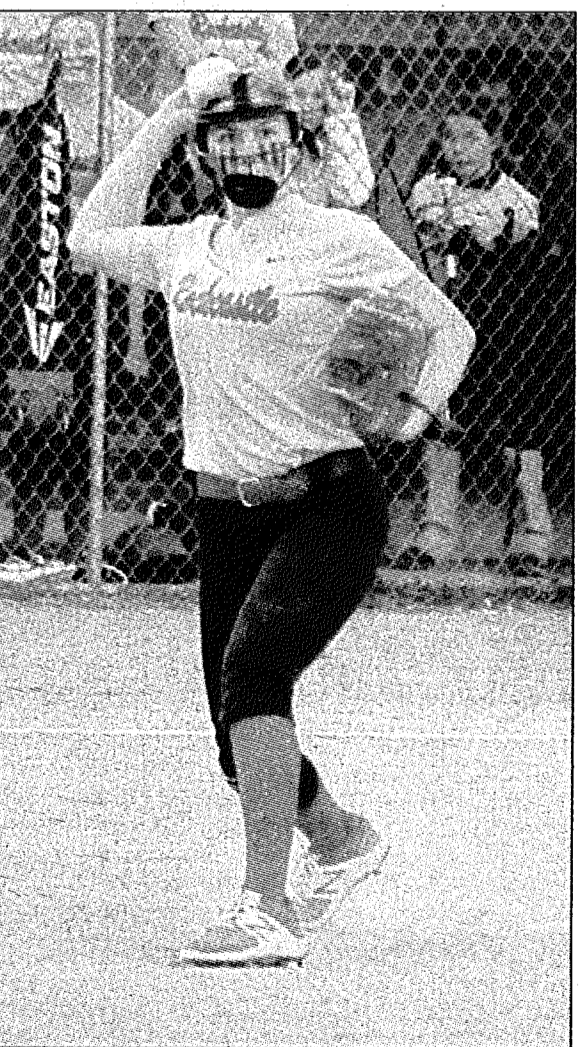

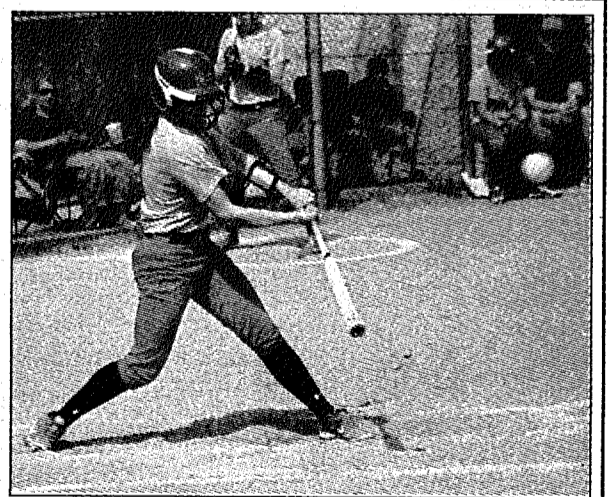

Yates competes in state swim meet



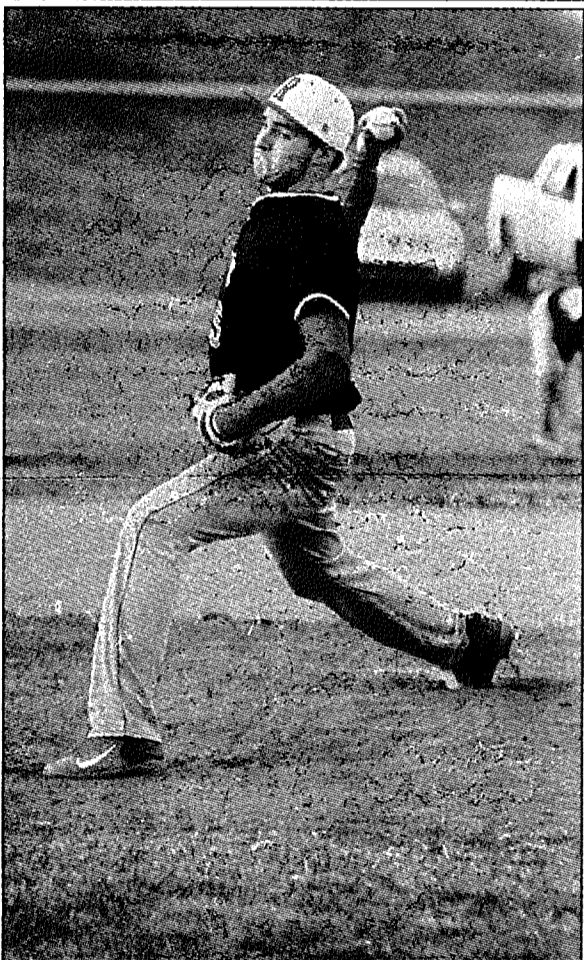

However, Fowles says, as the need grows and the community becomes familiar with the office, hours will be expanded to meet local needs.

from people interested in seeing the park built, particularly since this is the 100th anniversary of our country's entry into WWI. He said that some callers had suggested the memorial be built in front of the courthouse but he felt there was not adequate space for it there.

Magistrate Shannon Bishop asked the tourist commission members if they were in favor of the park at the location behind the Aunt Polly House since this issue needed to be decided before plans could be carried further for financing, etc.

Tomes answered that she didn't want there to be any question about it that she was "100% behind the project" but that she couldn't speak for the

board.

Judge Bishop noted that the county currently holds a lien on the property as security for a \$400,000 note which the county helped the former board of the Kentucky Music Hall of Fame acquire and insinuated that there might be some payment made to the tourist commission for the land. "We can have a clause in the contract that if it (the veterans park) doesn't happen, the land would revert to the tourist commission for the same price paid them." The judge also reported that he had had offers of donations to help with funding the project.

Late in the discussion, Neal Sluder, a tourist commission board member, asked if the land in front of the Aunt Polly House wouldn't be a better site, because of its visibility.

Bishop responded that he had always thought that would be the best site but didn't think the tourist commission would approve its location there. This site is slightly smaller than the area behind the Aunt Polly House.

When contacted, Ms. Bobo told the *Signal* that she was "very excited" and would be very much in favor of using the site in front of the Aunt Polly House for the park because of the enhanced visibility and because of possible water problems in the area which is lower lying than the area in front of the Aunt Polly House.

The upshot of the discussion was that the tourist commission board members would review the sites and discuss the proposal at their Monday night board meeting.

tract tourists from all over the county to our campground area. This brings dollars to our community and benefits every citizen."

With over 20 campsites available, the city sees tourists from across America visiting Mount Vernon and with the new, refurbished boat docks, local residents are able to utilize the benefits of leaving their boat at the lake.

Bray says the dock fee is only \$65 per month and new gates and locks have been installed at the local park protecting everyone on site.

The city has also placed new grills at the picnic sites and the whole area provides a clean, family environment for anyone local or visiting from a distance.

There are also shelters available for birthday parties as well as a baseball field for anyone who wishes to use them.

Bray says it may be a good idea to call and reserve the baseball field or volleyball courts just to make sure the area is available. But both areas are free to the public.

"The city is proud to provide this park for our citizens. It's a good, clean, safe atmosphere for everyone to enjoy the summer and their free time," he said. "The Mayor and city council are dedicated to providing this park to our citizens as well as bringing tourists to our area."

DAR needs assistance with WWI tribute

World War I called the "Great War" was fought from 1914-1918. The United States, by declaration of President Woodrow Wilson, formally entered the war 6 April 1917 and tipped the balance to Allied victory. The United States responded to threats to its economic and diplomatic interests but also wanted to, in the words of President Wilson, "make the world safe for democracy". Our nation would emerge from the war a significant world power.

Mobilization of Americans and its industry was unprecedented. Nearly one million women joined the workforce and African Americans along with other minorities worked in the factories to produce weapons, equipment and supplies. Two million Americans volunteered for the army, and nearly three million were drafted.

By Armistice Day, 11 November 1918, approximately 116,516 Americans died as a result of combat and another 200,000 were wounded. The impact of World War I was felt for generations. Methods of warfare were forever altered. The map of Europe was completely redrawn at the conclusion of the war,

and decisions that followed may be attributed to the start of World War II in 1939.

In preparation for our nation's WWI centennial, Congress established the United States World War One Centennial Commission to commemorate the war through various programs, projects, and activities. The National Society Daughters of the American Revolution is a Partner Organization with the Commission. Their goals of "Honor, Educate, and Com-

memorate" align closely with the DAR goals of "Historic Preservation, Education and Patriotism."

The Rockcastle Chapter DAR is in the process of working on a tribute to Rockcastle County World War I soldiers who served in the war. Research has shown that not all of the county men were in Rockcastle at the time of registration and some did not register at all but still served in the military.

Every effort is being

made to include every soldier but as any genealogist knows, someone will inadvertently be left out. We are looking to the Rockcastle community to help make sure that doesn't happen. 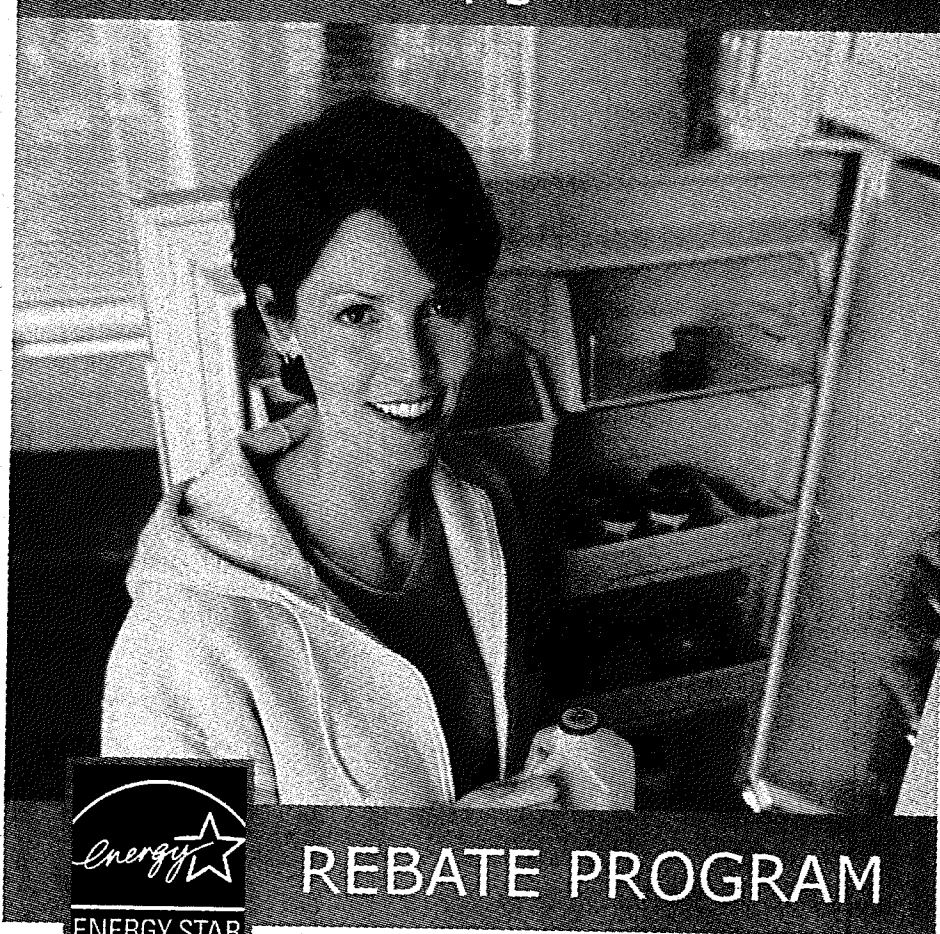

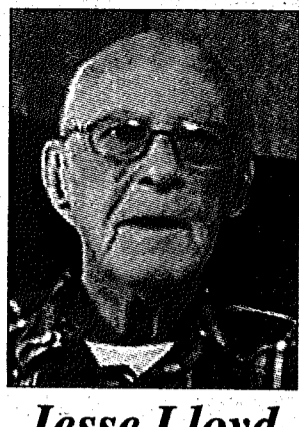

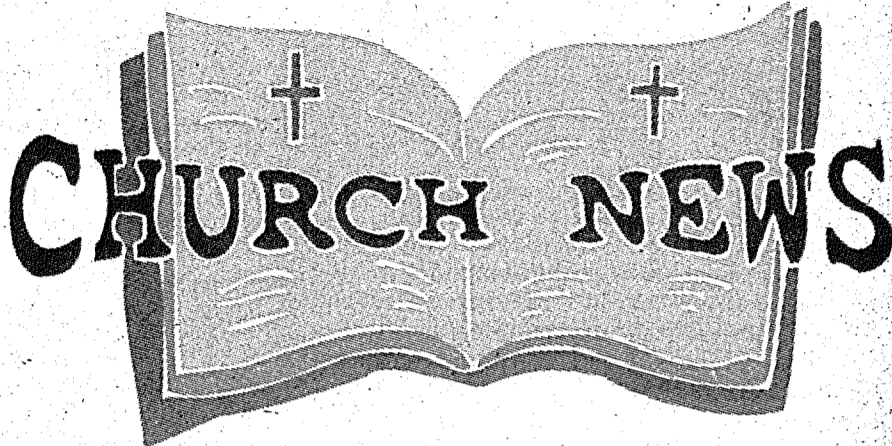

Frankfort Update

Legislature Moves into Final Days of Session

This week, the House and Senate are meeting for the final two days of this legislative session, following a ten day recess for the Governor to either sign bills into law or veto them. During this veto period, Governor Bevin signed a multitude of bills into law that will positively benefit Kentuckians and help move our state forward.



Of special interest to me and many people in our community, it was good to see the Governor sign legislation dealing with foster care and adoption placement. HB 180 would allow for foster children to be placed with a responsible adult who is not a blood relative, but has a significant relationship with the child. HB 192 will allow a foster child to sign their own application for a driver's license or permit. These minors often do not have an adult guardian to sign for them, leaving them unable to get their license, as many of their peers are able to do.

I was also glad to see him sign into law the 'Blue Lives Matter' bill, House Bill 14. This legislation gives additional legal protections to police officers, firefighters, and EMS personnel by making it a hate crime to target them due to their status as a first responder.

Earlier this week, the Governor did decide to veto four bills passed by the General Assembly. In the final legislative days this week, legislative leaders from both chambers will come together and decide whether we want to override these vetoes or not. If we were to override them, as the Kentucky Constitution gives the legislature the authority to do, it would take a constitutional majority, or 51 votes. Below are the four bills that he chose to veto:

• HB 471- This legislation was an appropriation measure that amended the state budget, which included a variety of appropriations. The Governor line-item vetoed one provision, meaning he struck it from the

bill while leaving the rest intact, which would have put settlement money the state received from Volkswagen into a trust fund that only the legislature could spend. The Governor wishes for the \$19 million in settlement money to go straight into the state's general fund.

• SB 91- This legislation, commonly referred to as 'Tim's Law,' would allow a judge to order outpatient treatment for some individuals who have a history of psychiatric hospitalization.

• SJR 57- This resolution would rename certain roads in Southeastern Kentucky, forming the "Copperhead Trail" that would go through eleven different counties. He cited confusion within the Transportation Cabinet over roads in the area which have already been named.

• HB 540- This bill deals with airport safety by regulating the usage of drones in airspace near airports. HB 540 would allow commercial airports to create flight maps for drone users to abide by, therefore creating more localized restrictions on drones separate from FAA regulations.

We will do our due diligence in the coming days to review the Governor's veto messages, and decide how to

proceed on the measures. After doing this, we will take action on a few more important bills, and then conclude this session on Thursday.

While the 2017 Regular Session of the General Assembly will be gaveling out, it is likely that we will be meeting again in the fall for a special session to tackle the pension crisis and tax reform. A lot of work must be done in the meantime. I am committed to working with my fellow legislators, the Governor, and all stakeholders towards developing positive outcomes on both of these major issues.

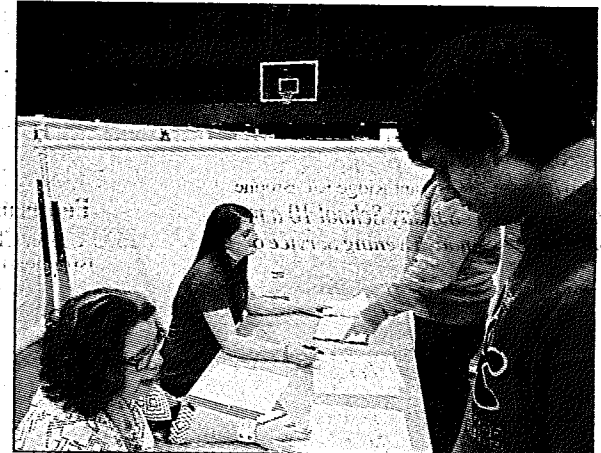

After their taxes were deducted, the students began the experience by opening checking and savings accounts.

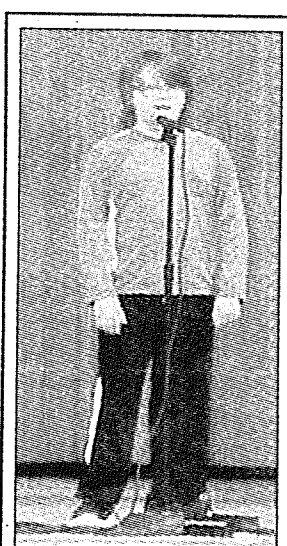
Students then had the opportunity to go to many stations and purchase a home and car, obtain insurance and pay for other regular monthly household expenses.

The goal of the experience was that at the end of the "month" the students were able to meet their obligations and still have money to put in savings.

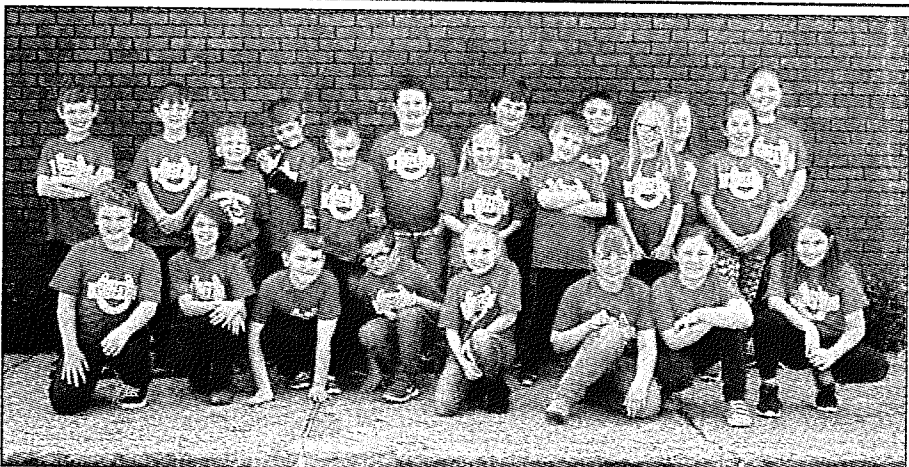
While some students have expensive tastes, they learned that they may have to scale down on their expenses to make ends meet. Some took second jobs while others learned to make due with less.



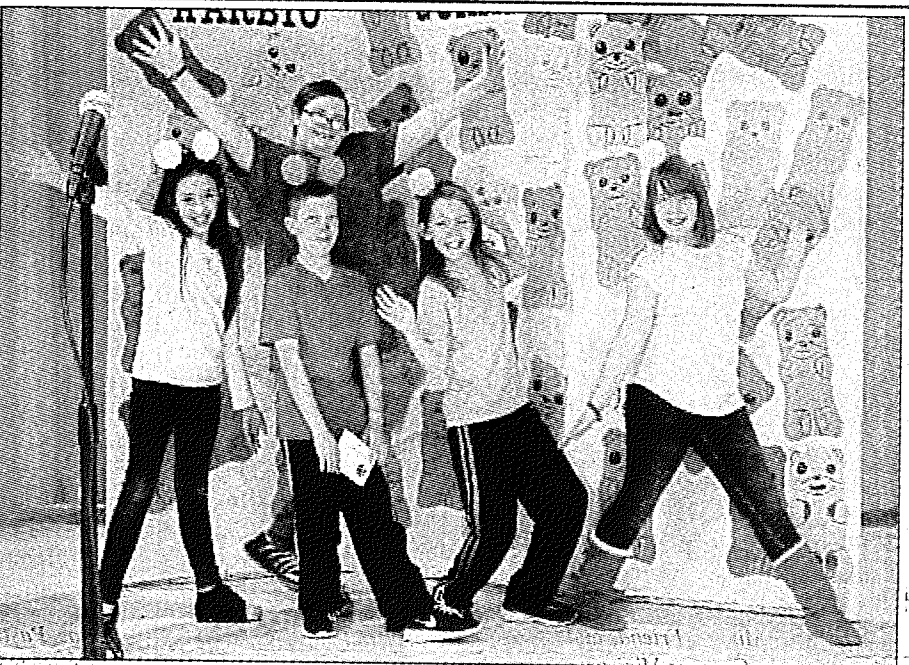
